6	A BILL to amend and reenact § 46.2-739 of the Code of Virginia, relating to special license plates for
7	disabled veterans.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 46.2-739 of the Code of Virginia are amended and reenacted as follows:
10	§ 46.2-739. Special license plates for certain disabled veterans; fees.
11	A. On receipt of an application, the Commissioner shall issue special license plates to applicants who
12	are disabled veterans as defined in § 46.2-100 who have been certified by the U.S. Department of
13	Veterans Affairs to have a service-connected disability or unremarried surviving spouses of such disabled
14	veterans as defined in § 46.2-100. These license plates shall be special permanent red, white, and blue
15	license plates bearing the letters "DV." The application shall be accompanied by a certification from the
16	U.S. Department of Veterans Affairs that the veteran has been so designated and that his veteran's
17	disability is service-connected. License plates issued under this subsection shall not permit the vehicles
18	upon which they are displayed to use parking spaces reserved for persons with disabilities that limit or
19	impair their ability to walk.
20	B. On receipt of an application, the Commissioner shall issue special DV disabled parking license
21	plates displaying the international symbol of access in the same size as the numbers and letters on the
22	plate and in a color that contrasts to the background to veterans who are also persons with disabilities
23	that limit or impair their ability to walk as defined in § 46.2-100. The Commissioner shall require that
24	such application be accompanied by a certification signed by a licensed physician, licensed podiatrist,

licensed chiropractor, licensed nurse practitioner, or licensed physician assistant to that effect. Special
DV disabled parking license plates issued under this subsection shall authorize the vehicles upon which
they are displayed to use parking spaces reserved for persons with disabilities that limit or impair their
ability to walk.

C. No annual registration fee, as prescribed in § 46.2-694, and no annual fee, as set forth in
subdivision B 3 of subsection B of § 46.2-725, shall be required for any one motor vehicle owned and
used personally by any disabled veteran as defined in § 46.2-100 or the unremarried surviving spouse of
such disabled veteran, provided that such vehicle displays license plates issued under this section.

33 D. The provisions of subdivisions B 1 and 2 of subsection **B** of § 46.2-725 shall not apply to license 34 plates issued under this section.
