10	Be it enacted by the General Assembly of Virginia:	NTRODUCED
11	1. That § 46.2-646 of the Code of Virginia is amended and reenacted as follows:	
12	§ 46.2-646. Expiration and renewal of registration.	
13	A. Every registration <i>issued</i> under this title <i>prior to July 1, 2015</i> , unless otherwise provided, shall	
14	expire on the last day of the twelfth month next succeeding the date of registration. Every registration,	
15	unless otherwise provided, shall be renewed annually on application by the owner and by payment of	
16	the fees required by law, the renewal to take effect on the first day of the month succeeding the date of	Ŭ
17	expiration. Notwithstanding these limitations, the Commissioner may extend the validity period of an	
18	expiring registration if (i) the Department is unable to process an application for renewal due to	
19	circumstances beyond its control, and (ii) the extension has been authorized under a directive from the	
20	Governor. However, in no event shall the validity period be extended more than 90 days per occurrence	
21	of such conditions.	
22	B. All motor vehicles, trailers, and semitrailers registered in the Commonwealth shall, at the	
23	discretion of the Commissioner, be placed in a system of registration on a monthly basis to distribute	HI
