11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 54.1-4200 and 54.1-4201.1 of the Code of Virginia are amended and reenacted and that
13	the Code of Virginia is amended by adding sections numbered 18.2-308.2:5 and 54.1-4201.2 as
14	follows:
15	§ 18.2-308.2:5. Criminal history record information check required to obtain firearm from firearms
16 17	show vendor; penalties. No firearms show vendor, as defined in § 54.1-4200, shall transfer a firearm at a firearms show, as
18	defined in § 54.1-4200, unless the firearms show vendor has obtained verification from a dealer in
19	firearms, as defined in § 54.1-4200, that information on the prospective purchaser or transferee has
20	been submitted for a criminal history record information check as set out in § 18.2-308.2:2 and a
21	determination has been received from the Department of State Police that the prospective purchaser or
22	transferee is not prohibited under state or federal law from possessing a firearm. The firearms show
23	promoter's designated dealer, as provided in accordance with subsection B of § 54.1-4201.2, shall
24	provide a means by which vendors may obtain the approval or denial of firearm transfer requests based
25	on criminal history record information checks. The Department of State Police shall provide a means by
26	which the firearms show promoter's designated dealer may obtain criminal history record information.
27	The processes established shall conform to the provisions of § 18.2-308.2:2, and the definitions and
28	provisions of § 18.2-308.2:2 regarding criminal history record information checks shall apply to this
29	section mutatis mutandis. The firearms show promoter's designated dealer shall collect and disseminate
30	the fees described in § 18.2-308.2:2 as required by that section. The dealer may charge and retain an
31 32	additional fee not to exceed \$15 for obtaining criminal history record information checks for vendors.
32 33	This section shall not apply to the transfer of any antique firearms, curios, or relics as defined in § 18.2-308.2:2.
33 34	Any person who willfully and intentionally requests, obtains, or seeks to obtain criminal history
35	record information under false pretenses or who willfully and intentionally disseminates or seeks to
36	disseminate criminal history record information except as authorized by law is guilty of a Class 2
37	misdemeanor.
38	Any person who willfully and intentionally makes a materially false statement on the consent form
39	required by § 18.2-308.2:2 or on such firearm transaction records as may be required by federal law is
40	guilty of a Class 5 felony.
41	Any person who willfully and intentionally sells, rents, trades, or transfers a firearm in violation of
42	this section is guilty of a Class 6 felony.
43	§ 54.1-4200. Definitions.
44 45	For the purpose of this chapter, unless the context requires a different meaning:
45 46	"Dealer in firearms" means (i) any person, firm, partnership, or corporation engaged in the business of selling, trading or transferring firearms at wholesale or retail; (ii) any person, firm, partnership, or
47	corporation engaged in the business of making or fitting special barrels, stocks, or trigger mechanisms to
48	firearms; or (iii) any person, firm, partnership, or corporation that is a pawnbroker.
49	"Engaged in business" means as applied to a dealer in firearms a person, firm, partnership, or
50	corporation that devotes time, attention, and labor to dealing in firearms as a regular course of trade or
51	business with the principal objective of livelihood and profit through repetitive purchase or resale of
52	firearms, but such term shall not involve a person who makes occasional sales, exchanges, or purchases
53	of firearms for the enhancement of a personal collection or for a hobby, or who sells all or part of his
54	personal collection of firearms.
55	"Firearms show" means any gathering or exhibition, open to the public, not occurring on the
56 57	permanent premises of a dealer in firearms, conducted principally for the purposes of exchanging, selling or trading firearms as defined in $8.182-308.2$ .

58 "Firearms show vendor" or "vendor" means any person not licensed as a Virginia dealer pursuant to

59 18 U.S.C. § 921 et seq. who exhibits, sells, offers for sale, transfers, or exchanges any firearm at a 60 firearms show, regardless of whether the person arranges with a firearms show promoter for a fixed 61 location from which to exhibit, sell, offer for sale, transfer, or exchange any firearm.

62 "Promoter" means a person, firm, corporation, club, association, or organization holding a firearms 63 show in the Commonwealth.

64 § 54.1-4201.1. Notification by sponsor of firearms show to State Police and local 65 law-enforcement authorities required; records; penalty.

A. No promoter of a firearms show shall hold such show without giving notice at least 30 days prior 66 to the show to the State Police and the sheriff or chief of police of the locality in which the firearms 67 show will be held. The notice shall be given on a form provided by the State Police. A separate notice 68 69 shall be required for each firearms show.

70 "Promoter" means every person, firm, corporation, club, association, or organization holding a 71 firearms show in the Commonwealth.

The promoter shall maintain for the duration of the show a list of all *dealers*, vendors, or exhibitors 72 73 in the show for immediate inspection by any law-enforcement authorities, and within five days after the 74 conclusion of the show, by mail, by hand, by email, or by fax, transmit a copy of the complete *dealer*, 75 vendor, or exhibitor list to the law-enforcement authorities to which the 30-day prior notice was 76 required. The vendor or exhibitor list shall contain the full name and residence address and the business 77 name and address, if any, of the *dealers*, vendors, or exhibitors. 78

B. A willful violation of this section shall be a Class 3 misdemeanor.

79 C. The provisions of this section shall not apply to firearms shows held in any town with a population of not less than 1,995 and not more than 2,010, according to the 1990 United States census. 80

§ 54.1-4201.2. Duties of promoter; verification of vendor identity; records; penalty. 81

A. Before the start of the firearms show, the promoter shall verify the identity of each participating 82 firearms show vendor by examining a photo identification issued by the Virginia Department of Motor 83 84 Vehicles or a similar agency in the vendor's state of residence if the vendor is not a Virginia resident 85 and require the vendor to sign a ledger with identifying information concerning the vendor. Before the start of the firearms show, the promoter shall provide each vendor with a notice advising the vendor of 86 the obligations of the vendor under this chapter and § 18.2-308.2:5. The promoter shall maintain a copy 87 88 of the records described in this subsection at the permanent place of business of the firearms show 89 promoter for four years from the date of the firearms show.

90 B. The promoter shall make available to firearms show vendors one or more Virginia dealers 91 licensed pursuant to 18 U.S.C. § 921 et seq. to conduct the criminal history record information check required by §§ 18.2-308.2:2 and 18.2-308.2:5. 92

93 C. The promoter shall post in a prominent location at the firearms show a notice, in the form to be 94 prescribed by the Department of State Police, setting forth the requirement for a criminal history record 95 information check.

2. That the provisions of this act may result in a net increase in periods of imprisonment or 96 97 commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot

98 be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter

99 2 of the Acts of Assembly of 2014, Special Session I, requires the Virginia Criminal Sentencing Commission to assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4, the estimated 100

101 amount of the necessary appropriation is \$0 for periods of commitment to the custody of the

**Department of Juvenile Justice.** 102
