### VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact §§ 2.2-1604 and 2.2-4310 of the Code of Virginia, relating to the Virginia 3 Public Procurement Act; small, women-owned, and minority-owned businesses.

#### Be it enacted by the General Assembly of Virginia: 6 7

#### 1. That §§ 2.2-1604 and 2.2-4310 of the Code of Virginia are amended and reenacted as follows: § 2.2-1604. Definitions.

As used in this chapter, unless the context requires a different meaning:

10 "Certification" means the process by which a business is determined to be a small, women-owned, or minority-owned business for the purpose of reporting small, women-owned, and minority-owned 11 business participation in state contracts and purchases pursuant to §§ 2.2-1608 and 2.2-1610. "Department" means the Department of Small Business and Supplier Diversity or any division of the 12

13 14 Department to which the Director has delegated or assigned duties and responsibilities.

"Employment services organization" means an organization that provides community-based 15 employment services to individuals with disabilities that is an approved Commission on Accreditation of 16 17 Rehabilitation Facilities (CARF) accredited vendor of the Department for Aging and Rehabilitative 18 Services.

19 "Historically black colleges and university" includes any college or university that was established prior to 1964; whose principal mission was, and is, the education of black Americans; and that is 20 21 accredited by a nationally recognized accrediting agency or association determined by the Secretary of 22 Education.

23 "Minority individual" means an individual who is a citizen of the United States or a legal resident 24 alien and who satisfies one or more of the following definitions:

25 1. "African American" means a person having origins in any of the original peoples of Africa and 26 who is regarded as such by the community of which this person claims to be a part.

27 2. "Asian American" means a person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China, 28 29 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of 30 the Pacific, India, Pakistan, Bangladesh, or Sri Lanka, and who is regarded as such by the community of 31 which this person claims to be a part.

32 3. "Hispanic American" means a person having origins in any of the Spanish-speaking peoples of 33 Mexico, South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and 34 who is regarded as such by the community of which this person claims to be a part.

4. "Native American" means a person having origins in any of the original peoples of North America 35 and who is regarded as such by the community of which this person claims to be a part or who is 36 37 recognized by a tribal organization.

38 "Minority-owned business" means a business that is at least 51 percent owned by one or more 39 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 40 partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 41 interest in the corporation, partnership, or limited liability company or other entity is owned by one or 42 more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 43 daily business operations are controlled by one or more minority individuals, or any historically black 44 college or university, regardless of the percentage ownership by minority individuals or, in the case of a 45 corporation, partnership, or limited liability company or other entity, the equity ownership interest in the corporation, partnership, or limited liability company or other entity. 46

"Small business" means a business that is at least 51 percent independently owned and controlled by 47 48 one or more individuals who are U.S. citizens or legal resident aliens and, together with affiliates, has 250 or fewer employees or average annual gross receipts of \$10 million or less averaged over the 49 50 previous three years. One or more of the individual owners shall control both the management and daily 51 business operations of the small business.

"State agency" means any authority, board, department, instrumentality, institution, agency, or other 52 53 unit of state government. "State agency" does not include any county, city, or town.

54 "Women-owned business" means a business that is at least 51 percent owned by one or more women 55 who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited 56 liability company or other entity, at least 51 percent of the equity ownership interest is owned by one or HB2148ER

more women who are U.S. citizens or legal resident aliens, and both the management and daily business 57 58 operations are controlled by one or more women.

59 § 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, 60 and service disabled veteran-owned business.

61 A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or 62 offeror because of race, religion, color, sex, national origin, age, disability, status as a service disabled veteran, or any other basis prohibited by state law relating to discrimination in employment. Whenever 63 solicitations are made, each public body shall include businesses selected from a list made available by 64 65 the Department of Small Business and Supplier Diversity.

B. All public bodies shall establish programs consistent with this chapter to facilitate the participation 66 67 of small businesses and businesses owned by women, minorities, and service disabled veterans in 68 procurement transactions. The programs established shall be in writing and shall comply with the provisions of any enhancement or remedial measures authorized by the Governor pursuant to subsection 69 70 C or, where applicable, by the chief executive of a local governing body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. State agencies shall submit annual progress reports on small, women-owned, and minority-owned business procurement and on service 71 72 73 disabled veteran-owned business procurement to the Department of Small Business and Supplier 74 Diversity in a form specified by the Department of Small Business and Supplier Diversity. The 75 Department of Small Business and Supplier Diversity shall make information on service disabled 76 veteran-owned procurement available to the Department of Veterans Services upon request.

77 C. Whenever there exists (i) a rational basis for small business enhancement or (ii) a persuasive 78 analysis that documents a statistically significant disparity between the availability and utilization of 79 women-owned and minority-owned businesses, the Governor is authorized and encouraged to require 80 state agencies to implement appropriate enhancement or remedial measures consistent with prevailing 81 law.

82 D. In the solicitation or awarding of contracts, no state agency, department or institution shall 83 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the 84 state agency, department or institution has made a written determination that employing ex-offenders on 85 the specific contract is not in its best interest. 86

E. As used in this section:

87 "Minority individual" means an individual who is a citizen of the United States or a legal resident 88 alien and who satisfies one or more of the following definitions:

89 1. "African American" means a person having origins in any of the original peoples of Africa and 90 who is regarded as such by the community of which this person claims to be a part.

91 2. "Asian American" means a person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China, 92 93 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of 94 the Pacific, India, Pakistan, Bangladesh, or Sri Lanka and who is regarded as such by the community of 95 which this person claims to be a part.

3. "Hispanic American" means a person having origins in any of the Spanish-speaking peoples of 96 97 Mexico, South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and 98 who is regarded as such by the community of which this person claims to be a part.

99 4. "Native American" means a person having origins in any of the original peoples of North America 100 and who is regarded as such by the community of which this person claims to be a part or who is 101 recognized by a tribal organization.

"Minority-owned business" means a business that is at least 51 percent owned by one or more 102 103 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 104 partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 105 interest in the corporation, partnership, or limited liability company or other entity is owned by one or more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 106 107 daily business operations are controlled by one or more minority individuals, or any historically black college or university as defined in § 2.2-1604, regardless of the percentage ownership by minority 108 109 individuals or, in the case of a corporation, partnership, or limited liability company or other entity, the 110 equity ownership interest in the corporation, partnership, or limited liability company or other entity.

"Service disabled veteran" means a veteran who (i) served on active duty in the United States 111 military ground, naval, or air service, (ii) was discharged or released under conditions other than 112 dishonorable, and (iii) has a service-connected disability rating fixed by the United States Department of 113 114 Veterans Affairs.

115 "Service disabled veteran business" means a business that is at least 51 percent owned by one or 116 more service disabled veterans or, in the case of a corporation, partnership, or limited liability company 117 or other entity, at least 51 percent of the equity ownership interest in the corporation, partnership, or 118 limited liability company or other entity is owned by one or more individuals who are service disabled
119 veterans and both the management and daily business operations are controlled by one or more
120 individuals who are service disabled veterans.

"Small business" means a business, independently owned and controlled by one or more individuals
who are U.S. citizens or legal resident aliens, and together with affiliates, has 250 or fewer employees,
or annual gross receipts of \$10 million or less averaged over the previous three years. One or more of
the individual owners shall control both the management and daily business operations of the small
business.

"State agency" means any authority, board, department, instrumentality, institution, agency, or otherunit of state government. "State agency" shall not include any county, city, or town.

128 "Women-owned business" means a business that is at least 51 percent owned by one or more women 129 who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited 130 liability company or other entity, at least 51 percent of the equity ownership interest is owned by one or 131 more women who are U.S. citizens or legal resident aliens, and both the management and daily business

132 operations are controlled by one or more women.
