11	WHEREAS, according to the Virginia Department of Education, children who repeat at least one
12	grade in kindergarten through grade three cost taxpayers in the Commonwealth approximately \$80
13	million per year; and
14	WHEREAS, according to a 2013 Voices for Virginia's Children report, one in eight children in the
15	Commonwealth arrive in kindergarten without the basic skills to succeed in school; and
16 17	WHEREAS, according to a 2011 Annie E. Casey Foundation report, children who do not demonstrate proficiency in reading in third grade are four times more likely to fail to graduate from
18	high school than children who demonstrate proficiency in reading in third grade; and
19	WHEREAS, national data indicates that children who enter the elementary through secondary
20	education system without sufficient preparedness are more likely to fall behind grade-level expectations,
21	move into special education, and drop out of high school, and less likely to enter postsecondary
22 23	education programs; and WHEREAS, although the Virginia Preschool Initiative has been in effect since 1994, the General
23 24	Assembly has directed only one study to evaluate its effectiveness, accountability, and program costs:
25	House Joint Resolution No. 729 of the Acts of Assembly of 2007; and
26	WHEREAS, in 1993, the Virginia Board of Education, the Virginia Department of Education, and
27	the former Virginia Council on Child Day Care and Early Childhood Programs developed a report
28 29	entitled "A Study of Programs Serving At-Risk Four-Year-Old Children" that found that "[t]here is no central data base tracking all the funding streams or demographic information on at-risk children or the
3 0	quality of the programs" and that such information is "either non-existent, or inconsistent as well as
31	scattered among agencies"; and
32	WHEREAS, no effort to track such information in a central database has been completed; and
33 34	WHEREAS, according to a 2011 National Conference of State Legislatures report, Virginia spent
34 35	more than \$229 million in federal, state, and grant funding on "early care" programs including child care, the Virginia Preschool Initiative, home visiting programs, and additional programs, notably mental
36	health programs; now, therefore, be it
37	RESOLVED by the House of Delegates, the Senate concurring, That the Joint Legislative Audit and
38	Review Commission be directed to study specific early childhood development programs, prenatal to age
39 40	five, in the Commonwealth in order for the General Assembly to determine the best strategy for future early childhood development investments.
41	In conducting its study, the Joint Legislative Audit and Review Commission (JLARC) shall:
42	1. To the greatest extent possible, focus on early childhood development programs currently
43	supported with state assistance including the Virginia Preschool Initiative, locally based programs that
44 45	receive federal child care and Title I assistance, family support and home visiting programs, and quality
45 46	improvement models such as the Virginia Star Quality Initiative; 2. Include a listing of the lead agency, a description and the objectives of the program, an
47	identification of the target audience, and a catalog of the types and amounts of funding for each early
48	childhood program studied;
49	3. Identify eligibility requirements and characteristics of populations that each program serves;
50 51	4. Assess program design, implementation, and measurement of outcomes;
51 52	5. Assess program outcomes, including effectiveness and cost-effectiveness;6. Assess alignment of programs with kindergarten readiness;
5 <u>3</u>	7. Identify best practices in the Commonwealth and other states for program design, implementation,
54	and outcome measurement;
55 5(8. Review other aspects of each program as deemed appropriate; and
56 57	9. Provide options for improving early childhood development programs in the Commonwealth. Technical assistance shall be provided to JLARC by appropriate state agencies. To assist JLARC in
57 58	its work, local school boards shall provide standardized test result data and other information to JLARC,

and school board personnel shall meet with the staff of JLARC, upon request, to discuss program
implementation and effectiveness so that JLARC may satisfy the requirements of this resolution. All
agencies of the Commonwealth shall provide assistance to JLARC for this study, upon request.

62 The Joint Legislative Audit and Review Commission shall complete its meetings by November 30, 63 2015, and the chairman shall submit to the Division of Legislative Automated Systems an executive 64 summary of its findings and recommendations no later than the first day of the 2016 Regular Session of 65 the General Assembly. The executive summary shall state whether JLARC intends to submit to the 66 General Assembly and the Governor a report of its findings and recommendations for publication as a

67 House or Senate document. The executive summary and report shall be submitted as provided in the

68 procedures of the Division of Legislative Automated Systems for the processing of legislative documents

69 and reports and shall be posted on the General Assembly's website.
