VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact §§ 23-218, 40.1-118, and 40.1-125 of the Code of Virginia, relating to 3 apprenticeship-related instruction.

Be it enacted by the General Assembly of Virginia: 6

7 1. That §§ 23-218, 40.1-118, and 40.1-125 of the Code of Virginia are amended and reenacted as 8 follows:

9 § 23-218. Plan for comprehensive community colleges; appropriations; tuition fees and charges; 10 grants or contributions; apprenticeships.

A. The Board is authorized and directed to prepare and administer a plan providing standards and 11 12 policies for the establishment, development and administration of comprehensive community colleges 13 under its authority. It shall determine the need for comprehensive community colleges, develop a statewide plan for their location and a time schedule for their establishment. In the development of such 14 15 plan, a principal objective shall be to provide and maintain a system of comprehensive community colleges through which appropriate educational opportunities and programs to accomplish the purposes 16 set forth in subdivision (a) of § 23-214 shall be made available throughout the Commonwealth. In 17 18 providing these offerings, the Board shall recognize the need for excellence in all curricula and shall 19 endeavor to establish and maintain standards appropriate to the various purposes the respective programs 20 are designed to serve.

21 B. The Board shall have the authority to control and expend funds appropriated by law, and to fix 22 tuition fees and charges. The Board may establish policies and guidelines providing for reduced tuition 23 rates at Virginia's community colleges for employees of the Virginia Community College System. The 24 Board may exercise the powers conferred by Chapter 3 (§ 23-14 et seq.) of this title as any other 25 educational institution as defined in § 23-14.

26 C. The Board shall be authorized, with the approval of the Governor, to accept from any government 27 or governmental department or agency or any public or private body or from any other source, grants or 28 contributions of money or property which the Board may use for or in aid of any of its purposes.

29 D. The Board shall establish policies to coordinate apprenticeship related instruction delivered by 30 state and local public education agencies. The Chancellor, with the approval of the State Board for 31 Community Colleges, shall provide for the administration and supervision of related and supplemental instruction for apprentices. 32 33

§ 40.1-118. Authority of Council.

The Council may:

35 1. Determine standards for apprentice agreements, which standards shall not be lower than those 36 prescribed by this chapter;

37 2. Appoint the secretary of the Apprenticeship Council to act as secretary of each state joint 38 apprenticeship committee;

39 3. Review decisions of local joint apprenticeship committees relating to apprenticeship disputes 40 pursuant to subdivision C 3 of § 40.1-119; 41

4. Perform such other duties as are necessary to carry out the intent of this chapter; and

42 5. Advise the State Board for Community Colleges Commissioner on policies to coordinate 43 apprenticeship-related instruction delivered by state and local public education agencies. 44

§ 40.1-125. Commissioner to administer chapter.

45 A. The Commissioner, with the advice and guidance of the Council, shall be responsible for administering the provisions of this chapter. 46 47

B. The Commissioner shall:

48 1. Approve, if approval is in the best interests of the apprentice, any apprenticeship agreement that 49 meets the standards established under this chapter;

50 2. Terminate or cancel any apprenticeship agreement in accordance with the provisions of such 51 agreement: 52

3. Keep a record of apprenticeship agreements and their disposition;

4. Issue certificates of completion upon the completion of the apprenticeship;

Initiate deregistration proceedings when an apprenticeship program is not conducted, operated, and 55 administered in accordance with the registered provisions, except that deregistration proceedings for 56 violation of equal opportunity requirements shall be processed in accordance with the provisions of the **SB1024ER**

- Virginia State Plan for Equal Employment Opportunity in Apprenticeship; and
 6. Establish policies governing the provision of apprenticeship-related instruction delivered by state
 and local public education agencies and shall provide for the administration and supervision of related
 and supplemental instruction for apprentices; and
 7. Perform such other duties as are necessary to carry out the intent of this chapter.
