A BILL to amend and reenact §§ 2.2-115, 2.2-419, 2.2-424, 2.2-426, 2.2-430, 2.2-431, 2.2-433, 2.2-3101, 2.2-3103 through 2.2-3104.01, 2.2-3106, 2.2-3114 through 2.2-3118, 2.2-3121, 2.2-3124, 30-101, 30-103, 30-103.1, 30-110, 30-111, 30-124, 30-126, 30-129.1, 30-355, 30-356, and 30-357 of the Code of Virginia and to amend the Code of Virginia by adding sections numbered 30-356.1 through 30-356.4, relating to the State and Local Government Conflict of Interests Act, General Assembly Conflicts of Interests Act, and Virginia Conflict of Interest and Ethics Advisory Council; ethics reforms.

Be it enacted by the General Assembly of Virginia:

1. That §§ 2.2-115, 2.2-419, 2.2-424, 2.2-426, 2.2-430, 2.2-431, 2.2-433, 2.2-3101, 2.2-3103 through 2.2-3104.01, 2.2-3106, 2.2-3114 through 2.2-3118, 2.2-3121, 2.2-3124, 30-101, 30-103, 30-103.1, 30-110, 30-111, 30-124, 30-126, 30-129.1, 30-355, 30-356, and 30-357 of the Code of Virginia are amended and reenacted and that the Code of Virginia is amended by adding sections numbered 30-356.1 through 30-356.4 as follows:

§ 2.2-115. Commonwealth's Development Opportunity Fund.

A. As used in this section, unless the context requires otherwise:

"New job" means employment of an indefinite duration, created as the direct result of the private investment, for which the firm pays the wages and standard fringe benefits for its employee, requiring a minimum of either (i) 35 hours of the employee's time a week for the entire normal year of the firm's operations, which "normal year" must consist of at least 48 weeks or (ii) 1,680 hours per year.

Seasonal or temporary positions, positions created when a job function is shifted from an existing location in the Commonwealth to the location of the economic development project, positions with suppliers, and multiplier or spin-off jobs shall not qualify as new jobs. The term "new job" shall include positions with contractors provided that all requirements included within the definition of the term are met.

"Prevailing average wage" means that amount determined by the Virginia Employment Commission to be the average wage paid workers in the city or county of the Commonwealth where the economic development project is located. The prevailing average wage shall be determined without regard to any fringe benefits.

"Private investment" means the private investment required under this section.

B. There is created the ~~Governor's~~ Commonwealth's Development Opportunity Fund (the Fund) to be used by the Governor to attract economic development prospects and secure the expansion of existing industry in the Commonwealth. The Fund shall consist of any funds appropriated to it by the general appropriation act and revenue from any other source, public or private. The Fund shall be established on the books of the Comptroller, and any funds remaining in the Fund at the end of a biennium shall not revert to the general fund but shall remain in the Fund. Interest earned on the Fund shall be credited to the Fund. The Governor shall report to the Chairmen of the House Committees on Appropriations and Finance and the Senate Committee on Finance as funds are awarded in accordance with this section.

C. Funds shall be awarded from the Fund by the Governor as grants or loans to political subdivisions. The criteria for making such grants or loans shall include (i) job creation, (ii) private capital investment, and (iii) anticipated additional state tax revenue expected to accrue to the state and affected localities as a result of the capital investment and jobs created. Loans shall be approved by the Governor and made in accordance with guidelines established by the Virginia Economic Development Partnership and approved by the Comptroller. Loans shall be interest-free unless otherwise determined by the Governor and shall be repaid to the Fund. The Governor may establish the interest rate to be charged; otherwise, any interest charged shall be at market rates as determined by the State Treasurer and shall be indicative of the duration of the loan. The Virginia Economic Development Partnership shall be responsible for monitoring repayment of such loans and reporting the receivables to the Comptroller as required.

Beginning with the five fiscal years from fiscal year 2006-2007 through fiscal year 2010-2011, and for every five fiscal years' period thereafter, in general, no less than one-third of the moneys appropriated to the Fund in every such five-year period shall be awarded to counties and cities having an annual average unemployment rate that is greater than the final statewide average unemployment rate for the calendar year that immediately precedes the calendar year of the award. However, if such

60 one-third requirement will not be met because economic development prospects in such counties and  
61 cities are unable to fulfill the applicable minimum private investment and new jobs requirements set  
62 forth in this section, then any funds remaining in the Fund at the end of the five-year period that would  
63 have otherwise been awarded to such counties and cities shall be made available for awards in the next  
64 five fiscal years' period.

65 D. Funds may be used for public and private utility extension or capacity development on and off  
66 site; public and private installation, extension, or capacity development of high-speed or broadband  
67 Internet access, whether on or off site; road, rail, or other transportation access costs beyond the funding  
68 capability of existing programs; site acquisition; grading, drainage, paving, and any other activity  
69 required to prepare a site for construction; construction or build-out of publicly or privately owned  
70 buildings; training; or grants or loans to an industrial development authority, housing and redevelopment  
71 authority, or other political subdivision for purposes directly relating to any of the foregoing. However,  
72 in no case shall funds from the Fund be used, directly or indirectly, to pay or guarantee the payment for  
73 any rental, lease, license, or other contractual right to the use of any property.

74 It shall be the policy of the Commonwealth that moneys in the Fund shall not be used for any  
75 economic development project in which a business relocates or expands its operations in one or more  
76 Virginia localities and simultaneously closes its operations or substantially reduces the number of its  
77 employees in another Virginia locality. The Secretary of Commerce and Trade shall enforce this policy  
78 and for any exception thereto shall promptly provide written notice to the Chairmen of the Senate  
79 Finance and House Appropriations Committees, which notice shall include a justification for any  
80 exception to such policy.

81 E. 1. a. Except as provided in this subdivision, no grant or loan shall be awarded from the Fund  
82 unless the project involves a minimum private investment of \$5 million and creates at least 50 new jobs  
83 for which the average wage, excluding fringe benefits, is no less than the prevailing average wage. For  
84 projects, including but not limited to projects involving emerging technologies, for which the average  
85 wage of the new jobs created, excluding fringe benefits, is at least twice the prevailing average wage for  
86 that locality or region, the Governor shall have the discretion to require no less than one-half the  
87 number of new jobs as set forth for that locality in this subdivision.

88 b. Notwithstanding the provisions of subdivision a, a grant or loan may be awarded from the Fund if  
89 the project involves a minimum private investment of \$100 million and creates at least 25 new jobs for  
90 which the average wage, excluding fringe benefits, is no less than the prevailing average wage.

91 2. Notwithstanding the provisions of subdivision 1 a, in localities (i) with an annual unemployment  
92 rate for the most recent calendar year for which such data is available that is greater than the final  
93 statewide average unemployment rate for that calendar year or (ii) with a poverty rate for the most  
94 recent calendar year for which such data is available that exceeds the statewide average poverty rate for  
95 that year, a grant or loan may be awarded from the Fund pursuant to subdivision 1 a if the project  
96 involves a minimum private investment of \$2.5 million and creates at least 25 new jobs for which the  
97 average wage, excluding fringe benefits, is no less than 85 percent of the prevailing average wage.

98 3. Notwithstanding the provisions of subdivisions 1 a and 2, in localities (i) with an annual  
99 unemployment rate for the most recent calendar year for which such data is available that is greater than  
100 the final statewide average unemployment rate for that calendar year and (ii) with a poverty rate for the  
101 most recent calendar year for which such data is available that exceeds the statewide average poverty  
102 rate for that year, a grant or loan may be awarded from the Fund pursuant to such subdivisions if the  
103 project involves a minimum private investment of \$1.5 million and creates at least 15 new jobs for  
104 which the average wage, excluding fringe benefits, is no less than 85 percent of the prevailing average  
105 wage.

106 4. For projects that are eligible under subdivision 2 or 3, the average wage of the new jobs,  
107 excluding fringe benefits, shall be no less than 85 percent of the prevailing average wage. In addition,  
108 for projects in such localities, the Governor may award a grant or loan for a project paying less than 85  
109 percent of the prevailing average wage but still providing customary employee benefits, only after the  
110 Secretary of Commerce and Trade has made a written finding that the economic circumstances in the  
111 area are sufficiently distressed (i.e., high unemployment or underemployment and negative economic  
112 forecasts) that assistance to the locality to attract the project is nonetheless justified. However, the  
113 minimum private investment and number of new jobs required to be created as set forth in this  
114 subsection shall still be a condition of eligibility for an award from the Fund. Such written finding shall  
115 promptly be provided to the chairs of the Senate Committee on Finance and the House Committee on  
116 Appropriations.

117 F. 1. The Virginia Economic Development Partnership shall assist the Governor in developing  
118 objective guidelines and criteria that shall be used in awarding grants or making loans from the Fund.  
119 The guidelines may require that as a condition of receiving any grant or loan incentive that is based on  
120 employment goals, a recipient company must provide copies of employer quarterly payroll reports that  
121 have been provided to the Virginia Employment Commission to verify the employment status of any

122 position included in the employment goal. The guidelines may include a requirement for the affected  
 123 locality or localities to provide matching funds which may be cash or in-kind, at the discretion of the  
 124 Governor. The guidelines and criteria shall include provisions for geographic diversity and a cap on the  
 125 amount of funds to be provided to any individual project. At the discretion of the Governor, this cap  
 126 may be waived for qualifying projects of regional or statewide interest. In developing the guidelines and  
 127 criteria, the Virginia Economic Development Partnership shall use the measure for Fiscal Stress  
 128 published by the Commission on Local Government of the Department of Housing and Community  
 129 Development for the locality in which the project is located or will be located as one method of  
 130 determining the amount of assistance a locality shall receive from the Fund.

131 2. a. Notwithstanding any provision in this section or in the guidelines, each political subdivision that  
 132 receives a grant or loan from the Fund shall enter into a contract with each business beneficiary of  
 133 funds from the Fund. A person or entity shall be a business beneficiary of funds from the Fund if grant  
 134 or loan moneys awarded from the Fund by the Governor are paid to a political subdivision and (i)  
 135 subsequently distributed by the political subdivision to the person or entity or (ii) used by the political  
 136 subdivision for the benefit of the person or entity but never distributed to the person or entity.

137 b. The contract between the political subdivision and the business beneficiary shall provide in detail  
 138 (i) the fair market value of all funds that the Commonwealth has committed to provide, (ii) the fair  
 139 market value of all matching funds (or in-kind match) that the political subdivision has agreed to  
 140 provide, (iii) how funds committed by the Commonwealth (including but not limited to funds from the  
 141 Fund committed by the Governor) and funds that the political subdivision has agreed to provide are to  
 142 be spent, (iv) the minimum private investment to be made and the number of new jobs to be created  
 143 agreed to by the business beneficiary, (v) the average wage (excluding fringe benefits) agreed to be paid  
 144 in the new jobs, (vi) the prevailing average wage, and (vii) the formula, means, or processes agreed to  
 145 be used for measuring compliance with the minimum private investment and new jobs requirements,  
 146 including consideration of any layoffs instituted by the business beneficiary over the course of the  
 147 period covered by the contract.

148 The contract shall state the date by which the agreed upon private investment and new job  
 149 requirements shall be met by the business beneficiary of funds from the Fund and may provide for the  
 150 political subdivision to grant up to a 15-month extension of such date if deemed appropriate by the  
 151 political subdivision subsequent to the execution of the contract. Any extension of such date granted by  
 152 the political subdivision shall be in writing and promptly delivered to the business beneficiary, and the  
 153 political subdivision shall simultaneously provide a copy of the extension to the Virginia Economic  
 154 Development Partnership.

155 The contract shall provide that if the private investment and new job contractual requirements are not  
 156 met by the expiration of the date stipulated in the contract, including any extension granted by the  
 157 political subdivision, the business beneficiary shall be liable to the political subdivision for repayment of  
 158 a portion of the funds provided under the contract. The contract shall include a formula for purposes of  
 159 determining the portion of such funds to be repaid. The formula shall, in part, be based upon the fair  
 160 market value of all funds that have been provided by the Commonwealth and the political subdivision  
 161 and the extent to which the business beneficiary has met the private investment and new job contractual  
 162 requirements. Any such funds repaid to the political subdivision that relate to the award from the  
 163 Governor's Commonwealth's Development Opportunity Fund shall promptly be paid over by the political  
 164 subdivision to the Commonwealth by payment remitted to the State Treasurer. Upon receipt by the State  
 165 Treasurer of such payment, the Comptroller shall deposit such repaid funds into the Governor's  
 166 Commonwealth's Development Opportunity Fund.

167 c. The contract shall be amended to reflect changes in the funds committed by the Commonwealth or  
 168 agreed to be provided by the political subdivision.

169 d. Notwithstanding any provision in this section or in the guidelines, whenever layoffs instituted by a  
 170 business beneficiary over the course of the period covered by a contract cause the net total number of  
 171 the new jobs created to be fewer than the number agreed to, then the business beneficiary shall return  
 172 the portion of any funds received pursuant to the repayment formula established by the contract.

173 3. Notwithstanding any provision in this section or in the guidelines, prior to executing any such  
 174 contract with a business beneficiary, the political subdivision shall provide a copy of the proposed  
 175 contract to the Attorney General. The Attorney General shall review the proposed contract (i) for  
 176 enforceability as to its provisions and (ii) to ensure that it is in appropriate legal form. The Attorney  
 177 General shall provide any written suggestions to the political subdivision within seven days of his  
 178 receipt of the copy of the contract. The Attorney General's suggestions shall be limited to the  
 179 enforceability of the contract's provisions and the legal form of the contract.

180 4. Notwithstanding any provision in this section or in the guidelines, a political subdivision shall not  
 181 expend, distribute, pledge, use as security, or otherwise use any award from the Fund unless and until  
 182 such contract as described herein is executed with the business beneficiary.

183 G. Within the 30 days immediately following June 30 and December 30 of each year, the Governor  
 184 shall provide a report to the Chairmen of the House Committees on Appropriations and Finance and the  
 185 Senate Committee on Finance which shall include, but is not limited to, the following information  
 186 regarding grants and loans awarded from the Fund during the immediately preceding six-month period  
 187 for economic development projects: the name of the company that is the business beneficiary of the  
 188 grant or loan and the type of business in which it engages; the location (county, city, or town) of the  
 189 project; the amount of the grant or loan committed from the Fund and the amount of all other funds  
 190 committed by the Commonwealth from other sources and the purpose for which such grants, loans, or  
 191 other funds will be used; the amount of all moneys or funds agreed to be provided by political  
 192 subdivisions and the purposes for which they will be used; the number of new jobs agreed to be created  
 193 by the business beneficiary; the amount of investment in the project agreed to be made by the business  
 194 beneficiary; the timetable for the completion of the project and new jobs created; the prevailing average  
 195 wage; and the average wage (excluding fringe benefits) agreed to be paid in the new jobs.

196 H. The Governor shall provide grants and commitments from the Fund in an amount not to exceed  
 197 the dollar amount contained in the Fund. If the Governor commits funds for years beyond the fiscal  
 198 years covered under the existing appropriation act, the State Treasurer shall set aside and reserve the  
 199 funds the Governor has committed, and the funds shall remain in the Fund for those future fiscal years.  
 200 No grant or loan shall be payable in the years beyond the existing appropriation act unless the funds are  
 201 currently available in the Fund.

202 *I. No person or entity that is seeking to become a business beneficiary of funds from the Fund and*  
 203 *no individual who is an officer, director, or employee, including an agent or consultant, of such entity*  
 204 *shall knowingly provide a contribution, gift, or other item with a value greater than \$50 or make an*  
 205 *express or implied promise to make such a contribution or gift to the Governor, or to his campaign*  
 206 *committee or a political action committee established on his behalf, while seeking such funds and for a*  
 207 *period of one year following the date the grant or loan sought is awarded. The provisions of this*  
 208 *subsection shall apply only for any grant or loan where the stated or expected value of the grant or*  
 209 *loan is \$100,000 or more. Any person who knowingly violates this section shall be subject to a civil*  
 210 *penalty of \$500 or up to two times the amount of the contribution or gift, whichever is greater, and the*  
 211 *contribution, gift, or other item shall be returned to the donor. The attorney for the Commonwealth*  
 212 *shall initiate civil proceedings to enforce the civil penalties. Any civil penalties collected shall be*  
 213 *payable to the State Treasurer for deposit to the general fund and used exclusively to fund the Virginia*  
 214 *Conflict of Interest and Ethics Advisory Council.*

215 **§ 2.2-419. Definitions.**

216 As used in this article, unless the context requires a different meaning:

217 "Anything of value" means:

- 218 1. A pecuniary item, including money, or a bank bill or note;
- 219 2. A promissory note, bill of exchange, order, draft, warrant, check, or bond given for the payment  
 220 of money;
- 221 3. A contract, agreement, promise, or other obligation for an advance, conveyance, forgiveness of  
 222 indebtedness, deposit, distribution, loan, payment, gift, pledge, or transfer of money;
- 223 4. A stock, bond, note, or other investment interest in an entity;
- 224 5. A receipt given for the payment of money or other property;
- 225 6. A right in action;
- 226 7. A gift, tangible good, chattel, or an interest in a gift, tangible good, or chattel;
- 227 8. A loan or forgiveness of indebtedness;
- 228 9. A work of art, antique, or collectible;
- 229 10. An automobile or other means of personal transportation;
- 230 11. Real property or an interest in real property, including title to realty, a fee simple or partial  
 231 interest, present or future, contingent or vested within realty, a leasehold interest, or other beneficial  
 232 interest in realty;
- 233 12. An honorarium or compensation for services;
- 234 13. A rebate or discount in the price of anything of value unless the rebate or discount is made in  
 235 the ordinary course of business to a member of the public without regard to that person's status as an  
 236 executive or legislative official, or the sale or trade of something for reasonable compensation that  
 237 would ordinarily not be available to a member of the public;
- 238 14. A promise or offer of employment; or
- 239 15. Any other thing of value that is pecuniary or compensatory in value to a person.

240 "Anything of value" does not mean a campaign contribution properly received and reported pursuant  
 241 to Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2.

242 "Compensation" means:

- 243 1. An advance, conveyance, forgiveness of indebtedness, deposit, distribution, loan, payment, gift,  
 244 pledge, or transfer of money or anything of value; or

245 2. A contract, agreement, promise or other obligation for an advance, conveyance, forgiveness of  
 246 indebtedness, deposit, distribution, loan, payment, gift, pledge, or transfer of money or anything of  
 247 value, for services rendered or to be rendered.

248 "Compensation" does not mean reimbursement of expenses if the reimbursement does not exceed the  
 249 amount actually expended for the expenses and it is substantiated by an itemization of expenses.

250 "*Council*" means the Virginia Conflict of Interest and Ethics Advisory Council established in  
 251 § 30-355.

252 "Executive action" means the proposal, drafting, development, consideration, amendment, adoption,  
 253 approval, promulgation, issuance, modification, rejection, or postponement by an executive agency or  
 254 official of legislation or executive orders issued by the Governor. "*Executive action*" includes  
 255 *procurement transactions*.

256 "Executive agency" means an agency, board, commission, or other body in the executive branch of  
 257 state government. "Executive agency" includes the State Corporation Commission, the Virginia Workers'  
 258 Compensation Commission, and the Virginia Lottery.

259 "Executive official" means:

260 1. The Governor;

261 2. The Lieutenant Governor;

262 3. The Attorney General;

263 4. Any officer or employee of the office of the Governor or, Lieutenant Governor, or Attorney  
 264 General other than a clerical or secretarial employee;

265 5. The Governor's Secretaries, the Deputy Secretaries, and the chief executive officer of each  
 266 executive agency; or

267 6. Members of supervisory and policy boards, commissions and councils, as defined in § 2.2-2100,  
 268 however selected.

269 "Expenditure" means:

270 1. A purchase, payment, distribution, loan, forgiveness of a loan or payment of a loan by a third  
 271 party, advance, deposit, transfer of funds, a promise to make a payment, or a gift of money or anything  
 272 of value for any purpose;

273 2. A payment to a lobbyist for salary, fee, reimbursement for expenses, or other purpose by a person  
 274 employing, retaining, or contracting for the services of the lobbyist separately or jointly with other  
 275 persons;

276 3. A payment in support of or assistance to a lobbyist or the lobbyist's activities, including the direct  
 277 payment of expenses incurred at the request or suggestion of the lobbyist;

278 4. A payment that directly benefits an executive or legislative official or a member of the official's  
 279 immediate family;

280 5. A payment, including compensation, payment, or reimbursement for the services, time, or expenses  
 281 of an employee for or in connection with direct communication with an executive or legislative official;

282 6. A payment for or in connection with soliciting or urging other persons to enter into direct  
 283 communication with an executive or legislative official; or

284 7. A payment or reimbursement for categories of expenditures required to be reported pursuant to  
 285 this chapter.

286 "Expenditure" does not mean a campaign contribution properly received and reported pursuant to  
 287 Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2.

288 "Fair market value" means the price that a good or service would bring between a willing seller and  
 289 a willing buyer in the open market after negotiations. If the fair market value cannot be determined, the  
 290 actual price paid for the good or service shall be given consideration.

291 "Gift" means ~~anything of value to the extent that a consideration of equal or greater value is not~~  
 292 ~~received any gratuity, favor, discount, entertainment, hospitality, loan, forbearance, or other item having~~  
 293 ~~monetary value, and includes services as well as gifts of transportation, local travel, lodgings and~~  
 294 ~~meals, whether provided in-kind, or by purchase of a ticket, payment in advance, or reimbursement after~~  
 295 ~~the expense has been incurred.~~

296 "Gift" does not mean:

297 1. Printed informational or promotional material;

298 2. A gift that is not used and, no later than 60 days after receipt, is returned to the donor or  
 299 delivered to a charitable organization and is not claimed as a charitable contribution for federal income  
 300 tax purposes;

301 3. A gift, devise, or inheritance from an individual's spouse, child, parent, grandparent, brother, sister,  
 302 parent-in-law, brother-in-law, sister-in-law, nephew, niece, aunt, uncle, or first cousin or the spouse of  
 303 that individual, if the donor is not acting as the agent or intermediary for someone other than a person  
 304 covered by this subdivision; or

305 4. A gift of a value of \$50 or less;

306 5. A gift made to a nonpartisan state, regional, national, or international legislative organization, or  
307 an affiliated organization of such organization, of which the General Assembly or a legislative official is  
308 a member due to his official position or employment;

309 6. Any offer of a ticket, coupon, or other admission or pass unless the ticket, coupon, admission, or  
310 pass is used;

311 7. Any food or beverages provided to an individual at an event at which the individual is performing  
312 official duties related to his public service;

313 8. An unsolicited, personally inscribed award of appreciation or recognition in the form of a plaque,  
314 trophy, wall memento, or similar item that is given in recognition of public, civic, charitable, or  
315 professional service; or

316 [ 9. Any gift from an individual's spouse, child, parent, grandparent, brother, sister, parent-in-law,  
317 brother-in-law, sister-in-law, nephew, niece, aunt, uncle, or first cousin or the spouse of that individual.  
318 Any gift from a family member or personal friend, as long as that gift is not otherwise prohibited by  
319 this section. ]

320 "Immediate family" means (i) the spouse and (ii) any child who resides in the same household as the  
321 executive or legislative official and who is a dependent of the official.

322 "Legislative action" means:

323 1. Preparation, research, drafting, introduction, consideration, modification, amendment, approval,  
324 passage, enactment, tabling, postponement, defeat, or rejection of a bill, resolution, amendment, motion,  
325 report, nomination, appointment, or other matter by the General Assembly or a legislative official;

326 2. Action by the Governor in approving, vetoing, or recommending amendments for a bill passed by  
327 the General Assembly; or

328 3. Action by the General Assembly in overriding or sustaining a veto by the Governor, considering  
329 amendments recommended by the Governor, or considering, confirming, or rejecting an appointment of  
330 the Governor.

331 "Legislative official" means:

332 1. A member or member-elect of the General Assembly;

333 2. A member of a committee, subcommittee, commission, or other entity established by and  
334 responsible to the General Assembly or either house of the General Assembly; or

335 3. Persons employed by the General Assembly or an entity established by and responsible to the  
336 General Assembly.

337 "Lobbying" means:

338 1. Influencing or attempting to influence executive or legislative action through oral or written  
339 communication with an executive or legislative official; or

340 2. Solicitation of others to influence an executive or legislative official.

341 "Lobbying" does not mean:

342 1. Requests for appointments, information on the status of pending executive and legislative actions,  
343 or other ministerial contacts if there is no attempt to influence executive or legislative actions;

344 2. Responses to published notices soliciting public comment submitted to the public official  
345 designated in the notice to receive the responses;

346 3. The solicitation of an association by its members to influence legislative or executive action; or

347 4. Communications between an association and its members and communications between a principal  
348 and its lobbyists.

349 "Lobbyist" means:

350 1. An individual who is employed and receives payments, or who contracts for economic  
351 consideration, including reimbursement for reasonable travel and living expenses, for the purpose of  
352 lobbying;

353 2. An individual who represents an organization, association, or other group for the purpose of  
354 lobbying; or

355 3. A local government employee who lobbies.

356 "Lobbyist's principal" or "principal" means the entity on whose behalf the lobbyist influences or  
357 attempts to influence executive or legislative action. An organization whose employees conduct lobbying  
358 activities on its behalf is both a principal and an employer of the lobbyists. In the case of a coalition or  
359 association that employs or retains others to conduct lobbying activities on behalf of its membership, the  
360 principal is the coalition or association and not its individual members.

361 "Local government" means:

362 1. Any county, city, town, or other local or regional political subdivision;

363 2. Any school division;

364 3. Any organization or entity that exercises governmental powers that is established pursuant to an  
365 interstate compact; or

366 4. Any organization composed of members representing entities listed in subdivisions 1, 2, or 3 of  
367 this definition.

368 "Local government employee" means a public employee of a local government.

369 "Person" means an individual, proprietorship, firm, partnership, joint stock company,  
370 syndicate, business trust, estate, company, corporation, association, club, committee, organization, or  
371 group of persons acting in concert.

372 "Procurement transaction" means all functions that pertain to obtaining all goods, services, or  
373 construction on behalf of an executive agency, including description of requirements, selection and  
374 solicitation of sources, preparation and award of contract, and all phases of contract administration.

375 "Secretary" means the Secretary of the Commonwealth.

376 "Value" means the actual cost or fair market value of an item or items, whichever is greater. If the  
377 fair market value cannot be determined, the actual amount paid for the item or items shall be given  
378 consideration.

379 "Widely attended event" means an event for which there is a reasonable expectation that at least 25  
380 persons will attend the event and the event has a civic or regional interest or is open to individuals  
381 from a particular industry or profession or who represent persons interested in a particular issue.

382 **§ 2.2-424. Registration fees.**

383 The Secretary shall collect an annual registration fee of ~~fifty dollars~~ \$100 from the lobbyist for each  
384 principal for whom, or on whose behalf, the lobbyist will act. *This fee shall be deposited into the*  
385 *general fund and used exclusively to fund the Council.*

386 **§ 2.2-426. Lobbyist reporting; penalty.**

387 A. Each lobbyist shall file with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~ a  
388 separate semiannual report of expenditures, including gifts, for each principal for whom he lobbies by  
389 December 15 for the preceding six-month period complete through the last day of October and June 15  
390 for the preceding six-month period complete through the last day of April.

391 B. Each principal who expends more than \$500 to employ or compensate multiple lobbyists shall be  
392 responsible for filing a consolidated lobbyist report pursuant to this section in any case in which the  
393 lobbyists are each exempt under the provisions of subdivision 7 or 8 of § 2.2-420 from the reporting  
394 requirements of this section.

395 C. The report shall be on a form ~~provided prescribed and made available by the Virginia Conflict of~~

586 E. Certain information regarding entertainment expenses shall be reported. Only entertainment events  
587 for which the average value per person exceeds \$50 shall be reported. For each such entertainment  
588 event, such report shall include:

- 589 1. The date and location of the event;
- 590 2. A description of the event, including whether or not it meets the criteria of a widely attended  
591 event;
- 592 3. The approximate total number of persons in attendance, if such number is ascertainable; and
- 593 4. The total amount of the expenses of the event. Such expenses shall include food, beverages,  
594 rentals, performers or speakers, service personnel, the transportation of legislative and executive  
595 officials and members of their immediate families, the lodging of legislative and executive officials and  
596 members of their immediate families, and any miscellaneous items.

597 F. Certain information regarding gifts shall be reported. Only gifts with a value exceeding \$50 shall

598 *be reported. For each reportable gift provided to a legislative or executive official or a member of his*  
 599 *immediate family, such report shall include:*

- 601 2. *The name of the recipient or recipients;*

 616 *include the effective date of the termination.*

617 **§ 2.2-431. Penalties; filing of substituted statement.**

618 A. Every lobbyist failing to file the statement prescribed by § 2.2-426 within the time prescribed  
 619 therein shall be assessed a civil penalty of ~~fifty dollars~~ \$50, and every individual failing to file the  
 620 statement within ~~ten~~ 10 days after the time prescribed herein shall be assessed an additional civil penalty  
 621 of ~~fifty dollars~~ \$50 per day from the eleventh day of such default until the statement is filed. The  
 622 *Council shall notify the Secretary of any lobbyist's failure to file the statement within the time*  
 623 *prescribed, and the penalties shall be assessed and collected by the Secretary. The Attorney General*  
 624 *shall assist the Secretary in collecting the penalties, upon request.*

625 B. Every lobbyist's principal whose lobbyist fails to file the statement prescribed by § 2.2-426 shall  
 626 be assessed a civil penalty of ~~fifty dollars~~ \$50, and shall be assessed an additional civil penalty of ~~fifty~~  
 627 ~~dollars~~ \$50 per day from the eleventh day of such default until the statement is filed. The *Council shall*  
 628 *notify the Secretary of any lobbyist's failure to file the statement within the time prescribed, and the*  
 629 *penalty shall be assessed and collected by the Secretary. The Attorney General shall assist the Secretary*  
 630 *in collecting the penalties, upon request.*

631 C. No individual who has failed to file the statement required by § 2.2-426 or who has failed to pay  
 632 all penalties assessed pursuant to this section, shall register or act as a lobbyist as long as he remains in  
 633 default.

634 D. Whenever any lobbyist is or will be in default under § 2.2-426, and the reasons for such default  
 635 are or will be beyond his control, or the control of his principal, or both, the Secretary may suspend the  
 636 assessment of any penalty otherwise assessable and accept a substituted statement, upon the submission  
 637 of sworn proofs that shall satisfy him that the default has been beyond the control of the lobbyist or his  
 638 principal, and that the substituted statement contains the most accurate and complete information  
 639 available after the exercise of due diligence.

640 E. Penalties collected pursuant to this section shall be payable to the State Treasurer for deposit to  
 641 the general fund *and shall be used exclusively to fund the Council.*

642 **§ 2.2-433. Prohibited acts; violation a misdemeanor.**

643 A. No lobbyist shall:

- 644 1. Lobby in violation of the provisions of this article;
- 645 2. Make any expenditure, or obligate himself to do so, in connection with lobbying, unless he fully  
 646 discloses the expenditure as required in this article; or
- 647 3. Misrepresent in any material respect or omit any information required to be reported pursuant to  
 648 this article.

649 B. No lobbyist's principal shall:

- 650 1. Fail to file any statement required to be filed by the provisions of this article;
- 651 2. Misrepresent in any material respect or omit any information required to be reported pursuant to  
 652 this article; or
- 653 3. Violate any of the provisions of this article.

654 C. Except as provided in subsection ~~D~~ C of § 2.2-426 *or subsection A of § 2.2-431*, any lobbyist or  
 655 lobbyist's principal violating any provision of this article shall be guilty of a Class 1 misdemeanor.  
 656 However, a lobbyist who receives no compensation or anything of value for lobbying shall not be  
 657 subject to the criminal penalties prescribed by this section.

658 **§ 2.2-3101. Definitions.**

659 As used in this chapter, unless the context requires a different meaning:

660 "Advisory agency" means any board, commission, committee or post which does not exercise any  
661 sovereign power or duty, but is appointed by a governmental agency or officer or is created by law for  
662 the purpose of making studies or recommendations, or advising or consulting with a governmental  
663 agency.

664 "Affiliated business entity relationship" means a relationship, other than a parent-subsidary  
665 relationship, that exists when (i) one business entity has a controlling ownership interest in the other  
666 business entity, (ii) a controlling owner in one entity is also a controlling owner in the other entity, or  
667 (iii) there is shared management or control between the business entities. Factors that may be considered  
668 in determining the existence of an affiliated business entity relationship include that the same person or  
669 substantially the same person owns or manages the two entities, there are common or commingled funds  
670 or assets, the business entities share the use of the same offices or employees, or otherwise share  
671 activities, resources or personnel on a regular basis, or there is otherwise a close working relationship  
672 between the entities.

673 "Business" means a corporation, partnership, sole proprietorship, firm, enterprise, franchise,  
674 association, trust or foundation, or any other individual or entity carrying on a business or profession,  
675 whether or not for profit.

676 "*Close financial association*" means an association in which the person filing shares significant  
677 financial involvement with an individual and the filer would reasonably be expected to be aware of the  
678 individual's business activities and would have access to the necessary records either directly or through  
679 the individual. "*Close financial association*" does not mean an association based on (i) the receipt of  
680 retirement benefits or deferred compensation from a business by which the person filing this statement is  
681 no longer employed, or (ii) the receipt of compensation for work performed by the person filing as an  
682 independent contractor of a business that represents an entity before any state governmental agency  
683 when the person filing has had no communications with the state governmental agency.

684 "Contract" means any agreement to which a governmental agency is a party, or any agreement on  
685 behalf of a governmental agency that involves the payment of money appropriated by the General  
686 Assembly or a political subdivision, whether or not such agreement is executed in the name of the  
687 Commonwealth, or some political subdivision thereof. "Contract" includes a subcontract only when the  
688 contract of which it is a part is with the officer's or employee's own governmental agency.

689 "Council" means the Virginia Conflict of Interest and Ethics Advisory Council established in  
690 § 30-355.

691 "Employee" means all persons employed by a governmental or advisory agency, unless otherwise  
692 limited by the context of its use.

693 "Financial institution" means any bank, trust company, savings institution, industrial loan association,  
694 consumer finance company, credit union, broker-dealer as defined in subsection A of § 13.1-501, or  
695 investment company or advisor registered under the federal Investment Advisors Act or Investment  
696 Company Act of 1940.

697 "Gift" means any gratuity, favor, discount, entertainment, hospitality, loan, forbearance, or other item  
698 having monetary value. It includes services as well as gifts of transportation, local travel, lodgings and  
699 meals, whether provided in-kind, or by purchase of a ticket, payment in advance, or reimbursement after  
700 the expense has been incurred. "Gift" does not include (i) any offer of a ticket, coupon, or other  
701 admission or pass unless the ticket, coupon, admission, or pass is used; (ii) *food or beverages consumed*  
702 *while attending an event at which the filer is performing official duties related to his public service*; (iii)  
703 honorary degrees; ~~(iii)~~ (iv) any athletic, merit, or need-based scholarship or any other financial aid  
704 awarded by a public or private school, institution of higher education, or other educational program  
705 pursuant to such school, institution, or program's financial aid standards and procedures applicable to the  
706 general public; ~~(iv)~~ (v) *unsolicited, personally inscribed awards of appreciation or recognition in the*  
707 *form of a plaque, trophy, wall memento, or similar item that is given in recognition of public, civic,*  
708 *charitable, or professional service*; (vi) a campaign contribution properly received and reported pursuant  
709 to Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2; ~~(v)~~ (vii) *a devise or inheritance*; (viii) any gift given by  
710 *a business associate or otherwise related to the private profession or occupation of an officer or*  
711 *employee or of a member of his immediate family; or ~~(vi)~~ (ix) gifts from relatives or [ personal friends*  
712 *received in conjunction with a personal celebration* personal friends ]. For the purpose of this  
713 definition, "relative" means the donee's spouse, child, uncle, aunt, niece, or nephew; a person to whom  
714 the donee is engaged to be married; the donee's or his spouse's parent, grandparent, grandchild, brother,  
715 or sister; or the donee's brother's or sister's spouse. [ For the purpose of this definition, "personal friend"  
716 does not include any person that the filer knows or has reason to know is (a) a lobbyist registered  
717 pursuant to Article 3 (§ 2.2-418 et seq.) of Chapter 4 of Title 2.2; (b) a lobbyist's principal as defined in  
718 § 2.2-419; (c) for an officer or employee of a local governmental or advisory agency, a person,  
719 organization, or business who is a party to or is seeking to become a party to a contract with the local  
720 agency of which he is an officer or an employee; or (d) for an officer or employee of a state

721 governmental or advisory agency, a person, organization, or business who is a party to or is seeking to  
 722 become a party to a contract with the Commonwealth. For purposes of this definition, "person,  
 723 organization, or business" includes individuals who are officers, directors, or owners of or who have a  
 724 controlling ownership interest in such organization or business. For the purpose of this definition,

 731 to or is seeking to become a party to a contract with the Commonwealth. For purposes of this definition,  
 732 "person, organization, or business" includes individuals who are officers, directors, or owners of or who  
 733 have a controlling ownership interest in such organization or business. ]

734 "Governmental agency" means each component part of the legislative, executive or judicial branches  
 735 of state and local government, including each office, department, authority, post, commission,  
 736 committee, and each institution or board created by law to exercise some regulatory or sovereign power  
 737 or duty as distinguished from purely advisory powers or duties. Corporations organized or controlled by  
 738 the Virginia Retirement System are "governmental agencies" for purposes of this chapter.

739 "Immediate family" means (i) a spouse and (ii) any child who resides in the same household as the  
 740 officer or employee and who is a dependent of the officer or employee.

741 "Officer" means any person appointed or elected to any governmental or advisory agency including  
 742 local school boards, whether or not he receives compensation or other emolument of office. Unless the  
 743 context requires otherwise, "officer" includes members of the judiciary.

744 "Parent-subsidiary relationship" means a relationship that exists when one corporation directly or  
 745 indirectly owns shares possessing more than 50 percent of the voting power of another corporation.

746 [ *"Personal celebration" means a social occasion attended by or held for relatives and personal*  
 747 *friends or an event of a religious nature.* ]

748 "Personal interest" means a financial benefit or liability accruing to an officer or employee or to a  
 749 member of his immediate family. Such interest shall exist by reason of (i) ownership in a business if the  
 750 ownership interest exceeds three percent of the total equity of the business; (ii) annual income that  
 751 exceeds, or may reasonably be anticipated to exceed, \$5,000 from ownership in real or personal property  
 752 or a business; (iii) salary, other compensation, fringe benefits, or benefits from the use of property, or  
 753 any combination thereof, paid or provided by a business or governmental agency that exceeds, or may  
 754 reasonably be anticipated to exceed, \$5,000 annually; (iv) ownership of real or personal property if the  
 755 interest exceeds \$5,000 in value and excluding ownership in a business, income, or salary, other  
 756 compensation, fringe benefits or benefits from the use of property; (v) personal liability incurred or  
 757 assumed on behalf of a business if the liability exceeds three percent of the asset value of the business;  
 758 or (vi) an option for ownership of a business or real or personal property if the ownership interest will  
 759 consist of clause (i) or (iv) above.

760 "Personal interest in a contract" means a personal interest that an officer or employee has in a  
 761 contract with a governmental agency, whether due to his being a party to the contract or due to a  
 762 personal interest in a business that is a party to the contract.

763 "Personal interest in a transaction" means a personal interest of an officer or employee in any matter  
 764 considered by his agency. Such personal interest exists when an officer or employee or a member of his  
 765 immediate family has a personal interest in property or a business or governmental agency, or represents  
 766 or provides services to any individual or business and such property, business or represented or served  
 767 individual or business (i) is the subject of the transaction or (ii) may realize a reasonably foreseeable  
 768 direct or indirect benefit or detriment as a result of the action of the agency considering the transaction.  
 769 Notwithstanding the above, such personal interest in a transaction shall not be deemed to exist where (a)  
 770 an elected member of a local governing body serves without remuneration as a member of the board of  
 771 trustees of a not-for-profit entity and such elected member or member of his immediate family has no  
 772 personal interest related to the not-for-profit entity or (b) an officer, employee, or elected member of a  
 773 local governing body is appointed by such local governing body to serve on a governmental agency, or  
 774 an officer, employee, or elected member of a separate local governmental agency formed by a local  
 775 governing body is appointed to serve on a governmental agency, and the personal interest in the  
 776 transaction of the governmental agency is the result of the salary, other compensation, fringe benefits, or  
 777 benefits provided by the local governing body or the separate governmental agency to the officer,  
 778 employee, elected member, or member of his immediate family.

779 "State and local government officers and employees" shall not include members of the General  
 780 Assembly.

781 "State filer" means those officers and employees required to file a disclosure statement of their

782 personal interests pursuant to subsection A or B of § 2.2-3114.

783 "Transaction" means any matter considered by any governmental or advisory agency, whether in a  
784 committee, subcommittee, or other entity of that agency or before the agency itself, on which official  
785 action is taken or contemplated.

786 **§ 2.2-3103. Prohibited conduct.**

787 No officer or employee of a state or local governmental or advisory agency shall:

788 1. Solicit or accept money or other thing of value for services performed within the scope of his  
789 official duties, except the compensation, expenses or other remuneration paid by the agency of which he  
790 is an officer or employee. This prohibition shall not apply to the acceptance of special benefits that may  
791 be authorized by law;

792 2. Offer or accept any money or other thing of value for or in consideration of obtaining  
793 employment, appointment, or promotion of any person with any governmental or advisory agency;

794 3. Offer or accept any money or other thing of value for or in consideration of the use of his public  
795 position to obtain a contract for any person or business with any governmental or advisory agency;

796 4. Use for his own economic benefit or that of another party confidential information that he has  
797 acquired by reason of his public position and which is not available to the public;

798 5. Accept any money, loan, gift, favor, service, or business or professional opportunity that  
799 reasonably tends to influence him in the performance of his official duties. This subdivision shall not  
800 apply to any political contribution actually used for political campaign or constituent service purposes  
801 and reported as required by Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2;

802 6. Accept any business or professional opportunity when he knows that there is a reasonable  
803 likelihood that the opportunity is being afforded him to influence him in the performance of his official  
804 duties;

805 7. Accept any honoraria for any appearance, speech, or article in which the officer or employee  
806 provides expertise or opinions related to the performance of his official duties. The term "honoraria"  
807 shall not include any payment for or reimbursement to such person for his actual travel, lodging, or  
808 subsistence expenses incurred in connection with such appearance, speech, or article or in the alternative  
809 a payment of money or anything of value not in excess of the per diem deduction allowable under § 162  
810 of the Internal Revenue Code, as amended from time to time. The prohibition in this subdivision shall  
811 apply only to the Governor, Lieutenant Governor, Attorney General, Governor's Secretaries, and heads  
812 of departments of state government;

813 8. Accept a gift from a person who has interests that may be substantially affected by the  
814 performance of the officer's or employee's official duties under circumstances where the timing and  
815 nature of the gift would cause a reasonable person to question the officer's or employee's impartiality in  
816 the matter affecting the donor. Violations of this subdivision shall not be subject to criminal law  
817 penalties; or

818 9. Accept gifts from sources on a basis so frequent as to raise an appearance of the use of his public  
819 office for private gain. Violations of this subdivision shall not be subject to criminal law penalties; or

820 10. *Solicit, accept, or receive any gift of travel with a value exceeding \$100 from a third party prior*  
821 *to submitting to the Council a request for a waiver to accept such gift of travel and receiving such a*  
822 *waiver pursuant to § 30-356.2. Gifts of travel include transportation, lodging, meals, hospitality, and*  
823 *any other travel-related thing of value.*

824 **§ 2.2-3103.1. Certain gifts prohibited.**

825 A. For purposes of this section:

826 "Intangible gift" means a thing of temporary value or a thing that upon the happening of a certain  
827 event or expiration of a given date loses its value. "Intangible gift" includes entertainment, hospitality, a  
828 ticket, admission, or pass, transportation, lodgings, and meals that are reportable on Schedule E of the  
829 disclosure form prescribed in § 2.2-3117.

830 "Tangible gift" means a thing of value that does not lose its value upon the happening of a certain  
831 event or expiration of a given date. "Tangible gift" includes currency, negotiable instruments, securities,  
832 stock options, or other financial instruments that are reportable on Schedule E of the disclosure form  
833 prescribed in § 2.2-3117. "Tangible gift" does not include payments or reimbursements received for any  
834 intangible gift.

835 B. An officer or employee of a *state or* local governmental or advisory agency or candidate required  
836 to file the disclosure form prescribed in § 2.2-3117 (i) shall not solicit, accept, or receive within any  
837 calendar year any single ~~tangible~~ gift with a value in excess of \$250 ~~\$100~~ or a *any* combination of  
838 ~~tangible~~ gifts with an aggregate value in excess of \$250 ~~\$100~~ from any person that he knows or has  
839 reason to know is (a) a lobbyist registered pursuant to Article 3 (§ 2.2-418 et seq.) of Chapter 4; (b) a  
840 lobbyist's principal as defined in § 2.2-419; or (c) a person, organization, or business who is a party to  
841 or is seeking to become a party to a contract with the local agency of which he is an officer or an  
842 employee; (ii) shall report any ~~tangible~~ gift with a value of \$250 or less or any intangible gift received  
843 from any person listed in clause (i) on Schedule E of such disclosure form; and (iii) shall report any

844 payments for talks, meetings, and publications on Schedule D of such disclosure form. Gifts received  
 845 from business associates, relatives, or in conjunction with a personal celebration are not subject to this  
 846 prohibition or the disclosure requirements of § 2.2-3117. Gifts with a value of less than \$20 are not  
 847 subject to aggregation for purposes of this prohibition.

848 ~~C.~~ B. Notwithstanding the provisions of subsection A, an officer or employee of a state or local  
 849 governmental or advisory agency or candidate required to file the disclosure form prescribed in  
 850 § 2.2-3117 (i) shall not solicit, accept, or receive within any calendar year any single tangible gift with a  
 851 value in excess of \$250 or a combination of tangible gifts with an aggregate value in excess of \$250  
 852 from any person that he knows or has reason to know is (a) a lobbyist registered pursuant to Article 3  
 853 (§ 2.2-418 et seq.) of Chapter 4; (b) a lobbyist's principal as defined in § 2.2-419; or (c) a person,  
 854 organization, or business who is a party to or is seeking to become a party to a contract with the  
 855 Commonwealth; (ii) shall report any tangible gift with a value of \$250 or less or any intangible gift  
 856 received from any person listed in clause (i) on Schedule E of such disclosure form; and (iii) shall  
 857 report any payments for talks, meetings, and publications on Schedule D of such disclosure form may  
 858 accept or receive a gift or a combination of gifts with a value in excess of \$100 when such gift is  
 859 accepted or received while in attendance at a widely attended event. A widely attended event is an event  
 860 for which there is a reasonable expectation that at least 25 persons will attend the event and the event  
 861 has a civic or regional interest or is open to individuals from a particular industry or profession or who  
 862 represent persons interested in a particular issue.

863 C. Food and beverages received at or registration or attendance fees waived for any event at which  
 864 the officer, employee, or candidate is a featured speaker, presenter, or lecturer shall not be subject to  
 865 the provisions of subsection A.

866 D. Notwithstanding the provisions of subsection A, an officer or employee of a state or local  
 867 governmental or advisory agency or candidate required to file the disclosure form prescribed in  
 868 § 2.2-3117 may accept or receive certain gifts with a value in excess of \$100 when he has submitted a  
 869 request for a waiver to and has received the approval of the Council pursuant to § 30-356.2. An officer,  
 870 employee, or candidate may request a waiver for the following gifts:

871 1. A gift or a combination of gifts from a personal friend. In making its determination to grant the  
 872 waiver, the Council shall consider the nature and length of the friendship.

873 2. Transportation, lodging, hospitality, or other travel-related thing of value that is provided by a  
 874 third party and is directly related to the official duties of the officer or employee. In making its  
 875 determination to grant the waiver, the Council shall consider the purpose of the trip as it relates to the  
 876 officer's or employee's public duties and responsibilities.

877 E. Any gift received by an officer or employee subject to the provisions of this section (i) from a  
 878 foreign dignitary, (ii) with a value exceeding \$100, and (iii) for which the fair market value or a gift of  
 879 greater or equal value has not been provided or exchanged, shall be accepted on behalf of the  
 880 Commonwealth and archived in accordance with guidelines established by the Library of Virginia. Such  
 881 gift shall be disclosed as having been accepted on behalf of the Commonwealth but the value of such  
 882 gift shall not be required to be disclosed.

883 ~~D.~~ F. During the pendency of a civil action in any state or federal court to which the Commonwealth  
 884 is a party, the Governor or the Attorney General or any employee of the Governor or the Attorney  
 885 General who is subject to the provisions of this chapter shall not solicit, accept, or receive any tangible  
 886 gift from any person that he knows or has reason to know is a person, organization, or business who is  
 887 a party to such civil action. A person, organization, or business who is a party to such civil action shall  
 888 not knowingly give any tangible gift to the Governor or the Attorney General or any of their employees  
 889 who are subject to the provisions of this chapter. For purposes of this subsection, "person, organization,  
 890 or business" includes individuals who are officers, directors, or owners of or who have a controlling  
 891 ownership interest in such organization or business.

892 E. The \$250 limitation imposed in accordance with this section shall be adjusted by the Council  
 893 every five years, as of January 1 of that year, in an amount equal to the annual increases for that  
 894 five-year period in the United States Average Consumer Price Index for all items, all urban consumers  
 895 (CPI-U), as published by the Bureau of Labor Statistics of the U.S. Department of Labor, rounded to the  
 896 nearest whole dollar.

897 F. G. For purposes of this section, "person, organization, or business" includes individuals who are  
 898 officers, directors, or owners of or who have a controlling ownership interest in such organization or  
 899 business "candidate" means a person who seeks or campaigns for an office of the Commonwealth or  
 900 one of its governmental units in a general, primary, or special election and who is qualified to have his  
 901 name placed on the ballot for the office. The candidate shall become subject to the provisions of this  
 902 section upon the filing of a statement of organization pursuant to § 24.2-947.1. The State Board of  
 903 Elections or the local electoral board, as appropriate, shall notify each such candidate of the provisions  
 904 of this section.

905 **§ 2.2-3104. Prohibited conduct for certain officers and employees of state government.**

906 For one year after the termination of public employment or service, no state officer or employee  
 907 shall, before the agency of which he was an officer or employee, represent a client or act in a  
 908 representative capacity on behalf of any person or group, for compensation, on matters related to  
 909 legislation, executive orders, or regulations promulgated by the agency of which he was an officer or  
 910 employee. This prohibition shall be in addition to the prohibitions contained in § 2.2-3103.

911 For the purposes of this section, "state officer or employee" ~~shall mean~~ *means* (i) the Governor,  
 912 Lieutenant Governor, Attorney General, and officers appointed by the Governor, whether confirmation  
 913 by the General Assembly or by either house thereof is required or not, who are regularly employed on a  
 914 full-time salaried basis; those officers and employees of executive branch agencies who report directly to  
 915 the agency head; and those at the level immediately below those who report directly to the agency head  
 916 and are at a payband 6 or higher and (ii) the officers and professional employees of the legislative  
 917 branch designated by the joint rules committee of the General Assembly. For the purposes of this  
 918 section, the General Assembly and the legislative branch agencies shall be deemed one agency.

919 *As this prohibition applies to the Governor's Secretaries, "agency" means all agencies assigned to*  
 920 *the Secretary by law or by executive order of the Governor.*

921 Any person subject to the provisions of this section may apply to the Council or Attorney General,  
 922 as provided in § 2.2-3121 or 2.2-3126, for an advisory opinion as to the application of the restriction  
 923 imposed by this section on any post-public employment position or opportunity.

924 **§ 2.2-3104.01. Prohibited conduct; bids or proposals under the Virginia Public Procurement**  
 925 **Act, Public-Private Transportation Act, and Public-Private Education Facilities and Infrastructure**  
 926 **Act; loans or grants from the Commonwealth's Development Opportunity Fund.**

927 A. Neither the Governor, his political action committee, or the Governor's Secretaries, if the  
 928 Secretary is responsible to the Governor for an executive branch agency with jurisdiction over the  
 929 matters at issue, shall knowingly solicit or accept a contribution, gift, or other item with a value greater  
 930 than \$50 from any bidder, offeror, or private entity, or from an officer or director of such bidder,  
 931 offeror, or private entity, who has submitted a bid or proposal to an executive branch agency that is  
 932 directly responsible to the Governor pursuant to the Virginia Public Procurement Act (§ 2.2-4300 et  
 933 seq.), the Public-Private Transportation Act of 1995 (§ 56-556 et seq.), or the Public-Private Education  
 934 Facilities and Infrastructure Act of 2002 (§ 56-575.1 et seq.) (i) during the period between the  
 935 submission of the bid and the award of the public contract under the Virginia Public Procurement Act or  
 936 (ii) following the submission of a proposal under the Public-Private Transportation Act of 1995 or the  
 937 Public-Private Education Facilities and Infrastructure Act of 2002 until the execution of a comprehensive  
 938 agreement thereunder.

939 *B. Neither the Governor, his campaign committee, nor a political action committee established on his*  
 940 *behalf shall knowingly solicit or accept a contribution, gift, or other item with a value greater than \$50*  
 941 *from any person or entity that is seeking to become a business beneficiary of grants or loans from the*  
 942 *Commonwealth's Development Opportunity Fund, or any individual who is an officer, director, or*  
 943 *employee, including an agent or consultant, of such entity, while the person or entity is seeking such*  
 944 *funds and for a period of one year following the date the grant or loan sought is awarded.*

945 *B- C. The provisions of this section shall apply only for public contracts, proposals, or*  
 946 *comprehensive agreements where the stated or expected value of the contract is \$5 million or more or*  
 947 *for grants or loans from the Commonwealth's Development Opportunity Fund where the value of the*  
 948 *grant or loan is \$100,000 or more. The provisions of this section shall not apply to contracts awarded*  
 949 *as the result of competitive sealed bidding as set forth in § 2.2-4302.1.*

950 *C- D. Any person who knowingly violates this section shall be subject to a civil penalty of \$500 or*  
 951 *up to two times the amount of the contribution or gift, whichever is greater, and the contribution, gift,*  
 952 *or other item shall be returned to the donor. The attorney for the Commonwealth shall initiate civil*  
 953 *proceedings to enforce the civil penalties. Any civil penalties collected shall be payable to the State*  
 954 *Treasurer for deposit to the general fund and shall be used exclusively to fund the Council.*

955 **§ 2.2-3106. Prohibited contracts by officers and employees of state government and Eastern**  
 956 **Virginia Medical School.**

957 A. No officer or employee of any governmental agency of state government or Eastern Virginia  
 958 Medical School shall have a personal interest in a contract with the governmental agency of which he is  
 959 an officer or employee, other than his own contract of employment.

960 B. No officer or employee of any governmental agency of state government or Eastern Virginia  
 961 Medical School shall have a personal interest in a contract with any other governmental agency of state  
 962 government unless such contract is (i) awarded as a result of competitive sealed bidding or competitive  
 963 negotiation as set forth in § 2.2-4302.1 or 2.2-4302.2 or (ii) is awarded after a finding, in writing, by the  
 964 administrative head of the governmental agency that competitive bidding or negotiation is contrary to the  
 965 best interest of the public.

966 C. The provisions of this section shall not apply to:

- 967 1. An employee's personal interest in additional contracts of employment with his own governmental  
 968 agency that accrue to him because of a member of his immediate family, provided the employee does  
 969 not exercise any control over the employment or the employment activities of the member of his  
 970 immediate family and the employee is not in a position to influence those activities;
- 971 2. The personal interest of an officer or employee of a state institution of higher education or the  
 972 Eastern Virginia Medical School in additional contracts of employment with his own governmental  
 973 agency that accrue to him because of a member of his immediate family, provided (i) the officer or  
 974 employee and the immediate family member are engaged in teaching, research or administrative support  
 975 positions at the educational institution or the Eastern Virginia Medical School, (ii) the governing board  
 976 of the educational institution finds that it is in the best interests of the institution or the Eastern Virginia  
 977 Medical School and the Commonwealth for such dual employment to exist, and (iii) after such finding,  
 978 the governing board of the educational institution or the Eastern Virginia Medical School ensures that  
 979 the officer or employee, or the immediate family member, does not have sole authority to supervise,  
 980 evaluate or make personnel decisions regarding the other;
- 981 3. An officer's or employee's personal interest in a contract of employment with any other  
 982 governmental agency of state government;
- 983 4. Contracts for the sale by a governmental agency or the Eastern Virginia Medical School of  
 984 services or goods at uniform prices available to the general public;
- 985 5. An employee's personal interest in a contract between a public institution of higher education in  
 986 Virginia or the Eastern Virginia Medical School and a publisher or wholesaler of textbooks or other  
 987 educational materials for students, which accrues to him solely because he has authored or otherwise  
 988 created such textbooks or materials;
- 989 6. An employee's personal interest in a contract with his or her employing public institution of higher  
 990 education to acquire the collections or scholarly works owned by the employee, including manuscripts,  
 991 musical scores, poetry, paintings, books or other materials, writings, or papers of an academic, research,  
 992 or cultural value to the institution, provided the president of the institution approves the acquisition of  
 993 such collections or scholarly works as being in the best interests of the institution's public mission of  
 994 service, research, or education;
- 995 7. Subject to approval by the board of visitors, an employee's personal interest in a contract between  
 996 the Eastern Virginia Medical School or a public institution of higher education in Virginia that operates  
 997 a school of medicine or dentistry and a not-for-profit nonstock corporation that operates a clinical  
 998 practice within such public institution of higher education or the Eastern Virginia Medical School and of  
 999 which such employee is a member or employee;
- 1000 8. Subject to approval by the relevant board of visitors, an employee's personal interest in a contract  
 1001 for research and development or commercialization of intellectual property between a public institution  
 1002 of higher education in Virginia or the Eastern Virginia Medical School and a business in which the  
 1003 employee has a personal interest, if (i) the employee's personal interest has been disclosed to and  
 1004 approved by such public institution of higher education or the Eastern Virginia Medical School prior to  
 1005 the time at which the contract is entered into; (ii) the employee promptly files a disclosure statement  
 1006 pursuant to § 2.2-3117 and thereafter files such statement annually on or before ~~January~~ *December* 15;  
 1007 (iii) the institution has established a formal policy regarding such contracts, approved by the State  
 1008 Council of Higher Education or, in the case of the Eastern Virginia Medical School, a formal policy  
 1009 regarding such contracts in conformity with any applicable federal regulations that has been approved by  
 1010 its board of visitors; and (iv) no later than December 31 of each year, the institution or the Eastern  
 1011 Virginia Medical School files an annual report with the Secretary of the Commonwealth disclosing each  
 1012 open contract entered into subject to this provision, the names of the parties to each contract, the date  
 1013 each contract was executed and its term, the subject of each contractual arrangement, the nature of the  
 1014 conflict of interest, the institution's or the Eastern Virginia Medical School's employee responsible for  
 1015 administering each contract, the details of the institution's or the Eastern Virginia Medical School's  
 1016 commitment or investment of resources or finances for each contract, and any other information  
 1017 requested by the Secretary of the Commonwealth; or
- 1018 9. Subject to approval by the relevant board of visitors, an employee's personal interest in a contract  
 1019 between a public institution of higher education in Virginia or the Eastern Virginia Medical School and  
 1020 a business in which the employee has a personal interest, if (i) the personal interest has been disclosed  
 1021 to the institution or the Eastern Virginia Medical School prior to the time the contract is entered into;  
 1022 (ii) the employee files a disclosure statement pursuant to § 2.2-3117 and thereafter annually on or before  
 1023 ~~January~~ *December* 15; (iii) the employee does not participate in the institution's or the Eastern Virginia  
 1024 Medical School's decision to contract; (iv) the president of the institution or the Eastern Virginia  
 1025 Medical School finds and certifies in writing that the contract is for goods and services needed for  
 1026 quality patient care, including related medical education or research, by the institution's medical center  
 1027 or the Eastern Virginia Medical School, its affiliated teaching hospitals and other organizations necessary

1028 for the fulfillment of its mission, including the acquisition of drugs, therapies and medical technologies;  
 1029 and (v) no later than December 31 of each year, the institution or the Eastern Virginia Medical School  
 1030 files an annual report with the Secretary of the Commonwealth disclosing each open contract entered  
 1031 subject to this provision, the names of the parties to each contract, the date each contract was executed  
 1032 and its term, the subject of each contractual arrangement, the nature of the conflict of interest, the  
 1033 institution's or the Eastern Virginia Medical School's employee responsible for administering each  
 1034 contract, the details of the institution's or the Eastern Virginia Medical School's commitment or  
 1035 investment of resources or finances for each contract, and any other information requested by the  
 1036 Secretary of the Commonwealth.

1037 D. Notwithstanding the provisions of subdivisions C 8 and C 9, if the research and development or  
 1038 commercialization of intellectual property or the employee's personal interest in a contract with a  
 1039 business is subject to policies and regulations governing conflicts of interest promulgated by any agency  
 1040 of the United States government, including the adoption of policies requiring the disclosure and  
 1041 management of such conflicts of interests, the policies established by the Eastern Virginia Medical  
 1042 School pursuant to such federal requirements shall constitute compliance with subdivisions C 8 and C 9,  
 1043 upon notification by the Eastern Virginia Medical School to the Secretary of the Commonwealth by  
 1044 January 31 of each year of evidence of their compliance with such federal policies and regulations.

1045 E. The board of visitors may delegate the authority granted under subdivision C 8 to the president of  
 1046 the institution. If the board elects to delegate such authority, the board shall include this delegation of  
 1047 authority in the formal policy required by clause (iii) of subdivision C 8. In those instances where the  
 1048 board has delegated such authority, on or before December 1 of each year, the president of the relevant  
 1049 institution shall file a report with the relevant board of visitors disclosing each open contract entered  
 1050 into subject to this provision, the names of the parties to each contract, the date each contract was  
 1051 executed and its term, the subject of each contractual arrangement, the nature of the conflict of interest,  
 1052 the institution's or the Eastern Virginia Medical School's employee responsible for administering each  
 1053 contract, the details of the institution's or the Eastern Virginia Medical School's commitment or  
 1054 investment of resources or finances for each contract, the details of how revenues are to be dispersed,  
 1055 and any other information requested by the board of visitors.

1056 **§ 2.2-3114. Disclosure by state officers and employees.**

1057 A. The Governor, Lieutenant Governor, Attorney General, Justices of the Supreme Court, judges of  
 1058 the Court of Appeals, judges of any circuit court, judges and substitute judges of any district court,  
 1059 members of the State Corporation Commission, members of the Virginia Workers' Compensation  
 1060 Commission, members of the Commonwealth Transportation Board, members of the Board of Trustees  
 1061 of the Virginia Retirement System, and members of the Virginia Lottery Board and other persons  
 1062 occupying such offices or positions of trust or employment in state government, including members of  
 1063 the governing bodies of authorities, as may be designated by the Governor, or, in the case of officers or  
 1064 employees of the legislative branch, *as may be designated* by the Joint Rules Committee of the General  
 1065 Assembly, shall file with the Council, as a condition to assuming office or employment, a disclosure  
 1066 statement of their personal interests and such other information as is specified on the form set forth in  
 1067 § 2.2-3117 and thereafter shall file such a statement semiannually by December 15 for the preceding  
 1068 six-month period complete through the last day of October and by June 15 for the preceding six-month  
 1069 period complete through the last day of April. When the filing deadline falls on a Saturday, Sunday, or  
 1070 legal holiday, the disclosure statement shall be filed on the next day that is not a Saturday, Sunday, or  
 1071 legal holiday.

1072 B. Nonsalaried citizen members of all policy and supervisory boards, commissions, and councils in  
 1073 the executive branch of state government, other than the Commonwealth Transportation Board, members  
 1074 of the Board of Trustees of the Virginia Retirement System, and the Virginia Lottery Board, shall file  
 1075 with the Council, as a condition to assuming office, a disclosure form of their personal interests and  
 1076 such other information as is specified on the form set forth in § 2.2-3118 and thereafter shall file such  
 1077 form annually on or before December 15. When the filing deadline falls on a Saturday, Sunday, or legal  
 1078 holiday, the disclosure statement shall be filed on the next day that is not a Saturday, Sunday, or legal  
 1079 holiday. Nonsalaried citizen members of other boards, commissions, and councils, including advisory  
 1080 boards and authorities, may be required to file a disclosure form if so designated by the Governor, in  
 1081 which case the form shall be that set forth in § 2.2-3118.

1082 C. The disclosure forms required by subsections A and B shall be ~~provided~~ *made available* by the  
 1083 Council to each officer and employee so designated, including officers appointed by legislative  
 1084 authorities at least 30 days prior to the filing deadline. Disclosure forms shall be filed ~~and electronically~~  
 1085 *with the Council in accordance with the standards approved by it pursuant to § 30-356. All forms shall*  
 1086 *be maintained as public records for five years in the office of the Council.*

1087 D. Candidates for the offices of Governor, Lieutenant Governor or Attorney General shall file a  
 1088 disclosure statement of their personal interests as required by § 24.2-502.

1089 E. Any officer or employee of state government who has a personal interest in any transaction before

1090 the governmental or advisory agency of which he is an officer or employee and who is disqualified  
 1091 from participating in that transaction pursuant to subdivision A 1 of § 2.2-3112, or otherwise elects to  
 1092 disqualify himself, shall forthwith make disclosure of the existence of his interest, including the full  
 1093 name and address of the business and the address or parcel number for the real estate if the interest  
 1094 involves a business or real estate, and his disclosure shall also be reflected in the public records of the  
 1095 agency for five years in the office of the administrative head of the officer's or employee's governmental  
 1096 agency or advisory agency or, if the agency has a clerk, in the clerk's office.

1097 F. An officer or employee of state government who is required to declare his interest pursuant to  
 1098 subdivision A 2 of § 2.2-3112, shall declare his interest by stating (i) the transaction involved, (ii) the  
 1099 nature of the officer's or employee's personal interest affected by the transaction, (iii) that he is a  
 1100 member of a business, profession, occupation, or group the members of which are affected by the  
 1101 transaction, and (iv) that he is able to participate in the transaction fairly, objectively, and in the public  
 1102 interest. The officer or employee shall either make his declaration orally to be recorded in written  
 1103 minutes for his agency or file a signed written declaration with the clerk or administrative head of his  
 1104 governmental or advisory agency, as appropriate, who shall, in either case, retain and make available for  
 1105 public inspection such declaration for a period of five years from the date of recording or receipt. If  
 1106 reasonable time is not available to comply with the provisions of this subsection prior to participation in  
 1107 the transaction, the officer or employee shall prepare and file the required declaration by the end of the  
 1108 next business day.

1109 G. An officer or employee of state government who is required to declare his interest pursuant to  
 1110 subdivision A 3 of § 2.2-3112, shall declare his interest by stating (i) the transaction involved, (ii) that a  
 1111 party to the transaction is a client of his firm, (iii) that he does not personally represent or provide  
 1112 services to the client, and (iv) that he is able to participate in the transaction fairly, objectively, and in  
 1113 the public interest. The officer or employee shall either make his declaration orally to be recorded in  
 1114 written minutes for his agency or file a signed written declaration with the clerk or administrative head  
 1115 of his governmental or advisory agency, as appropriate, who shall, in either case, retain and make  
 1116 available for public inspection such declaration for a period of five years from the date of recording or  
 1117 receipt. If reasonable time is not available to comply with the provisions of this subsection prior to  
 1118 participation in the transaction, the officer or employee shall prepare and file the required declaration by  
 1119 the end of the next business day.

1120 *H. Notwithstanding any other provision of law, chairs or deans of departments at a public institution*  
 1121 *of higher education in the Commonwealth shall not be required to file the disclosure form prescribed by*  
 1122 *§ 2.2-3117 or 2.2-3118.*

1123 **§ 2.2-3114.1. Filings of statements of economic interests by General Assembly members.**

1124 The filing of a current statement of economic interests by a General Assembly member,  
 1125 member-elect, or candidate for the General Assembly pursuant to §§ 30-110 and 30-111 of the General  
 1126 Assembly Conflicts of Interests Act (§ 30-100 et seq.) shall suffice for the purposes of this chapter  
 1127 (~~§ 2.2-3100 et seq.~~). The Secretary of the Commonwealth may obtain from the ~~Clerk of the House of~~  
 1128 ~~Delegates or the Senate, as appropriate, Council~~ a copy of the statement of a General Assembly member  
 1129 who is appointed to a position for which a statement is required pursuant to § 2.2-3114. No General  
 1130 Assembly member, member-elect, or candidate shall be required to file a separate statement of economic  
 1131 interests for the purposes of § 2.2-3114.

1132 **§ 2.2-3115. Disclosure by local government officers and employees.**

1133 A. The members of every governing body and school board of each county and city and of towns  
 1134 with populations in excess of 3,500 shall file with the Council, as a condition to assuming office or  
 1135 employment, a disclosure statement of their personal interests and other information as is specified on  
 1136 the form set forth in § 2.2-3117 and thereafter shall file such a statement semiannually by December 15  
 1137 for the preceding six-month period complete through the last day of October and by June 15 for the  
 1138 preceding six-month period complete through the last day of April.

1139 The members of the governing body of any authority established in any county or city, or part or  
 1140 combination thereof, and having the power to issue bonds or expend funds in excess of \$10,000 in any  
 1141 fiscal year, shall file with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~, as a condition  
 1142 to assuming office, a disclosure statement of their personal interests and other information as is specified  
 1143 on the form set forth in § 2.2-3118 and thereafter shall file such a statement annually on or before  
 1144 December 15, unless the governing body of the jurisdiction that appoints the members requires that the  
 1145 members file the form set forth in § 2.2-3117 semiannually by December 15 for the preceding six-month  
 1146 period complete through the last day of October and by June 15 for the preceding six-month period  
 1147 complete through the last day of April.

1148 Persons occupying such positions of trust appointed by governing bodies and persons occupying such  
 1149 positions of employment with governing bodies as may be designated to file by ordinance of the  
 1150 governing body shall file with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~, as a

1151 condition to assuming office or employment, a disclosure statement of their personal interests and other  
1152 information as is specified on the form set forth in § 2.2-3117 and thereafter shall file such a statement  
1153 semiannually by December 15 for the preceding six-month period complete through the last day of  
1154 October and by June 15 for the preceding six-month period complete through the last day of April.

1155 Persons occupying such positions of trust appointed by school boards and persons occupying such  
1156 positions of employment with school boards as may be designated to file by an adopted policy of the  
1157 school board shall file with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~, as a condition  
1158 to assuming office or employment, a disclosure statement of their personal interests and other  
1159 information as is specified on the form set forth in § 2.2-3117 and thereafter shall file such a statement  
1160 semiannually by December 15 for the preceding six-month period complete through the last day of  
1161 October and by June 15 for the preceding six-month period complete through the last day of April.

1162 B. Nonsalaried citizen members of local boards, commissions and councils as may be designated by  
1163 the governing body shall file with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~, as a  
1164 condition to assuming office, a disclosure form of their personal interests and such other information as  
1165 is specified on the form set forth in § 2.2-3118 and thereafter shall file such form annually on or before  
1166 December 15.

1167 C. No person shall be mandated to file any disclosure not otherwise required by this article.

1168 D. The disclosure forms required by subsections A and B shall be ~~provided~~ *made available* by the  
1169 ~~Virginia Conflict of Interest and Ethics Advisory Council to the clerks of the governing bodies and~~  
1170 ~~school boards at least 30 days prior to the filing deadline; and the clerks of the governing body and~~  
1171 ~~school board shall distribute the forms to designated individuals at least 20 days prior to the filing~~  
1172 ~~deadline. Forms shall be filed and maintained as public records for five years in the office of the~~  
1173 ~~Virginia Conflict of Interest and Ethics Advisory Council. Forms filed by members of governing bodies~~  
1174 ~~of authorities shall be filed and electronically with the Council in accordance with the standards~~  
1175 ~~approved by it pursuant to § 30-356. All forms shall be maintained as public records for five years in~~  
1176 ~~the office of the Virginia Conflict of Interest and Ethics Advisory Council.~~

1177 E. Candidates for membership in the governing body or school board of any county, city or town  
1178 with a population of more than 3,500 persons shall file a disclosure statement of their personal interests  
1179 as required by § 24.2-502.

1180 F. Any officer or employee of local government who has a personal interest in any transaction before  
1181 the governmental or advisory agency of which he is an officer or employee and who is disqualified  
1182 from participating in that transaction pursuant to subdivision A 1 of § 2.2-3112 or otherwise elects to  
1183 disqualify himself, shall forthwith make disclosure of the existence of his interest, including the full  
1184 name and address of the business and the address or parcel number for the real estate if the interest  
1185 involves a business or real estate, and his disclosure shall be reflected in the public records of the  
1186 agency for five years in the office of the administrative head of the officer's or employee's governmental  
1187 or advisory agency.

1188 G. In addition to any disclosure required by subsections A and B, in each county and city and in  
1189 towns with populations in excess of 3,500, members of planning commissions, boards of zoning appeals,  
1190 real estate assessors, and all county, city and town managers or executive officers shall make annual  
1191 disclosures of all their interests in real estate located in the county, city or town in which they are  
1192 elected, appointed, or employed. Such disclosure shall include any business in which such persons own  
1193 an interest, or from which income is received, if the primary purpose of the business is to own, develop  
1194 or derive compensation through the sale, exchange or development of real estate in the county, city or  
1195 town. Such disclosure shall be filed as a condition to assuming office or employment, and thereafter  
1196 shall be filed annually with the ~~Virginia Conflict of Interest and Ethics Advisory Council~~ on or before  
1197 December 15. Such disclosures shall be filed and maintained as public records for five years. Forms for  
1198 the filing of such reports shall be ~~prepared and distributed~~ *made available* by the ~~Virginia Conflict of~~  
1199 ~~Interest and Ethics Advisory Council to the clerk of each governing body.~~

1200 H. An officer or employee of local government who is required to declare his interest pursuant to  
1201 subdivision A 2 of § 2.2-3112 shall declare his interest by stating (i) the transaction involved, (ii) the  
1202 nature of the officer's or employee's personal interest affected by the transaction, (iii) that he is a  
1203 member of a business, profession, occupation, or group the members of which are affected by the  
1204 transaction, and (iv) that he is able to participate in the transaction fairly, objectively, and in the public

1217 services to the client, and (iv) that he is able to participate in the transaction fairly, objectively, and in  
1218 the public interest. The officer or employee shall either make his declaration orally to be recorded in  
1219 written minutes for his agency or file a signed written declaration with the clerk or administrative head  
1220 of his governmental or advisory agency, as appropriate, who shall, in either case, retain and make  
1221 available for public inspection such declaration for a period of five years from the date of recording or  
1222 receipt. If reasonable time is not available to comply with the provisions of this subsection prior to

1225 **§ 2.2-3116. Disclosure by certain constitutional officers.**

1226 For the purposes of this chapter, holders of the constitutional offices of treasurer, sheriff, attorney for  
1227 the Commonwealth, clerk of the circuit court and commissioner of the revenue of each county and city,  
1228 shall be deemed to be local officers and shall be required to file *with the Council, as a condition to*  
1229 *assuming office, the Statement of Economic Interests disclosure form* set forth in § 2.2-3117. These  
1230 officers shall file ~~statements pursuant to § 2.2-3115 and candidates such forms~~ *semiannually by*  
1231 *December 15 for the preceding six-month period complete through the last day of October and by June*  
1232 *15 for the preceding six-month period complete through the last day of April. Candidates shall file*  
1233 *statements such forms* as required by § 24.2-502. *Disclosure forms shall be filed electronically with the*  
1234 *Council in accordance with the standards approved by it pursuant to § 30-356.* These officers shall be  
1235 subject to the prohibition on certain gifts set forth in subsection B of § 2.2-3103.1.

1236 **§ 2.2-3117. Disclosure form; penalty.**

1237 A. The disclosure form to be used for filings required by subsections A and D of § 2.2-3114 and  
1238 subsections A and E of § 2.2-3115 shall be ~~substantially as follows: on a form prescribed by the~~  
1239 *Council. All completed forms shall be filed electronically and in accordance with the standards*  
1240 *approved by the Council pursuant to § 30-356. A person required to file this disclosure form who does*  
1241 *so knowing it to contain a material misstatement of fact is guilty of a Class 6 felony.*

1273 donee's or his spouse's parent, grandparent, grandchild, brother, or sister; or the donee's brother's or

1274 sister's spouse. "Personal friend" does not include any person that the filer knows or has reason to know  
 1275 is (a) a lobbyist registered pursuant to Article 3 (§ 2-2-418 et seq.) of Chapter 4 of Title 2-2; (b) a  
 1276 lobbyist's principal as defined in § 2-2-419; (c) for an officer or employee of a local governmental or  
 1277 advisory agency, a person, organization, or business who is a party to or is seeking to become a party to  
 1278 a contract with the local agency of which he is an officer or an employee; or (d) for an officer or  
 1279 employee of a state governmental or advisory agency, a person, organization, or business who is a party  
 1280 to or is seeking to become a party to a contract with the Commonwealth. "Person, organization, or  
 1281 business" includes individuals who are officers, directors, or owners of or who have a controlling  
 1282 ownership interest in such organization or business.

 1284 officer or employee and who is a dependent of the officer or employee.

2080 "Personal interest" means a financial benefit or liability accruing to a legislator or to a member of his  
 2081 immediate family. Such interest shall exist by reason of (i) ownership in a business if the ownership  
 2082 interest exceeds three percent of the total equity of the business; (ii) annual income that exceeds, or may  
 2083 reasonably be anticipated to exceed, \$5,000 from ownership in real or personal property or a business;  
 2084 (iii) salary, other compensation, fringe benefits, or benefits from the use of property, or any combination  
 2085 thereof, paid or provided by a business or governmental agency that exceeds, or may reasonably be  
 2086 anticipated to exceed, \$5,000 annually; (iv) ownership of real or personal property if the interest exceeds

2092 "Personal interest in a contract" means a personal interest that a legislator has in a contract with a

2095 "Personal interest in a transaction" means a personal interest of a legislator in any matter considered  
 2096 by the General Assembly. Such personal interest exists when an officer or employee or a member of his  
 2097 immediate family has a personal interest in property or a business, or represents or provides services to  
 2098 any individual or business and such property, business or represented or served individual or business (i)  
 2099 is the subject of the transaction or (ii) may realize a reasonably foreseeable direct or indirect benefit or  
 2100 detriment as a result of the action of the agency considering the transaction. A "personal interest in a

2113 Assembly. This prohibition shall not apply to the acceptance of special benefits which may be

2115 2. Offer or accept any money or other thing of value for or in consideration of obtaining  
2116 employment, appointment, or promotion of any person with any governmental or advisory agency;

2117 3. Offer or accept any money or other thing of value for or in consideration of the use of his public  
2118 position to obtain a contract for any person or business with any governmental or advisory agency;

2119 4. Use for his own economic benefit or that of another party confidential information which he has  
2120 acquired by reason of his public position and which is not available to the public;

2121 5. Accept any money, loan, gift, favor, service, or business or professional opportunity that  
2122 reasonably tends to influence him in the performance of his official duties. This subdivision shall not  
2123 apply to any political contribution actually used for political campaign or constituent service purposes  
2124 and reported as required by Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2;

2125 6. Accept any business or professional opportunity when he knows that there is a reasonable  
2126 likelihood that the opportunity is being afforded him to influence him in the performance of his official  
2127 duties;

2128 7. During the one year after the termination of his service as a legislator, represent a client or act in  
2129 a representative capacity on behalf of any person or group, for compensation, on any matter before the  
2130 General Assembly or any agency of the legislative branch of government. The prohibitions of this  
2131 subdivision shall apply only to persons engaged in activities that would require registration as a lobbyist  
2132 under § 2.2-422. Any person subject to the provisions of this subdivision may apply to the Attorney  
2133 General, as provided in § 30-122, for an advisory opinion as to the application of the restriction imposed  
2134 by this subdivision on any post-public employment position or opportunity;

2135 8. Accept any honoraria for any appearance, speech, or article in which the legislator provides  
2136 expertise or opinions related to the performance of his official duties. The term "honoraria" shall not  
2137 include any payment for or reimbursement to such person for his actual travel, lodging, or subsistence  
2138 expenses incurred in connection with such appearance, speech, or article or in the alternative a payment  
2139 of money or anything of value not in excess of the per diem deduction allowable under § 162 of the  
2140 Internal Revenue Code, as amended from time to time;

2141 9. Accept appointment to serve on a body or board of any corporation, company or other legal  
2142 entity, vested with the management of the corporation, company or entity, and on which two other  
2143 members of the General Assembly already serve, which is operated for profit and regulated by the State  
2144 Corporation Commission as (i) a financial institution, (ii) a mortgage lender or broker, (iii) any business  
2145 under Chapter 5 (§ 13.1-501 et seq.) of Title 13.1, (iv) any business under Title 38.2, or (v) any  
2146 business under Title 56;

2147 10. Accept a gift from a person who has interests that may be substantially affected by the  
2148 performance of the legislator's official duties under circumstances where the timing and nature of the gift  
2149 would cause a reasonable person to question the legislator's impartiality in the matter affecting the  
2150 donor. Violations of this subdivision shall not be subject to criminal law penalties; ~~or~~

2151 11. Accept gifts from sources on a basis so frequent as to raise an appearance of the use of his  
2152 public office for private gain. Violations of this subdivision shall not be subject to criminal law  
2153 penalties; *or*

2154 12. *Solicit, accept, or receive any gift of travel with a value exceeding \$100 from a third party prior*  
2155 *to submitting to the Council a request for a waiver to accept such gift of travel and receiving such a*  
2156 *waiver pursuant to § 30-356.2. Gifts of travel include transportation, lodging, meals, hospitality, and*  
2157 *any other travel-related thing of value.*

2158 **§ 30-103.1. Certain gifts prohibited.**

2159 A. For purposes of this section:

2160 "Intangible gift" means a thing of temporary value or a thing that upon the happening of a certain  
2161 event or expiration of a given date loses its value. "Intangible gift" includes entertainment, hospitality, a  
2162 ticket, admission, or pass, transportation, lodgings, and meals that are reportable on Schedule E of the

2164 "Tangible gift" means a thing of value that does not lose its value upon the happening of a certain  
2165 event or expiration of a given date. "Tangible gift" includes currency, negotiable instruments, securities,  
2166 stock options, or other financial instruments that are reportable on Schedule E of the disclosure form  
2167 prescribed in § 30-111. "Tangible gift" does not include payments or reimbursements received for any  
2168 intangible gift.

2169 B. A legislator or candidate for the General Assembly required to file the disclosure form prescribed  
2170 in § 30-111 (~~+~~) shall not solicit, accept, or receive within any calendar year any single tangible gift with  
2171 a value in excess of ~~\$250~~ \$100 or a *any* combination of tangible gifts with an aggregate value in excess

2172 of \$250 \$100 from any person that he knows or has reason to know is (a) a lobbyist registered pursuant  
 2173 to Article 3 (§ ~~2.2-418~~ et seq.) of Chapter 4 of Title 2.2; (b) a lobbyist's principal as defined in  
 2174 § 2.2-419; or (c) a person, organization, or business who is a party to or is seeking to become a party to  
 2175 a contract with the Commonwealth; (ii) shall report any tangible gift with a value of \$250 or less or any  
 2176 intangible gift received from any person listed in clause (i) on Schedule E of such disclosure form; and  
 2177 (iii) shall report any payments for talks, meetings, and publications on Schedule D-1 of such disclosure  
 2178 form. For purposes of this subsection, "person, organization, or business" includes individuals who are  
 2179 officers, directors, or owners of or who have a controlling ownership interest in such organization or  
 2180 business. Gifts received from business associates, relatives, or in conjunction with a personal celebration  
 2181 are not subject to this prohibition or the disclosure requirements of § 30-111. Gifts with a value of less  
 2182 than \$20 are not subject to aggregation for purposes of this prohibition.

2183 B. Notwithstanding the provisions of subsection A, a legislator or candidate for the General  
 2184 Assembly required to file the disclosure form prescribed in § 30-111 may accept or receive a gift or a  
 2185 combination of gifts with a value in excess of \$100 when such gift is accepted or received while in  
 2186 attendance at a widely attended event. A widely attended event is an event for which there is a  
 2187 reasonable expectation that at least 25 persons will attend the event and the event has a civic or  
 2188 regional interest or is open to individuals from a particular industry or profession or who represent  
 2189 persons interested in a particular issue.

2190 C. The \$250 limitation imposed in accordance with this section shall be adjusted by the Council  
 2191 every five years, as of January 1 of that year, in an amount equal to the annual increases for that  
 2192 five-year period in the United States Average Consumer Price Index for all items, all urban consumers  
 2193 (CPI-U), as published by the Bureau of Labor Statistics of the U.S. Department of Labor, rounded to the  
 2194 nearest whole dollar Food and beverages received at or registration or attendance fees waived for any  
 2195 event at which the legislator or candidate is a featured speaker, presenter, or lecturer shall not be  
 2196 subject to the provisions of subsection A.

2197 D. Notwithstanding the provisions of subsection A, a legislator or candidate for the General  
 2198 Assembly required to file the disclosure form prescribed in § 30-111 may accept or receive certain gifts  
 2199 with a value in excess of \$100 when he has submitted a request for a waiver to and has received the  
 2200 approval of the Council pursuant to § 30-356.2. A legislator or candidate for the General Assembly may  
 2201 request a waiver for the following gifts:

2202 1. A gift or combination of gifts from a personal friend. In making its determination to grant the  
 2203 waiver, the Council shall consider the nature and length of the friendship.

2204 2. Transportation, lodging, hospitality, or other travel-related thing of value that is provided by a  
 2205 third party and is directly related to the official duties of the legislator. In making its determination to  
 2206 grant the waiver, the Council shall consider the purpose of the trip as it relates to the legislator's public  
 2207 duties and responsibilities.

2208 E. Any gift received by a legislator subject to the provisions of this section (i) from a foreign  
 2209 dignitary, (ii) with a value exceeding \$100, and (iii) for which the fair market value or a gift of greater  
 2210 or equal value has not been provided or exchanged, shall be accepted on behalf of the Commonwealth  
 2211 and archived in accordance with guidelines established by the Library of Virginia. Such gift shall be  
 2212 disclosed as having been accepted on behalf of the Commonwealth but the value of such gift shall not  
 2213 be required to be disclosed

2214 F. For purposes of this section, "candidate" means a person who seeks or campaigns for election to  
 2215 the General Assembly in a general, primary, or special election and who is qualified to have his name  
 2216 placed on the ballot for the office. The candidate shall become subject to the provisions of this section  
 2217 upon the filing of a statement of organization pursuant to § 24.2-947.1. The State Board of Elections  
 2218 shall notify each such candidate of the provisions of this section.

#### 2219 § 30-110. Disclosure.

2220 A. Every legislator and legislator-elect shall file, as a condition to assuming office, a disclosure  
 2221 statement of his personal interests and such other information as is specified on the form set forth in  
 2222 § 30-111 and thereafter shall file such a statement semiannually by December 15 for the preceding  
 2223 six-month period complete through the last day of October and by June 15 for the preceding six-month  
 2224 period complete through the last day of April. When the filing deadline falls on a Saturday, Sunday, or  
 2225 legal holiday, the disclosure statement shall be filed on the next day that is not a Saturday, Sunday, or  
 2226 legal holiday. Disclosure forms shall be provided made available by the Virginia Conflict of Interest and  
 2227 Ethics Advisory Council at least 30 days prior to the filing deadline. Members of the Senate and  
 2228 members of the House of Delegates shall file their disclosure forms with the Virginia Conflict of  
 2229 Interest and Ethics Advisory Council. The Disclosure statements shall be filed electronically with the  
 2230 Council in accordance with the standards approved by it pursuant to § 30-356. All disclosure forms of  
 2231 the members of the General Assembly shall be maintained as public records for five years in the office  
 2232 of the Virginia Conflict of Interest and Ethics Advisory Council.

2233 B. Candidates for the General Assembly shall file a disclosure statement of their personal interests as  
2234 required by §§ 24.2-500 through 24.2-503.

2235 C. Any legislator who has a personal interest in any transaction pending before the General  
2236 Assembly and who is disqualified from participating in that transaction pursuant to § 30-108 and the  
2237 rules of his house shall disclose his interest in accordance with the applicable rule of his house.

2238 **§ 30-111. Disclosure form; penalty.**

2239 A. The disclosure form to be used for filings required by subsections A and B of § 30-110 shall be  
2240 substantially as follows: *on a form prescribed by the Council. All completed forms shall be filed*  
2241 *electronically and in accordance with the standards approved by the Council pursuant to § 30-356. A*  
2242 *person required to file this disclosure form who does so knowing it to contain a material misstatement*  
2243 *of fact is guilty of a Class 6 felony.*

2264 having monetary value. It includes services as well as gifts of transportation, lodgings and meals,  
2265 whether provided in-kind, by purchase of a ticket, payment in advance or reimbursement after the  
2266 expense has been incurred. "Gift" does not include (i) any offer of a ticket, coupon, or other admission  
2267 or pass unless the ticket, coupon, admission, or pass is used; (ii) honorary degrees; (iii) any athletic,  
2268 merit, or need-based scholarship or any other financial aid awarded by a public or private school,  
2269 institution of higher education, or other educational program pursuant to such school, institution, or  
2270 program's financial aid standards and procedures applicable to the general public; (iv) a campaign  
2271 contribution properly received and reported pursuant to Chapter 9.3 (§ 24.2-945 et seq.) of Title 24.2;  
2272 (v) any gift related to the private profession or occupation of a legislator or of a member of his  
2273 immediate family; or (vi) gifts from relatives or personal friends. "Relative" means the donee's spouse,  
2274 child, uncle, aunt, niece, or nephew; a person to whom the donee is engaged to be married; the donee's  
2275 or his spouse's parent, grandparent, grandchild, brother, or sister; or the donee's brother's or sister's  
2276 spouse. "Personal friend" does not include any person that the filer knows or has reason to know is (a) a  
2277 lobbyist registered pursuant to Article 3 (§ 2.2-418 et seq.) of Chapter 4 of Title 2.2; (b) a lobbyist's  
2278 principal as defined in § 2.2-419; or (c) a person, organization, or business who is a party to or is  
2279 seeking to become a party to a contract with the Commonwealth. "Person, organization, or business"  
2280 includes individuals who are officers, directors, or owners of or who have a controlling ownership  
2281 interest in such organization or business.

2282 "Immediate family" means (i) a spouse and (ii) any child who resides in the same household as the  
2283 legislator and who is a dependent of the legislator.

2284 "Lobbyist relationship" means (i) an engagement, agreement, or representation that relates to legal  
2285 services, consulting services, or public relations services, whether gratuitous or for compensation,  
2286 between a member or member-elect and any person who is, or has been within the prior calendar year,  
2287 registered as a lobbyist with the Secretary of the Commonwealth or (ii) a greater than three percent  
2288 ownership interest by a member or member-elect in a business that employs, or engages as an  
2289 independent contractor, any person who is, or has been within the prior calendar year, registered as a  
2290 lobbyist with the Secretary of the Commonwealth. The disclosure of a lobbyist relationship shall not (a)  
2291 constitute a waiver of any attorney-client or other privilege, (b) require a waiver of any attorney-client  
2292 or other privilege for a third party, or (c) be required where a member or member-elect is employed or  
2293 engaged by a person and such person also employs or engages a person in a lobbyist relationship so

- 2294 long as the member or member-elect has no financial interest in the lobbyist relationship.
- 2295 TRUST. If you or your immediate family, separately or together, are the only beneficiaries of a trust,
- 2296 treat the trust's assets as if you own them directly. If you or your immediate family has a proportional
- 2297 interest in a trust, treat that proportion of the trust's assets as if you own them directly. For example, if

 2869 conduct established pursuant to § 30-120, an opinion of the Attorney General as provided in § 30-122,  
 2870 or a formal opinion of the Virginia Conflict of Interest and Ethics Advisory Council established pursuant  
 2871 to § 30-355 30-356.1, and the opinion was made after his full disclosure of the facts.

2872 **§ 30-126. Civil penalty from violation of this chapter.**

2873 A. In addition to any other fine or penalty provided by law, any money or other thing of value  
 2874 derived by a legislator from a violation of §§ 30-103 through 30-108 shall be forfeited and, in the event  
 2875 of a knowing violation, there may also be imposed a civil penalty in an amount equal to the amount of  
 2876 money or thing of value forfeited to the Commonwealth. If the thing of value received by the legislator  
 2877 in violation of this chapter should enhance in value between the time of the violation and the time of  
 2878 discovery of the violation, the greater value shall determine the amount of the civil penalty.

2879 B. A legislator who fails to file the disclosure form required by § 30-111 within the time period

 2906 Committee on Rules, ~~one~~ *two* of whom shall be a ~~member~~ *members* of the Senate; ~~and one of whom~~  
 2907 ~~shall be a former member of the Senate, and two of whom shall be nonlegislative citizen members~~  
 2908 ~~retired judge; and four~~ *three* members appointed by the Governor, ~~two~~ of whom shall be executive  
 2909 branch employees and ~~two~~ of whom shall be nonlegislative citizen members ~~one of whom shall be a~~  
 2910 ~~retired judge, one of whom shall be appointed from a list of nominees submitted by the Virginia~~  
 2911 ~~Association of Counties, and one of whom shall be appointed from a list of nominees submitted by the~~  
 2912 ~~Virginia Municipal League; one~~ member designated by the Attorney General; ~~one~~ member appointed by  
 2913 the Senate Committee on Rules from a list of three nominees submitted by the Virginia Association of  
 2914 Counties; and one member appointed by the Speaker of the House of Delegates from a list of three  
 2915 nominees submitted by the Virginia Municipal League. *In the appointment to the Council of members of*  
 2916 *House of Delegates made by the Speaker and members of the Senate made by the Senate Committee on*  
 2917 *Rules, equal representation shall be given to each of the political parties having the highest and next*  
 2918 *highest number of members elected to the respective body. All members of the Council are subject to*  
 2919 *confirmation by the General Assembly by a majority vote in each house of (i) the members present of*  
 2920 *the majority party and (ii) the members present of the minority party. No member of the Council may be*  
 2921 *removed from his term except for cause.*

2922 C. All appointments following the initial staggering of terms shall be for terms of four years, except  
 2923 that appointments to fill vacancies shall be for the unexpired terms in the same manner as the original  
 2924 appointment. No nonlegislative citizen member shall be eligible to serve for more than two successive  
 2925 four-year terms. However, after the expiration of a term of three years or less, or after the expiration of  
 2926 the remainder of a term to which appointed to fill a vacancy, two additional terms may be served by  
 2927 such member if appointed thereto. Legislative members and other state government officials shall serve  
 2928 terms coincident with their terms of office. Legislative members may be reappointed for successive  
 2929 terms.

2930 D. The members of the Council shall elect from among their membership a chairman and a  
 2931 vice-chairman for two-year terms. The chairman and vice-chairman may not succeed themselves to the  
 2932 same position. The Council shall hold meetings quarterly or upon the call of the chairman. A majority  
 2933 of the Council *appointed* shall constitute a quorum.

2991 *A. Upon the request of any person subject to the requirements of Article 3 or the Acts, the Council*  
 2992 *shall furnish informal advice or formal advisory opinions or guidance with respect to ethics, conflicts*  
 2993 *issues, or such person's duties under Article 3 or the Acts. The Council may authorize a designee to*  
 2994 *furnish informal advice or formal advisory opinions or guidance.*

2995 *B. Formal advisory opinions are public record and shall be published on the Council's website.*  
 2996 *Published formal advisory opinions may have such deletions and changes as may be necessary to*  
 2997 *protect the identity of the person involved. The informal advice given by the Council or the Council's*  
 2998 *designee is confidential, protected by the attorney-client privilege, and excluded from the provisions of*

3004 **§ 30-356.2. Waivers for travel and certain prohibited gifts.**

3005 *A. The Council shall receive, review, and approve or deny requests for waivers submitted by persons*  
 3006 *required to file the disclosure form prescribed in § 2.2-3117 or 30-111 to accept any gift of travel,*  
 3007 *including transportation, lodging, meal, hospitality, or other travel-related thing of value, provided by a*  
 3008 *third party that has a value exceeding \$100. A waiver shall not be required for acceptance of travel*  
 3009 *paid for or provided by the government of the United States, any of its territories, or another state in*

3010 *the United States or the political subdivision of such other state. The Council shall approve a waiver for*  
 3011 *transportation if the transportation is provided to facilitate attendance by the legislator at a regular or*  
 3012 *special session of the General Assembly, a meeting of a legislative committee or commission, or a*

3017 *C. The Council may authorize a designee to review and approve or deny requests for waivers*  
 3018 *pursuant to this section. Unless the circumstances giving rise to the request for waiver make it*  
 3019 *necessary that approval or denial be completed sooner, the Council shall approve or deny a waiver*  
 3020 *within seven days of receipt of a request for a waiver. The Council may request additional information*  
 3021 *if necessary and if such information has been requested, the Council shall approve or deny the waiver*  
 3022 *within seven days of receipt of such information. When reviewing the request for a waiver, the Council*

3074 *Rules, shall employ an executive director. The executive director shall be responsible for the*

3077 **2. That the provisions of this act requiring the Virginia Conflict of Interest and Ethics Advisory**

3086 **be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter**  
3087 **2 of the Acts of Assembly of 2014, Special Session I, requires the Virginia Criminal Sentencing**  
3088 **Commission to assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4, the estimated**  
3089 **amount of the necessary appropriation cannot be determined for periods of commitment to the**  
3090 **custody of the Department of Juvenile Justice.**
