9 10	Be it enacted by the General Assembly of Virginia:
11	1. That § 33.2-1400 of the Code of Virginia is amended and reenacted as follows:
12	§ 33.2-1400. Virginia-North Carolina Interstate High-Speed Rail Compact.
13	§ 1. Short title.
14	This act shall be known and may be cited as the Virginia-North Carolina Interstate High-Speed Rail
15	Compact.
16	§ 2. Compact established.
17	Pursuant to the invitation in 49 U.S.C. § 24101 Interstate Compacts, in which the United States
18	Congress grants consent to states with an interest in a specific form, route, or corridor of intercity
19	passenger rail service (including high-speed rail service) to enter into interstate compacts, there is hereby
20	established the Virginia-North Carolina Interstate High-Speed Rail Compact.
21	§ 3. Agreement.
22 23	The Commonwealth of Virginia and the State of North Carolina agree, upon adoption of this compact:
23 24	1. To study, develop, and promote a plan for the design, construction, financing, and operation of
25	interstate high-speed rail service through and between points in the Commonwealth of Virginia and the
26	State of North Carolina and adjacent states;
27	2. To coordinate efforts to establish high-speed rail service at the federal, state, and local
28	governmental levels;
29	3. To advocate for federal funding to support the establishment of high-speed interstate rail service
30	within and through Virginia and North Carolina and to receive federal funds made available for rail
31 32	development; and 4. To provide funding and resources to the Virginia North Caroline High Speed Bail Compact
32 33	4. To provide funding and resources to the Virginia-North Carolina High-Speed Rail Compact Commission from funds that are or may become available and are appropriated for that purpose.
33 34	§ 4. Commission established; appointment and terms of members; chairman; reports; Commission
35	funds; staff.
36	The Virginia-North Carolina High-Speed Rail Compact Commission is hereby established as a
37	regional instrumentality and a common agency of each signatory party, empowered in a manner
38	hereinafter set forth to carry out the purposes of the Compact.
39	The Virginia members of the Commission shall be appointed as follows: three members of the House
40	of Delegates appointed by the Speaker of the House of Delegates, and two members of the Senate
41 42	appointed by the Senate Committee on Rules. The North Carolina members of the Commission shall be composed of five members as follows: two members of the Senate appointed by the General Assembly
43	upon recommendation of the President Pro Tempore of the Senate, two members of the House of
44	Representatives appointed by the General Assembly upon recommendation of the Speaker of the House
45	of Representatives, and one appointed by the Governor.
<b>46</b>	The chairman of A Co-Chairman to the Commission shall be chosen by the Virginia members of the
47	Commission from among its Virginia membership for a term of one year, and shall alternate between
48	the member states.
49 50	A Co-Chairman to the Commission shall be chosen by the North Carolina members of the
50 51	Commission from among its North Caroline membership for a term of one year. The Commission shall meet at least twice each year, at least once in Virginia and once in North
51 52	Carolina, and shall issue a report of its activities each year.
53	The Commission may utilize, for its operation and expenses, funds appropriated to it therefor by the
54	legislatures of Virginia and North Carolina or received from federal sources.
55	Virginia members of the Commission shall receive compensation and reimbursement for the
56	necessary and actual expenses as provided in the general appropriations act; North Carolina members of
57	the Commission shall receive per diem, subsistence and travel allowances in accordance with applicable
58	statutes of North Carolina, as appropriate.
