2 An Act to amend and reenact §§ 2.2-1604 and 2.2-4310 of the Code of Virginia, relating to the 3 Department of Small Business and Supplier Diversity; definition of small business.

### 6 Be it enacted by the General Assembly of Virginia: 7

### 1. That §§ 2.2-1604 and 2.2-4310 of the Code of Virginia are amended and reenacted as follows: 8 § 2.2-1604. Definitions.

As used in this chapter, unless the context requires a different meaning:

10 "Certification" means the process by which a business is determined to be a small, women-owned, or minority-owned business for the purpose of reporting small, women-owned, and minority-owned 11 business participation in state contracts and purchases pursuant to §§ 2.2-1608 and 2.2-1610. "Department" means the Department of Small Business and Supplier Diversity or any division of the 12

13 14 Department to which the Director has delegated or assigned duties and responsibilities.

"Employment services organization" means an organization that provides community-based 15 employment services to individuals with disabilities that is an approved Commission on Accreditation of 16 17 Rehabilitation Facilities (CARF) accredited vendor of the Department for Aging and Rehabilitative 18 Services.

19 "Minority individual" means an individual who is a citizen of the United States or a legal resident 20 alien and who satisfies one or more of the following definitions:

21 1. "African American" means a person having origins in any of the original peoples of Africa and who is regarded as such by the community of which this person claims to be a part. 22

23 2. "Asian American" means a person having origins in any of the original peoples of the Far East, 24 Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China, 25 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of 26 the Pacific, India, Pakistan, Bangladesh, or Sri Lanka, and who is regarded as such by the community of 27 which this person claims to be a part.

28 3. "Hispanic American" means a person having origins in any of the Spanish-speaking peoples of 29 Mexico, South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and 30 who is regarded as such by the community of which this person claims to be a part.

31 4. "Native American" means a person having origins in any of the original peoples of North America 32 and who is regarded as such by the community of which this person claims to be a part or who is 33 recognized by a tribal organization.

"Minority-owned business" means a business that is at least 51 percent owned by one or more minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 34 35 partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 36 interest in the corporation, partnership, or limited liability company or other entity is owned by one or more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 37 38 39 daily business operations are controlled by one or more minority individuals.

40 "Small business" means a business that is at least 51 percent independently owned and controlled by 41 one or more individuals who are U.S. citizens or legal resident aliens and, that together with affiliates, 42 has 250 or fewer employees or average annual gross receipts of \$10 million or less averaged over the 43 previous three years meets the small business size standards established by the regulations of the United 44 States Small Business Administration. One or more of the individual owners shall control both the 45 management and daily business operations of the small business.

"State agency" means any authority, board, department, instrumentality, institution, agency, or other 46 unit of state government. "State agency" does not include any county, city, or town. 47

"Women-owned business" means a business that is at least 51 percent owned by one or more women **48** 49 who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited 50 liability company or other entity, at least 51 percent of the equity ownership interest is owned by one or more women who are U.S. citizens or legal resident aliens, and both the management and daily business 51 52 operations are controlled by one or more women.

#### 53 § 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, 54 and service disabled veteran-owned business.

55 A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or 56 offeror because of race, religion, color, sex, national origin, age, disability, status as a service disabled

veteran, or any other basis prohibited by state law relating to discrimination in employment. Whenever 57 58 solicitations are made, each public body shall include businesses selected from a list made available by 59 the Department of Small Business and Supplier Diversity.

60 B. All public bodies shall establish programs consistent with this chapter to facilitate the participation 61 of small businesses and businesses owned by women, minorities, and service disabled veterans in 62 procurement transactions. The programs established shall be in writing and shall comply with the provisions of any enhancement or remedial measures authorized by the Governor pursuant to subsection 63 64 C or, where applicable, by the chief executive of a local governing body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. State agencies shall submit annual 65 66 progress reports on small, women-owned, and minority-owned business procurement and on service 67 disabled veteran-owned business procurement to the Department of Small Business and Supplier Diversity in a form specified by the Department of Small Business and Supplier Diversity. The 68 Department of Small Business and Supplier Diversity shall make information on service disabled 69 veteran-owned procurement available to the Department of Veterans Services upon request. 70

C. Whenever there exists (i) a rational basis for small business enhancement or (ii) a persuasive 71 72 analysis that documents a statistically significant disparity between the availability and utilization of 73 women-owned and minority-owned businesses, the Governor is authorized and encouraged to require 74 state agencies to implement appropriate enhancement or remedial measures consistent with prevailing 75 law.

76 D. In the solicitation or awarding of contracts, no state agency, department or institution shall 77 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the 78 state agency, department or institution has made a written determination that employing ex-offenders on 79 the specific contract is not in its best interest. 80

E. As used in this section:

"Minority individual" means an individual who is a citizen of the United States or a legal resident 81 82 alien and who satisfies one or more of the following definitions:

83 1. "African American" means a person having origins in any of the original peoples of Africa and 84 who is regarded as such by the community of which this person claims to be a part.

85 2. 96 "Minority-owned business" means a business that is at least 51 percent owned by one or more 97 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 98 partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 99 interest in the corporation, partnership, or limited liability company or other entity is owned by one or more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 100 daily business operations are controlled by one or more minority individuals. 101

102 "Service disabled veteran" means a veteran who (i) served on active duty in the United States 103 military ground, naval, or air service, (ii) was discharged or released under conditions other than 104 dishonorable, and (iii) has a service-connected disability rating fixed by the United States Department of 105 Veterans Affairs.

106 "Service disabled veteran business" means a business that is at least 51 percent owned by one or 107 more service disabled veterans or, in the case of a corporation, partnership, or limited liability company 108 or other entity, at least 51 percent of the equity ownership interest in the corporation, partnership, or 109 limited liability company or other entity is owned by one or more individuals who are service disabled 110 veterans and both the management and daily business operations are controlled by one or more individuals who are service disabled veterans. 111

"Small business" means a business, independently owned and controlled by one or more individuals 112 who are U.S. citizens or legal resident aliens, and together with affiliates, has 250 or fewer employees, 113 114 or annual gross receipts of \$10 million or less averaged over the previous three years meets the small business size standards established by the regulations of the United States Small Business 115 Administration. One or more of the individual owners shall control both the management and daily 116 business operations of the small business. 117

- 127 3. That the Secretary of Commerce and Trade shall convene a workgroup of interested
- 128 stakeholders to examine the definition of small business in §§ 2.2-1604 and 2.2-4310 of the Code of 129 Virginia and report its findings and recommendations to the Governor and General Assembly on
- 129 Virginia and report its findings and recommendation or before December 1, 2015.
