That § 33.2-319 of the Code of Virginia is amended and reenacted as follows: 11 12 § 33.2-319. Payments to cities and certain towns for maintenance of certain highways. 13 The Commissioner of Highways, subject to the approval of the Board, shall make payments for 14 maintenance, construction, or reconstruction of highways to all cities and towns eligible for allocation of construction funds for urban highways under § 33.2-362. Such payments, however, shall only be made if 15 16 those highways functionally classified as principal and minor arterial roads are maintained to a standard satisfactory to the Department. Whenever any city or town qualifies under this section for allocation of 17 18 funds, such qualification shall continue to apply to such city or town regardless of any subsequent 19 change in population and shall cease to apply only when so specifically provided by an act of the General Assembly. All allocations made prior to July 1, 2001, to cities and towns meeting the criteria of 20 21 the foregoing provisions of this section are hereby confirmed. No payments shall be made to any such city or town unless the portion of the highway for which 22 23 such payment is made either (i) has (a) an unrestricted right-of-way at least 50 feet wide and (b) a hard-surface width of at least 30 feet; (ii) has (a) an unrestricted right-of-way at least 80 feet wide, (b) a 24 25 hard-surface width of at least 24 feet, and (c) approved engineering plans for the ultimate construction of an additional hard-surface width of at least 24 feet within the same right-of-way; (iii)(a) is a 26 27 cul-de-sac, (b) has an unrestricted right-of-way at least 40 feet wide, and (c) has a turnaround that meets 28 applicable standards set by the Department; (iv) either (a) has been paved and has constituted part of the 29 primary or secondary state highway system prior to annexation or incorporation or (b) has constituted 30 part of the secondary state highway system prior to annexation or incorporation and is paved to a 31 minimum width of 16 feet subsequent to such annexation or incorporation and with the further exception 32 of streets or portions thereof that have previously been maintained under the provisions of § 33.2-339 33 or 33.2-340; (v) was eligible for and receiving such payments under the laws of the Commonwealth in 34 effect on June 30, 1985; (vi) is a street established prior to July 1, 1950, that has an unrestricted 35 right-of-way width of not less than 30 feet and a hard-surface width of not less than 16 feet; (vii) is a 36 street functionally classified as a local street that was constructed on or after January 1, 1996, and that 37 at the time of approval by the city or town met the criteria for pavement width and right-of-way of the 38 then-current design standards for subdivision streets as set forth in regulations adopted by the Board; 39 (viii) is a street previously eligible to receive street payments that is located in the City of Norfolk or 40 the City of Richmond and is closed to public travel, pursuant to legislation enacted by the governing 41 body of the locality in which it is located, for public safety reasons, within the boundaries of a publicly funded housing development owned and operated by the local housing authority; or (ix) is a local street, 42 otherwise eligible, containing one or more physical protuberances placed within the right-of-way for the 43 44 purpose of controlling the speed of traffic. 45

45 However, the Commissioner of Highways may waive the requirements as to hard-surface pavement 46 or right-of-way width for highways where the width modification is at the request of the governing body 47 of the locality and is to protect the quality of the affected locality's drinking water supply or, for 48 highways constructed on or after July 1, 1994, to accommodate some other special circumstance where 49 such action would not compromise the health, safety, or welfare of the public. The modification is 50 subject to such conditions as the Commissioner of Highways may prescribe.

For the purpose of calculating allocations and making payments under this section, the Department 51 52 shall divide affected highways into two categories, which shall be distinct from but based on functional 53 classifications established by the Federal Highway Administration: (1) principal and minor arterial roads and (2) collector roads and local streets. Payments made to affected localities shall be based on the 54 55 number of moving-lane-miles of highways or portions thereof available to peak-hour traffic in that locality. Those portions of any trail that lie within the boundaries of a city, if the trail (i) was 56 constructed primarily by the Department, (ii) is paved throughout its entire length to accommodate all 57 58 modes of nonmotorized transportation, and (iii) ranges in paved width between eight and 10 feet, shall

be eligible for payments under this section. Such payments shall be at the rate of 50 percent of the 59 60 per-miles rate established for collector roads and local streets.

61 The Department shall recommend to the Board an annual rate per category to be computed using the 62 base rate of growth planned for the Department's Highway Maintenance and Operations program. The

63 Board shall establish the annual rates of such payments as part of its allocation for such purpose, and 64 the Department shall use those rates to calculate and put into effect annual changes in each qualifying 65 city's or town's payment under this section.

The payments by the Department shall be paid in equal sums in each quarter of the fiscal year, and 66

payments shall not exceed the allocation of the Board. 67

68 The chief administrative officer of the city or town receiving this fund shall make annual categorical reports of expenditures to the Department, in such form as the Board shall prescribe, accounting for all

expenditures, certifying that none of the money received has been expended for other than maintenance, construction, or reconstruction of the streets, and reporting on their performance as specified in 71

subsection B of § 33.2-352. Such reports shall be included in the scope of the annual audit of each 72

73 municipality conducted by independent certified public accountants.
