- **3.** Committee: Passed the Senate.
- **4. Title:** Renewal of waterfowl blind licenses.
- 5. Summary: This bill provides that, until such time as new waterfowl blinds are permitted to be licensed in Virginia Beach, licenses for blinds in Virginia Beach that have expired in 2014 and thereafter may be renewed by the license holder up to one year after such license expired. The bill requires that the licensee pay a late fee of \$75 for each license renewed. Lastly, the bill states that blinds in Virginia Beach shall not be required to be removed upon initial expiration of the license if the licensee notifies the Department of Game and Inland Fisheries of his intention to renew the license.

**8.** Fiscal Implications: It is anticipated that this bill will result in minimal fiscal impact to the Department of Game and Inland Fisheries (DGIF). According to the department, the changes

to the statute will require revisions to regulation booklets and other materials. These updated materials will then need to printed and shipped to the affected audience. DGIF estimates the costs associated with this work to be approximately \$7,500 in the first year. These costs can be absorbed within current resources.

Current regulation prohibits new blinds in Virginia Beach. In 2014, 265 waterfowl blind licenses were held in Virginia Beach. Out of this amount, 15 blinds expired with no renewal. Therefore, the number of licenses for this locality will remain at 265 or decrease because of expired licenses with no renewal. If there continues to be about five percent of lapsed licenses in this area, the department may receive \$1,125 in revenue each year as the bill provides for a \$75 late fee.
