7 **Be it enacted by the General Assembly of Virginia:**8 **1. That §§ 1.2 and 3.6, as amended, of Chapter 646 of the Acts of Assembly of 1968 are amended**
9 **and reenacted as follows:**

10 § 1.2. Boundaries.

11 The territory embraced within the Town of Herndon is that territory in the County of Fairfax,
12 Virginia, established in chapter 376 of the Acts of Assembly of 1938, as amended by order entered in a
13 voluntary boundary line adjustment case by the Circuit Court of Fairfax County, Virginia, on December
14 20, 1988, in "Board of Supervisors of Fairfax County and Town Council of Herndon," Law 85815,
15 recorded in the Clerk's Office of the Circuit Court of Fairfax County, Virginia, on November 6, 1997, as
16 instrument number 97-151937, Deed Book 10166, Page 1311, *and as further amended by order entered*
17 *affirming a voluntary settlement agreement in a boundary line adjustment case by the Special Court*
18 *sitting in the Circuit Court of Loudoun County, Virginia, on August 21, 2015, in "Town of Herndon,*
19 *Virginia and the County of Loudoun, Virginia," recorded in the Clerk's Office of the Circuit Court of*
20 *Loudoun County, Virginia, on October 7, 2015, as instrument number 20151007-0067932.*

21 § 3.6. Powers and duties of mayor.

22 The mayor shall be the chief executive officer of the town. He shall have and exercise all power and
23 authority conferred by general law not inconsistent with this charter. He shall preside over the meetings
24 of the town council and shall have the same right to speak and vote therein as members of the town
25 council. He shall be recognized as the head of the town government for all ceremonial and military
26 purposes. He shall perform such other duties consistent with his office as may be imposed by the
27 council. He shall see that the duties of the various town officers are faithfully performed. ~~In times of~~
28 ~~public danger, or emergencies, he may take command of the police and maintain order and enforce laws,~~
29 ~~and for this purpose, may deputize such assistant policemen as may be necessary.~~ He, or the person
30 acting as mayor, may sign and deliver such documents or instruments as the council, this charter, or the
31 laws of the Commonwealth shall require or authorize.
