o 9	Be it enacted by the General Assembly of Virginia:
	1. That § 13.1-514 of the Code of Virginia is amended and reenacted as follows:
11	§ 13.1-514. Exemptions.
12	A. The following securities are exempted from the securities registration requirements of this chapter:
13	1. Any security (including a revenue obligation) issued or guaranteed by the United States, any state,
	any political subdivision of a state or any agency or corporate or other instrumentality of one or more of
	the foregoing; or any certificate of deposit for any of the foregoing;
16	2. Any security issued or guaranteed by Canada, any Canadian province, any political subdivision of
	any such province, any agency or corporate or other instrumentality of one or more of the foregoing or
	any other foreign government with which the United States currently maintains diplomatic relations, if
	the security is recognized as a valid obligation by such issuer or guarantor;

secured thereby is offered and sold as a unit;

69 6. Any offer or sale to a corporation, investment company or pension or profit-sharing trust or to a broker-dealer;

73 security holders, and if its securities have not been offered to the general public by advertisement or

The 80 Commission may, by rule or order, as to any security or transaction or any type of security or 81 transaction, withdraw or further condition this exemption, increase or decrease the number of purchasers 82 83 permitted, or waive the condition relating to their investment intent. The Commission may assess and collect in connection with any filing pursuant to this exemption a nonrefundable fee not to exceed \$250. 84

85 With respect to this subdivision 7, and except to the extent the Commission by rule or order may otherwise permit, the number of security holders of an issuer or the number of purchasers from an 86 87 issuer, as the case may be, shall not be deemed to include the security holders of any other corporation, 88 partnership, limited liability company, unincorporated association or trust unless it was organized to raise 89 capital for the issuer. Notwithstanding the provisions of subdivision 15, the merger or consolidation of 90 corporations, partnerships, limited liability companies, unincorporated associations or other entities shall 91 be a violation of this chapter if the surviving or new entity has more than 35 security holders or 92 purchasers and all the securities of the parties thereto were issued under this exemption, unless all of the 93 parties thereto have been engaged in transacting business for more than two years prior to the merger or 94 consolidation:

8. Any transaction pursuant to an offer to existing security holders of the issuer including holders of transferable warrants issued to existing security holders and exercisable within 90 days of their issuance, if either (i) no commission or other remuneration (other than a standby commission) is paid or given directly or indirectly for soliciting any security holder in this Commonwealth or (ii) the issuer first notifies the Commission in writing of the terms of the offer and the Commission does not by order disallow the exemption within five full business days after the date of the receipt of the notice;

9. Any offer (but not a sale) of a security for which registration statements have been filed, but are not effective, under both this chapter and the Securities Act of 1933; but this exemption shall not apply while a stop order is in effect or, after notice to the issuer, while a proceeding or examination looking toward such an order is pending under either act;

105 10. The issuance of not more than three shares of common stock to one or more of the incorporators 106 of a corporation and the initial transfer thereof;

107 11. Sales of an issue of bonds, aggregating \$150,000 or less, secured by a first lien deed of trust on
 108 realty situated in Virginia, to 30 persons or less who are residents of Virginia;

109 12. Any offer or sale of any interest in any partnership, corporation, association or other entity
110 created solely to provide residential housing located in the Commonwealth, provided that such offer or
111 sale is by the issuer or by a real estate broker or real estate agent duly licensed in Virginia;

13. The Commission is authorized to create by rule a limited offering exemption, the purpose of 112 113 which shall be to further the objectives of compatibility with similar exemptions from federal securities regulation and uniformity among the states; providing that such rule shall not exempt broker-dealers or 114 agents from the registration requirements of this chapter, except in the case of an agent of the issuer 115 who either (i) receives no sales commission directly or indirectly for offering or selling the securities or 116 (ii) effects transactions in a security exempt from registration under the Securities Act of 1933 pursuant 117 to rules and regulations promulgated under § 4(2) thereof. Any filing made with the Commission 118 119 pursuant to any exemption created under this subdivision shall be accompanied by a \$250 fee;

120 14. The issuance of any security dividend, whether the corporation distributing the dividend is the

121 issuer of the security or not, if nothing of value is given by stockholders for the distribution other than 122 the surrender of a right to a cash dividend where the stockholder can elect to take a dividend in cash or 123 in a security;

124 15. Any transaction incident to a right of conversion or a statutory or judicially approved 125 reclassification, recapitalization, reorganization, quasi-reorganization, stock split, reverse stock split, 126 merger, consolidation, sale of assets, or exchange of securities;

127 16. Any offer or sale of a security issued by a Virginia church if the offer and sale are only to its 128 members and the security is offered and sold only by its members who are Virginia residents and who 129 do not receive remuneration or compensation directly or indirectly for offering or selling the security;

130 17. Any offer or sale of securities issued by a professional business entity (as defined in subsection A of § 13.1-1102) to a person licensed or otherwise legally authorized to render within this 131 132 Commonwealth the same professional services (as defined in subsection A of § 13.1-1102) rendered by 133 the professional business entity. Notwithstanding the foregoing, nothing in this subdivision shall be 134 deemed to provide that shares of stock, partnership or membership interests or other representations of 135 ownership in a professional business entity are securities except to the extent otherwise provided by 136 subsection A of this section;

137 18. Any offer that is communicated on the Internet, World Wide Web or similar proprietary or 138 common carrier electronic system and that is in compliance with requirements prescribed by rule or 139 order of the Commission;

140 19. To the extent the Commission by rule or order permits, any offer or sale to an accredited 141 investor, as defined by the Commission, if the issuer reasonably believes before the sale that the 142 accredited investor, either alone or with the accredited investor's representative, has such knowledge and 143 experience in financial and business matters as to be capable of evaluating the merits and risks of the 144 prospective investment. The Commission may assess and collect in connection with any filing pursuant 145 to this exemption a nonrefundable fee not to exceed \$250;

- 146 20. Any transaction by a bank pursuant to an unsolicited offer or order to buy or sell any security, 147 provided such transaction is not effected by an employee of the bank who is also an employee of a 148 broker-dealer; and
- 149 21. (Expires July 1, 2020) To the extent the Commission by rule or order permits, any security 150 issued by an entity formed, organized, or existing under the laws of the Commonwealth, if:
- 151 a. The offering of the security is conducted in accordance with \S 3(a)(11) of the Securities Act of 152 1933 and Rule 147 adopted under the Securities Act of 1933;
- 153 b. The offer and sale of the security are made only to residents of Virginia;
- 154 c. The aggregate price of securities in an offering under this exemption does not exceed \$2 million, 155 which sum the Commission, by rule or order, may increase or decrease;

156 d. The total consideration paid by any purchaser of securities in an offering under this exemption 157 does not exceed \$10,000, unless the purchaser is an accredited investor as defined by Rule 501 of the 158 U.S. Securities and Exchange Commission's Regulation D (17 C.F.R. § 230.501). The Commission, by 159 rule or order, may increase or decrease such limit on the total consideration to be paid by any purchaser 160 of securities in an offering under this exemption;

- 161 e. No compensation is paid to employees, agents, or other persons for the solicitation of, or based on 162 the sale of, securities in connection with an offering of securities under this exemption to any person 163 who is not registered as a broker-dealer or agent, except to the extent permitted by rule or order of the 164 Commission;
- 165 f. Neither the issuer nor any person related to the issuer is subject to disgualification as established 166 by the Commission by rule or order; and
- 167 g. The security is sold in an offering conducted in compliance with any conditions established by 168 rule or order of the Commission, which may include:
- 169 (1) Restrictions on the nature of the issuer;
- 170 (2) Limitations on the number and manner of offerings;
- 171 (3) Disclosures required to be provided to investors, including disclosures of risk factors related to 172 the issuer and the offering;
- 173 (4) Requirements that all proceeds received from purchasers be placed in escrow in a depository 174 institution located in the Commonwealth until the minimum amount of the offering is raised; 175
 - (5) Filings with the Commission of notices and other materials related to the offering; and
- 176 (6) Requirements regarding the preparation and submission of the issuer's financial statements, 177 including (i) the form and content of such statements and (ii) whether such statements are required to be 178 audited or reviewed by an independent certified public accountant in accordance with generally accepted 179 accounting principles.
- 180 The Commission may assess and collect in connection with any filing pursuant to this exemption a 181 nonrefundable fee in an amount to be set by the Commission by rule or order, provided such amount

182 shall not exceed \$500; and

22. Any offer or sale of securities conducted in accordance with Tier 2 of federal Regulation A (17
CFR 230.251 to 230.263) promulgated under § 3(b)(2) of the Securities Act of 1933 (U.S. Securities and Exchange Commission Release No. 33-9741, 80 Fed. Reg. 21806) [to the extent such securities are preempted from the registration requirements of this chapter pursuant to Tier 2 of federal Regulation A
The Commission shall by rule or order prescribe any filings with the Commission of notices,
