That § 33.2-232 of the Code of Virginia is amended and reenacted as follows: § 33.2-232. Annual report by Commissioner of Highways. 10 The Commissioner of Highways shall annually report in writing to the Governor, the General 11 Assembly, the Joint Legislative Audit and Review Commission, and the Board no later than November 12 30 each year. The Commissioner shall make such report available on the Department's website. The 13 content of such report shall be specified by the Board and shall contain, at a minimum: 14 15 1. The condition of existing transportation assets, using asset management methodology pursuant to 16 § 33.2-352; 17 2. The methodology used to determine maintenance needs, including an explanation of the transparent methodology used for the allocation of funds from the Highway Maintenance and Operating 18 19 Fund pursuant to subsection A of § 33.2-352; 20 3. Beginning with the November 2015 report through the November 2019 report, the allocations to 21 the reconstruction and rehabilitation of functionally obsolete or structurally deficient bridges and to the 22 reconstruction of pavements determined to have a combined condition index of less than 60 and beginning with the November 2020 report, the methodology used to determine allocations of 23 24 construction funds for state of good repair purposes as defined in § 33.2-369 and any waiver of the cap 25 provided for in subsection B of § 33.2-369; 26 4. The performance targets and outcomes for (i) the current two-year period starting July 1 of 27 even-numbered years and (ii) the following two-year period starting July 1 of the next even-numbered 28 year. The targets and outcomes shall state what is expected to be achieved, based on funding identified 29 for maintenance and state of good repair purposes, over each two-year period; 30 5. Beginning with the November 2016 report, a listing of prioritized pavement and bridge needs based on the priority ranking system developed by the Board pursuant to § 33.2-369 and a description of 31 32 the priority ranking system; 33 6. The Department's (i) strategies for improving safety and security and (ii) strategies and activities 34 to improve highway operations within the Commonwealth, including the use of funds in the Innovation 35 and Technology Transportation Fund established pursuant to § 33.2-1531 and improved incident 36 management; and 37 7. A review of the Department's collaboration with the private sector in delivering services; and 38 8. Traffic modeling results for all federally funded projects requiring a multi-alternative National 39 Environmental Policy Act analysis.
