A *BILL to amend the Code of Virginia by adding in Article 2 of Chapter 3 of Title 24.2 a section numbered 24.2-304.04, relating to technical adjustments of certain House of Delegates district boundaries.*

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding in Article 2 of Chapter 3 of Title 24.2 a section numbered 24.2-304.04 as follows:

§ 24.2-304.04. House of Delegates districts.

Subject to the provisions of subsections A, B, and C of § 24.2-304.03, the following House of Delegates districts shall be comprised as follows:

Twenty-eighth. Part of Stafford County comprised of the Aquia (401), Brooke (403), Chatham (602), Courthouse (402), Drew (503), Falmouth (502), Ferry Farm (601), Gayle (504), Grafton (501), Griffis (301), Harbor (303), and White Oak (603) Precincts and part of the Hampton (703) Precinct; and part of the City of Fredericksburg comprised of the District 2 (201) and District 4-Precinct 2 (402) Precincts and parts of the District 3 (301) and District 4 (401) Precincts.

Eighty-eighth. Part of Fauquier County comprised of the Lois (104), Morrisville (301), and Remington (302) Precincts; part of Spotsylvania County comprised of the Brent's Mill (702), Elys Ford (201), Grange Hall (303), Hazel Run (302), Ni River (203), Plank Road (301), and Wilderness (202) Precincts; part of Stafford County comprised of the Hartwood (101), Ramoth (104), Rocky Run (102), and Simpson (103) Precincts and parts of the Hampton (703) and Whitson (702) Precincts; and part of the City of Fredericksburg comprised of the District 1 (101) Precinct and parts of the District 3 (301) and District 4 (401) Precincts.

All other House of Delegates districts shall be comprised as provided in § 24.2-304.03.

2. That the first enactment changes the assignment of certain census blocks to House of Delegates districts as follows:

In the City of Fredericksburg, blocks 516300003022000, 516300003022001, 516300003022011, 516300003022028, 516300003022029, 516300003022030, 516300003022031, 516300003022032, 516300003022033, 516300003022034, 516300003022035, 516300003022037, 516300003022038, and 516300003022039 are reassigned from District 88 to District 28 in order to place the entire current Precinct 401 in District 28.
