10 11	Be it enacted by the General Assembly of Virginia: 1. That § 2.2-2237 of the Code of Virginia is amended and reenacted as follows:
11	§ 2.2-2237. Powers of Authority.
12	The Authority is granted all powers necessary or convenient for the carrying out of its statutory
13	purposes, including, but not limited to, the power to:
15	1. Sue and be sued, implead and be impleaded, complain and defend in all courts;
16	2. Adopt, use, and alter at will a common seal;
17	3. Acquire, purchase, hold, use, lease or otherwise dispose of any property, real, personal or mixed,
18	tangible or intangible, or any interest therein necessary or desirable for carrying out the purposes of the
19	Authority, and to lease as lessee, any property, real, personal or mixed, tangible or intangible, or any
20	interest therein, at such annual rental and on such terms and conditions as may be determined by the
21	Board and to lease as lessor to any person, any property, real, personal or mixed, tangible or intangible,
22	or any interest therein, at any time acquired by the Authority, whether wholly or partially completed, at
23	such annual rental and on such terms and conditions as may be determined by the Board and to sell,
24	transfer or convey any property, real, personal or mixed, tangible or intangible, or any interest therein, at
25	any time acquired or held by the Authority on such terms and conditions as may be determined by the
26	Board, provided that the terms of any conveyance or lease of real property shall be subject to the prior
27	written approval of the Governor;
28 29	4. Fix, alter, charge and collect rates, rentals, fees, and other charges for the use of property of, the sale of products of, or services rendered by the Authority at rates to be determined by it for the purpose

31	5. Make and enter into all contracts and agreements necessary or incidental to the performance of its
32	duties, the furtherance of its purposes, and the execution of its powers under this article, including
33	agreements with any person or federal agency;
34	6. Employ, at its discretion, consultants, researchers, <i>attorneys</i> , architects, engineers, accountants,
35	financial experts, investment bankers, superintendents, managers, and such other employees and agents
36	as may be necessary, and to fix their compensation to be payable from funds made available to the
37	Authority. The Authority may hire employees within and without the Commonwealth and the United
38	States without regard to whether such employees are citizens of the Commonwealth. Legal services for
39	the Authority shall be provided by the Attorney General in accordance with Chapter 5 (§ 2.2-500 et
40	seq.) of this title;
41 42	7. Receive and accept from any federal or private agency, foundation, corporation, association or person, grants or other aid to be expended in accomplishing the objectives of the Authority, and receive
43	and accept from the Commonwealth or any state, and any municipality, county or other political
