10	Be it enacted by the General Assembly of Virginia:
11	1. That § 54.1-2731 of the Code of Virginia is amended and reenacted as follows:
12	§ 54.1-2731. Prohibited terms; penalty.
13	A. As used in this section, "nutritional genomics" means the consideration of biochemical or genetic
14	information to evaluate how genetics affect gene function and how genetic variation alters nutrient
15	response, including the study of how dietary and other lifestyle choices influence the function of humans
16	at the molecular, cellular, organismal, and populational levels.
17	B. No person shall hold himself out to be or advertise or permit to be advertised that such person is
18	a dietitian or nutritionist unless such person:
19 20	1. Has (i) received a baccalaureate or higher degree in nutritional sciences, community nutrition, public health nutrition, food and nutrition, dietetics, or human nutrition from a regionally accredited
20 21	college or university and (ii) satisfactorily completed a program of supervised clinical experience
22	approved by the Commission on Dietetic Registration of the American Dietetic Association Academy of
23	Nutrition and Dietetics;
24	2. Has active registration through the Commission on Dietetic Registration of the American Dietetic
25	Association Academy of Nutrition and Dietetics;
26	3. Has an active certificate of the Certification Board for Certification of Nutrition Specialists by the
27 28	Board of Nutrition Specialists as a Certified Nutrition Specialist; 4. Has an active accreditation by the Diplomats or Fellows certification as a Diplomate of the
20 29	American <i>Clinical</i> Board of Nutrition;
<b>3</b> 0	5. Has a current license or certificate as a dietitian or nutritionist issued by another state; or
31	6. Has the minimum requisite education, training and experience determined by the Board of Health
32	Professions appropriate for such person to hold himself out to be, or advertise or allow himself to be
33	advertised as, a dietitian or nutritionist.
34	The restrictions of this section apply to the use of the terms "dietitian" and "nutritionist" as used
35	alone or in any combination with the terms "licensed," "certified," or "registered," as those terms also
36 37	imply a minimum level of education, training and competence. C. Any person who meets the requirements set forth in subsection B may practice as a dietitian or
38	nutritionist in any setting and shall have the authority to undertake any activity that falls within the
39	scope of his professional practice, which shall include the practice of nutritional genomics.
40	D. A person who does not meet the requirements of subsection B but who (i) has a baccalaureate
41	degree with a major in food and nutrition or dietetics or has equivalent hours of food and nutrition
42	coursework and (ii) has two years of work experience in nutrition or dietetics concurrent with or
43	subsequent to completion of such degree may hold himself out as a dietitian or nutritionist, provided he
44 45	is employed by or under contract to a government agency and practices solely within the scope of such employment.
<b>4</b> 6	B. E. Any person who willfully violates the provisions of this section shall be is guilty of a Class 3
47	misdemeanor.
