16104148D **HOUSE BILL NO. 580** 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the House Committee on Health, Welfare and Institutions 4 on January 21, 2016) 5 (Patron Prior to Substitute—Delegate Robinson) 6 A BILL to amend and reenact §§ 54.1-2900 and 54.1-3000 of the Code of Virginia, relating to nurses; 7 definitions. 8 Be it enacted by the General Assembly of Virginia: 9 1. That §§ 54.1-2900 and 54.1-3000 of the Code of Virginia are amended and reenacted as follows: 10 § 54.1-2900. Definitions. As used in this chapter, unless the context requires a different meaning: 11 "Acupuncturist" means an individual approved by the Board to practice acupuncture. This is limited 12 to "licensed acupuncturist" which means an individual other than a doctor of medicine, osteopathy, 13 14 chiropractic or podiatry who has successfully completed the requirements for licensure established by the Board (approved titles are limited to: Licensed Acupuncturist, Lic.Ac., and L.Ac.). 15 "Auricular acupuncture" means the subcutaneous insertion of sterile, disposable acupuncture needles 16 in predetermined, bilateral locations in the outer ear when used exclusively and specifically in the 17 18 context of a chemical dependency treatment program. "Board" means the Board of Medicine. 19 "Certified nurse midwife" means an advanced practice registered nurse who is certified in the 20 specialty of nurse midwifery and who is jointly licensed by the Boards of Medicine and Nursing as a 21 22 nurse practitioner pursuant to § 54.1-2957. 23 "Certified registered nurse anesthetist" means an advanced practice registered nurse who is certified 24 in the specialty of nurse anesthesia, who is jointly licensed by the Boards of Medicine and Nursing as a nurse practitioner pursuant to § 54.1-2957, and who practices under the supervision of a doctor of 25 26 medicine, osteopathy, podiatry, or dentistry but is not subject to the practice agreement requirement 27 described in § 54.1-2957. 28 "Genetic counselor" means a person licensed by the Board to engage in the practice of genetic 29 counseling. 30 "Healing arts" means the arts and sciences dealing with the prevention, diagnosis, treatment and cure 31 or alleviation of human physical or mental ailments, conditions, diseases, pain or infirmities. "Medical malpractice judgment" means any final order of any court entering judgment against a 32 33 licensee of the Board that arises out of any tort action or breach of contract action for personal injuries 34 or wrongful death, based on health care or professional services rendered, or that should have been 35 rendered, by a health care provider, to a patient. 36 "Medical malpractice settlement" means any written agreement and release entered into by or on 37 behalf of a licensee of the Board in response to a written claim for money damages that arises out of 38 any personal injuries or wrongful death, based on health care or professional services rendered, or that 39 should have been rendered, by a health care provider, to a patient. 40 "Nurse practitioner" means an advanced practice registered nurse who is jointly licensed by the Boards of Medicine and Nursing pursuant to § 54.1-2957. 41 "Occupational therapy assistant" means an individual who has met the requirements of the Board for 42 licensure and who works under the supervision of a licensed occupational therapist to assist in the 43 practice of occupational therapy. 44 "Patient care team" means a multidisciplinary team of health care providers actively functioning as a 45 unit with the management and leadership of one or more patient care team physicians for the purpose of 46 47 providing and delivering health care to a patient or group of patients. "Patient care team physician" means a physician who is actively licensed to practice medicine in the **48** 49 Commonwealth, who regularly practices medicine in the Commonwealth, and who provides management 50 and leadership in the care of patients as part of a patient care team. 51 "Physician assistant" means an individual who has met the requirements of the Board for licensure 52 and who works under the supervision of a licensed doctor of medicine, osteopathy, or podiatry. 53 "Practice of acupuncture" means the stimulation of certain points on or near the surface of the body 54 by the insertion of needles to prevent or modify the perception of pain or to normalize physiological functions, including pain control, for the treatment of certain ailments or conditions of the body and 55 includes the techniques of electroacupuncture, cupping and moxibustion. The practice of acupuncture 56 does not include the use of physical therapy, chiropractic, or osteopathic manipulative techniques; the 57 use or prescribing of any drugs, medications, serums or vaccines; or the procedure of auricular 58 59 acupuncture as exempted in § 54.1-2901 when used in the context of a chemical dependency treatment

program for patients eligible for federal, state or local public funds by an employee of the program who
 is trained and approved by the National Acupuncture Detoxification Association or an equivalent
 certifying body.

<sup>63</sup> "Practice of athletic training" means the prevention, recognition, evaluation, and treatment of injuries
<sup>64</sup> or conditions related to athletic or recreational activity that requires physical skill and utilizes strength,
<sup>65</sup> power, endurance, speed, flexibility, range of motion or agility or a substantially similar injury or
<sup>66</sup> condition resulting from occupational activity immediately upon the onset of such injury or condition;
<sup>67</sup> and subsequent treatment and rehabilitation of such injuries or conditions under the direction of the
<sup>68</sup> patient's physician or under the direction of any doctor of medicine, osteopathy, chiropractic, podiatry, or
<sup>69</sup> dentistry, while using heat, light, sound, cold, electricity, exercise or mechanical or other devices.

"Practice of behavior analysis" means the design, implementation, and evaluation of environmental
 modifications, using behavioral stimuli and consequences, to produce socially significant improvement in
 human behavior, including the use of direct observation, measurement, and functional analysis of the
 relationship between environment and behavior.

"Practice of chiropractic" means the adjustment of the 24 movable vertebrae of the spinal column,
and assisting nature for the purpose of normalizing the transmission of nerve energy, but does not
include the use of surgery, obstetrics, osteopathy or the administration or prescribing of any drugs,
medicines, serums or vaccines.

78 "Practice of genetic counseling" means (i) obtaining and evaluating individual and family medical 79 histories to assess the risk of genetic medical conditions and diseases in a patient, his offspring, and 80 other family members; (ii) discussing the features, history, diagnosis, environmental factors, and risk 81 management of genetic medical conditions and diseases; (iii) ordering genetic laboratory tests and other diagnostic studies necessary for genetic assessment; (iv) integrating the results with personal and family 82 83 medical history to assess and communicate risk factors for genetic medical conditions and diseases; (v) 84 evaluating the patient's and family's responses to the medical condition or risk of recurrence and 85 providing client-centered counseling and anticipatory guidance; (vi) identifying and utilizing community resources that provide medical, educational, financial, and psychosocial support and advocacy; and (vii) 86 87 providing written documentation of medical, genetic, and counseling information for families and health 88 care professionals.

89 "Practice of medicine or osteopathic medicine" means the prevention, diagnosis and treatment of90 human physical or mental ailments, conditions, diseases, pain or infirmities by any means or method.

91 "Practice of occupational therapy" means the therapeutic use of occupations for habilitation and 92 rehabilitation to enhance physical health, mental health, and cognitive functioning and includes the 93 evaluation, analysis, assessment, and delivery of education and training in basic and instrumental 94 activities of daily living; the design, fabrication, and application of orthoses (splints); the design, 95 selection, and use of adaptive equipment and assistive technologies; therapeutic activities to enhance 96 functional performance; vocational evaluation and training; and consultation concerning the adaptation of 97 physical, sensory, and social environments.

"Practice of podiatry" means the prevention, diagnosis, treatment, and cure or alleviation of physical 98 99 conditions, diseases, pain, or infirmities of the human foot and ankle, including the medical, mechanical 100 and surgical treatment of the ailments of the human foot and ankle, but does not include amputation of the foot proximal to the transmetatarsal level through the metatarsal shafts. Amputations proximal to the 101 102 metatarsal-phalangeal joints may only be performed in a hospital or ambulatory surgery facility accredited by an organization listed in § 54.1-2939. The practice includes the diagnosis and treatment of 103 lower extremity ulcers; however, the treatment of severe lower extremity ulcers proximal to the foot and 104 ankle may only be performed by appropriately trained, credentialed podiatrists in an approved hospital 105 or ambulatory surgery center at which the podiatrist has privileges, as described in § 54.1-2939. The 106 Board of Medicine shall determine whether a specific type of treatment of the foot and ankle is within 107 108 the scope of practice of podiatry.

109 "Practice of radiologic technology" means the application of ionizing radiation to human beings for110 diagnostic or therapeutic purposes.

"Practice of respiratory care" means the (i) administration of pharmacological, diagnostic, and 111 112 therapeutic agents related to respiratory care procedures necessary to implement a treatment, disease prevention, pulmonary rehabilitative, or diagnostic regimen prescribed by a practitioner of medicine or 113 114 osteopathic medicine; (ii) transcription and implementation of the written or verbal orders of a practitioner of medicine or osteopathic medicine pertaining to the practice of respiratory care; (iii) 115 116 observation and monitoring of signs and symptoms, general behavior, general physical response to respiratory care treatment and diagnostic testing, including determination of whether such signs, 117 symptoms, reactions, behavior or general physical response exhibit abnormal characteristics; and (iv) 118 119 implementation of respiratory care procedures, based on observed abnormalities, or appropriate reporting, 120 referral, respiratory care protocols or changes in treatment pursuant to the written or verbal orders by a licensed practitioner of medicine or osteopathic medicine or the initiation of emergency procedures, 121

pursuant to the Board's regulations or as otherwise authorized by law. The practice of respiratory care 122 123 may be performed in any clinic, hospital, skilled nursing facility, private dwelling or other place deemed 124 appropriate by the Board in accordance with the written or verbal order of a practitioner of medicine or 125 osteopathic medicine, and shall be performed under qualified medical direction.

126 "Qualified medical direction" means, in the context of the practice of respiratory care, having readily 127 accessible to the respiratory therapist a licensed practitioner of medicine or osteopathic medicine who 128 has specialty training or experience in the management of acute and chronic respiratory disorders and 129 who is responsible for the quality, safety, and appropriateness of the respiratory services provided by the 130 respiratory therapist.

"Radiologic technologist" means an individual, other than a licensed doctor of medicine, osteopathy, 131 132 podiatry, or chiropractic or a dentist licensed pursuant to Chapter 27 (§ 54.1-2700 et seq.), who (i) 133 performs, may be called upon to perform, or is licensed to perform a comprehensive scope of diagnostic 134 or therapeutic radiologic procedures employing ionizing radiation and (ii) is delegated or exercises 135 responsibility for the operation of radiation-generating equipment, the shielding of patient and staff from unnecessary radiation, the appropriate exposure of radiographs, the administration of radioactive 136 137 chemical compounds under the direction of an authorized user as specified by regulations of the 138 Department of Health, or other procedures that contribute to any significant extent to the site or dosage 139 of ionizing radiation to which a patient is exposed.

140 "Radiologic technologist, limited" means an individual, other than a licensed radiologic technologist, 141 dental hygienist, or person who is otherwise authorized by the Board of Dentistry under Chapter 27 142 (§ 54.1-2700 et seq.) and the regulations pursuant thereto, who performs diagnostic radiographic 143 procedures employing equipment that emits ionizing radiation that is limited to specific areas of the 144 human body.

145 "Radiologist assistant" means an individual who has met the requirements of the Board for licensure 146 as an advanced-level radiologic technologist and who, under the direct supervision of a licensed doctor 147 of medicine or osteopathy specializing in the field of radiology, is authorized to (i) assess and evaluate 148 the physiological and psychological responsiveness of patients undergoing radiologic procedures; (ii) 149 evaluate image quality, make initial observations, and communicate observations to the supervising 150 radiologist; (iii) administer contrast media or other medications prescribed by the supervising radiologist; 151 and (iv) perform, or assist the supervising radiologist to perform, any other procedure consistent with the 152 guidelines adopted by the American College of Radiology, the American Society of Radiologic 153 Technologists, and the American Registry of Radiologic Technologists.

154 "Respiratory care" means the practice of the allied health profession responsible for the direct and 155 indirect services, including inhalation therapy and respiratory therapy, in the treatment, management, 156 diagnostic testing, control, and care of patients with deficiencies and abnormalities associated with the 157 cardiopulmonary system under qualified medical direction. 158

## § 54.1-3000. Definitions.

159 As used in this chapter, unless the context requires a different meaning:

160 "Advanced practice registered nurse" means a registered nurse who has completed an advanced graduate-level education program in a specialty category of nursing and has passed a national 161 162 certifying examination for that specialty.

163 "Board" means the Board of Nursing.

164 "Certified nurse aide" means a person who meets the qualifications specified in this article and who 165 is currently certified by the Board.

166 "Clinical nurse specialist" means a person who is registered by the Board in addition to holding a 167 license under the provisions of this chapter to practice professional nursing as defined in this section. 168 Such a person shall be recognized as being able to provide advanced services according to the specialized training received from a program approved by the Board, but shall not be entitled to perform 169 170 any act that is not within the scope of practice of professional nursing.

171 "Certified massage therapist" means a person who meets the qualifications specified in this chapter 172 and who is currently certified by the Board.

173 "Massage therapy" means the treatment of soft tissues for therapeutic purposes by the application of 174 massage and bodywork techniques based on the manipulation or application of pressure to the muscular 175 structure or soft tissues of the human body. The terms "massage therapy" and "therapeutic massage" do 176 not include the diagnosis or treatment of illness or disease or any service or procedure for which a 177 license to practice medicine, nursing, chiropractic therapy, physical therapy, occupational therapy, 178 acupuncture, or podiatry is required by law.

179 "Nurse practitioner" means an advanced practice registered nurse who is jointly licensed by the 180 Boards of Medicine and Nursing pursuant to § 54.1-2957.

181 "Practical nurse" or "licensed practical nurse" means a person who is licensed or holds a multistate 182 licensure privilege under the provisions of this chapter to practice practical nursing as defined in this

183 section. Such a licensee shall be empowered to provide nursing services without compensation. The184 abbreviation "L.P.N." shall stand for such terms.

185 "Practical nursing" or "licensed practical nursing" means the performance for compensation of 186 selected nursing acts in the care of individuals or groups who are ill, injured, or experiencing changes in 187 normal health processes; in the maintenance of health; in the prevention of illness or disease; or, subject 188 to such regulations as the Board may promulgate, in the teaching of those who are or will be nurse 189 aides. Practical nursing or licensed practical nursing requires knowledge, judgment and skill in nursing 190 procedures gained through prescribed education. Practical nursing or licensed practical nursing is performed under the direction or supervision of a licensed medical practitioner, a professional nurse, 191 192 registered nurse or registered professional nurse or other licensed health professional authorized by 193 regulations of the Board.

"Practice of a nurse aide" or "nurse aide practice" means the performance of services requiring the
education, training, and skills specified in this chapter for certification as a nurse aide. Such services are
performed under the supervision of a dentist, physician, podiatrist, professional nurse, licensed practical
nurse, or other licensed health care professional acting within the scope of the requirements of his
profession.

"Professional nurse," "registered nurse" or "registered professional nurse" means a person who is
licensed or holds a multistate licensure privilege under the provisions of this chapter to practice
professional nursing as defined in this section. Such a licensee shall be empowered to provide
professional services without compensation, to promote health and to teach health to individuals and
groups. The abbreviation "R.N." shall stand for such terms.

"Professional nursing," "registered nursing" or "registered professional nursing" means the performance for compensation of any nursing acts in the observation, care and counsel of individuals or 204 205 206 groups who are ill, injured or experiencing changes in normal health processes or the maintenance of 207 health; in the prevention of illness or disease; in the supervision and teaching of those who are or will be involved in nursing care; in the delegation of selected nursing tasks and procedures to appropriately 208 209 trained unlicensed persons as determined by the Board; or in the administration of medications and 210 treatments as prescribed by any person authorized by law to prescribe such medications and treatment. Professional nursing, registered nursing and registered professional nursing require specialized education, 211 judgment, and skill based upon knowledge and application of principles from the biological, physical, 212 213 social, behavioral and nursing sciences.
