16105479D **HOUSE BILL NO. 986** 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the House Committee on General Laws 4 5 6 on February 11, 2016) (Patron Prior to Substitute—Delegate Yancey) A BILL to amend and reenact § 30-178 of the Code of Virginia, relating to the Virginia Freedom of Information Advisory Council; membership. 7 8 Be it enacted by the General Assembly of Virginia: 1. That § 30-178 of the Code of Virginia is amended and reenacted as follows: 9 10 § 30-178. Virginia Freedom of Information Advisory Council; membership; terms; quorum; expenses. 11 A. The Virginia Freedom of Information Advisory Council (the Council) is hereby created as an 12 13 advisory council in the legislative branch to encourage and facilitate compliance with the Freedom of 14 Information Act. 15 B. The Council shall consist of 12 13 members as follows: the Attorney General or his designee; the 16 Librarian of Virginia or his designee; the Director of the Division of Legislative Services or his 17 designee; four five members appointed by the Speaker of the House of Delegates, one of whom shall be a member of the House of Delegates, and three four nonlegislative citizen members, at least one two of 18 whom shall be or have been a representative of the news media; three members appointed by the Senate 19 20 Committee on Rules, one of whom shall be a member of the Senate, one of whom shall be or have been an officer of local government, and one nonlegislative citizen at-large member; and two 21 nonlegislative citizen members appointed by the Governor, one of whom shall not be a state employee. 22 23 The local government representative may be selected from a list recommended by the Virginia 24 Association of Counties and the Virginia Municipal League, after due consideration of such list by the 25 Senate Committee on Rules. The citizen members may be selected from a list recommended by the Virginia Press Association, the Virginia Association of Broadcasters, and the Virginia Coalition for Open 26 27 Government, after due consideration of such list by the appointing authorities. C. All appointments following the initial staggering of terms shall be for terms of four years, except 28 29 that appointments to fill vacancies shall be for the unexpired terms in the same manner as the original 30 appointment. No nonlegislative citizen member shall be eligible to serve for more than two successive four-year terms. However, after the expiration of a term of three years or less, or after the expiration of 31 32 the remainder of a term to which appointed to fill a vacancy, two additional terms may be served by such member if appointed thereto. Legislative members and other state government officials shall serve 33 terms coincident with their terms of office. Legislative members may be reappointed for successive 34 35 terms. 36 D. The members of the Council shall elect from among their membership a chairman and a 37 vice-chairman for two-year terms. The chairman and vice-chairman may not succeed themselves to the 38 same position. The Council shall hold meetings quarterly or upon the call of the chairman. A majority 39 of the Council shall constitute a quorum. 40 E. Members of the Council shall receive no compensation for their services but shall be reimbursed 41 for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813, 2.2-2825 and 30-19.12, as appropriate. Funding for expenses of the members shall be 42 provided from existing appropriations to the Council. 43 2. That this act shall not be construed to affect existing appointments for which the terms have 44 not expired. However, any new appointments made after July 1, 2016, shall be made in 45 accordance with the provisions of this act. 46
