10	Be it enacted by the General Assembly of Virginia:
11	1. That § 8.01-296 of the Code of Virginia is amended and reenacted as follows:
12	§ 8.01-296. Manner of serving process upon natural persons.
13	Subject to the provisions of § 8.01-286.1, in any action at law or in equity or any other civil
14	proceeding in any court, process, for which no particular mode of service is prescribed, may be served
15	upon natural persons as follows:
16 17	1. By delivering a copy thereof in writing to the party in person; or
17	2. By substituted service in the following manner: a. If the party to be served is not found at his usual place of abode, by delivering a copy of such
19	process and giving information of its purport to any person found there, who is a member of his family
20	<i>household</i> , other than a temporary sojourner or guest, and who is of the age of 16 years or older; or
$\overline{21}$	b. If such service cannot be effected under subdivision 2 a, then by posting a copy of such process at
22	the front door or at such other door as appears to be the main entrance of such place of abode, provided
23	that not less than 10 days before judgment by default may be entered, the party causing service or his
24	attorney or agent mails to the party served a copy of such process and thereafter files in the office of
25	the clerk of the court a certificate of such mailing. In any civil action brought in a general district court,
26	the mailing of the application for a warrant in debt or affidavit for summons in unlawful detainer or
27	other civil pleading or a copy of such pleading, whether yet issued by the court or not, which contains
28	the date, time and place of the return, prior to or after filing such pleading in the general district court,
29 30	shall satisfy the mailing requirements of this section. In any civil action brought in a circuit court, the mailing of a copy of the pleadings with a notice that the proceedings are pending in the court indicated
30 31	and that upon the expiration of 10 days after the giving of the notice and the expiration of the statutory
32	period within which to respond, without further notice, the entry of a judgment by default as prayed for
33	in the pleadings may be requested, shall satisfy the mailing requirements of this section and any notice
34	requirement of the Rules of Court. Any judgment by default entered after July 1, 1989, upon posted
35	service in which proceedings a copy of the pleadings was mailed as provided for in this section prior to
36	July 1, 1989, is validated.
37	c. The person executing such service shall note the manner and the date of such service on the
38	original and the copy of the process so delivered or posted under this subdivision and shall effect the
39 40	return of process as provided in §§ 8.01-294 and 8.01-325. 3. If service cannot be effected under subdivisions 1 and 2, then by order of publication in
40 41	appropriate cases under the provisions of §§ 8.01-316 through 8.01-320.
42	4. The landlord or his duly authorized agent or representative may serve notices required by the

rental agreement or by law upon the tenant or occupant under a rental agreement that is within the purview of Chapter 13 (§ 55-217 et seq.) of Title 55.
