10	Be it enacted by the General Assembly of Virginia:
11	1. That the Code of Virginia is amended by adding in Title 17.1 a chapter numbered 10, consisting
12	of sections numbered 17.1-1000 through 17.1-1012 as follows:
13	CHAPTER 10.
13	JUDICIAL NOMINATIONS COMMISSION.
15	§ 17.1-1000. Judicial Nominations Commission created.
16	There is hereby created the Judicial Nominations Commission, which shall be selected and have the
17	duties and authority as provided in this chapter.
18	§ 17.1-1001. Composition of Judicial Nominations Commission; number and terms of members;
19	how elected; how chairman elected; staff.
20	The Judicial Nominations Commission (the Commission) shall consist of 15 members who shall be
<b>20</b> <b>21</b>	elected by the General Assembly in the same manner as judges are elected. One member shall be
22	elected from each congressional district, and the remaining four from the Commonwealth at large. Five
$\overline{23}$	members shall be active members in good standing of the Virginia State Bar and shall have been
24 24	members of the Virginia State Bar for at least 15 years each. Ten members shall be citizens of the
25	Commonwealth and shall never have been licensed to practice law in the Commonwealth. No member of
26	the Commission shall be a member of the General Assembly at the time of his election, and membership
27	on the Commission shall be vacated upon taking office as a member of the General Assembly.
28	Of the initial membership, five members shall be elected for a term of four years, five for a term of
<b>29</b>	three years, and five for a term of two years. Thereafter, all members shall be elected for a term of four
30	years. Members may succeed themselves for one additional consecutive term. Vacancies in office shall
31	be filled in the same manner as the original election for the unexpired term. Members elected to fill
32	vacancies may serve two consecutive terms in addition to the unexpired term.
33	The Commission shall elect a chairman from among its members and determine its rules of
34	procedure. The Division of Legislative Services shall serve as staff to the Commission.
35	§ 17.1-1002. Vacancies on appellate courts; studies and investigations; public hearings;
36	Commission reports to the General Assembly; qualifications; confidentiality.
37	A. Notwithstanding the provisions of this subsection, whenever it appears that a vacancy on the
38	Supreme Court or the Court of Appeals is imminent, the Commission may initiate its studies and
39	investigations and shall consider and examine the merits of candidates for nomination, taking into
40	consideration the factors set out in subsection C. However, no nominations shall be submitted prior to
41	the receipt by the Commission of the report of the Executive Secretary as herein provided.
42	Whenever there is a vacancy on the Supreme Court or the Court of Appeals, the Executive Secretary
43	of the Supreme Court shall report the vacancy to the Chairman of the Commission. The report shall be
44	submitted within five days of the vacancy. The expiration of the term of an incumbent justice or judge
45	shall not be considered a vacancy, unless the incumbent justice or judge is not reelected.
46	B. The Commission shall, in determining those persons qualified for appellate judicial office,
47	investigate and examine and submit to the Clerks of both houses of the General Assembly and to the
48	Chairmen of the House and Senate Committees for Courts of Justice for consideration by the General
<b>49</b>	Assembly the names of no more than three persons who are qualified on the basis of merit to hold such
50	office.
51	In the case of pro tempore vacancies to be filled, such nominations shall be submitted by the
52 53	Commission to the Governor. The Commission shall furnish copies of its reports to the General
53 54	Assembly, to the Clerks of both houses of the General Assembly, and to the Chairmen of the House and Sanata Committees for Courts of Justice
54 55	Senate Committees for Courts of Justice. Submission by the Commission of a person's name to the General Assembly shall not be deemed a

57 58	C. The Commission shall submit the names of persons it deems qualified on the basis of merit and

59 shall examine the character, temperament, intelligence, mental and physical fitness, education, legal 60 ability, experience, general interest, and past conduct of each person considered. The Commission shall 61 hold at least one public hearing in each congressional district for each vacancy the nominations for

62 which it considers.

63 Any person whose name is submitted by the Commission for consideration for judicial office shall 64 have been licensed to practice law in the Commonwealth for at least five years. Members of the General 65 Assembly, during the term of office for which they were elected, shall not be eligible for submission for consideration for judicial office. 66

D. The submission of a nomination by the Commission to fill a vacancy or new judgeship shall be 67 accompanied by a written report in which a majority of Commission members concur. The report shall 68 contain an explanation of the method by which the Commission has selected each nominee and his 69 qualifications, as set out in subsection C. If one or more members of the Commission disagree with the 70 71 majority of the Commission as to the qualifications of any nominee, they may file a dissenting report in 72 writing setting forth their reasons therefor.

73 E. Except as otherwise provided in this chapter, such reports shall be confidential, until a nominee 74 directs in writing to the chairman of the Commission otherwise, in which case the contents of any report 75 as to that nominee may be released to the public. 76

# § 17.1-1003. Commission papers and proceedings confidential; how made available to Committee.

77 Upon the written request of the Chairman of the House or Senate Committee for Courts of Justice, 78 the Commission shall divulge all papers filed with the proceedings before the Commission with respect 79 to a nominee before that Committee for consideration. Except as provided in subsection  $\vec{E}$  of § 17.1-1002, all papers and proceedings of the Commission shall be confidential and shall not be 80 81 divulged to anyone, whether such papers or proceedings are in the custody of the Commission or such 82 Committee.

# § 17.1-1004. Expenses and compensation of members.

84 Members of the Commission shall receive compensation as provided in § 2.2-2813. Compensation 85 and reimbursement shall be paid in the manner provided by law from the general fund of the state 86 treasury. 87

### § 17.1-1005. Civil immunity for members of the Commission.

88 Every member of the Commission shall be immune from civil liability for any act, decision, omission, 89 or utterance done or made in performance of his duties while serving as such member, provided that 90 such act, decision, omission, or utterance is not done or made in bad faith or with malicious intent. 91

# § 17.1-1006. Local judicial nominations committees; membership.

92 There is hereby created a local judicial nominations committee for each judicial circuit. Each 93 member of the General Assembly who represents any portion of the circuit shall designate two persons who reside within the circuit to sit as members of the local judicial nominations committee for that 94 95 circuit. At least one member shall be appointed from each county and from each city wherein court is held in the circuit. In no case shall the number of licensed attorneys exceed 30 percent of the total 96 97 membership of the committee. However, if a majority of the members of the General Assembly within the 98 circuit agree that the appointment of two citizens by each member would create a committee of more 99 members than would be practicable, they may, by majority vote, reduce the size to one appointment per 100 member of the General Assembly. Members of a local judicial nominations committee shall serve at the 101 pleasure of the member of the General Assembly by whom they were appointed. Vacancies shall be 102 filled in the same manner as original appointments. A majority of members shall constitute a quorum 103 for the conduct of the business of any committee.

104 Each committee shall elect a chairman from among its members. Each committee shall determine its 105 rules of procedure not inconsistent with the provisions of this chapter and shall establish procedures for maximizing relevant input from the general public into the process for nomination of judges and ensuring the selection of qualified candidates for the bench. 106 107

#### 108 § 17.1-1007. Duties of local judicial nominations committees; investigation; public hearings; 109 nomination and report.

110 A. Each local judicial nominations committee shall consider qualified persons to fill anticipated 111 vacancies and new seats in the circuit and district courts within its circuit. A committee may receive 112 advice and recommendations from individuals, bar associations, other organizations, and members of 113 the General Assembly and may investigate and consider persons on its own initiative. Each committee 114 shall develop a process and criteria by which individuals may submit themselves for consideration by 115 the committee.

116 The committee shall investigate the merits of persons for nomination to such vacancies and new seats 117 and shall examine the character, temperament, intelligence, mental and physical fitness, education, legal ability, experience, general interest, and past conduct of each person considered. The committee shall 118 119 hold at least one public hearing in each county and city wherein court is held in the circuit. Any person who is nominated by a local committee shall have been licensed to practice law in the Commonwealth 120

121 for at least five years. Members of the General Assembly, during the term of office for which they were 122 elected, shall not be eligible for consideration as nominees for judicial office.

123 B. In the case of a vacancy or new judgeship in a circuit or district court, the committee shall, by a 124 majority vote of the members present and voting, nominate up to three persons it deems qualified for 125 that seat on the basis of merit. If the committee nominates more than one person for a particular 126 judgeship, it shall indicate in the written report required by subsection C which person it finds to be the 127 most qualified for the judgeship. The committee shall submit nominations to the clerks of both houses of 128 the General Assembly for consideration by the General Assembly. In the case of vacancies that may be 129 filled by pro tempore appointment pursuant to §§ 16.1-69.9:2 and 17.1-509, nominations shall be made 130 by the committee to the appropriate appointing authority.

131 C. The submission of nominations to fill a vacancy or new judgeship shall be accompanied by a 132 written report in which a majority of committee members concur. The report shall include an explanation of the method by which the committee has selected each nominee and his qualifications, as 133 set out in subsection A. If one or more members of a committee disagree with the majority of the 134 135 committee as to the qualifications of any nominee, they may file a dissenting report in writing setting 136 forth their reasons therefor, but no other nomination may be submitted unless the General Assembly 137 fails to elect one of the nominees of the committee.

138 D. Submission by a local judicial nominations committee of the name of a person to the General 139 Assembly or appointing authority shall not be deemed a prerequisite for that person's election or 140 appointment as a judge.

#### 141 § 17.1-1008. How vacancies certified; reports of Judicial Council and Committee on District 142 Courts; studies and investigations.

143 Whenever the Supreme Court certifies that there is a need to fill a vacancy in the office of judge of a 144 circuit court or the Committee on District Courts certifies that there is a need to fill a vacancy in the 145 office of judge of any district court, the Executive Secretary of the Supreme Court shall report the 146 vacancy to the chairman of the appropriate local judicial nominations committee. The report shall be 147 submitted within five days of the vacancy or certification of the need to fill a vacancy. The expiration of 148 the term of an incumbent judge shall not be considered a vacancy, unless the incumbent judge is not 149 reelected.

150 Upon the filing by the Committee on District Courts of the report required by § 16.1-69.10 as to the 151 need for additional district court judges, and upon the filing by the Judicial Council of the 152 recommendations required by § 17.1-507 as to the need for additional circuit court judges, the Executive 153 Secretary shall forward a copy of such report to the chairman of the local judicial nominations 154 committee in the appropriate circuit or district.

155 Notwithstanding the provisions of this section, whenever it appears that a vacancy in a circuit or 156 district court is imminent, the appropriate local judicial nominations committee may initiate its studies 157 and investigations. However, no nominations shall be submitted prior to receipt by the committee of the 158 report of the Executive Secretary as herein provided.

#### 159 § 17.1-1009. Committee papers made available to the Committees for Courts of Justice; 160 confidentiality.

161 Upon the written request of the Chairman of the House or Senate Committee for Courts of Justice, a 162 local judicial nominations committee shall divulge all papers filed with and proceedings before the 163 committee with respect to a nominee before the General Assembly for consideration for election to any 164 *judicial office.* 165

# § 17.1-1010. Expenses of members.

Members of local judicial nominations committees shall be reimbursed for reasonable expenses 166 167 necessary to performing their duties and shall be paid in the manner provided by law from the general 168 fund of the state treasury.

#### 169 § 17.1-1011. Civil immunity for members of local judicial nominations committees.

170 Every member of a local judicial nominations committee shall be immune from civil liability for any 171 act, decision, omission, or utterance done or made in the performance of his duties while serving as a 172 member of such committee, provided that such act, decision, omission, or utterance is not done or made 173 in bad faith or with malicious intent.

#### 174 § 17.1-1012. Exception to chapter; alternate processes.

175 The provisions of this chapter shall not apply to any circuit wherein the members of the General 176 Assembly who represent a portion of such circuit, hereinafter referred to as "the delegation," certify in 177 writing to the Clerk of their respective houses that an alternative process for judicial nomination has 178 been developed within that delegation that ensures participation of each delegation member and 179 participation by the general public in the nomination process. The most senior member of the delegation 180 within each house shall submit to the Clerk, with the certification, a detailed summary of the delegation's alternative process. The Clerk shall send a copy of such certification and summary to the 181

182 Chairman of the Committee for Courts of Justice of his house.
