2	AMENDMENT IN THE NATURE OF A SUBSTITUTE
3	(Proposed by the Senate Committee for Courts of Justice
4	on February 1, 2016)
5	(Patron Prior to Substitute—Senator Locke)
6	A BILL to amend and reenact § 18.2-60 of the Code of Virginia, relating to threats of death or bodily
7	injury; penalty.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 18.2-60 of the Code of Virginia is amended and reenacted as follows:
10	§ 18.2-60. Threats of death or bodily injury to a person or member of his family; threats to
11	commit bodily harm to persons on school property; penalty.
12	A. 1. Any person who knowingly communicates, in a writing, including an electronically transmitted
13	communication producing a visual or electronic message, a threat to kill or do bodily injury to a person,
14	regarding that person or any member of his family, and the threat places such person in reasonable
15	apprehension of death or bodily injury to himself or his family member, is guilty of a Class 6 felony.
16	However, any person who violates this subsection with the intent to commit an act of terrorism as
17	defined in § 18.2-46.4 is guilty of a Class 5 felony.
18	2. Any person who knowingly communicates, including in an electronically transmitted
19	communication producing a visual or electronic message, a threat to kill a person, or any member of
20	that person's family, and the threat places such person in reasonable apprehension of death to himself
21	or his family member, is guilty of a Class 6 felony. However, any person who violates this subsection
22	with the intent to commit an act of terrorism as defined in § 18.2-46.4 is guilty of a Class 5 felony.
23	3. Any person who communicates a threat, in a writing, including an electronically transmitted
24	communication producing a visual or electronic message, to kill or do bodily harm, (i) on the grounds
25	or premises of any elementary, middle or secondary school property, (ii) at any elementary, middle or
26 27	secondary school-sponsored event or (iii) on a school bus to any person or persons, regardless of whether the person who is the chiest of the threat extually receives the threat would
27 28	whether the person who is the object of the threat actually receives the threat, and the threat would place the person who is the object of the threat in reasonable apprehension of death or bodily harm, is
20 29	guilty of a Class 6 felony.
30	B. Any person who orally makes a threat to any employee of any elementary, middle or secondary
30 31	school, while on a school bus, on school property or at a school-sponsored activity, to kill or to do
32	bodily injury to such person, is guilty of a Class 1 misdemeanor.
33	A prosecution pursuant to this section may be either in the county, city or town in which the
34	communication was made or received.
35	2. That the provisions of this act may result in a net increase in periods of imprisonment or
36	commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot
37	be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter
38	665 of the Acts of Assembly of 2015 requires the Virginia Criminal Sentencing Commission to
39	assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4, the estimated amount of the
40	necessary appropriation cannot be determined for periods of commitment to the custody of the
41	Department of Juvenile Justice.
