FLOOR AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by Delegate Ware

on February 6, 2017)

(Patron Prior to Substitute—Delegate Ware)

- 5 A BILL to amend and reenact § 22.1-273 of the Code of Virginia, relating to student vision screenings. 6 7 Be it enacted by the General Assembly of Virginia:
 - 1. That § 22.1-273 of the Code of Virginia is amended and reenacted as follows:

§ 22.1-273. Vision and hearing of student to be tested.

A. As used in this section:

"Comprehensive vision program" means a program that incorporates the following quality-controlled 11 12 requirements:

13 1. Program staff who perform vision screenings and administer and maintain student paperwork and 14 data related to such screenings are credentialed pursuant to a credentialing process that includes 15 training and certification on vision screening equipment, tuberculosis risk assessment or screening, and documentation from the employing qualified nonprofit vision health organization certifying completion of 16 a search of the registry of founded complaints of child abuse and neglect maintained by the Department 17 of Social Services pursuant to § 63.2-1515 and a search of the Central Criminal Records Exchange 18 through the Federal Bureau of Investigation based on fingerprints and personal descriptive information 19 20 for the purpose of obtaining criminal history record information;

21 2. The vision screening program is based on best practices as determined by scientific research and program performance and is evaluated by an advisory council consisting of (i) representatives of the 22 23 ophthalmology and optometry fields and (ii) members from elementary and secondary education and 24 school health to support the implementation of best practices and administrative policies to ensure 25 compliance with Department of Education requirements;

26 3. Vision screening results are communicated to parents in a relevant and informative format that is 27 designed to increase parental awareness and encourage parental action;

28 4. Parents receive information on the difference between vision screenings and eve examinations, the 29 importance of taking action on a referral for an eye examination by taking their child to a licensed 30 optometrist or ophthalmologist, the identification of potential vision problems beyond the results or scope of the vision screening, and the importance of vision to a child's education and success; 31

32 5. Parents are provided with information regarding follow-up resources related to eye examinations 33 and eveglasses: and 34

6. Vision screening results are managed for the purposes of reporting, outcome measurement, and program analysis.

36 Qualified nonprofit vision health organization" means a single nonprofit organization that is exempt 37 from taxation under § 501(c)(3) of the Internal Revenue Code, has at least 10 years of direct experience 38 in the delivery of vision and vision education services, and does not directly or indirectly derive profit 39 from the sale of vision equipment, insurance, medication, merchandise, or vision-related products.

40 B. The Superintendent of Public Instruction shall prepare or cause to be prepared, with the advice 41 and approval of the State Health Commissioner, suitable test cards, blanks, record books, and other 42 appliances for testing the sight and hearing of the pupils students in the public schools and necessary instructions for the use thereof. The State Department of Education shall furnish the same free of 43 44 expense to all schools in a school division upon request of the school board of such division accompanied by a resolution of the school board directing the use of such test eards, blanks, record 45 books and other appliances in the schools of the school division. 46

47 C. Within the time periods and at the grades provided in regulations promulgated by the Board of **48** Education, the principal of each such school shall cause the sight and hearing of the relevant pupils students in the school to be tested, unless such students are pupils students admitted for the first time to 49 a public kindergarten or elementary school who have been so tested as part of the comprehensive 50 51 physical examination required by § 22.1-270 or the parents or guardians of such students object on religious grounds and the students show no obvious evidence of any defect or disease of the eves or 52 53 ears. The principal shall keep a record of such examinations in accordance with instructions furnished. 54 Whenever a pupil student is found to have any defect of vision or hearing or a disease of the eyes or ears, the principal shall forthwith notify the parent or guardian, in writing, of such defect or disease. 55 Copies of the report shall be preserved for the use of the Superintendent of Public Instruction as he may 56 57 require.

D. The principal of each public elementary school shall cause the vision of students enrolled in 58 59 kindergarten and students enrolled in grade two or grade three to be tested, unless such students are

60 students admitted for the first time to a public elementary school and produce a written record of a comprehensive eve examination performed within the preceding 24 months or the parents or guardians 61 62 of such students object on religious grounds. Any such screening may be conducted by a qualified 63 nonprofit vision health organization that uses a digital photoscreening method pursuant to a 64 comprehensive vision program. The scheduling of such screenings may be completed no later than the sixtieth administrative working day of the school year. The principal shall keep a record of such 65 66 screenings in accordance with instructions furnished. Whenever a student does not receive a passing result on such screening and requires referral to an optometrist or ophthalmologist for a comprehensive 67 **68** eye examination, the principal shall cause the parent or guardian to be notified in writing. Copies of the 69 report shall be preserved for the use of the Superintendent of Public Instruction as he may require.

E. The principal of each public middle school and high school shall cause the vision of students 70 71 enrolled in grade seven and grade 10 to be tested, unless such students have received a vision screening from a physician or the parents or guardians of such students object on religious grounds. Any such 72 screening may be conducted by a qualified nonprofit vision health organization that uses a digital 73 74 photoscreening method pursuant to a comprehensive vision program. The scheduling of such screenings 75 may be completed no later than the sixtieth administrative working day of the school year. The principal 76 shall keep a record of such screenings in accordance with instructions furnished. Whenever a student does not receive a passing result on such screening and requires referral to an optometrist or 77 ophthalmologist for a comprehensive eye examination, the principal shall cause the parent or guardian 78 79 to be notified in writing. Copies of the report shall be preserved for the use of the Superintendent of 80 Public Instruction as he may require.

81 F. School boards are hereby authorized to enter into contracts with qualified nonprofit vision health 82 organizations for the purpose of conducting screenings pursuant to subsections D and E.
