2 *An Act to amend and reenact § 46.2-613 of the Code of Virginia, relating to farm use vehicles;*
3 *exemption from registration requirements.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 46.2-613 of the Code of Virginia is amended and reenacted as follows:**8 **§ 46.2-613. Offenses relating to registration, licensing, and certificates of title; penalties.**

9 No person shall:

10 1. Operate or permit the operation of a motor vehicle, trailer, or semitrailer owned, leased, or
11 otherwise controlled by him to be operated on a highway unless (i) it is registered, (ii) a certificate of
12 title therefor has been issued, and (iii) it has displayed on it the license plate or plates and decal or
13 decals, if any, assigned to it by the Department for the current registration period, subject to the
14 exemptions mentioned in Article 5 (§ 46.2-655 et seq.) and Article 6 (§ 46.2-662 et seq.) of this chapter.
15 The provisions of this subdivision shall apply to the registration, licensing, and titling of mopeds on or
16 after July 1, 2014.

17 2. Display, cause or permit to be displayed, any registration card, certificate of title, or license plate
18 or decal which he knows is fictitious or which he knows has been cancelled, revoked, suspended, or
19 altered; or display or cause or permit to be displayed on any motor vehicle, trailer, or semitrailer any
20 license plate or decal that he knows is currently issued for another vehicle. Violation of this subdivision
21 shall constitute a Class 2 misdemeanor.

22 3. Possess or lend or knowingly permit the use of any registration card, license plate, or decal by
23 anyone not entitled to it.

24 4. Fail or refuse to surrender to the Department or the Department of State Police, on demand, any
25 certificate of title, registration card, or license plate or decal which has been suspended, cancelled, or
26 revoked. Violation of this subdivision shall constitute a Class 2 misdemeanor.

27 5. Use a false name or address in any application for the registration of any motor vehicle, trailer, or
28 semitrailer or for a certificate of title or for any renewal or duplicate certificate, or knowingly to make a
29 false statement of a material fact or to conceal a material fact or otherwise commit a fraud in any
30 registration application. Violation of this subdivision shall constitute a Class 1 misdemeanor.

31 6. *Willfully and intentionally violate the limitations imposed under §§ 46.2-665, 46.2-666, and*
32 *46.2-670 while operating an unregistered vehicle pursuant to the agricultural and horticultural*
33 *exemptions allowed under those sections. A first violation of this subdivision shall constitute a traffic*
34 *infraction punishable by a fine of not more than \$250, and a second or subsequent violation of this*
35 *subdivision shall constitute a traffic infraction punishable by a fine of \$250.*
