9 **Be it enacted by the General Assembly of Virginia:**

10 **1. That §§ 2.2-3701, 2.2-3704, 2.2-3704.1, 2.2-3704.2, 2.2-3705.1 through 2.2-3705.8, 2.2-3711,**
 11 **2.2-3714, 2.2-3806, 22.1-253.13:3, 22.1-279.8, 23.1-2425, 32.1-48.08, 32.1-48.011, 32.1-48.015,**
 12 **32.1-283.1, 32.1-283.2, 32.1-283.3, 32.1-283.5, 32.1-283.6, 44-146.18, 44-146.22, 54.1-2517, and**
 13 **54.1-2523 of the Code of Virginia are amended and reenacted as follows:**

14 **§ 2.2-3701. Definitions.**

15 As used in this chapter, unless the context requires a different meaning:

16 "Closed meeting" means a meeting from which the public is excluded.

17 "Electronic communication" means any audio or combined audio and visual communication method.

18 "Emergency" means an unforeseen circumstance rendering the notice required by this chapter
 19 impossible or impracticable and which circumstance requires immediate action.

20 "Information" as used in the exclusions established by §§ 2.2-3705.1 through 2.2-3705.7, means the
 21 content within a public record that references a specifically identified subject matter, and shall not be
 22 interpreted to require the production of information that is not embodied in a public record.

23 "Meeting" or "meetings" means the meetings including work sessions, when sitting physically, or
 24 through telephonic or video equipment pursuant to § 2.2-3708 or 2.2-3708.1, as a body or entity, or as
 25 an informal assemblage of (i) as many as three members or (ii) a quorum, if less than three, of the
 26 constituent membership, wherever held, with or without minutes being taken, whether or not votes are
 27 cast, of any public body. Neither the gathering of employees of a public body nor the gathering or
 28 attendance of two or more members of a public body (i) at any place or function where no part of the
 29 purpose of such gathering or attendance is the discussion or transaction of any public business, and such
 30 gathering or attendance was not called or prearranged with any purpose of discussing or transacting any
 31 business of the public body, or (ii) at a public forum, candidate appearance, or debate, the purpose of
 32 which is to inform the electorate and not to transact public business or to hold discussions relating to
 33 the transaction of public business, even though the performance of the members individually or
 34 collectively in the conduct of public business may be a topic of discussion or debate at such public
 35 meeting, shall be deemed a "meeting" subject to the provisions of this chapter.

36 "Open meeting" or "public meeting" means a meeting at which the public may be present.

37 "Public body" means any legislative body, authority, board, bureau, commission, district or agency of
 38 the Commonwealth or of any political subdivision of the Commonwealth, including cities, towns and
 39 counties, municipal councils, governing bodies of counties, school boards and planning commissions;
 40 boards of visitors of public institutions of higher education; and other organizations, corporations or
 41 agencies in the Commonwealth supported wholly or principally by public funds. It shall include (i) the
 42 Virginia Birth-Related Neurological Injury Compensation Program and its board of directors established
 43 pursuant to Chapter 50 (§ 38.2-5000 et seq.) of Title 38.2 and (ii) any committee, subcommittee, or
 44 other entity however designated, of the public body created to perform delegated functions of the public
 45 body or to advise the public body. It shall not exclude any such committee, subcommittee or entity
 46 because it has private sector or citizen members. Corporations organized by the Virginia Retirement
 47 System are "public bodies" for purposes of this chapter.

48 For the purposes of the provisions of this chapter applicable to access to public records,
 49 constitutional officers and private police departments as defined in § 9.1-101 shall be considered public
 50 bodies and, except as otherwise expressly provided by law, shall have the same obligations to disclose
 51 public records as other custodians of public records.

52 "Public records" means all writings and recordings that consist of letters, words or numbers, or their
 53 equivalent, set down by handwriting, typewriting, printing, photostating, photography, magnetic impulse,
 54 optical or magneto-optical form, mechanical or electronic recording or other form of data compilation,
 55 however stored, and regardless of physical form or characteristics, prepared or owned by, or in the
 56 possession of a public body or its officers, employees or agents in the transaction of public business.

57 Records that are not prepared for or used in the transaction of public business are not public records.

58 "Regional public body" means a unit of government organized as provided by law within defined
59 boundaries, as determined by the General Assembly, whose members are appointed by the participating
60 local governing bodies, and such unit includes two or more counties or cities.

61 "Scholastic records" means those records containing information directly related to a student or an
62 applicant for admission and maintained by a public body that is an educational agency or institution or
63 by a person acting for such agency or institution.

64 **§ 2.2-3704. Public records to be open to inspection; procedure for requesting records and**
65 **responding to request; charges; transfer of records for storage, etc.**

66 A. Except as otherwise specifically provided by law, all public records shall be open to inspection
67 and copying by any citizens of the Commonwealth, *representatives of newspapers and magazines with*
68 *circulation in the Commonwealth, and representatives of radio and television stations broadcasting in or*
69 *into the Commonwealth* during the regular office hours of the custodian of such records. Access to such
70 records shall not be denied to citizens of the Commonwealth, *representatives of newspapers and*
71 *magazines with circulation in the Commonwealth, and representatives of radio and television stations*
72 *broadcasting in or into the Commonwealth be provided by the custodian in accordance with this chapter*
73 *by inspection or by providing copies of the requested records, at the option of the requester.* The
74 custodian may require the requester to provide his name and legal address. The custodian of such
75 records shall take all necessary precautions for their preservation and safekeeping.

76 B. A request for public records shall identify the requested records with reasonable specificity. The
77 request need not make reference to this chapter in order to invoke the provisions of this chapter or to
78 impose the time limits for response by a public body. Any public body that is subject to this chapter
79 and that is the custodian of the requested records shall promptly, but in all cases within five working
80 days of receiving a request, provide the requested records to the requester or make one of the following
81 responses in writing:

82 1. The requested records are being entirely withheld. Such response shall identify with reasonable
83 particularity the volume and subject matter of withheld records, and cite, as to each category of withheld
84 records, the specific Code section that authorizes the withholding of the records.

85 2. The requested records are being provided in part and are being withheld in part. Such response
86 shall identify with reasonable particularity the subject matter of withheld portions, and cite, as to each
87 category of withheld records, the specific Code section that authorizes the withholding of the records.

88 3. The requested records could not be found or do not exist. However, if the public body that
89 received the request knows that another public body has the requested records, the response shall include
90 contact information for the other public body.

91 4. It is not practically possible to provide the requested records or to determine whether they are
92 available within the five-work-day period. Such response shall specify the conditions that make a
93 response impossible. If the response is made within five working days, the public body shall have an
94 additional seven work days in which to provide one of the four preceding responses.

95 C. Any public body may petition the appropriate court for additional time to respond to a request for
96 records when the request is for an extraordinary volume of records or requires an extraordinarily lengthy
97 search, and a response by the public body within the time required by this chapter will prevent the
98 public body from meeting its operational responsibilities. Before proceeding with the petition, however,
99 the public body shall make reasonable efforts to reach an agreement with the requester concerning the
100 production of the records requested.

101 D. Subject to the provisions of subsection G, no public body shall be required to create a new record
102 if the record does not already exist. However, a public body may abstract or summarize information
103 under such terms and conditions as agreed between the requester and the public body.

104 E. Failure to respond to a request for records shall be deemed a denial of the request and shall
105 constitute a violation of this chapter.

106 F. A public body may make reasonable charges not to exceed its actual cost incurred in accessing,
107 duplicating, supplying, or searching for the requested records. No public body shall impose any
108 extraneous, intermediary, or surplus fees or expenses to recoup the general costs associated with creating
109 or maintaining records or transacting the general business of the public body. Any duplicating fee
110 charged by a public body shall not exceed the actual cost of duplication. The public body may also
111 make a reasonable charge for the cost incurred in supplying records produced from a geographic
112 information system at the request of anyone other than the owner of the land that is the subject of the
113 request. However, such charges shall not exceed the actual cost to the public body in supplying such
114 records, except that the public body may charge, on a pro rata per acre basis, for the cost of creating
115 topographical maps developed by the public body, for such maps or portions thereof, which encompass
116 a contiguous area greater than 50 acres. All charges for the supplying of requested records shall be
117 estimated in advance at the request of the citizen.

118 G. Public records maintained by a public body in an electronic data processing system, computer
 119 database, or any other structured collection of data shall be made available to a requester at a reasonable
 120 cost, not to exceed the actual cost in accordance with subsection F. When electronic or other databases
 121 are combined or contain exempt and nonexempt records, the public body may provide access to the
 122 exempt records if not otherwise prohibited by law, but shall provide access to the nonexempt records as
 123 provided by this chapter.

124 Public bodies shall produce nonexempt records maintained in an electronic database in any tangible
 125 medium identified by the requester, including, where the public body has the capability, the option of
 126 posting the records on a website or delivering the records through an electronic mail address provided
 127 by the requester, if that medium is used by the public body in the regular course of business. No public
 128 body shall be required to produce records from an electronic database in a format not regularly used by
 129 the public body. However, the public body shall make reasonable efforts to provide records in any
 130 format under such terms and conditions as agreed between the requester and public body, including the
 131 payment of reasonable costs. The excision of exempt fields of information from a database or the
 132 conversion of data from one available format to another shall not be deemed the creation, preparation, or
 133 compilation of a new public record.

134 H. In any case where a public body determines in advance that charges for producing the requested
 135 records are likely to exceed \$200, the public body may, before continuing to process the request, require
 136 the requester to agree to payment of a deposit not to exceed the amount of the advance determination.
 137 The deposit shall be credited toward the final cost of supplying the requested records. The period within
 138 which the public body shall respond under this section shall be tolled for the amount of time that
 139 elapses between notice of the advance determination and the response of the requester.

140 I. Before processing a request for records, a public body may require the requester to pay any
 141 amounts owed to the public body for previous requests for records that remain unpaid 30 days or more
 142 after billing.

143 J. In the event a public body has transferred possession of public records to any entity, including but
 144 not limited to any other public body, for storage, maintenance, or archiving, the public body initiating
 145 the transfer of such records shall remain the custodian of such records for purposes of responding to
 146 requests for public records made pursuant to this chapter and shall be responsible for retrieving and
 147 supplying such public records to the requester. In the event a public body has transferred public records
 148 for storage, maintenance, or archiving and such transferring public body is no longer in existence, any
 149 public body that is a successor to the transferring public body shall be deemed the custodian of such
 150 records. In the event no successor entity exists, the entity in possession of the public records shall be
 151 deemed the custodian of the records for purposes of compliance with this chapter, and shall retrieve and
 152 supply such records to the requester. Nothing in this subsection shall be construed to apply to records
 153 transferred to the Library of Virginia for permanent archiving pursuant to the duties imposed by the
 154 Virginia Public Records Act (§ 42.1-76 et seq.). In accordance with § 42.1-79, the Library of Virginia
 155 shall be the custodian of such permanently archived records and shall be responsible for responding to
 156 requests for such records made pursuant to this chapter.

157 **§ 2.2-3704.1. Posting of notice of rights and responsibilities by state and local public bodies;**
 158 **assistance by the Freedom of Information Advisory Council.**

159 A. All state public bodies subject to the provisions of this chapter ~~and~~, any county or city, ~~and~~ any
 160 town with a population of more than 250, *and any school board* shall make available the following
 161 information to the public upon request and shall post a link to such information on the homepage of
 162 their respective *official* public government websites:

163 1. A plain English explanation of the rights of a requester under this chapter, the procedures to
 164 obtain public records from the public body, and the responsibilities of the public body in complying
 165 with this chapter. For purposes of this section, "plain English" means written in nontechnical, readily
 166 understandable language using words of common everyday usage and avoiding legal terms and phrases
 167 or other terms and words of art whose usage or special meaning primarily is limited to a particular field
 168 or profession;

169 2. Contact information for the FOIA officer designated by the public body pursuant to § 2.2-3704.2
 170 to (i) assist a requester in making a request for records or (ii) respond to requests for public records;

171 3. A general description, summary, list, or index of the types of public records maintained by such
 172 state public body;

173 4. A general description, summary, list, or index of any exemptions in law that permit or require
 174 such public records to be withheld from release;

175 5. Any policy the public body has concerning the type of public records it routinely withholds from
 176 release as permitted by this chapter or other law; and

177 6. The following statement: "A public body may make reasonable charges not to exceed its actual
 178 cost incurred in accessing, duplicating, supplying, or searching for the requested records. No public body

179 shall impose any extraneous, intermediary, or surplus fees or expenses to recoup the general costs
 180 associated with creating or maintaining records or transacting the general business of the public body.
 181 Any duplicating fee charged by a public body shall not exceed the actual cost of duplication. All
 182 charges for the supplying of requested records shall be estimated in advance at the request of the citizen
 183 as set forth in subsection F of § 2.2-3704 of the Code of Virginia."

184 B. The Freedom of Information Advisory Council, created pursuant to § 30-178, shall assist in the
 185 development and implementation of the provisions of subsection A, upon request.

186 **§ 2.2-3704.2. Public bodies to designate FOIA officer.**

187 A. All state public bodies, including state authorities, that are subject to the provisions of this chapter
 188 and all local public bodies that are subject to the provisions of this chapter, shall designate and publicly
 189 identify one or more Freedom of Information Act officers (FOIA officer) whose responsibility is to
 190 serve as a point of contact for members of the public in requesting public records and to coordinate the
 191 public body's compliance with the provisions of this chapter.

192 B. For such state public bodies, the name and contact information of the public body's FOIA officer
 193 to whom members of the public may direct requests for public records and who will oversee the public
 194 body's compliance with the provisions of this chapter shall be made available to the public upon request
 195 and be posted on the respective public body's *official public government* website at the time of
 196 designation and maintained thereafter on such website for the duration of the designation.

197 C. For such local public bodies, the name and contact information of the public body's FOIA officer
 198 to whom members of the public may direct requests for public records and who will oversee the public
 199 body's compliance with the provisions of this chapter shall be made available in a way reasonably
 200 calculated to provide notice to the public, including posting at the public body's place of business,
 201 posting on its *official public government* website, or including such information in its publications.

202 D. For the purposes of this section, local public bodies shall include constitutional officers.

203 E. Any such FOIA officer shall possess specific knowledge of the provisions of this chapter and be
 204 trained at least annually by legal counsel for the public body or the Virginia Freedom of Information
 205 Advisory Council.

206 **§ 2.2-3705.1. Exclusions to application of chapter; exclusions of general application to public**
 207 **bodies.**

208 The following information contained in a public record is excluded from the mandatory disclosure
 209 provisions of this chapter but may be disclosed by the custodian in his discretion, except where such
 210 disclosure is prohibited by law. Redaction of information excluded under this section from a public
 211 record shall be conducted in accordance with § 2.2-3704.01.

212 1. Personnel information concerning identifiable individuals, except that access shall not be denied to
 213 the person who is the subject thereof. Any person who is the subject of such information and who is 18
 214 years of age or older may waive, in writing, the protections afforded by this subdivision. If the
 215 protections are so waived, such information shall be disclosed. Nothing in this subdivision shall be
 216 construed to authorize the withholding of any resumes or applications submitted by persons who are
 217 appointed by the Governor pursuant to § 2.2-106 or 2.2-107.

218 *No provision of this chapter or any provision of Chapter 38 (§ 2.2-3800 et seq.) shall be construed*
 219 *as denying public access to (i) contracts between a public body and its officers or employees, other than*
 220 *contracts settling public employee employment disputes held confidential as personnel records under*
 221 *§ 2.2-3705.1; (ii) records of the name, position, job classification, official salary, or rate of pay of, and*
 222 *records of the allowances or reimbursements for expenses paid to, any officer, official, or employee of a*
 223 *public body; or (iii) the compensation or benefits paid by any corporation organized by the Virginia*
 224 *Retirement System or its officers or employees. The provisions of this subdivision, however, shall not*
 225 *require public access to records of the official salaries or rates of pay of public employees whose*
 226 *annual rate of pay is \$10,000 or less.*

227 2. Written advice of legal counsel to state, regional or local public bodies or the officers or
 228 employees of such public bodies, and any other information protected by the attorney-client privilege.

229 3. Legal memoranda and other work product compiled specifically for use in litigation or for use in
 230 an active administrative investigation concerning a matter that is properly the subject of a closed
 231 meeting under § 2.2-3711.

232 4. Any test or examination used, administered or prepared by any public body for purposes of
 233 evaluation of (i) any student or any student's performance, (ii) any employee or employment seeker's
 234 qualifications or aptitude for employment, retention, or promotion, or (iii) qualifications for any license
 235 or certificate issued by a public body.

236 As used in this subdivision, "test or examination" shall include (a) any scoring key for any such test
 237 or examination and (b) any other document that would jeopardize the security of the test or examination.
 238 Nothing contained in this subdivision shall prohibit the release of test scores or results as provided by
 239 law, or limit access to individual records as provided by law. However, the subject of such employment

240 tests shall be entitled to review and inspect all records relative to his performance on such employment
241 tests.

242 When, in the reasonable opinion of such public body, any such test or examination no longer has any
243 potential for future use, and the security of future tests or examinations will not be jeopardized, the test
244 or examination shall be made available to the public. However, minimum competency tests administered
245 to public school children shall be made available to the public contemporaneously with statewide release
246 of the scores of those taking such tests, but in no event shall such tests be made available to the public
247 later than six months after the administration of such tests.

248 5. Records recorded in or compiled exclusively for use in closed meetings lawfully held pursuant to
249 § 2.2-3711. However, no record that is otherwise open to inspection under this chapter shall be deemed
250 exempt by virtue of the fact that it has been reviewed or discussed in a closed meeting.

251 6. Vendor proprietary information software that may be in the public records of a public body. For
252 the purpose of this subdivision, "vendor proprietary information software" means computer programs
253 acquired from a vendor for purposes of processing data for agencies or political subdivisions of the
254 Commonwealth.

255 7. Computer software developed by or for a state agency, state-supported institution of higher
256 education or political subdivision of the Commonwealth.

257 8. Appraisals and cost estimates of real property subject to a proposed purchase, sale, or lease, prior
258 to the completion of such purchase, sale, or lease.

259 9. Information concerning reserves established in specific claims administered by the Department of
260 the Treasury through its Division of Risk Management as provided in Article 5 (§ 2.2-1832 et seq.) of
261 Chapter 18, or by any county, city, or town; and investigative notes, correspondence and information
262 furnished in confidence with respect to an investigation of a claim or a potential claim against a public
263 body's insurance policy or self-insurance plan. However, nothing in this subdivision shall ~~authorize the~~
264 ~~withholding~~ *prevent the disclosure* of information taken from inactive reports upon expiration of the
265 period of limitations for the filing of a civil suit.

266 10. Personal ~~contact~~ information; ~~as defined in § 2.2-3801, including electronic mail addresses,~~
267 furnished to a public body for the purpose of receiving electronic mail from the public body, provided
268 that the electronic mail recipient has requested that the public body not disclose such information.
269 However, access shall not be denied to the person who is the subject of the record. *As used in this*
270 *subdivision, "personal contact information" means the information provided to the public body for the*
271 *purpose of receiving electronic mail from the public body and includes home or business (i) address, (ii)*
272 *email address, or (iii) telephone number or comparable number assigned to any other electronic*
273 *communication device.*

274 11. Communications and materials required to be kept confidential pursuant to § 2.2-4119 of the
275 Virginia Administrative Dispute Resolution Act (§ 2.2-4115 et seq.).

276 12. Information relating to the negotiation and award of a specific contract where competition or
277 bargaining is involved and where the release of such information would adversely affect the bargaining
278 position or negotiating strategy of the public body. Such information shall not be withheld after the
279 public body has made a decision to award or not to award the contract. In the case of procurement
280 transactions conducted pursuant to the Virginia Public Procurement Act (§ 2.2-4300 et seq.), the
281 provisions of this subdivision shall not apply, and any release of information relating to such
282 transactions shall be governed by the Virginia Public Procurement Act.

283 13. Account numbers or routing information for any credit card, debit card, or other account with a
284 financial institution of any person or public body. However, access shall not be denied to the person
285 who is the subject of the information. For the purposes of this subdivision, "financial institution" means
286 any organization authorized to do business under state or federal laws relating to financial institutions,
287 including, without limitation, banks and trust companies, savings banks, savings and loan companies or
288 associations, and credit unions.

289 **§ 2.2-3705.2. Exclusions to application of chapter; records relating to public safety.**

290 The following information contained in a public record is excluded from the mandatory disclosure
291 provisions of this chapter but may be disclosed by the custodian in his discretion, except where such
292 disclosure is prohibited by law. Redaction of information excluded under this section from a public
293 record shall be conducted in accordance with § 2.2-3704.01.

294 1. Confidential information, including victim identity, provided to or obtained by staff in a rape crisis
295 center or a program for battered spouses.

296 2. ~~Information contained in engineering and construction drawings and plans submitted for the sole~~
297 ~~purpose of complying with the Building Code in obtaining a building permit if disclosure of such~~
298 ~~information would identify specific trade secrets or other information that would be harmful to the~~
299 ~~competitive position of the owner or lessee. However, such information shall be exempt only until the~~
300 ~~building is completed. Information relating to the safety or environmental soundness of any building~~

301 shall not be exempt from disclosure.

302 Information contained in engineering and construction drawings and plans that reveal critical
 303 structural components, security equipment and systems, ventilation systems, fire protection equipment,
 304 mandatory building emergency equipment or systems, elevators, electrical systems, telecommunications
 305 equipment and systems, and other utility equipment and systems submitted for the purpose of complying
 306 with the Uniform Statewide Building Code (§ 36-97 et seq.) or the Statewide Fire Prevention Code
 307 (§ 27-94 et seq.) if disclosure of such information would jeopardize the safety or security of any public
 308 or private commercial office, multifamily residential, or retail building or its occupants in the event of
 309 terrorism or other threat to public safety. In order for the information to be excluded from mandatory
 310 disclosure, the owner or lessee of such property, equipment, or system in writing shall (i) invoke the
 311 protections of this paragraph; (ii) identify the drawings, plans, or other materials to be protected; and
 312 (iii) state the reasons why protection is necessary.

313 Nothing in this subdivision shall authorize the withholding of information relating to any building in
 314 connection with an inquiry into the performance of that building after it has been subjected to fire,
 315 explosion, natural disaster, or other catastrophic event.

316 3. Information that describes the design, function, operation, or access control features of any
 317 security system, whether manual or automated, which is used to control access to or use of any
 318 automated data processing or telecommunications system.

319 4. Information concerning the prevention or response to terrorist activity or cyber attacks, including
 320 (i) critical infrastructure information; (ii) vulnerability assessments, operational, procedural,
 321 transportation, and tactical planning or training manuals, and staff meeting minutes; (iii) engineering or
 322 architectural plans or drawings, or information derived from such plans or drawings; and (iv)
 323 information not lawfully available to the public regarding specific cybersecurity threats or vulnerabilities
 324 or security plans and measures of an entity, facility, building, structure, information technology system,
 325 or software program if disclosure of such information would (a) reveal the location or operation of
 326 security equipment and systems, elevators, ventilation, fire protection, emergency, electrical,
 327 telecommunications or utility equipment and systems of any public building, structure or information
 328 storage facility, or telecommunications or utility equipment or systems or (b) jeopardize the safety of
 329 any person.

330 The same categories of information concerning any person or entity submitted to a public body for
 331 the purpose of antiterrorism response planning or cybersecurity planning or protection may be withheld
 332 from disclosure if such person or entity in writing (1) invokes the protections of this subdivision, (2)
 333 identifies with specificity the information for which protection is sought, and (3) states with reasonable
 334 particularity why the protection of such information from public disclosure is necessary to meet the
 335 objective of antiterrorism, cybersecurity planning or protection, or critical infrastructure information
 336 security and resilience. Such statement shall be a public record and shall be disclosed upon request.

337 Any public body receiving a request for records excluded under this subdivision shall notify the
 338 Secretary of Public Safety and Homeland Security or his designee of such request and the response
 339 made by the public body in accordance with § 2.2-3704.

340 Nothing in this subdivision shall be construed to authorize the withholding of information relating to

661 8. Information held by a threat assessment team established by a local school board pursuant to
 662 § 22.1-79.4 or by a public institution of higher education pursuant to § 23.1-805 relating to the
 663 assessment or intervention with a specific individual. However, in the event an individual who has been

667 available as provided by this chapter, with the exception of any criminal history records obtained

 669 records as defined in § 22.1-289. The public body providing such information shall remove personally
 670 identifying information of any person who provided information to the threat assessment team under a
 671 promise of confidentiality.

 680 facility, the administrator or chief medical officer of such facility may assert such confined person's right
 681 of access to the health records if the administrator or chief medical officer has reasonable cause to
 682 believe that such confined person has an infectious disease or other medical condition from which other
 683 persons so confined need to be protected. Health records shall only be reviewed and shall not be copied
 684 by such administrator or chief medical officer. The information in the health records of a person so
 685 confined shall continue to be confidential and shall not be disclosed by the administrator or chief
 686 medical officer of the facility to any person except the subject or except as provided by law.

687 Where the person who is the subject of health records is under the age of 18, his right of access may

789 confidentiality from a public body, used by the public body for business, trade, and tourism
 790 development or retention; and memoranda, working papers, or other information related to businesses
 791 that are considering locating or expanding in Virginia, prepared by a public body, where competition or
 792 bargaining is involved and where disclosure of such information would adversely affect the financial
 793 interest of the public body.

 907 (ii) be harmful to the competitive position of the applicant.

1011 In order for the information specified in this subdivision to be excluded from the provisions of this
1012 chapter, the public-use airport shall make a written request to the Department of Aviation:

1013 a. Invoking such exclusion upon submission of the data or other materials for which protection from
1014 disclosure is sought;

1015 b. Identifying with specificity the data or other materials for which protection is sought; and

1016 c. Stating the reasons why protection is necessary.

1017 28. Records submitted as a grant or loan application, or accompanying a grant or loan application,
1018 for an award from the Virginia Research Investment Fund pursuant to Article 8 (§ 23.1-3130 et seq.) of
1019 Chapter 31 of Title 23.1, to the extent that such records contain proprietary business or research-related
1020 information produced or collected by the applicant in the conduct of or as a result of study or research
1021 on medical, rehabilitative, scientific, technical, technological, or scholarly issues, when such information
1022 has not been publicly released, published, copyrighted, or patented, if the disclosure of such information
1023 would be harmful to the competitive position of the applicant.

1024 29. *Information contained in engineering and construction drawings and plans submitted for the sole

 1045 *not otherwise subject to an exclusion under this chapter or other provision of law that has been*
 1046 *aggregated, combined, or changed in format but does not contain a material revision to such*
 1047 *information shall not be deemed working papers.* Nothing in this subdivision shall be construed to
 1048 authorize the withholding of any resumes or applications submitted by persons who are appointed by the

1050 As used in this subdivision:

1051 "Members of the General Assembly" means each member of the Senate of Virginia and the House of
 1052 Delegates and their legislative aides when working on behalf of such member.

1070 7. Customer account information of a public utility affiliated with a political subdivision of the
 1071 Commonwealth, including the customer's name and service address, but excluding the amount of utility
 1072 service provided and the amount of money *charged or* paid for such utility service.

1073 8. Personal information, as defined in § 2.2-3801, (i) filed with the Virginia Housing Development
 1074 Authority concerning individuals who have applied for or received loans or other housing assistance or
 1075 who have applied for occupancy of or have occupied housing financed, owned or otherwise assisted by
 1076 the Virginia Housing Development Authority; (ii) concerning persons participating in or persons on the
 1077 waiting list for federally funded rent-assistance programs; (iii) filed with any local redevelopment and
 1078 housing authority created pursuant to § 36-4 concerning persons participating in or persons on the
 1079 waiting list for housing assistance programs funded by local governments or by any such authority; or

 1304 be present during the taking of testimony or presentation of evidence at a closed meeting, if such
 1305 student, parents, or guardians so request in writing and such request is submitted to the presiding officer
 1306 of the appropriate board.

1307 3. Discussion or consideration of the acquisition of real property for a public purpose, or of the
 1308 disposition of publicly held real property, where discussion in an open meeting would adversely affect
 1309 the bargaining position or negotiating strategy of the public body.

1310 4. The protection of the privacy of individuals in personal matters not related to public business.

1311 5. Discussion concerning a prospective business or industry or the expansion of an existing business
 1312 or industry where no previous announcement has been made of the business' or industry's interest in
 1313 locating or expanding its facilities in the community.

1314 6. Discussion or consideration of the investment of public funds where competition or bargaining is
 1315 involved, where, if made public initially, the financial interest of the governmental unit would be
 1316 adversely affected.

1317 7. Consultation with legal counsel and briefings by staff members or consultants pertaining to actual
 1318 or probable litigation, where such consultation or briefing in open meeting would adversely affect the
 1319 negotiating or litigating posture of the public body; and consultation with legal counsel employed or
 1320 retained by a public body regarding specific legal matters requiring the provision of legal advice by such
 1321 counsel. For the purposes of this subdivision, "probable litigation" means litigation that has been
 1322 specifically threatened or on which the public body or its legal counsel has a reasonable basis to believe
 1323 will be commenced by or against a known party. Nothing in this subdivision shall be construed to
 1324 permit the closure of a meeting merely because an attorney representing the public body is in attendance
 1325 or is consulted on a matter.

1326 8. In the case of boards of visitors of public institutions of higher education, discussion or
 1327 consideration of matters relating to gifts, bequests and fund-raising activities, and grants and contracts
 1328 for services or work to be performed by such institution. However, the terms and conditions of any such
 1329 gifts, bequests, grants, and contracts made by a foreign government, a foreign legal entity, or a foreign
 1330 person and accepted by a public institution of higher education in Virginia shall be subject to public
 1331 disclosure upon written request to the appropriate board of visitors. For the purpose of this subdivision,
 1332 (i) "foreign government" means any government other than the United States government or the
 1333 government of a state or a political subdivision thereof; (ii) "foreign legal entity" means any legal entity
 1334 created under the laws of the United States or of any state thereof if a majority of the ownership of the
 1335 stock of such legal entity is owned by foreign governments or foreign persons or if a majority of the
 1336 membership of any such entity is composed of foreign persons or foreign legal entities, or any legal
 1337 entity created under the laws of a foreign government; and (iii) "foreign person" means any individual

- 1338 who is not a citizen or national of the United States or a trust territory or protectorate thereof.
- 1339 9. In the case of the boards of trustees of the Virginia Museum of Fine Arts, the Virginia Museum
- 1340 of Natural History, the Jamestown-Yorktown Foundation, and The Science Museum of Virginia,
- 1341 discussion or consideration of matters relating to specific gifts, bequests, and grants.
- 1342 10. Discussion or consideration of honorary degrees or special awards.
- 1343 11. Discussion or consideration of tests, examinations, or other information excluded from this
- 1344 chapter pursuant to subdivision 4 of § 2.2-3705.1.
- 1345 12. Discussion, consideration, or review by the appropriate House or Senate committees of possible
- 1346 disciplinary action against a member arising out of the possible inadequacy of the disclosure statement
- 1347 filed by the member, provided the member may request in writing that the committee meeting not be
- 1348 conducted in a closed meeting.
- 1349 13. Discussion of strategy with respect to the negotiation of a hazardous waste siting agreement or to
- 1350 consider the terms, conditions, and provisions of a hazardous waste siting agreement if the governing
- 1351 body in open meeting finds that an open meeting will have an adverse effect upon the negotiating
- 1352 position of the governing body or the establishment of the terms, conditions and provisions of the siting
- 1353 agreement, or both. All discussions with the applicant or its representatives may be conducted in a
- 1354 closed meeting.
- 1355 14. Discussion by the Governor and any economic advisory board reviewing forecasts of economic
- 1356 activity and estimating general and nongeneral fund revenues.
- 1357 15. Discussion or consideration of medical and mental health records excluded from this chapter
- 1358 pursuant to subdivision 1 of § 2.2-3705.5.
- 1359 16. Deliberations of the Virginia Lottery Board in a licensing appeal action conducted pursuant to
- 1360 subsection D of § 58.1-4007 regarding the denial or revocation of a license of a lottery sales agent; and
- 1361 discussion, consideration or review of Virginia Lottery matters related to proprietary lottery game
- 1362 information and studies or investigations exempted from disclosure under subdivision 6 of § 2.2-3705.3
- 1363 and subdivision 11 of § 2.2-3705.7.
- 1364 17. Those portions of meetings by local government crime commissions where the identity of, or
- 1365 information tending to identify, individuals providing information about crimes or criminal activities
- 1366 under a promise of anonymity is discussed or disclosed.
- 1367 18. Those portions of meetings in which the Board of Corrections discusses or discloses the identity
- 1368 of, or information tending to identify, any prisoner who (i) provides information about crimes or
- 1369 criminal activities, (ii) renders assistance in preventing the escape of another prisoner or in the
- 1370 apprehension of an escaped prisoner, or (iii) voluntarily or at the instance of a prison official renders
- 1371 other extraordinary services, the disclosure of which is likely to jeopardize the prisoner's life or safety.
- 1372 19. Discussion of plans to protect public safety as it relates to terrorist activity or specific
- 1373 cybersecurity threats or vulnerabilities and briefings by staff members, legal counsel, or law-enforcement
- 1374 or emergency service officials concerning actions taken to respond to such matters or a related threat to
- 1375 public safety; discussion of information excluded from this chapter pursuant to subdivision 3 of § 2.2-3705.2, or
- 1376 14 of § 2.2-3705.2, where discussion in an open meeting would jeopardize the safety of any person or
- 1377 the security of any facility, building, structure, information technology system, or software program; or

1416 Medical School, as the case may be.

1417 23. In the case of the Virginia Commonwealth University Health System Authority, discussion or
1418 consideration of any of the following: the acquisition or disposition of real or personal property where
1419 disclosure would adversely affect the bargaining position or negotiating strategy of the Authority;
1420 operational plans that could affect the value of such property, real or personal, owned or desirable for
1421 ownership by the Authority; matters relating to gifts, bequests and fund-raising activities; grants and
1422 contracts for services or work to be performed by the Authority; marketing or operational strategies
1423 where disclosure of such strategies would adversely affect the competitive position of the Authority;
1424 members of its medical and teaching staffs and qualifications for appointments thereto; and qualifications
1425 or evaluations of other employees. This exclusion shall also apply when the foregoing discussions occur
1426 at a meeting of the Virginia Commonwealth University Board of Visitors.

1434 of Title 23.1 is discussed.

1435 26. Discussion or consideration, by the Wireless Carrier E-911 Cost Recovery Subcommittee created
1436 pursuant to § 56-484.15, of trade secrets, as defined in the Uniform Trade Secrets Act (§ 59.1-336 et
1437 seq.), submitted by CMRS providers as defined in § 56-484.12, related to the provision of wireless

 1540 2.2-3708, 2.2-3708.1, 2.2-3710, 2.2-3711 or 2.2-3712, the court, if it finds that a violation was willfully
 1541 and knowingly made, shall impose upon such officer, employee, or member in his individual capacity,
 1542 whether a writ of mandamus or injunctive relief is awarded or not, a civil penalty of not less than \$500
 1543 nor more than \$2,000, which amount shall be paid into the State Literary Fund. For a second or
 1544 subsequent violation, such civil penalty shall be not less than \$2,000 nor more than \$5,000.

1545 **§ 2.2-3806. Rights of data subjects.**

1546 A. Any agency maintaining personal information shall:

1547 1. Inform an individual who is asked to supply personal information about himself whether he is
 1548 legally required, or may refuse, to supply the information requested, and also of any specific
 1549 consequences that are known to the agency of providing or not providing the information.

1550 2. Give notice to a data subject of the possible dissemination of part or all of this information to
 1551 another agency, nongovernmental organization or system not having regular access authority, and
 1552 indicate the use for which it is intended, and the specific consequences for the individual, which are
 1553 known to the agency, of providing or not providing the information. However documented permission
 1554 for dissemination in the hands of the other agency or organization shall satisfy the requirement of this
 1555 subdivision. The notice may be given on applications or other data collection forms prepared by data
 1556 subjects.

1557 3. Upon request and proper identification of any data subject, or of his authorized agent, grant the
 1558 data subject or agent the right to inspect, in a form comprehensible to him:

1559 a. All personal information about that data subject except as provided in subdivision 1 of
 1560 § 2.2-3705.1, subdivision 1 of § 2.2-3705.4, and subdivision 1 of § 2.2-3705.5.

1561 b. The nature of the sources of the information.

1562 c. The names of recipients, other than those with regular access authority, of personal information
 1563 about the data subject including the identity of all persons and organizations involved and their
 1564 relationship to the system when not having regular access authority, except that if the recipient has
 1565 obtained the information as part of an ongoing criminal investigation such that disclosure of the
 1566 investigation would jeopardize law-enforcement action, then no disclosure of such access shall be made
 1567 to the data subject.

1568 4. Comply with the following minimum conditions of disclosure to data subjects:

1569 a. An agency shall make disclosures to data subjects required under this chapter, during normal
 1570 business hours, in accordance with the procedures set forth in subsections B and C of § 2.2-3704 for
 1571 responding to requests under the Virginia Freedom of Information Act (§ 2.2-3700 et seq.) or within a
 1572 time period as may be mutually agreed upon by the agency and the data subject.

1573 b. The disclosures to data subjects required under this chapter shall be made (i) in person, if he
 1574 appears in person and furnishes proper identification, or (ii) by mail, if he has made a written request,
 1575 with proper identification. Copies of the documents containing the personal information sought by a data
 1576 subject shall be furnished to him or his representative at reasonable charges for document search and
 1577 duplication in accordance with subsection F of § 2.2-3704.

1578 c. The data subject shall be permitted to be accompanied by a person of his choosing, who shall
 1579 furnish reasonable identification. An agency may require the data subject to furnish a written statement
 1580 granting the agency permission to discuss the individual's file in such person's presence.

1581 5. If the data subject gives notice that he wishes to challenge, correct, or explain information about

1582 him in the information system, the following minimum procedures shall be followed:

1583 a. The agency maintaining the information system shall investigate, and record the current status of
1584 that personal information.

1585 b. If, after such investigation, the information is found to be incomplete, inaccurate, not pertinent, not
1586 timely, or not necessary to be retained, it shall be promptly corrected or purged.

1587 c. If the investigation does not resolve the dispute, the data subject may file a statement of not more
1588 than 200 words setting forth his position.

1589 d. Whenever a statement of dispute is filed, the agency maintaining the information system shall
1590 supply any previous recipient with a copy of the statement and, in any subsequent dissemination or use
1591 of the information in question, clearly note that it is disputed and supply the statement of the data
1592 subject along with the information.

1593 e. The agency maintaining the information system shall clearly and conspicuously disclose to the data
1594 subject his rights to make such a request.

1595 f. Following any correction or purging of personal information the agency shall furnish to past
1596 recipients notification that the item has been purged or corrected whose receipt shall be acknowledged.

1597 B. Nothing in this chapter shall be construed to require an agency to disseminate any
1598 recommendation or letter of reference from or to a third party that is a part of the personnel file of any
1599 data subject nor to disseminate any test or examination used, administered or prepared by any public
1600 body for purposes of evaluation of (i) any student or any student's performance, (ii) any seeker's
1601 qualifications or aptitude for employment, retention, or promotion, or (iii) qualifications for any license
1602 or certificate issued by any public body.

1603 As used in this subsection, "test or examination" includes (i) any scoring key for any such test or
1604 examination and (ii) any other document that would jeopardize the security of the test or examination.
1605 Nothing contained in this subsection shall prohibit the release of test scores or results as provided by
1606 law, or to limit access to individual records as provided by law; however, the subject of the employment
1607 tests shall be entitled to review and inspect all documents relative to his performance on those
1608 employment tests.

1609 When, in the reasonable opinion of the public body, any such test or examination no longer has any
1610 potential for future use, and the security of future tests or examinations will not be jeopardized, the test
1611 or examination shall be made available to the public. Minimum competency tests administered to public
1612 school children shall be made available to the public contemporaneously with statewide release of the
1613 scores of those taking such tests, but in no event shall such tests be made available to the public later
1614 than six months after the administration of such tests.

1615 C. Neither any provision of this chapter nor any provision of the Freedom of Information Act
1616 (§ 2.2-3700 et seq.) shall be construed to deny public access to records of the position, job classification,
1617 official salary or rate of pay of, and to records of the allowances or reimbursements for expenses paid to
1618 any public officer, official or employee at any level of state, local or regional government in the
1619 Commonwealth. The provisions of this subsection shall not apply to records of the official salaries or
1620 rates of pay of public employees whose annual rate of pay is \$10,000 or less.

1621 D. Nothing in this section or in this chapter shall be construed to require an agency to disseminate
1622 information derived from tax returns in violation of §§ 2.2-3705.7 and prohibited from release pursuant
1623 to § 58.1-3.

1624 **§ 22.1-253.13:3. Standard 3. Accreditation, other standards, assessments, and releases from state**
1625 **regulations.**

1626 A. The Board of Education shall promulgate regulations establishing standards for accreditation
1627 pursuant to the Administrative Process Act (§ 2.2-4000 et seq.), which shall include, but not be limited
1628 to, student outcome measures, requirements and guidelines for instructional programs and for the
1629 integration of educational technology into such instructional programs, administrative and instructional
1630 staffing levels and positions, including staff positions for supporting educational technology, student
1631 services, auxiliary education programs such as library and media services, requirements for graduation
1632 from high school, community relations, and the philosophy, goals, and objectives of public education in
1633 Virginia.

1634 The Board of Education shall promulgate regulations establishing standards for accreditation of
1635 public virtual schools under the authority of the local school board that enroll students full time.

1636 The Board shall review annually the accreditation status of all schools in the Commonwealth. The
1637 Board shall review the accreditation status of a school once every three years if the school has been
1638 fully accredited for three consecutive years. Upon such triennial review, the Board shall review the
1639 accreditation status of the school for each individual year within that triennial review period. If the
1640 Board finds that the school would have been accredited every year of that triennial review period the
1641 Board shall accredit the school for another three years. The Board may review the accreditation status of
1642 any other school once every two years or once every three years, provided that any school that receives

1643 a multiyear accreditation status other than full accreditation shall be covered by a Board-approved
1644 multiyear corrective action plan for the duration of the period of accreditation. Such multiyear corrective
1645 action plan shall include annual written progress updates to the Board. A multiyear accreditation status
1646 shall not relieve any school or division of annual reporting requirements.

1647 Each local school board shall maintain schools that are fully accredited pursuant to the standards for
1648 accreditation as prescribed by the Board of Education. Each local school board shall report the
1649 accreditation status of all schools in the local school division annually in public session. Within the time
1650 specified by the Board of Education, each school board shall submit corrective action plans for any
1651 schools within its school division that have been designated as not meeting the standards as approved by
1652 the Board.

1653 When the Board of Education determines through the school academic review process that the failure
1654 of schools within a division to achieve full accreditation status is related to division-level failure to
1655 implement the Standards of Quality or other division-level action or inaction, the Board may require a
1656 division-level academic review. After the conduct of such review and within the time specified by the
1657 Board of Education, each school board shall submit to the Board for approval a corrective action plan,
1658 consistent with criteria established by the Board setting forth specific actions and a schedule designed to
1659 ensure that schools within its school division achieve full accreditation status. If the Board determines
1660 that the proposed corrective action plan is not sufficient to enable all schools within the division to
1661 achieve full accreditation, the Board may return the plan to the local school board with directions to
1662 submit an amended plan pursuant to Board guidance. Such corrective action plans shall be part of the
1663 relevant school division's comprehensive plan pursuant to § 22.1-253.13:6.

1664 With such funds as are appropriated or otherwise received for this purpose, the Board shall adopt and
1665 implement an academic review process, to be conducted by the Department of Education, to assist
1666 schools that are accredited with warning. The Department shall forward a report of each academic
1667 review to the relevant local school board, and such school board shall report the results of such
1668 academic review and the required annual progress reports in public session. The local school board shall
1669 implement any actions identified through the academic review and utilize them for improvement
1670 planning.

1671 B. The Superintendent of Public Instruction shall develop and the Board of Education shall approve
1672 criteria for determining and recognizing educational performance in the Commonwealth's public school
1673 divisions and schools. Such criteria, when approved, shall become an integral part of the accreditation
1674 process and shall include student outcome measurements. The Superintendent of Public Instruction shall
1675 annually report to the Board on the accreditation status of all school divisions and schools. Such report
1676 shall include an analysis of the strengths and weaknesses of public education programs in the various
1677 school divisions in Virginia and recommendations to the General Assembly for further enhancing student
1678 learning uniformly across the Commonwealth. In recognizing educational performance in the school
1679 divisions, the Board shall include consideration of special school division accomplishments, such as
1680 numbers of dual enrollments and students in Advanced Placement and International Baccalaureate
1681 courses, and participation in academic year Governor's Schools.

1682 The Superintendent of Public Instruction shall assist local school boards in the implementation of
1683 action plans for increasing educational performance in those school divisions and schools that are
1684 identified as not meeting the approved criteria. The Superintendent of Public Instruction shall monitor
1685 the implementation of and report to the Board of Education on the effectiveness of the corrective actions
1686 taken to improve the educational performance in such school divisions and schools.

1687 C. With such funds as are available for this purpose, the Board of Education shall prescribe
1688 assessment methods to determine the level of achievement of the Standards of Learning objectives by all
1689 students. Such assessments shall evaluate knowledge, application of knowledge, critical thinking, and
1690 skills related to the Standards of Learning being assessed. The Board shall, with the assistance of
1691 independent testing experts, conduct a regular analysis and validation process for these assessments. The
1692 Department of Education shall make available to school divisions Standards of Learning assessments
1693 typically administered by the middle and high schools by December 1 of the school year in which such
1694 assessments are to be administered or when newly developed assessments are available, whichever is
1695 later.

1696 The Board shall also provide the option of industry certification and state licensure examinations as a
1697 student-selected credit.

1698 The Board of Education shall make publicly available such assessments in a timely manner and as
1699 soon as practicable following the administration of such tests, so long as the release of such assessments
1700 does not compromise test security or deplete the bank of assessment questions necessary to construct
1701 subsequent tests, or limit the ability to test students on demand and provide immediate results in the
1702 web-based assessment system.

1703 The Board shall include in the student outcome measures that are required by the Standards for

1704 Accreditation end-of-course or end-of-grade assessments for various grade levels and classes, including
 1705 the completion of the alternative assessments implemented by each local school board, in accordance
 1706 with the Standards of Learning. These assessments shall include end-of-course or end-of-grade tests for
 1707 English, mathematics, science, and history and social science and may be integrated to include multiple
 1708 subject areas.

1709 The Board shall prescribe alternative methods of Standards of Learning assessment administration for
 1710 children with disabilities, as that term is defined in § 22.1-213, who meet criteria established by the
 1711 Board to demonstrate achievement of the Standards of Learning. An eligible student's Individual
 1712 Education Program team shall make the final determination as to whether an alternative method of
 1713 administration is appropriate for the student.

1714 The Standards of Learning assessments administered to students in grades three through eight shall
 1715 not exceed (a) reading and mathematics in grades three and four; (b) reading, mathematics, and science
 1716 in grade five; (c) reading and mathematics in grades six and seven; (d) reading, writing, and
 1717 mathematics in grade eight; (e) science after the student receives instruction in the grade six science, life
 1718 science, and physical science Standards of Learning and before the student completes grade eight; and
 1719 (f) Virginia Studies and Civics and Economics once each at the grade levels deemed appropriate by each
 1720 local school board.

1721 Each school board shall annually certify that it has provided instruction and administered an
 1722 alternative assessment, consistent with Board guidelines, to students in grades three through eight in
 1723 each Standards of Learning subject area in which a Standards of Learning assessment was not
 1724 administered during the school year. Such guidelines shall (1) incorporate options for age-appropriate,
 1725 authentic performance assessments and portfolios with rubrics and other methodologies designed to
 1726 ensure that students are making adequate academic progress in the subject area and that the Standards of
 1727 Learning content is being taught; (2) permit and encourage integrated assessments that include multiple
 1728 subject areas; and (3) emphasize collaboration between teachers to administer and substantiate the
 1729 assessments and the professional development of teachers to enable them to make the best use of
 1730 alternative assessments.

1731 Local school divisions shall provide targeted mathematics remediation and intervention to students in
 1732 grades six through eight who show computational deficiencies as demonstrated by their individual
 1733 performance on any diagnostic test or grade-level Standards of Learning mathematics test that measures
 1734 non-calculator computational skills.

1735 The Department of Education shall award recovery credit to any student in grades three through eight
 1736 who fails a Standards of Learning assessment in English reading or mathematics, receives remediation,
 1737 and subsequently retakes and passes such an assessment, including any such student who subsequently
 1738 retakes such an assessment on an expedited basis.

1739 In addition, to assess the educational progress of students, the Board of Education shall (A) develop
 1740 appropriate assessments, which may include criterion-referenced tests and other assessment instruments
 1741 that may be used by classroom teachers; (B) select appropriate industry certification and state licensure
 1742 examinations; and (C) prescribe and provide measures, which may include nationally normed tests to be
 1743 used to identify students who score in the bottom quartile at selected grade levels. An annual
 1744 justification that includes evidence that the student meets the participation criteria defined by the
 1745 Virginia Department of Education shall be provided for each student considered for the Virginia Grade
 1746 Level Alternative. Each Individual Education Program team shall review such justification and make the
 1747 final determination as to whether or not the Virginia Grade Level Alternative is appropriate for the
 1748 student. The superintendent and the school board chairman shall certify to the Board of Education, as a
 1749 part of certifying compliance with the Standards of Quality, that there is a justification in the Individual
 1750 Education Program for every student who takes the Virginia Grade Level Alternative. Compliance with
 1751 this requirement shall be monitored as a part of the special education monitoring process conducted by
 1752 the Department of Education. The Board shall report to the Governor and General Assembly in its
 1753 annual reports pursuant to § 22.1-18 any school division that is not in compliance with this requirement.

1754 The Standards of Learning requirements, including all related assessments, shall be waived for any
 1755 student awarded a scholarship under the Brown v. Board of Education Scholarship Program, pursuant to
 1756 § 30-231.2, who is enrolled in a preparation program for a high school equivalency examination
 1757 approved by the Board of Education or in an adult basic education program or an adult secondary
 1758 education program to obtain the high school diploma or a high school equivalency certificate.

1759 The Department of Education shall develop processes for informing school divisions of changes in
 1760 the Standards of Learning.

1761 The Board of Education may adopt special provisions related to the administration and use of any
 1762 Standards of Learning test or tests in a content area as applied to accreditation ratings for any period
 1763 during which the Standards of Learning content or assessments in that area are being revised and phased
 1764 in. Prior to statewide administration of such tests, the Board of Education shall provide notice to local

1765 school boards regarding such special provisions.

1766 The Board of Education shall not include in its calculation of the passage rate of a Standards of
1767 Learning assessment for the purposes of state accountability any student whose parent has decided to not
1768 have his child take such Standards of Learning assessment, unless such exclusions would result in the
1769 school's not meeting any required state or federal participation rate.

1770 D. The Board of Education may pursue all available civil remedies pursuant to § 22.1-19.1 or
1771 administrative action pursuant to § 22.1-292.1 for breaches in test security and unauthorized alteration of
1772 test materials or test results.

1773 The Board may initiate or cause to be initiated a review or investigation of any alleged breach in
1774 security, unauthorized alteration, or improper administration of tests, including the exclusion of students
1775 from testing who are required to be assessed, by local school board employees responsible for the
1776 distribution or administration of the tests.

1777 Records and other information furnished to or prepared by the Board during the conduct of a review
1778 or investigation may be withheld pursuant to subdivision ~~10~~ of § 2.2-3705.3. However, this section
1779 shall not prohibit the disclosure of records to (i) a local school board or division superintendent for the
1780 purpose of permitting such board or superintendent to consider or to take personnel action with regard to
1781 an employee or (ii) any requester, after the conclusion of a review or investigation, in a form that (a)
1782 does not reveal the identity of any person making a complaint or supplying information to the Board on
1783 a confidential basis and (b) does not compromise the security of any test mandated by the Board. Any
1784 local school board or division superintendent receiving such records or other information shall, upon
1785 taking personnel action against a relevant employee, place copies of such records or information relating
1786 to the specific employee in such person's personnel file.

1787 Notwithstanding any other provision of state law, no test or examination authorized by this section,
1788 including the Standards of Learning assessments, shall be released or required to be released as
1789 minimum competency tests, if, in the judgment of the Board, such release would breach the security of
1790 such test or examination or deplete the bank of questions necessary to construct future secure tests.

1791 E. With such funds as may be appropriated, the Board of Education may provide, through an
1792 agreement with vendors having the technical capacity and expertise to provide computerized tests and
1793 assessments, and test construction, analysis, and security, for (i) web-based computerized tests and
1794 assessments, including computer-adaptive Standards of Learning assessments, for the evaluation of
1795 student progress during and after remediation and (ii) the development of a remediation item bank
1796 directly related to the Standards of Learning.

1797 F. To assess the educational progress of students as individuals and as groups, each local school
1798 board shall require the use of Standards of Learning assessments, alternative assessments, and other
1799 relevant data, such as industry certification and state licensure examinations, to evaluate student progress
1800 and to determine educational performance. Each local school shall require the administration of
1801 appropriate assessments to students, which may include criterion-referenced tests and teacher-made tests
1802 and shall include the Standards of Learning assessments, the local school board's alternative assessments,
1803 and the National Assessment of Educational Progress state-by-state assessment. Each school board shall
1804 analyze and report annually, in compliance with any criteria that may be established by the Board of
1805 Education, the results from the Stanford Achievement Test Series, Ninth Edition (Stanford Nine)
1806 assessment, if administered, industry certification examinations, and the Standards of Learning
1807 Assessments to the public.

1808 The Board of Education shall not require administration of the Stanford Achievement Test Series,
1809 Ninth Edition (Stanford Nine) assessment, except as may be selected to facilitate compliance with the
1810 requirements for home instruction pursuant to § 22.1-254.1.

1811 The Board shall include requirements for the reporting of the Standards of Learning assessment
1812 scores and averages for each year, regardless of accreditation frequency, as part of the Board's
1813 requirements relating to the School Performance Report Card. Such scores shall be disaggregated for
1814 each school by student subgroups on the Virginia assessment program as appropriate and shall be
1815 reported to the public within three months of their receipt. These reports (i) shall be posted on the
1816 portion of the Department of Education's website relating to the School Performance Report Card, in a
1817 format and in a manner that allows year-to-year comparisons, and (ii) may include the National
1818 Assessment of Educational Progress state-by-state assessment.

1819 G. Each local school division superintendent shall regularly review the division's submission of data
1820 and reports required by state and federal law and regulations to ensure that all information is accurate
1821 and submitted in a timely fashion. The Superintendent of Public Instruction shall provide a list of the
1822 required reports and data to division superintendents annually. The status of compliance with this
1823 requirement shall be included in the Board of Education's annual report to the Governor and the General
1824 Assembly as required by § 22.1-18.

1825 H. Any school board may request the Board of Education for release from state regulations or, on

1826 behalf of one or more of its schools, for approval of an Individual School Accreditation Plan for the
 1827 evaluation of the performance of one or more of its schools as authorized for certain other schools by
 1828 the Standards of Accreditation pursuant to 8VAC20-131-280 C of the Virginia Administrative Code.
 1829 Waivers of regulatory requirements may be granted by the Board of Education based on submission of a
 1830 request from the division superintendent and chairman of the local school board. The Board of
 1831 Education may grant, for a period up to five years, a waiver of regulatory requirements that are not (i)
 1832 mandated by state or federal law or (ii) designed to promote health or safety. The school board shall
 1833 provide in its waiver request a description of how the releases from state regulations are designed to
 1834 increase the quality of instruction and improve the achievement of students in the affected school or
 1835 schools. The Department of Education shall provide (a) guidance to any local school division that
 1836 requests releases from state regulations and (b) information about opportunities to form partnerships with
 1837 other agencies or entities to any local school division in which the school or schools granted releases
 1838 from state regulations have demonstrated improvement in the quality of instruction and the achievement
 1839 of students.

1840 The Board of Education may also grant local school boards waivers of specific requirements in
 1841 § 22.1-253.13:2, based on submission of a request from the division superintendent and chairman of the
 1842 local school board, permitting the local school board to assign instructional personnel to the schools with
 1843 the greatest needs, so long as the school division employs a sufficient number of personnel divisionwide
 1844 to meet the total number required by § 22.1-253.13:2 and all pupil/teacher ratios and class size
 1845 maximums set forth in subsection C of § 22.1-253.13:2 are met. The school board shall provide in its
 1846 request a description of how the waivers from specific Standards of Quality staffing standards are
 1847 designed to increase the quality of instruction and improve the achievement of students in the affected
 1848 school or schools. The waivers may be renewed in up to five-year increments, or revoked, based on
 1849 student achievement results in the affected school or schools.

1850 **§ 22.1-279.8. School safety audits and school crisis, emergency management, and medical**
 1851 **emergency response plans required.**

1852 A. For the purposes of this section, unless the context requires otherwise:

1853 "School crisis, emergency management, and medical emergency response plan" means the essential
 1854 procedures, operations, and assignments required to prevent, manage, and respond to a critical event or
 1855 emergency, including natural disasters involving fire, flood, tornadoes, or other severe weather; loss or
 1856 disruption of power, water, communications or shelter; bus or other accidents; medical emergencies,
 1857 including cardiac arrest and other life-threatening medical emergencies; student or staff member deaths;
 1858 explosions; bomb threats; gun, knife or other weapons threats; spills or exposures to hazardous
 1859 substances; the presence of unauthorized persons or trespassers; the loss, disappearance or kidnapping of
 1860 a student; hostage situations; violence on school property or at school activities; incidents involving acts
 1861 of terrorism; and other incidents posing a serious threat of harm to students, personnel, or facilities. The
 1862 plan shall include a provision that the Department of Criminal Justice Services and the Virginia Criminal
 1863 Injuries Compensation Fund shall be contacted immediately to deploy assistance in the event of an
 1864 emergency as defined in the emergency response plan when there are victims as defined in § 19.2-11.01.
 1865 The Department of Criminal Justice Services and the Virginia Criminal Injuries Compensation Fund
 1866 shall be the lead coordinating agencies for those individuals determined to be victims, and the plan shall
 1867 also contain current contact information for both agencies.

1868 "School safety audit" means a written assessment of the safety conditions in each public school to (i)
 1869 identify and, if necessary, develop solutions for physical safety concerns, including building security
 1870 issues and (ii) identify and evaluate any patterns of student safety concerns occurring on school property
 1871 or at school-sponsored events. Solutions and responses shall include recommendations for structural
 1872 adjustments, changes in school safety procedures, and revisions to the school board's standards for
 1873 student conduct.

1874 B. The Virginia Center for School and Campus Safety, in consultation with the Department of
 1875 Education, shall develop a list of items to be reviewed and evaluated in the school safety audits required
 1876 by this section. Such items shall include those incidents reported to school authorities pursuant to
 1877 § 22.1-279.3:1 and shall include a school inspection walk-through using a standardized checklist
 1878 provided by the Virginia Center for School and Campus Safety, which shall incorporate crime
 1879 prevention through environmental design principles.

1880 The Virginia Center for School and Campus Safety shall prescribe a standardized report format for
 1881 school safety audits, additional reporting criteria, and procedures for report submission, which may
 1882 include instructions for electronic submission.

1883 Each local school board shall require all schools under its supervisory control to annually conduct
 1884 school safety audits as defined in this section and consistent with such list.

1885 The results of such school safety audits shall be made public within 90 days of completion. The
 1886 local school board shall retain authority to withhold or limit the release of any security plans,

1887 walk-through checklists, and specific vulnerability assessment components as provided in subdivision 7 4
 1888 of § 2.2-3705.2. The completed walk-through checklist shall be made available upon request to the chief
 1889 law-enforcement officer of the locality or his designee. Each school shall maintain a copy of the school
 1890 safety audit, which may exclude such security plans, walk-through checklists, and vulnerability
 1891 assessment components, within the office of the school principal and shall make a copy of such report
 1892 available for review upon written request.

1893 Each school shall submit a copy of its school safety audit to the relevant school division
 1894 superintendent. The division superintendent shall collate and submit all such school safety audits, in the
 1895 prescribed format and manner of submission, to the Virginia Center for School and Campus Safety and
 1896 shall make available upon request to the chief law-enforcement officer of the locality the results of such
 1897 audits.

1898 C. The division superintendent shall establish a school safety audit committee to include, if available,
 1899 representatives of parents, teachers, local law-enforcement, emergency services agencies, local
 1900 community services boards, and judicial and public safety personnel. The school safety audit committee
 1901 shall review the completed school safety audits and submit any plans, as needed, for improving school
 1902 safety to the division superintendent for submission to the local school board.

1903 D. Each school board shall ensure that every school that it supervises shall develop a written school
 1904 crisis, emergency management, and medical emergency response plan, consistent with the definition
 1905 provided in this section, and shall provide copies of such plans to the chief law-enforcement officer, the
 1906 fire chief, the chief of the emergency medical services agency, and the emergency management official
 1907 of the locality. Each school division shall designate an emergency manager. The Department of
 1908 Education and the Virginia Center for School and Campus Safety shall provide technical assistance to
 1909 the school divisions of the Commonwealth in the development of the school crisis, emergency
 1910 management, and medical emergency response plans that describe the components of a medical
 1911 emergency response plan developed in coordination with local emergency medical services providers, the
 1912 training of school personnel and students to respond to a life-threatening emergency, and the equipment
 1913 required for this emergency response. The local school board shall annually review the written school
 1914 crisis, emergency management, and medical emergency response plans. The local school board shall
 1915 have the authority to withhold or limit the review of any security plans and specific vulnerability
 1916 assessment components as provided in subdivision 7 4 of § 2.2-3705.2. The local school division
 1917 superintendent shall certify this review in writing to the Virginia Center for School and Campus Safety
 1918 no later than August 31 of each year.

1919 Upon consultation with local school boards, division superintendents, the Virginia Center for School
 1920 and Campus Safety, and the Coordinator of Emergency Management, the Board of Education shall
 1921 develop, and may revise as it deems necessary, a model school crisis, emergency management, and
 1922 medical emergency response plan for the purpose of assisting the public schools in Virginia in
 1923 developing viable, effective crisis, emergency management, and medical emergency response plans. Such
 1924 model shall set forth recommended effective procedures and means by which parents can contact the
 1925 relevant school or school division regarding the location and safety of their school children and by
 1926 which school officials may contact parents, with parental approval, during a critical event or emergency.

1927 **§ 23.1-2425. Confidential and public information.**

1928 A. The Authority is subject to the provisions of the Freedom of Information Act (§ 2.2-3700 et seq.),
 1929 including the exclusions set forth in subdivision 15 14 of § 2.2-3705.7 and subdivision A 23 of
 1930 § 2.2-3711.

1931 B. For purposes of the Freedom of Information Act (§ 2.2-3700 et seq.), meetings of the board are
 1932 not considered meetings of the board of visitors of the University. Meetings of the board may be
 1933 conducted through telephonic or video means as provided in § 2.2-3708.

1934 **§ 32.1-48.08. Declaration of quarantine.**

1935 A. The State Health Commissioner may declare a quarantine of any person or persons or any
 1936 affected area after he finds that the quarantine is the necessary means to contain a communicable disease
 1937 of public health threat as defined in § 32.1-48.06 to which such person or persons or the people of an
 1938 affected area have been or may have been exposed and thus may become infected.

1939 B. The State Health Commissioner shall record his findings and any information on which he has
 1940 relied in making the finding required for quarantine pursuant to subsection A. The State Health
 1941 Commissioner's record of findings concerning any communicable disease of public health threat shall be
 1942 confidential and shall not be disclosed in accordance with subdivision 17 12 of § 2.2-3705.5.

1943 C. The State Health Commissioner may order the quarantined person or persons to remain in their
 1944 residences, to remain in another place where they are present, or to report to a place or places
 1945 designated by the State Health Commissioner for the duration of their quarantine. An electronic device
 1946 may be used to enforce any such quarantine. The Commissioner's order of quarantine shall be for a
 1947 duration consistent with the known incubation period for such disease or, if the incubation period is

1948 unknown, for a period anticipated as being consistent with the incubation period for other similar
1949 infectious agents.

1950 **§ 32.1-48.011. Isolation may be ordered under certain exceptional circumstances; Commissioner**
1951 **authorized to require hospitalization or other health care.**

1952 A. Whenever the State Health Commissioner makes a determination of exceptional circumstances
1953 pursuant to § 32.1-48.05 and that the isolation procedures set forth in Article 3.01 (§ 32.1-48.01 et seq.)
1954 of this chapter are insufficient control measures to contain a communicable disease of public health
1955 threat, the isolation procedures herein may be invoked.

1956 B. The State Health Commissioner may order the isolation of a person or persons upon a finding that
1957 (i) such person or persons are infected with or may reasonably be suspected to be infected with a
1958 communicable disease of public health threat and (ii) isolation is necessary to protect the public health,
1959 to ensure such isolated person or persons receive appropriate medical treatment, and to protect health
1960 care providers and others who may come into contact with such infected person or persons.

1961 C. The State Health Commissioner shall record his findings and any information on which he has
1962 relied in making the finding required for isolation pursuant to this section. The State Health
1963 Commissioner's record of findings concerning any communicable disease of public health threat that is
1964 involved in an order of isolation shall be confidential and shall not be disclosed in accordance with
1965 subdivision ~~17~~ 12 of § 2.2-3705.5.

1966 D. The Commissioner may order the isolated person or persons to remain in their places of
1967 residence, to remain in another place where they are present, or to report to a place or facility
1968 designated by the Commissioner for the duration of their isolation. An electronic device may be used to
1969 enforce any such isolation. The Commissioner's order of isolation shall be for a duration consistent with
1970 the known course of such communicable disease of public health threat or, if the course of the disease is
1971 unknown or uncertain, for a period consistent with the probable course of the communicable disease of
1972 public health threat.

1973 E. To the extent that persons subject to an order of isolation pursuant to this article require
1974 hospitalization or other health care services, the State Health Commissioner shall be authorized to
1975 require that such services be provided.

1976 F. The State Health Commissioner shall also have the authority to monitor the medical condition of
1977 any person or persons subject to an order of isolation pursuant to this article through regular visits by
1978 public health nurses or such other means as the Commissioner shall determine to be necessary.

1979 **§ 32.1-48.015. Authorization to disclose health records.**

1980 A. The provisions of this article are hereby declared to be necessary to prevent serious harm and
1981 serious threats to the health and safety of individuals and the public in Virginia for purposes of
1982 authorizing the State Health Commissioner or his designee to examine and review any health records of
1983 any person or persons subject to any order of quarantine or order of isolation pursuant to this article and
1984 the regulations of the Department of Health and Human Services promulgated in compliance with the
1985 Health Insurance Portability and Accountability Act of 1996, as amended. The State Health
1986 Commissioner shall authorize any designee in writing to so examine and review any health records of
1987 any person or persons subject to any order of quarantine or order of isolation pursuant to this article.

1988 B. Pursuant to the regulations concerning patient privacy promulgated by the federal Department of
1989 Health and Human Services, covered entities may disclose protected health information to the State
1990 Health Commissioner or his designee without obtaining consent or authorization for such disclosure
1991 from the person who is the subject of the records. Such protected health information shall be used to
1992 facilitate the health care of any person or persons who are subject to an order of quarantine or an order
1993 of isolation. The State Health Commissioner or his designee shall only redisclose such protected health
1994 information in compliance with the aforementioned federal regulations. Further, the protected health
1995 information disclosed to the State Health Commissioner or his designee shall be held confidential and
1996 shall not be disclosed pursuant to the provisions of subdivision ~~17~~ 12 of § 2.2-3705.5.

1997 C. Pursuant to subsection G of § 32.1-116.3, any person requesting or requiring any employee of a
1998 public safety agency as defined in subsection J of § 32.1-45.2 to arrest, transfer, or otherwise exercise
1999 custodial supervision over an individual known to the requesting person (i) to be infected with any
2000 communicable disease or (ii) to be subject to an order of quarantine or an order of isolation pursuant to
2001 Article 3.02 (§ 32.1-48.05 et seq.) of Chapter 2 shall inform such employee of a public safety agency of
2002 the potential risk of exposure to a communicable disease.

2003 **§ 32.1-283.1. State Child Fatality Review Team; membership; access to and maintenance of**
2004 **records; confidentiality; etc.**

2005 A. There is hereby created the State Child Fatality Review Team, referred to in this section as "the
2006 Team," which shall develop and implement procedures to ensure that child deaths occurring in Virginia
2007 are analyzed in a systematic way. The Team shall review (i) violent and unnatural child deaths, (ii)
2008 sudden child deaths occurring within the first 18 months of life, and (iii) those fatalities for which the

2009 cause or manner of death was not determined with reasonable medical certainty. No child death review
 2010 shall be initiated by the Team until conclusion of any law-enforcement investigation or criminal
 2011 prosecution. The Team shall (i) develop and revise as necessary operating procedures for the review of
 2012 child deaths, including identification of cases to be reviewed and procedures for coordination among the
 2013 agencies and professionals involved, (ii) improve the identification, data collection, and record keeping
 2014 of the causes of child death, (iii) recommend components for prevention and education programs, (iv)
 2015 recommend training to improve the investigation of child deaths, and (v) provide technical assistance,
 2016 upon request, to any local child fatality teams that may be established. The operating procedures for the
 2017 review of child deaths shall be exempt from the Administrative Process Act (§ 2.2-4000 et seq.)
 2018 pursuant to subdivision B 17 of § 2.2-4002.

2019 B. The 16-member Team shall be chaired by the Chief Medical Examiner and shall be composed of
 2020 the following persons or their designees: the Commissioner of Behavioral Health and Developmental
 2021 Services; the Director of Child Protective Services within the Department of Social Services; the
 2022 Superintendent of Public Instruction; the State Registrar of Vital Records; and the Director of the
 2023 Department of Criminal Justice Services. In addition, one representative from each of the following
 2024 entities shall be appointed by the Governor to serve for a term of three years: local law-enforcement
 2025 agencies, local fire departments, local departments of social services, the Medical Society of Virginia,
 2026 the Virginia College of Emergency Physicians, the Virginia Pediatric Society, local emergency medical
 2027 services personnel, attorneys for the Commonwealth, and community services boards.

2028 C. Upon the request of the Chief Medical Examiner in his capacity as chair of the Team, made after
 2029 the conclusion of any law-enforcement investigation or prosecution, information and records regarding a
 2030 child whose death is being reviewed by the Team may be inspected and copied by the Chief Medical
 2031 Examiner or his designee, including, but not limited to, any report of the circumstances of the event
 2032 maintained by any state or local law-enforcement agency or medical examiner, and information or
 2033 records maintained on such child by any school, social services agency or court. Information, records, or
 2034 reports maintained by any attorney for the Commonwealth shall be made available for inspection and
 2035 copying by the Chief Medical Examiner pursuant to procedures which shall be developed by the Chief
 2036 Medical Examiner and the Commonwealth's Attorneys' Services Council established by § 2.2-2617. Any
 2037 presentence report prepared pursuant to § 19.2-299 for any person convicted of a crime that led to the
 2038 death of the child shall be made available for inspection and copying by the Office of the Chief Medical
 2039 Examiner pursuant to procedures which shall be developed by the Chief Medical Examiner. In addition,
 2040 the Office of the Chief Medical Examiner may inspect and copy from any Virginia health care provider,
 2041 on behalf of the Team, (i) without obtaining consent, the health and mental health records of the child
 2042 and those perinatal medical records of the child's mother that related to such child and (ii) upon
 2043 obtaining consent from each adult regarding his personal records, or from a parent regarding the records
 2044 of a minor child, the health and mental health records of the child's family. All such information and
 2045 records shall be confidential and shall be excluded from the Virginia Freedom of Information Act
 2046 (§ 2.2-3700 et seq.) pursuant to subdivision 9 7 of § 2.2-3705.5. Upon the conclusion of the child death
 2047 review, all information and records concerning the child and the child's family shall be shredded or
 2048 otherwise destroyed by the Office of the Chief Medical Examiner in order to ensure confidentiality.
 2049 Such information or records shall not be subject to subpoena or discovery or be admissible in any
 2050 criminal or civil proceeding. If available from other sources, however, such information and records
 2051 shall not be immune from subpoena, discovery, or introduction into evidence when obtained through
 2052 such other sources solely because the information and records were presented to the Team during a child
 2053 death review. Further, the findings of the Team may be disclosed or published in statistical or other
 2054 form which shall not identify individuals. The portions of meetings in which individual child death cases
 2055 are discussed by the Team shall be closed pursuant to subdivision A 21 of § 2.2-3711. In addition to the
 2056 requirements of § 2.2-3712, all team members, persons attending closed team meetings, and persons
 2057 presenting information and records on specific child deaths to the Team during closed meetings shall
 2058 execute a sworn statement to honor the confidentiality of the information, records, discussions, and
 2059 opinions disclosed during any closed meeting to review a specific child death. Violations of this
 2060 subsection are punishable as a Class 3 misdemeanor.

2061 D. Upon notification of a child death, any state or local government agency maintaining records on
 2062 such child or such child's family which are periodically purged shall retain such records for the longer
 2063 of 12 months or until such time as the State Child Fatality Review Team has completed its child death
 2064 review of the specific case.

2065 E. The Team shall compile annual data which shall be made available to the Governor and the
 2066 General Assembly as requested. These statistical data compilations shall not contain any personally
 2067 identifying information and shall be public records.

2068 **§ 32.1-283.2. Local and regional child fatality review teams established; membership; authority;**
 2069 **confidentiality; immunity.**

2070 A. Upon the initiative of any local or regional law-enforcement agency, fire department, department
 2071 of social services, emergency medical services agency, attorney for the Commonwealth's office, or
 2072 community services board, local or regional child fatality teams may be established for the purpose of
 2073 conducting contemporaneous reviews of local child deaths in order to develop interventions and
 2074 strategies for prevention specific to the locality or region. Each team shall establish rules and procedures
 2075 to govern the review process. Agencies may share information but shall be bound by confidentiality and
 2076 execute a sworn statement to honor the confidentiality of the information they share. Violations are
 2077 punishable as a Class 3 misdemeanor. The State Child Fatality Review Team shall provide technical
 2078 assistance and direction as provided for in subsection A of § 32.1-283.1.

2079 B. Local and regional teams may be composed of the following persons from the localities
 2080 represented on a particular board or their designees: a medical examiner appointed pursuant to
 2081 § 32.1-282, a local social services official in charge of child protective services, a director of the
 2082 relevant local or district health department, a chief law-enforcement officer, a local fire marshal, a local
 2083 emergency medical services agency chief, the attorney for the Commonwealth, an executive director of
 2084 the local community services board or other local mental health agency, and such additional persons, not
 2085 to exceed four, as may be appointed to serve by the chairperson of the local or regional team. The
 2086 chairperson shall be elected from among the designated membership. The additional members appointed
 2087 by the chairperson may include, but are not restricted to, representatives of local human services
 2088 agencies; local public education agencies; local pediatricians, psychiatrists and psychologists; and local
 2089 child advocacy organizations.

2090 C. Each team shall establish local rules and procedures to govern the review process prior to
 2091 conducting the first child fatality review. The review of a death shall be delayed until any criminal
 2092 investigations connected with the death are completed or the Commonwealth consents to the
 2093 commencement of such review prior to the completion of the criminal investigation.

2094 D. All information and records obtained or created regarding the review of a fatality shall be
 2095 confidential and shall be excluded from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.)
 2096 pursuant to subdivision 9 7 of § 2.2-3705.5. All such information and records shall be used by the team
 2097 only in the exercise of its proper purpose and function and shall not be disclosed. Such information or
 2098 records shall not be subject to subpoena, subpoena duces tecum, or discovery or be admissible in any
 2099 criminal or civil proceeding. If available from other sources, however, such information and records
 2100 shall not be immune from subpoena, subpoena duces tecum, discovery or introduction into evidence
 2101 when obtained through such other sources solely because the information and records were presented to
 2102 the team during a fatality review. No person who participated in the reviews nor any member of the
 2103 team shall be required to make any statement as to what transpired during the review or what
 2104 information was collected during the review. Upon the conclusion of the fatality review, all information
 2105 and records concerning the victim and the family shall be returned to the originating agency or
 2106 destroyed. However, the findings of the team may be disclosed or published in statistical or other form
 2107 which shall not identify individuals. The portions of meetings in which individual cases are discussed by
 2108 the team shall be closed pursuant to subdivision A 21 of § 2.2-3711. All team members, persons
 2109 attending closed team meetings, and persons presenting information and records on specific fatalities to
 2110 the team during closed meetings shall execute a sworn statement to honor the confidentiality of the
 2111 information, records, discussions, and opinions disclosed during any closed meeting to review a specific
 2112 death. Violations of this subsection are punishable as a Class 3 misdemeanor.

2113 E. Members of teams, as well as their agents and employees, shall be immune from civil liability for
 2114 any act or omission made in connection with participation in a child fatality review team review, unless
 2115 such act or omission was the result of gross negligence or willful misconduct. Any organization,
 2116 institution, or person furnishing information, data, testimony, reports or records to review teams as part
 2117 of such review, shall be immune from civil liability for any act or omission in furnishing such
 2118 information, unless such act or omission was the result of gross negligence or willful misconduct.

2119 **§ 32.1-283.3. Family violence fatality review teams established; model protocol and data**
 2120 **management; membership; authority; confidentiality, etc.**

2121 A. The Office of the Chief Medical Examiner shall develop a model protocol for the development
 2122 and implementation of local family violence fatality review teams (teams) and such model protocol shall
 2123 include relevant procedures for conducting reviews of fatal family violence incidents. A "fatal family
 2124 violence incident" means any fatality that occurred or that is suspected of having occurred in the context
 2125 of abuse between family members or intimate partners. The Office of the Chief Medical Examiner shall
 2126 provide technical assistance to the local teams and serve as a clearinghouse for information.

2127 B. Subject to available funding, the Office of the Chief Medical Examiner shall provide ongoing
 2128 surveillance of fatal family violence occurrences and promulgate an annual report based on accumulated
 2129 data.

2130 C. Any county or city, or combination of counties, cities, or counties and cities, may establish a

2131 family violence fatality review team to examine fatal family violence incidents and to create a body of
 2132 information to help prevent future family violence fatalities. The team shall have the authority to review
 2133 the facts and circumstances of all fatal family violence incidents that occur within its designated
 2134 geographic area.

2135 D. Membership in the team may include, but shall not be limited to, health care professionals,
 2136 representatives from the local bar, attorneys for the Commonwealth, judges, law-enforcement officials,
 2137 criminologists, medical examiners appointed pursuant to § 32.1-282, other experts in forensic medicine
 2138 and pathology, family violence victim advocates, health department professionals, probation and parole
 2139 professionals, adult and child protective services professionals, and representatives of family violence
 2140 local coordinating councils.

2141 E. Each team shall establish local rules and procedures to govern the review process prior to the first
 2142 fatal family violence incident review conducted. The review of a death shall be delayed until any
 2143 criminal investigations or prosecutions connected with the death are completed.

2144 F. All information and records obtained or created regarding the review of a fatality shall be
 2145 confidential and shall be excluded from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.)
 2146 pursuant to subdivision 9 7 of § 2.2-3705.5. All such information and records shall be used by the team
 2147 only in the exercise of its proper purpose and function and shall not be disclosed. Such information or
 2148 records shall not be subject to subpoena, subpoena duces tecum or discovery or be admissible in any
 2149 criminal or civil proceeding. If available from other sources, however, such information and records
 2150 shall not be immune from subpoena, subpoena duces tecum, discovery or introduction into evidence
 2151 when obtained through such other sources solely because the information and records were presented to
 2152 the team during a fatality review. No person who participated in the review nor any member of the team
 2153 shall be required to make any statement as to what transpired during the review or what information was
 2154 collected during the review. Upon the conclusion of the fatality review, all information and records
 2155 concerning the victim and the family shall be returned to the originating agency or destroyed. However,
 2156 the findings of the team may be disclosed or published in statistical or other form which shall not
 2157 identify individuals. The portions of meetings in which individual cases are discussed by the team shall
 2158 be closed pursuant to subdivision A 21 of § 2.2-3711. All team members, persons attending closed team
 2159 meetings, and persons presenting information and records on specific fatalities to the team during closed
 2160 meetings shall execute a sworn statement to honor the confidentiality of the information, records,
 2161 discussions, and opinions disclosed during any closed meeting to review a specific death. Violations of
 2162 this subsection are punishable as a Class 3 misdemeanor.

2163 G. Members of teams, as well as their agents and employees, shall be immune from civil liability for
 2164 any act or omission made in connection with participation in a family violence fatality review, unless
 2165 such act or omission was the result of gross negligence or willful misconduct. Any organization,
 2166 institution, or person furnishing information, data, testimony, reports or records to review teams as part
 2167 of such review, shall be immune from civil liability for any act or omission in furnishing such
 2168 information, unless such act or omission was the result of gross negligence or willful misconduct.

2169 **§ 32.1-283.5. Adult Fatality Review Team; duties; membership; confidentiality; penalties;**
 2170 **report; etc.**

2171 A. There is hereby created the Adult Fatality Review Team, referred to in this section as "the Team,"
 2172 which shall develop and implement procedures to ensure that adult deaths occurring in the
 2173 Commonwealth are analyzed in a systematic way. The Team shall review the death of any person age
 2174 60 years or older, or any adult age 18 years or older who is incapacitated, who resides in the
 2175 Commonwealth, or who does not reside in the Commonwealth but who is temporarily in the
 2176 Commonwealth and who is in need of temporary or emergency protective services (i) who was the
 2177 subject of an adult protective services or law-enforcement investigation; (ii) whose death was due to
 2178 abuse, neglect, or exploitation or acts suggesting abuse, neglect, or exploitation; or (iii) whose death
 2179 came under the jurisdiction of or was investigated by the Office of the Chief Medical Examiner pursuant
 2180 to § 32.1-283. The Team shall not initiate an adult death review until the conclusion of any
 2181 law-enforcement investigation or criminal prosecution. The operating procedures for the review of adult
 2182 deaths shall be exempt from the Administrative Process Act (§ 2.2-4000 et seq.) pursuant to subdivision
 2183 B 17 of § 2.2-4002.

2184 B. The 16-member team shall consist of the following persons or their designees: the Chief Medical
 2185 Examiner, the Commissioner of Behavioral Health and Developmental Services, the Commissioner for
 2186 Aging and Rehabilitative Services, the Director of the Office of Licensure and Certification of the
 2187 Department of Health, and the State Long-Term Care Ombudsman. In addition, the Governor shall
 2188 appoint one representative from each of the following entities: a licensed funeral services provider, the
 2189 Medical Society of Virginia, and local departments of social services, emergency medical services,
 2190 attorneys for the Commonwealth, law-enforcement agencies, nurses specializing in geriatric care,
 2191 psychiatrists specializing in geriatric care, and long-term care providers. The Team further shall include

2192 two members appointed by the Governor who are advocates for elderly or disabled populations in
2193 Virginia. The Chief Medical Examiner shall serve as chair of the Team.

2194 After the initial staggering of terms, members appointed by the Governor shall be appointed for a
2195 term of four years. Appointments to fill vacancies, other than by expiration of a term, shall be for the
2196 unexpired terms. Vacancies shall be filled in the same manner as the original appointments. All
2197 members may be reappointed. The Chief Medical Examiner and other ex officio members of the Team
2198 shall serve terms coincident with their terms of office.

2199 C. Upon the request of the chair of the Team, made after the conclusion of any law-enforcement
2200 investigation or prosecution, information and records regarding an adult whose death is being reviewed
2201 by the Team shall be inspected and copied by the chair or his designee, including but not limited to any
2202 report of the circumstances of the event maintained by any state or local law-enforcement agency or the
2203 Office of the Chief Medical Examiner and information or records on the adult maintained by any facility
2204 that provided services to the adult, by any social services agency, or by any court. Information, records,
2205 or reports maintained by any attorney for the Commonwealth shall be made available for inspection and
2206 copying by the chair or his designee pursuant to procedures that shall be developed by the Chief
2207 Medical Examiner and the Commonwealth Attorneys Services Council established by § 2.2-2617. In
2208 addition, a health care provider shall provide the Team, upon request, with access to the health and
2209 mental health records of (i) the adult whose death is subject to review, without authorization; (ii) any
2210 adult relative of the deceased, with authorization; and (iii) any minor child of the deceased, with the
2211 authorization of the minor's parent or guardian. The chair of the Team also may copy and inspect the
2212 presentence report, prepared pursuant to § 19.2-299, of any person convicted of a crime that led to the
2213 death of the adult who is the subject of review by the Team.

2214 D. All information obtained or generated by the Team regarding a review shall be confidential and
2215 excluded from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.) pursuant to subdivision 9 7
2216 of § 2.2-3705.5. Such information shall not be subject to subpoena or discovery or be admissible in any
2217 civil or criminal proceeding. If available from other sources, however, such information and records
2218 shall not be immune from subpoena, discovery, or introduction into evidence when obtained through
2219 such other sources solely because the information and records were presented to the Team during an
2220 adult death review. The Team shall compile all information collected during a review. The findings of
2221 the Team may be disclosed or published in statistical or other form, but shall not identify any
2222 individuals. The portions of meetings in which individual adult death cases are discussed by the Team
2223 shall be closed pursuant to subdivision A 21 of § 2.2-3711.

2224 E. All Team members and other persons attending closed Team meetings, including any persons
2225 presenting information or records on specific fatalities, shall execute a sworn statement to honor the
2226 confidentiality of the information, records, discussions, and opinions disclosed during meetings at which
2227 the Team reviews a specific death. No Team member or other person who participates in a review shall
2228 be required to make any statement regarding the review or any information collected during the review.
2229 Upon conclusion of a review, all information and records concerning the victim and the family shall be
2230 shredded or otherwise destroyed in order to ensure confidentiality. Violations of this subsection are
2231 punishable as a Class 3 misdemeanor.

2232 F. Upon notification of an adult death, any state or local government agency or facility that provided
2233 services to the adult or maintained records on the adult or the adult's family shall retain the records for
2234 the longer of 12 months or until such time as the Team has completed its review of the case.

2235 G. The Team shall compile an annual report by October 1 of each year that shall be made available
2236 to the Governor and the General Assembly. The annual report shall include any policy, regulatory, or
2237 budgetary recommendations developed by the Team. Any statistical compilations prepared by the Team
2238 shall be public record and shall not contain any personally identifying information.

2239 **§ 32.1-283.6. Local and regional adult fatality review teams established; membership; authority;**
2240 **confidentiality; immunity.**

2241 A. Upon the initiative of any local or regional law-enforcement agency, department of social
2242 services, emergency medical services agency, attorney for the Commonwealth's office, community
2243 services board, or official with the Adult Protective Services Unit established pursuant to § 51.5-148,
2244 local or regional adult fatality review teams may be established for the purpose of conducting
2245 contemporaneous reviews of local adult deaths in order to develop interventions and strategies for
2246 prevention specific to the locality or region. For the purposes of this section, the team may review the
2247 death of any person age 60 years or older, or any adult age 18 years or older who is incapacitated, who
2248 resides in the Commonwealth and who is in need of temporary or emergency protective services (i) who
2249 was the subject of an adult protective services or law-enforcement investigation; (ii) whose death was
2250 due to abuse, neglect, or exploitation or acts suggesting abuse, neglect, or exploitation; or (iii) whose
2251 death came under the jurisdiction of or was investigated by the Office of the Chief Medical Examiner as
2252 occurring in any suspicious, unusual, or unnatural manner, pursuant to § 32.1-283. Each team shall

2253 establish rules and procedures to govern the review process. Agencies may share information but shall
 2254 be bound by confidentiality and execute a sworn statement to honor the confidentiality of the
 2255 information they share. A violation of this subsection is punishable as a Class 3 misdemeanor. The
 2256 Office of the Chief Medical Examiner shall develop a model protocol for the development and
 2257 implementation of local or regional adult fatality review teams and such model protocol shall include
 2258 relevant procedures for conducting reviews of adult fatalities.

2259 B. Local and regional teams may be composed of the following persons from the localities
 2260 represented on a particular board or their designees: a medical examiner appointed pursuant to
 2261 § 32.1-282, a local adult protective services official, a local social services official, a director of the
 2262 relevant local or district health department, an executive director of the local area agency on aging or
 2263 other department representing the interests of the elderly or disabled, a chief law-enforcement officer,
 2264 the attorney for the Commonwealth, an executive director of the local community services board or
 2265 other local mental health agency, a local judge, and such additional persons as may be appointed to
 2266 serve by the chair of the local or regional team. The chair shall be elected from among the designated
 2267 membership. The additional members appointed by the chair may include, but are not restricted to,
 2268 representatives of local human services agencies, local health care professionals specializing in geriatric
 2269 care or care of incapacitated adults, local emergency medical services personnel, local long-term care
 2270 providers, representatives of local advocacy or service organizations for elderly or disabled populations,
 2271 experts in forensic medicine and pathology, local funeral services providers, local centers for
 2272 independent living, local long-term care ombudsmen, and representatives of the local bar.

2273 C. Each local or regional team shall establish operating procedures to govern the review process prior
 2274 to conducting the first adult fatality review. The review of a death shall be delayed until any criminal
 2275 investigations connected with the death are completed or the Commonwealth consents to the
 2276 commencement of such review prior to the completion of the criminal investigation.

2277 D. All information and records obtained or created regarding a review of a fatality shall be
 2278 confidential and shall be excluded from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.)
 2279 pursuant to subdivision 9 7 of § 2.2-3705.5. All such information and records shall be used by the team
 2280 only in the exercise of its proper purpose and function and shall not be disclosed. Such information and
 2281 records shall not be subject to subpoena, subpoena duces tecum, discovery, or introduction into evidence
 2282 when obtained through such other sources solely because the information and records were presented to
 2283 the team during the fatality review. No person who participated in the review and no member of the
 2284 team shall be required to make any statement as to what transpired during the review or what
 2285 information was collected during the review. Upon the conclusion of the fatality review, all information
 2286 and records concerning the victim and family shall be returned to the originating agency or destroyed.
 2287 However, the findings of the team may be disclosed or published in statistical or other form that does
 2288 not identify any individuals. The portions of meetings in which individual cases are discussed by the
 2289 team shall be closed pursuant to subdivision A 21 of § 2.2-3711. All team members, persons attending
 2290 closed team meetings, and persons presenting information and records on specific fatalities to the team
 2291 during closed meetings shall execute a sworn statement to honor the confidentiality of the information,
 2292 records, discussions, and opinions disclosed during any closed meeting to review a specific death. A
 2293 violation of this subsection is punishable as a Class 3 misdemeanor.

2294 E. Members of teams, as well as their agents and employees, shall be immune from civil liability for
 2295 any act or omission made in connection with participation in an adult fatality review team review, unless
 2296 such act or omission was the result of gross negligence or willful misconduct. Any organization,
 2297 institution, or person furnishing information, data, testimony, reports, or records to review teams as part
 2298 of such review shall be immune from civil liability for any act or omission in furnishing such
 2299 information, unless such act or omission was the result of gross negligence or willful misconduct.

2300 **§ 44-146.18. Department of Emergency Services continued as Department of Emergency**
 2301 **Management; administration and operational control; coordinator and other personnel; powers**
 2302 **and duties.**

2303 A. The State Office of Emergency Services is continued and shall hereafter be known as the
 2304 Department of Emergency Management. Wherever the words "State Department of Emergency Services"
 2305 are used in any law of the Commonwealth, they shall mean the Department of Emergency Management.
 2306 During a declared emergency this Department shall revert to the operational control of the Governor.
 2307 The Department shall have a coordinator who shall be appointed by and serve at the pleasure of the
 2308 Governor and also serve as State Emergency Planning Director. The Department shall employ the
 2309 professional, technical, secretarial, and clerical employees necessary for the performance of its functions.

2310 B. The Department of Emergency Management shall in the administration of emergency services and
 2311 disaster preparedness programs:

2312 1. In coordination with political subdivisions and state agencies, ensure that the Commonwealth has
 2313 up-to-date assessments and preparedness plans to prevent, respond to and recover from all disasters

- 2314 including acts of terrorism;
- 2315 2. Conduct a statewide emergency management assessment in cooperation with political subdivisions,
 2316 private industry and other public and private entities deemed vital to preparedness, public safety and
 2317 security. The assessment shall include a review of emergency response plans, which include the variety
 2318 of hazards, natural and man-made. The assessment shall be updated annually;
- 2319 3. Submit to the Governor and to the General Assembly, no later than the first day of each regular
 2320 session of the General Assembly, an annual executive summary and report on the status of emergency
 2321 management response plans throughout the Commonwealth and other measures taken or recommended
 2322 to prevent, respond to and recover from disasters, including acts of terrorism. This report shall be made
 2323 available to the Division of Legislative Automated Systems for the processing of legislative documents
 2324 and reports. Information submitted in accordance with the procedures set forth in subdivision 4 14 of
 2325 § 2.2-3705.2 shall not be disclosed unless:
- 2326 a. It is requested by law-enforcement authorities in furtherance of an official investigation or the
 2327 prosecution of a criminal act;
- 2328 b. The agency holding the record is served with a proper judicial order; or
- 2329 c. The agency holding the record has obtained written consent to release the information from the
 2330 Department of Emergency Management;
- 2331 4. Promulgate plans and programs that are conducive to adequate disaster mitigation preparedness,
 2332 response and recovery programs;
- 2333 5. Prepare and maintain a State Emergency Operations Plan for disaster response and recovery
 2334 operations that assigns primary and support responsibilities for basic emergency services functions to
 2335 state agencies, organizations and personnel as appropriate;
- 2336 6. Coordinate and administer disaster mitigation, preparedness, response and recovery plans and
 2337 programs with the proponent federal, state and local government agencies and related groups;
- 2338 7. Provide guidance and assistance to state agencies and units of local government in developing and
 2339 maintaining emergency management and continuity of operations (COOP) programs, plans and systems;
- 2340 8. Make necessary recommendations to agencies of the federal, state, or local governments on
 2341 preventive and preparedness measures designed to eliminate or reduce disasters and their impact;
- 2342 9. Determine requirements of the Commonwealth and its political subdivisions for those necessities
 2343 needed in the event of a declared emergency which are not otherwise readily available;
- 2344 10. Assist state agencies and political subdivisions in establishing and operating training programs
 2345 and programs of public information and education regarding emergency services and disaster
 2346 preparedness activities;
- 2347 11. Consult with the Board of Education regarding the development and revision of a model school
 2348 crisis and emergency management plan for the purpose of assisting public schools in establishing,
 2349 operating, and maintaining emergency services and disaster preparedness activities;
- 2350 12. Consult with the State Council of Higher Education in the development and revision of a model
 2351 institutional crisis and emergency management plan for the purpose of assisting public and private
 2352 two-year and four-year institutions of higher education in establishing, operating, and maintaining
 2353 emergency services and disaster preparedness activities and, as needed, in developing an institutional
 2354 crisis and emergency management plan pursuant to § 23.1-804;
- 2355 13. Develop standards, provide guidance and encourage the maintenance of local and state agency
 2356 emergency operations plans, which shall include the requirement for a provision that the Department of
 2357 Criminal Justice Services and the Virginia Criminal Injuries Compensation Fund be contacted
 2358 immediately to deploy assistance in the event of an emergency as defined in the emergency response
 2359 plan when there are victims as defined in § 19.2-11.01. The Department of Criminal Justice Services and
 2360 the Virginia Criminal Injuries Compensation Fund shall be the lead coordinating agencies for those
 2361 individuals determined to be victims, and the plan shall also contain current contact information for both
 2362 agencies;
- 2363 14. Prepare, maintain, coordinate or implement emergency resource management plans and programs
 2364 with federal, state and local government agencies and related groups, and make such surveys of
 2365 industries, resources, and facilities within the Commonwealth, both public and private, as are necessary
 2366 to carry out the purposes of this chapter;
- 2367 15. Coordinate with the federal government and any public or private agency or entity in achieving
 2368 any purpose of this chapter and in implementing programs for disaster prevention, mitigation,
 2369 preparation, response, and recovery;
- 2370 16. Establish guidelines pursuant to § 44-146.28, and administer payments to eligible applicants as
 2371 authorized by the Governor;
- 2372 17. Coordinate and be responsible for the receipt, evaluation, and dissemination of emergency
 2373 services intelligence pertaining to all probable hazards affecting the Commonwealth;
- 2374 18. Coordinate intelligence activities relating to terrorism with the Department of State Police; and

2375 19. Develop an emergency response plan to address the needs of individuals with household pets and
 2376 service animals in the event of a disaster and assist and coordinate with local agencies in developing an
 2377 emergency response plan for household pets and service animals.

2378 The Department of Emergency Management shall ensure that all such plans, assessments, and
 2379 programs required by this subsection include specific preparedness for, and response to, disasters
 2380 resulting from electromagnetic pulses and geomagnetic disturbances.

2381 C. The Department of Emergency Management shall during a period of impending emergency or
 2382 declared emergency be responsible for:

2383 1. The receipt, evaluation, and dissemination of intelligence pertaining to an impending or actual
 2384 disaster;

2385 2. Providing facilities from which state agencies and supporting organizations may conduct
 2386 emergency operations;

2387 3. Providing an adequate communications and warning system capable of notifying all political
 2388 subdivisions in the Commonwealth of an impending disaster within a reasonable time;

2389 4. Establishing and maintaining liaison with affected political subdivisions;

2390 5. Determining requirements for disaster relief and recovery assistance;

2391 6. Coordinating disaster response actions of federal, state and volunteer relief agencies;

2392 7. Coordinating and providing guidance and assistance to affected political subdivisions to ensure
 2393 orderly and timely response to and recovery from disaster effects.

2394 D. The Department of Emergency Management shall be provided the necessary facilities and
 2395 equipment needed to perform its normal day-to-day activities and coordinate disaster-related activities of
 2396 the various federal, state, and other agencies during a state of emergency declaration by the Governor or
 2397 following a major disaster declaration by the President.

2398 E. The Department of Emergency Management is authorized to enter into all contracts and
 2399 agreements necessary or incidental to performance of any of its duties stated in this section or otherwise
 2400 assigned to it by law, including contracts with the United States, other states, agencies and government
 2401 subdivisions of the Commonwealth, and other appropriate public and private entities.

2402 F. The Department of Emergency Management shall encourage private industries whose goods and
 2403 services are deemed vital to the public good to provide annually updated preparedness assessments to
 2404 the local coordinator of emergency management on or before April 1 of each year, to facilitate overall
 2405 Commonwealth preparedness. For the purposes of this section, "private industry" means companies,
 2406 private hospitals, and other businesses or organizations deemed by the State Coordinator of Emergency
 2407 Management to be essential to the public safety and well-being of the citizens of the Commonwealth.

2408 G. The Department of Emergency Management shall establish a Coordinator of Search and Rescue.
 2409 Powers and duties of the Coordinator shall include:

2410 1. Coordinating the search and rescue function of the Department of Emergency Management;

2411 2. Coordinating with local, state, and federal agencies involved in search and rescue;

2412 3. Coordinating the activities of search and rescue organizations involved in search and rescue;

2413 4. Maintaining a register of search and rescue certifications, training, and responses;

2414 5. Establishing a memorandum of understanding with the Virginia Search and Rescue Council and its
 2415 respective member agencies regarding search and rescue efforts;

2416 6. Providing on-scene search and rescue coordination when requested by an authorized person;

2417 7. Providing specialized search and rescue training to police, fire-rescue, EMS, emergency managers,
 2418 volunteer search and rescue responders, and others who might have a duty to respond to a search and
 2419 rescue emergency;

2420 8. Gathering and maintaining statistics on search and rescue in the Commonwealth;

2421 9. Compiling, maintaining, and making available an inventory of search and rescue resources
 2422 available in the Commonwealth;

2423 10. Periodically reviewing search and rescue cases and developing best professional practices; and

2424 11. Providing an annual report to the Secretary of Public Safety and Homeland Security on the
 2425 current readiness of Virginia's search and rescue efforts.

2426 Nothing in this chapter shall be construed as authorizing the Department of Emergency Management
 2427 to take direct operational responsibilities from local, state, or federal law enforcement in the course of
 2428 search and rescue or missing person cases.

2429 **§ 44-146.22. Development of measures to prevent or reduce harmful consequences of disasters;
 2430 disclosure of information.**

2431 A. In addition to disaster prevention measures included in state, local and interjurisdictional
 2432 emergency operations plans, the Governor shall consider, on a continuing basis, hazard mitigation or
 2433 other measures that could be taken to prevent or reduce the harmful consequences of disasters. At his
 2434 direction, and pursuant to any other authority, state agencies, including, but not limited to, those charged
 2435 with responsibilities in connection with floodplain management, stream encroachment and flow

2436 regulation, weather modification, fire prevention and control, air quality, public works, critical
 2437 infrastructure protection, land use and land-use planning, and construction standards, shall make studies
 2438 of disaster prevention. The Governor, from time to time, shall make recommendations to the General
 2439 Assembly, local governments, and other appropriate public and private entities as may facilitate
 2440 measures for prevention or reduction of the harmful consequences of disasters.

2441 B. The Governor or agencies acting on his behalf may receive information, voluntarily submitted
 2442 from both public and nonpublic entities, related to the protection of the nation's critical infrastructure
 2443 sectors and components that are located in Virginia or affect the health, safety, and welfare of the
 2444 citizens of Virginia. Information submitted by any public or nonpublic entity in accordance with the
 2445 procedures set forth in subdivision 4 *14* of § 2.2-3705.2 shall not be disclosed unless:

2446 1. It is requested by law-enforcement authorities in furtherance of an official investigation or the
 2447 prosecution of a criminal act;

2448 2. The agency holding the record is served with a proper judicial order; or

2449 3. The agency holding the record has obtained the written consent to release the information from the
 2450 entity voluntarily submitting it.

2451 **§ 54.1-2517. Health Practitioners' Monitoring Program Committee; certain meetings, decisions**
 2452 **to be excepted from the Freedom of Information Act; confidentiality of records; immunity from**
 2453 **liability.**

2454 A. The Health Practitioners' Monitoring Program Committee shall consist of nine persons appointed
 2455 by the Director to advise and assist in the operation of the Program, of whom eight shall be licensed,
 2456 certified, or registered practitioners and one shall be a citizen member. Of the members who are
 2457 licensed, certified, or registered practitioners, at least one shall be licensed to practice medicine or
 2458 osteopathy in Virginia and engaged in active clinical practice, at least one shall be a registered nurse
 2459 engaged in active practice, and all shall be knowledgeable about impairment and rehabilitation,
 2460 particularly as related to the monitoring of health care practitioners. The Committee shall have the
 2461 following powers and duties:

2462 1. To determine, in accordance with the regulations, eligibility to enter into the Program;

2463 2. To determine, in accordance with the regulations, those Program participants who are eligible for
 2464 stayed disciplinary action;

2465 3. To enter into written contracts with practitioners which may include, among other terms and
 2466 conditions, withdrawal from practice or limitations on the scope of the practice for a period of time;

2467 4. To report to the Director and the health regulatory boards as necessary on the status of applicants
 2468 for and participants in the Program;

2469 5. To report to the Director, at least annually, on the performance of the Program; and

2470 6. To assist the Director in carrying out the provisions of this chapter.

2471 B. Records of the Program, to the extent such records identify individual practitioners in the
 2472 Program, shall be privileged and confidential, and shall not be disclosed consistent with the Virginia
 2473 Freedom of Information Act (§ 2.2-3700 et seq.). Such records shall be used only in the exercise of the
 2474 proper functions as set forth in this chapter and shall not be public records nor shall such records be
 2475 subject to court order, except as provided in subdivision C 4, or be subject to discovery or introduction
 2476 as evidence in any civil, criminal, or administrative proceedings except those conducted by a health
 2477 regulatory board.

2478 C. Notwithstanding the provisions of subsection B and of subdivision ~~4~~ 2 of § 2.2-3705.5, the
 2479 Committee may disclose such records relative to an impaired practitioner only:

2480 1. When disclosure of the information is essential to the monitoring needs of the impaired
 2481 practitioner;

2482 2. When release of the information has been authorized in writing by the impaired practitioner;

2483 3. To a health regulatory board within the Department of Health Professions; or

2484 4. When an order by a court of competent jurisdiction has been granted, upon a showing of good
 2485 cause therefor, including the need to avert a substantial risk of death or serious bodily harm. In
 2486 assessing good cause, the court shall weigh the public interest and the need for disclosure against the
 2487 injury to the patient, to the physician-patient relationship, and to the treatment services. Upon the
 2488 granting of such order, the court, in determining the extent to which any disclosure of all or any part of
 2489 any record is necessary, shall impose appropriate protections against unauthorized disclosures.

2490 D. Pursuant to subdivision A 24 of § 2.2-3711, the proceedings of the Committee which in any way
 2491 pertain or refer to a specific practitioner who may be, or who is actually, impaired and who may be or
 2492 is, by reason of such impairment, subject to disciplinary action by the relevant board shall be excluded
 2493 from the requirements of the Freedom of Information Act (§ 2.2-3700 et seq.) and may be closed. Such
 2494 proceedings shall be privileged and confidential.

2495 E. The members of the Committee shall be immune from liability resulting from the exercise of the
 2496 powers and duties of the Committee as provided in § 8.01-581.13.

2497 § 54.1-2523. Confidentiality of data; disclosure of information; discretionary authority of
2498 Director.

2499 A. All data, records, and reports relating to the prescribing and dispensing of covered substances to
2500 recipients and any abstracts from such data, records, and reports that are in the possession of the
2501 Prescription Monitoring Program pursuant to this chapter and any material relating to the operation or
2502 security of the program shall be confidential and shall be exempt from the Virginia Freedom of
2503 Information Act (§ 2.2-3700 et seq.) pursuant to subdivision 15 2 of § 2.2-3705.5. Records in possession
2504 of the Prescription Monitoring Program shall not be available for civil subpoena, nor shall such records
2505 be disclosed, discoverable, or compelled to be produced in any civil proceeding, nor shall such records
2506 be deemed admissible as evidence in any civil proceeding for any reason. Further, the Director shall
2507 only have discretion to disclose any such information as provided in subsections B and C.

2508 B. Upon receiving a request for information in accordance with the Department's regulations and in
2509 compliance with applicable federal law and regulations, the Director shall disclose the following:

2510 1. Information relevant to a specific investigation of a specific recipient or of a specific dispenser or
2511 prescriber to an agent who has completed the Virginia State Police Drug Diversion School designated by
2512 the superintendent of the Department of State Police or designated by the chief law-enforcement officer
2513 of any county, city, or town or campus police department to conduct drug diversion investigations
2514 pursuant to § 54.1-3405.

2515 2. Information relevant to an investigation or inspection of or allegation of misconduct by a specific
2516 person licensed, certified, or registered by or an applicant for licensure, certification, or registration by a
2517 health regulatory board; information relevant to a disciplinary proceeding before a health regulatory
2518 board or in any subsequent trial or appeal of an action or board order to designated employees of the
2519 Department of Health Professions; or to designated persons operating the Health Practitioners'
2520 Monitoring Program pursuant to Chapter 25.1 (§ 54.1-2515 et seq.).

2521 3. Information relevant to the proceedings of any investigatory grand jury or special grand jury that
2522 has been properly impaneled in accordance with the provisions of Chapter 13 (§ 19.2-191 et seq.) of
2523 Title 19.2.

2524 4. Information relevant to a specific investigation of a specific recipient, dispenser, or prescriber to
2525 an agent of a federal law-enforcement agency with authority to conduct drug diversion investigations.

2526 5. Information relevant to a specific investigation, supervision, or monitoring of a specific recipient
2527 for purposes of the administration of criminal justice pursuant to Chapter 1 (§ 9.1-100 et seq.) of Title
2528 9.1 to a probation or parole officer as described in Article 2 (§ 53.1-141 et seq.) of Chapter 4 of Title
2529 53.1 or a local community-based probation officer as described in § 9.1-176.1 who has completed the
2530 Virginia State Police Drug Diversion School designated by the Director of the Department of
2531 Corrections or his designee.

2532 C. In accordance with the Department's regulations and applicable federal law and regulations, the
2533 Director may, in his discretion, disclose:

2534 1. Information in the possession of the program concerning a recipient who is over the age of 18 to
2535 that recipient. The information shall be mailed to the street or mailing address indicated on the recipient
2536 request form.

2537 2. Information on a specific recipient to a prescriber, as defined in this chapter, for the purpose of
2538 establishing the treatment history of the specific recipient when such recipient is either under care and
2539 treatment by the prescriber or the prescriber is consulting on or initiating treatment of such recipient. In
2540 a manner specified by the Director in regulation, notice shall be given to patients that information may
2541 be requested by the prescriber from the Prescription Monitoring Program.

2542 3. Information on a specific recipient to a dispenser for the purpose of establishing a prescription
2543 history to assist the dispenser in (i) determining the validity of a prescription in accordance with
2544 § 54.1-3303 or (ii) providing clinical consultation on the care and treatment of the recipient. In a manner
2545 specified by the Director in regulation, notice shall be given to patients that information may be
2546 requested by the dispenser from the Prescription Monitoring Program.

2547 4. Information relevant to an investigation or regulatory proceeding of a specific dispenser or
2548 prescriber to other regulatory authorities concerned with granting, limiting or denying licenses,
2549 certificates or registrations to practice a health profession when such regulatory authority licenses such
2550 dispenser or prescriber or such dispenser or prescriber is seeking licensure by such other regulatory
2551 authority.

2552 5. Information relevant to an investigation relating to a specific dispenser or prescriber who is a
2553 participating provider in the Virginia Medicaid program or information relevant to an investigation
2554 relating to a specific recipient who is currently eligible for and receiving or who has been eligible for
2555 and has received medical assistance services to the Medicaid Fraud Control Unit of the Office of the
2556 Attorney General or to designated employees of the Department of Medical Assistance Services, as
2557 appropriate.

2558 6. Information relevant to determination of the cause of death of a specific recipient to the designated
 2559 employees of the Office of the Chief Medical Examiner.

2560 7. Information for the purpose of bona fide research or education to qualified personnel; however,
 2561 data elements that would reasonably identify a specific recipient, prescriber, or dispenser shall be deleted
 2562 or redacted from such information prior to disclosure. Further, release of the information shall only be
 2563 made pursuant to a written agreement between such qualified personnel and the Director in order to
 2564 ensure compliance with this subdivision.

2565 8. Information relating to prescriptions for covered substances issued by a specific prescriber, which
 2566 have been dispensed and reported to the Program, to that prescriber.

2567 9. Information about a specific recipient who is a member of a Virginia Medicaid managed care
 2568 program to a physician or pharmacist licensed in the Commonwealth and employed by the Virginia
 2569 Medicaid managed care program. Such information shall only be used to determine eligibility for and to
 2570 manage the care of the specific recipient in a Patient Utilization Management Safety or similar program.
 2571 Notice shall be given to recipients that information may be requested by a licensed physician or
 2572 pharmacist employed by the Virginia Medicaid managed care program from the Prescription Monitoring
 2573 Program.

2574 10. (Expires July 1, 2022) Information to the Board of Medicine about prescribers who meet a
 2575 certain threshold for prescribing covered substances for the purpose of requiring relevant continuing
 2576 education. The threshold shall be determined by the Board of Medicine in consultation with the
 2577 Program.

2578 D. The Director may enter into agreements for mutual exchange of information among prescription
 2579 monitoring programs in other jurisdictions, which shall only use the information for purposes allowed by
 2580 this chapter.

2581 E. This section shall not be construed to supersede the provisions of § 54.1-3406 concerning the
 2582 divulging of confidential records relating to investigative information.

2583 F. Confidential information that has been received, maintained or developed by any board or
 2584 disclosed by the board pursuant to subsection A shall not, under any circumstances, be available for
 2585 discovery or court subpoena or introduced into evidence in any medical malpractice suit or other action
 2586 for damages arising out of the provision of or failure to provide services. However, this subsection shall
 2587 not be construed to inhibit any investigation or prosecution conducted pursuant to Article 1 (§ 18.2-247
 2588 et seq.) of Chapter 7 of Title 18.2.

2589 **2. That the provisions of § 2.2-3704, subdivisions 10 and 14 of § 2.2-3705.2, subdivisions 2 and 3 of**
 2590 **§ 2.2-3705.5, and subdivision 29 of § 2.2-3705.6 of the Code of Virginia, as amended by this act,**
 2591 **are declaratory of existing law.**
