## Be it enacted by the General Assembly of Virginia:

#### 8 1. That § 22.1-298.1 of the Code of Virginia is amended and reenacted as follows: 9

# § 22.1-298.1. Regulations governing licensure.

A. As used in this section:

11 "Alternate route to licensure" means a nontraditional route to teacher licensure available to 12 individuals who meet the criteria specified in the regulations issued by the Board of Education.

"Industry certification credential" means an active career and technical education credential that is 13 earned by successfully completing a Board of Education-approved industry certification examination, 14 15 being issued a professional license in the Commonwealth, or successfully completing an occupational competency examination. 16

"Licensure by reciprocity" means a process used to issue a license to an individual coming into the 17 18 Commonwealth from another state when that individual meets certain conditions specified in the Board 19 of Education's regulations.

20 "Professional teacher's assessment" means those tests mandated for licensure as prescribed by the 21 Board of Education.

22 "Provisional license" means a nonrenewable license issued by the Board of Education for a specified 23 period of time, not to exceed three years, to an individual who may be employed by a school division in 24 the Commonwealth and who generally meets the requirements specified in the Board of Education's 25 regulations for licensure, but who may need to take additional coursework or pass additional assessments 26 to be fully licensed with a renewable license.

"Renewable license" means a license issued by the Board of Education for five years to an individual 27 28 who meets the requirements specified in the Board of Education's regulations.

29 B. The Board of Education shall prescribe, by regulation, the requirements for the licensure of 30 teachers and other school personnel required to hold a license. Such regulations shall include 31 requirements for the denial, suspension, cancellation, revocation, and reinstatement of licensure. The Board of Education shall revoke the license of any person for whom it has received a notice of 32 dismissal or resignation pursuant to subsection F of § 22.1-313 and, in the case of a person who is the 33 34 subject of a founded complaint of child abuse or neglect, after all rights to any appeal provided by 35 § 63.2-1526 have been exhausted. Regardless of the authority of any other agency of the Commonwealth to approve educational programs, only the Board of Education shall have the authority to license 36 37 teachers to be regularly employed by school boards, including those teachers employed to provide 38 nursing education.

39 The Board of Education shall prescribe by regulation the licensure requirements for teachers who 40 teach only online courses, as defined in § 22.1-212.23. Such license shall be valid only for teaching 41 online courses. Teachers who hold a five-year renewable license issued by the Board of Education may 42 teach online courses for which they are properly endorsed.

43 C. The Board of Education's regulations shall include requirements that a person seeking initial 44 licensure:

45 1. Complete professional assessments as prescribed by the Board of Education; 46

2. Complete study in attention deficit disorder;

3. Complete study in gifted education, including the use of multiple criteria to identify gifted 47 48 students; and

49 4. Complete study in methods of improving communication between schools and families and ways 50 of increasing family involvement in student learning at home and at school. 51

D. In addition, such regulations shall include requirements that:

1. Every person seeking initial licensure or renewal of a license demonstrate proficiency in the use of 52 53 educational technology for instruction;

54 2. Every person seeking initial licensure and persons seeking licensure renewal as teachers who have 55 not completed such study shall complete study in child abuse recognition and intervention in accordance 56 with curriculum guidelines developed by the Board of Education in consultation with the Department of HB1829ER

Social Services that are relevant to the specific teacher licensure routes;

57 3. Every person seeking initial licensure or renewal of a license shall receive professional 58 59 development in instructional methods tailored to promote student academic progress and effective 60 preparation for the Standards of Learning end-of-course and end-of-grade assessments;

61 4. Every person seeking renewal of a license shall complete all renewal requirements, including 62 professional development in a manner prescribed by the Board, except that no person seeking renewal of a license shall be required to satisfy any such requirement by completing coursework and earning credit 63 64 at an institution of higher education;

5. Every person seeking initial licensure or renewal of a license shall provide evidence of completion 65 66 of certification or training in emergency first aid, cardiopulmonary resuscitation, and the use of automated external defibrillators. The certification or training program shall (i) be based on the current 67 national evidence-based emergency cardiovascular care guidelines for cardiopulmonary resuscitation and 68 the use of an automated external defibrillator, such as a program developed by the American Heart 69 Association or the American Red Cross, and (ii) include hands-on practice of the skills necessary to 70 perform cardiopulmonary resuscitation. The Board shall provide a waiver for this requirement for any 71 72 person with a disability whose disability prohibits such person from completing the certification or 73 training;

74 6. Every person seeking licensure with an endorsement as a teacher of the blind and visually 75 impaired shall demonstrate proficiency in reading and writing Braille;

76 7. Every teacher seeking an initial license in the Commonwealth with an endorsement in the area of 77 career and technical education shall have an industry certification credential in the area in which the 78 teacher seeks endorsement. If a teacher seeking an initial license in the Commonwealth has not attained 79 an industry certification credential in the area in which the teacher seeks endorsement, the Board may, 80 upon request of the employing school division or educational agency, issue the teacher a provisional license to allow time for the teacher to attain such credential; and 81

8. (Effective July 1, 2017) Every person seeking initial licensure or renewal of a license shall 82 complete awareness training, provided by the Department of Education, on the indicators of dyslexia, as 83 84 that term is defined by the Board pursuant to regulations, and the evidence-based interventions and 85 accommodations for dyslexia.

E. The Board's regulations shall require that initial licensure for principals and assistant principals be 86 87 contingent upon passage of an assessment as prescribed by the Board.

F. The Board shall establish criteria in its regulations to effectuate the substitution of experiential 88 89 learning for coursework for those persons seeking initial licensure through an alternate route as defined 90 in Board regulations.

91 G. Notwithstanding any provision of law to the contrary, the Board (i) may provide for the issuance 92 of a provisional license, valid for a period not to exceed three years, pursuant to subdivision D 7 or to 93 any person who does not meet the requirements of this section or any other requirement for licensure 94 imposed by law and (ii) shall provide for the issuance of a provisional license, valid for a period not to 95 exceed three years, to any former member of the Armed Forces of the United States or the Virginia 96 National Guard who has received an honorable discharge and has the appropriate level of experience or 97 training but does not meet the requirements for a renewable license. 98

H. The Board's licensure regulations shall also provide for licensure by reciprocity:

99 1. With comparable endorsement areas for those individuals holding a valid out-of-state teaching 100 license and national certification from the National Board for Professional Teaching Standards or a 101 nationally recognized certification program approved by the Board of Education. The application for 102 such individuals shall require evidence of such valid licensure and national certification and shall not 103 require official student transcripts;

104 2. For individuals who have obtained a valid out-of-state license, with full credentials and without 105 deficiencies, that is in force at the time the application for a Virginia license is received by the 106 Department of Education. The individual must establish a file in the Department of Education by submitting a complete application packet, which shall include official student transcripts. An assessment of basic skills as provided in § 22.1-298.2 and service requirements shall not be imposed for these 107 108 109 licensed individuals; however, other licensing assessments, as prescribed by the Board of Education, 110 shall be required; and

111 3. The Board may include other provisions for reciprocity in its regulations.
