## HOUSE BILL NO. 2119

House Amendments in [ ] — February 6, 2017

A *BILL to amend and reenact § 54.1-700 of the Code of Virginia and to amend the Code of Virginia by adding in Article 6 of Chapter 29 of Title 54.1 a section numbered 54.1-2973.1, relating to the practice of laser hair removal.*

**Be it enacted by the General Assembly of Virginia:**

**1. That § 54.1-700 of the Code of Virginia is amended and reenacted and that the Code of Virginia is amended by adding in Article 6 of Chapter 29 of Title 54.1 a section numbered 54.1-2973.1 as follows:**

**§ 54.1-700. Definitions.**

As used in this chapter, unless the context requires a different meaning:

"Barber" means any person who shaves, shapes or trims the beard; cuts, singes, shampoos or dyes the hair or applies lotions thereto; applies, treats or massages the face, neck or scalp with oils, creams, lotions, cosmetics, antiseptics, powders, clays or other preparations in connection with shaving, cutting or trimming the hair or beard, and practices barbering for compensation and when such services are not performed for the treatment of disease.

"Barbering" means any one or any combination of the following acts, when done on the human body for compensation and not for the treatment of disease, shaving, shaping and trimming the beard; cutting, singeing, shampooing or dyeing the hair or applying lotions thereto; applications, treatment or massages of the face, neck or scalp with oils, creams, lotions, cosmetics, antiseptics, powders, clays, or other preparations in connection with shaving, cutting or trimming the hair or a beard. The term "barbering" shall not apply to the acts described hereinabove when performed by any person in his home if such service is not offered to the public.

"Barber instructor" means any person who has been certified by the Board as having completed an approved curriculum and who meets the competency standards of the Board as an instructor of barbering.

"Barbershop" means any establishment or place of business within which the practice of barbering is engaged in or carried on by one or more barbers.

"Board" means the Board for Barbers and Cosmetology.

"Body-piercer" means any person who for remuneration penetrates the skin of a person to make a hole, mark, or scar, generally permanent in nature.

"Body-piercing" means the act of penetrating the skin of a person to make a hole, mark, or scar, generally permanent in nature.

"Body-piercing salon" means any place in which a fee is charged for the act of penetrating the skin of a person to make a hole, mark, or scar, generally permanent in nature.

"Body-piercing school" means a place or establishment licensed by the Board to accept and train students in body-piercing.

"Cosmetologist" means any person who administers cosmetic treatments; manicures or pedicures the nails of any person; arranges, dresses, curls, waves, cleanses, cuts, shapes, singes, waxes, tweezes, shaves, bleaches, colors, relaxes, straightens, or performs similar work, upon human hair, or a wig or hairpiece, by any means, including hands or mechanical or electrical apparatus or appliances unless such acts as adjusting, combing, or brushing prestyled wigs or hairpieces do not alter the prestyled nature of the wig or hairpiece, and practices cosmetology for compensation.

"Cosmetology" includes, but is not limited to, the following practices: administering cosmetic treatments; manicuring or pedicuring the nails of any person; arranging, dressing, curling, waving, cleansing, cutting, shaping, singeing, waxing, tweezing, shaving, bleaching, coloring, relaxing, straightening, or similar work, upon human hair, or a wig or hairpiece, by any means, including hands or mechanical or electrical apparatus or appliances, but shall not include hair braiding or such acts as adjusting, combing, or brushing prestyled wigs or hairpieces when such acts do not alter the prestyled nature of the wig or hairpiece.

"Cosmetology instructor" means a person who has been certified by the Board as having completed an approved curriculum and who meets the competency standards of the Board as an instructor of cosmetology.

"Cosmetology salon" means any commercial establishment, residence, vehicle or other establishment,

59 place or event wherein cosmetology is offered or practiced on a regular basis for compensation and may  
60 include the training of apprentices under regulations of the Board.

61 "Esthetician" means a person who engages in the practice of esthetics for compensation.

62 "Esthetics" includes, but is not limited to, the following practices of administering cosmetic  
63 treatments to enhance or improve the appearance of the skin: cleansing, toning, performing effleurage or  
64 other related movements, stimulating, exfoliating, or performing any other similar procedure on the skin  
65 of the human body or scalp by means of cosmetic preparations, treatments, *or* any nonlaser device,  
66 *whether by* electrical, mechanical, or manual *means*, for care of the skin; applying make-up or eyelashes  
67 to any person, tinting or perming eyelashes and eyebrows, and lightening hair on the body except the  
68 scalp; and removing unwanted hair from the body of any person by the use of *any nonlaser device, by*  
69 *tweezing, or by use of* chemical, or mechanical means. However, "esthetics" is not a healing art and  
70 shall not include any practice, activity, or treatment that constitutes the practice of medicine, osteopathic  
71 medicine, or chiropractic. The terms "healing arts," "practice of medicine," "practice of osteopathic  
72 medicine," and "practice of chiropractic" shall mean the same as those terms are defined in § 54.1-2900.

73 "Esthetics instructor" means a licensed esthetician who has been certified by the Board as having  
74 completed an approved curriculum and who meets the competency standards of the Board as an  
75 instructor of esthetics.

76 "Esthetics spa" means any commercial establishment, residence, vehicle, or other establishment,  
77 place, or event wherein esthetics is offered or practiced on a regular basis for compensation under  
78 regulations of the Board.

79 "Master esthetician" means a licensed esthetician who, in addition to the practice of esthetics, offers  
80 to the public for compensation, without the use of laser technology, lymphatic drainage, chemical  
81 exfoliation, or microdermabrasion, and who has met such additional requirements as determined by the  
82 Board to practice lymphatic drainage, chemical exfoliation with products other than Schedules II through  
83 VI controlled substances as defined in the Drug Control Act (§ 54.1-3400 et seq.), and  
84 microdermabrasion of the epidermis.

85 "Nail care" means manicuring or pedicuring natural nails or performing artificial nail services.

86 "Nail salon" means any commercial establishment, residence, vehicle or other establishment, place or  
87 event wherein nail care is offered or practiced on a regular basis for compensation and may include the  
88 training of apprentices under regulations of the Board.

89 "Nail school" means a place or establishment licensed by the board to accept and train students in  
90 nail care.

91 "Nail technician" means any person who for compensation manicures or pedicures natural nails, or  
92 who performs artificial nail services for compensation, or any combination thereof.

93 "Nail technician instructor" means a licensed nail technician who has been certified by the Board as  
94 having completed an approved curriculum and who meets the competency standards of the Board as an  
95 instructor of nail care.

96 "Physical (wax) depilatory" means the wax depilatory product or substance used to remove  
97 superfluous hair.

98 "School of cosmetology" means a place or establishment licensed by the Board to accept and train  
99 students and which offers a cosmetology curriculum approved by the Board.

100 "School of esthetics" means a place or establishment licensed by the Board to accept and train  
101 students and which offers an esthetics curriculum approved by the Board.

102 "Tattoo parlor" means any place in which tattooing is offered or practiced.

103 "Tattoo school" means a place or establishment licensed by the Board to accept and train students in  
104 tattooing.

105 "Tattooer" means any person who for remuneration practices tattooing.

106 "Tattooing" means the placing of designs, letters, scrolls, figures, symbols or any other marks upon  
107 or under the skin of any person with ink or any other substance, resulting in the permanent coloration of  
108 the skin, including permanent make-up or permanent jewelry, by the aid of needles or any other  
109 instrument designed to touch or puncture the skin.

110 "Wax technician" means any person licensed by the Board who removes hair from the hair follicle  
111 using a physical (wax) depilatory or by tweezing.

112 "Wax technician instructor" means a licensed wax technician who has been certified by the Board as  
113 having completed an approved curriculum and who meets the competency standards of the Board as an  
114 instructor of waxing.

115 "Waxing" means the temporary removal of superfluous hair from the hair follicle on any area of the  
116 human body through the use of a physical (wax) depilatory or by tweezing.

117 "Waxing salon" means any commercial establishment, residence, vehicle or other establishment, place  
118 or event wherein waxing is offered or practiced on a regular basis for compensation and may include the  
119 training of apprentices under regulations of the Board.

120 "Waxing school" means a place or establishment licensed by the Board to accept and train students

121 in waxing.

122 ***§ 54.1-2973.1. Practice of laser hair removal.***

123 *The practice of laser hair removal shall be performed by a [ properly trained ] person licensed to*  
124 *practice medicine or osteopathic medicine [ or a physician assistant as authorized pursuant to*  
125 *§ 54.1-2952 or a nurse practitioner as authorized pursuant to § 54.1-2957 ] or by a properly trained*  
126 *person under the direction and supervision of a licensed doctor of medicine or osteopathic medicine [ or*  
127 *a physician assistant as authorized pursuant to § 54.1-2952 or a nurse practitioner as authorized*  
128 *pursuant to § 54.1-2957 ] who may delegate such practice in accordance with subdivision A 6 of*  
129 *§ 54.1-2901.*
