2 *An Act to amend and reenact §§ 46.2-802 and 46.2-804 of the Code of Virginia, relating to driving on*
3 *the right side of highways and special regulations applicable on highways laned for traffic;*
4 *penalties.*

7 **Be it enacted by the General Assembly of Virginia:**8 **1. That §§ 46.2-802 and 46.2-804 of the Code of Virginia are amended and reenacted as follows:**9 **§ 46.2-802. Drive on right side of highways; penalty.**

10 Except as otherwise provided by law, on all highways of sufficient width, the driver of a vehicle
11 shall drive on the right half of the highway, unless it is impracticable to travel on such side of the
12 highway and except when overtaking and passing another vehicle, subject to the provisions applicable to
13 overtaking and passing set forth in Article 4 (§ 46.2-837 et seq.) of this chapter. *A violation of this*
14 *section is punishable by a fine of \$250.*

15 **§ 46.2-804. Special regulations applicable on highways laned for traffic; penalty.**

16 For the purposes of this section, "traffic lines" includes any temporary traffic control devices used to
17 emulate the lines and markings in subdivisions 6 and 7.

18 Whenever any roadway has been divided into clearly marked lanes for traffic, drivers of vehicles
19 shall obey the following:

20 1. Any vehicle proceeding at less than the normal speed of traffic at the time and place and under
21 the conditions existing, shall be driven in the lane nearest the right edge or right curb of the highway
22 when such lane is available for travel except when overtaking and passing another vehicle or in
23 preparation for a left turn or where right lanes are reserved for slow-moving traffic as permitted in this
24 section;

25 2. A vehicle shall be driven as nearly as is practicable entirely within a single lane and shall not be
26 moved from that lane until the driver has ascertained that such movement can be made safely;

27 3. Except as otherwise provided in subdivision 5, on a highway which is divided into three lanes, no
28 vehicle shall be driven in the center lane except when overtaking and passing another vehicle or in
29 preparation for a left turn or unless such center lane is at the time allocated exclusively to traffic
30 moving in the direction the vehicle is proceeding and is signed or marked to give notice of such
31 allocation. Traffic-control devices may be erected directing specified traffic to use a designated lane or
32 designating those lanes to be used by traffic moving in a particular direction regardless of the center of
33 the roadway and drivers of vehicles shall obey the directions of every such device;

34 4. The Commissioner of Highways, or local authorities in their respective jurisdictions, may
35 designate right lanes for slow-moving vehicles and the Virginia Department of Transportation shall post
36 signs requiring trucks and combination vehicles to keep to the right on Interstate Highway System
37 components with no more than two travel lanes in each direction where terrain is likely to slow the
38 speed of such vehicles climbing hills and inclines to a speed that is less than the posted speed limit;

39 5. Wherever a highway is marked with double traffic lines consisting of a solid line immediately
40 adjacent to a broken line, no vehicle shall be driven to the left of such line if the solid line is on the
41 right of the broken line, except (i) when turning left for the purpose of entering or leaving a public,
42 private, or commercial road or entrance or (ii) in order to pass a pedestrian or a device moved by
43 human power, including a bicycle, skateboard, or foot-scooter, provided such movement can be made
44 safely. Where the middle lane of a highway is marked on both sides with a solid line immediately
45 adjacent to a broken line, such middle lane shall be considered a left-turn or holding lane and it shall be
46 lawful to drive to the left of such line if the solid line is on the right of the broken line for the purpose
47 of turning left into any road or entrance, provided that the vehicle may not travel in such lane further
48 than 150 feet;

49 6. Wherever a highway is marked with double traffic lines consisting of two immediately adjacent
50 solid yellow lines, no vehicle shall be driven to the left of such lines, except (i) when turning left or (ii)
51 in order to pass a pedestrian or a device moved by human power, including a bicycle, skateboard, or
52 foot-scooter, provided such movement can be made safely; and

53 7. Whenever a highway is marked with double traffic lines consisting of two immediately adjacent
54 solid white lines, no vehicle shall cross such lines.

55 *A violation of this section is punishable by a fine of \$250.*
