A BILL to amend and reenact § 2.2-4310 of the Code of Virginia, relating to the Virginia Public Procurement Act; SWaM goals.

Be it enacted by the General Assembly of Virginia:

1. That § 2.2-4310 of the Code of Virginia is amended and reenacted as follows: 10

§ 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, 11 and service disabled veteran-owned business and employment services organization. 12

A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or 13 14 offeror because of race, religion, color, sex, national origin, age, disability, status as a service disabled veteran, or any other basis prohibited by state law relating to discrimination in employment. Whenever 15 solicitations are made, each public body shall include businesses selected from a list made available by 16 the Department of Small Business and Supplier Diversity, which list shall include all companies and 17 18 organizations certified by the Department.

19 B. All public bodies shall establish programs consistent with this chapter to facilitate the participation of small businesses, businesses owned by women, minorities, and service disabled veterans, and employment services organizations in procurement transactions. The programs established shall be in 20 21 22 writing and shall comply with the provisions of any enhancement or remedial measures authorized by 23 the Governor pursuant to subsection C or, where applicable, by the chief executive of a local governing 24 body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. 25 State agencies shall submit annual progress reports on (i) small, women-owned, and minority-owned business procurement, (ii) service disabled veteran-owned business procurement, and (iii) employment 26 27 services organization procurement to the Department of Small Business and Supplier Diversity in a form 28 specified by the Department of Small Business and Supplier Diversity. Contracts and subcontracts 29 awarded to employment services organizations shall be credited toward an agency's and a contractor's 30 small business, women-owned, and minority-owned business contracting and subcontracting goals. The 31 Department of Small Business and Supplier Diversity shall make information on service disabled veteran-owned procurement available to the Department of Veterans Services upon request. 32

33 C. Whenever there exists (i) a rational basis for small business or employment services organization 34 enhancement or (ii) a persuasive analysis that documents a statistically significant disparity between the 35 availability and utilization of women-owned and minority-owned businesses, the Governor is authorized 36 and encouraged to require state agencies to implement appropriate enhancement or remedial measures 37 consistent with prevailing law.

38 D. In awarding a contract for services to a small, women-owned, or minority-owned business that is 39 certified in accordance with § 2.2-1606, or to a business identified by a public body as a service 40 disabled veteran-owned business where the award is being made pursuant to an enhancement or remedial 41 program as provided in subsection C, the public body shall include in every such contract of more than 42 \$10,000 the following:

"If the contractor intends to subcontract work as part of its performance under this contract, the 43 44 contractor shall include in the proposal a plan to subcontract to small, women-owned, minority-owned, 45 and service disabled veteran-owned businesses."

46 E. In the solicitation or awarding of contracts, no state agency, department or institution shall 47 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the 48 state agency, department or institution has made a written determination that employing ex-offenders on 49 the specific contract is not in its best interest. 50

F. As used in this section:

51 "Employment services organization" means an organization that provides community-based 52 employment services to individuals with disabilities that is an approved Commission on Accreditation of 53 Rehabilitation Facilities (CARF) accredited vendor of the Department for Aging and Rehabilitative 54 Services.

55 "Minority individual" means an individual who is a citizen of the United States or a legal resident 56 alien and who satisfies one or more of the following definitions:

1. "African American" means a person having origins in any of the original peoples of Africa and 57 58 who is regarded as such by the community of which this person claims to be a part.

8 9 59 2. "Asian American" means a person having origins in any of the original peoples of the Far East,
60 Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China,
61 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of

the Pacific, India, Pakistan, Bangladesh, or Sri Lanka and who is regarded as such by the community ofwhich this person claims to be a part.

64 3."Hispanic American" means a person having origins in any of the Spanish-speaking peoples of
65 Mexico, South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and
66 who is regarded as such by the community of which this person claims to be a part.

4. "Native American" means a person having origins in any of the original peoples of North America and who is regarded as such by the community of which this person claims to be a part or who is recognized by a tribal organization.

"Minority-owned business" means a business that is at least 51 percent owned by one or more 70 71 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 72 interest in the corporation, partnership, or limited liability company or other entity is owned by one or 73 74 more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 75 daily business operations are controlled by one or more minority individuals, or any historically black college or university as defined in § 2.2-1604, regardless of the percentage ownership by minority 76 individuals or, in the case of a corporation, partnership, or limited liability company or other entity, the 77 78 equity ownership interest in the corporation, partnership, or limited liability company or other entity.

79 "Šervice disabled veteran" means a veteran who (i) served on active duty in the United States
80 military ground, naval, or air service, (ii) was discharged or released under conditions other than
81 dishonorable, and (iii) has a service-connected disability rating fixed by the United States Department of
82 Veterans Affairs.

83 "Service disabled veteran business" means a business that is at least 51 percent owned by one or
84 more service disabled veterans or, in the case of a corporation, partnership, or limited liability company
85 or other entity, at least 51 percent of the equity ownership interest in the corporation, partnership, or
86 limited liability company or other entity is owned by one or more individuals who are service disabled
87 veterans and both the management and daily business operations are controlled by one or more
88 individuals who are service disabled veterans.

89 "Small business" means a business, independently owned and controlled by one or more individuals
90 who are U.S. citizens or legal resident aliens, and together with affiliates, has 250 or fewer employees,
91 or annual gross receipts of \$10 million or less averaged over the previous three years. One or more of
92 the individual owners shall control both the management and daily business operations of the small
93 business.

94 "State agency" means any authority, board, department, instrumentality, institution, agency, or other95 unit of state government. "State agency" shall not include any county, city, or town.

96 "Women-owned business" means a business that is at least 51 percent owned by one or more women 97 who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited 98 liability company or other entity, at least 51 percent of the equity ownership interest is owned by one or 99 more women who are U.S. citizens or legal resident aliens, and both the management and daily business 100 operations are controlled by one or more women.
