14	§ 2.2-205.2. Host Cities Economic Development Incentive Fund.
15	A. As used in this section, "host cities" means the Cities of Newport News, Norfolk, and Portsmouth.
16	B. There is hereby created in the state treasury a special nonreverting fund to be known as the Host
17	Cities Economic Development Incentive Fund, referred to in this section as "the Fund." The Fund shall
18	be established on the books of the Comptroller. The Fund shall consist of such moneys appropriated by
19	the General Assembly, donations, grants, and in-kind contributions made to the Fund for the purposes
20	stated herein. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it.
21	Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall not
22	revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for the
23	purposes of supporting economic development, growth of existing businesses, and job creation related to

The Fund shall be established on the books of the Comptroller. The Fund shall consist of such moneys appropriated by the
