That the Code of Virginia is amended by adding in Article 4 of Chapter 4 of Title 24.2 a 11 section numbered 24.2-425.1 as follows: 12 13 § 24.2-425.1. Election day voter registration; pilot program. 14 A.1. The State Board shall develop an election day voter registration pilot program (the pilot program) in order to study the advisability of implementing election day voter registration in the 15 16 Commonwealth. 2. Any county or city may participate in the pilot program by submitting an application to the State 17 Board. The application shall be signed by each member of the electoral board and the general registrar 18 19 for that locality. 20 3. Any county or city approved by the State Board for participation in the pilot program shall offer 21 election day voter registration at every election held in the locality while the locality is a participant in 22 the pilot program. 23 B.1. In a county or city participating in the pilot program, a person who (i) offers to vote on 24 election day but is not a registered voter, (ii) provides one of the forms of identification specified in 25 subsection B of § 24.2-643, and (iii) provides proof of his residency, in a form specified by the State Board for this purpose, in the precinct in which he offers to vote, shall be permitted to register to vote 26 27 and to cast a ballot in accordance with the provisions of this section. 28 2. Such person shall be given a printed ballot and provide, subject to the penalties for making false 29 statements pursuant to § 24.2-1016, on an envelope supplied by the Department of Elections, the 30 information required on the envelope, including full name; gender; date of birth; social security number, if any; whether he is presently a United States citizen; address of residence in the precinct; place of last 31 previous registration to vote; and whether he has ever been adjudicated incapacitated and disqualified 32 33 to vote or convicted of a felony and, if so, whether his right to vote has been restored. 34 3. In the presence of an officer of election, but in secret manner, such person shall mark the printed 35 ballot and seal it in the envelope. The envelope containing the ballot shall then promptly be placed in 36 the ballot container by an officer of election, and an officer of election shall enter the person in the 37 pollbook in accordance with the instructions of the State Board. 38 4. During its meeting following the election to determine the validity of provisional votes, the 39 electoral board shall also determine the eligibility of each person having submitted a ballot and 40 registration pursuant to this section. If the electoral board determines that such person is (i) entitled to 41 register to vote and (ii) a qualified voter of the precinct in which he offered to vote, but for not being registered to vote, his ballot shall be counted in accordance with the procedures set by the State Board 42 43 for the counting of such ballots. 44 5. The State Board shall develop guidelines for the secure storage and delivering of such envelopes 45 to the general registrar, who shall use the information provided to register such persons in the manner 46 provided by law. 47 C. The electoral board of any county or city participating in the pilot program shall provide information on the implementation of the program in the locality, including the number of ballots cast 48 49 by persons who registered on election day, to the State Board by December 1 of each year of its participation. The State Board shall provide guidance on the information to be provided and the form in 50 51 which it is to be provided. 52 2. That the provisions of this act shall expire on December 31, 2019. 53 3. That the State Board of Elections, on or before the first day of the 2020 Regular Session of the General Assembly, shall submit a report to the Governor, the General Assembly, and the House 54 55 and Senate Committees on Privileges and Elections on the implementation of the election day voter registration pilot program in participating localities. The report shall include a recommendation to 56 57 the General Assembly regarding whether to implement statewide election day voter registration on 58 a permanent, statewide basis. If making a recommendation to implement statewide election day

- 59 60 voter registration on a permanent, statewide basis, the report shall also include recommendations for implementing legislation.
