11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 59.1-69, 59.1-70, and 59.1-74 of the Code of Virginia are amended and reenacted as
13	follows:
14	§ 59.1-69. Certificate required of individual or entity transacting business under assumed or
15	fictitious name; filing certificate.
16	A. As used in this chapter unless the context requires a different meaning:
17	"Certificate" means an assumed or fictitious name certificate that complies with the requirements of
18	subdivision B 1.
19	"Entity" means a partnership, registered limited liability partnership required to register under
20	Article 9 (§ 50-73.132 et seq.) of Chapter 2.2 of Title 50, limited partnership filing a certificate under
2 1	§ 50-73.11, foreign limited partnership required to register with the Commission under § 50-73.54,
22	limited liability company, or corporation.
$\overline{23}$	B. No person, partnership, limited liability company individual or corporation entity shall conduct or
24	transact business in this the Commonwealth under any assumed or fictitious name unless such person,
25	partnership, limited liability company individual or corporation shall sign entity:
26	<i>1. Signs</i> and acknowledge a certificate setting forth the:
27	a. The name under which such business is to be conducted or transacted, and the;
28	b. The names of each person, partnership, limited liability company individual or corporation entity
29	owning the same, with their respective post-office and residence addresses (; and, (i) when the

32	(1) A foreign limited partnership or limited liability company, the date of the certificate of

46	B. D. No person, partnership, limited liability company individual or corporation entity shall use an
47	assumed or fictitious name in the conduct of its business to intentionally misrepresent the geographic
48	origin or location of any such person <i>individual</i> or entity.
49	§ 59.1-70. Filing certificate with clerk of State Corporation Commission; fee; release certificate.
50	A. When business is conducted in this the Commonwealth under an assumed or fictitious name by a
51	limited partnership filing a certificate under § 50-73.11, by a foreign limited partnership required to
52	register with the Commission under § 50-73.54, or by a limited liability company or corporation such
53	domestic or foreign limited partnership, limited liability company or corporation (i) an entity, the entity
54	shall file in the office of the clerk of the State Corporation Commission, prior to October 1, 2018, a
55	copy of the certificate described in § 59.1-69 filed under subdivision B 2 a of § 59.1-69, duly attested
56	by the clerk of the court in which the original is on file, and (ii) an individual or an entity, the
57	individual or entity shall file in the office of the clerk of the State Corporation Commission, on or after
58	October 1, 2018, the original of the certificate. The State Corporation Commission shall charge a

When business is no longer conducted in this the Commonwealth under an assumed or fictitious name by a limited partnership filing a certificate under § 50-73.11, by a foreign limited partnership required to register with the Commission under § 50-73.54, or by a limited liability company or 61 62 63 corporation an individual or entity that has filed an assumed or fictitious name certificate, the domestic 64 or foreign limited partnership, limited liability company individual or corporation entity may file with 65 the clerk of the State Corporation Commission a copy of a release certificate. If the assumed or fictitious name certificate has been filed in the office of a clerk of court under subdivision B 2 a of § 59.1-69, the 66 release certificate shall be duly attested by the clerk of the court in which the assumed or fictitious 67 name certificate is on file. The State Corporation Commission shall charge a ten dollar fee of \$10 for **68** 69 the filing of such the release certificate.

§ 59.1-74. Recordation of certificate and registration of names.

A. The clerk of court with whom the a certificate provided for in § 59.1-69 is filed shall keep (i) a 71 book in which all such certificates shall be recorded, with their date of record, and shall keep (ii) a 72 register in which shall be entered in alphabetical order the name under which every such business 73 74 identified in a certificate is conducted and the names of every person individual or entity owning the 75 same business. The clerk shall be entitled to a fee of ten dollars \$10 for filing and recording such each 76 certificate and entering such names.

No license shall be issued by the a Commissioner of the Revenue until the a certificate has been 78 made and filed (i) in the elerk's office of the clerk of court if required under subdivision $B \ 2 \ a \ of$ 79 § 59.1-69 or (ii) in the office of the clerk of the State Corporation Commission if required by subsection 80 B 2 b of § 59.1-69, and evidence of same produced before him the filing has been provided to the 81

Commissioner of the Revenue.
