That §§ 59.1-69, 59.1-70, and 59.1-74 of the Code of Virginia are amended and reenacted and 10 that the Code of Virginia is amended by adding sections numbered 59.1-70.1 and 59.1-75.1 as 11 12 follows: § 59.1-69. Certificate required of person transacting business under assumed name. 13 14 A. As used in this chapter, unless the context requires a different meaning: 15 "Commission" means the State Corporation Commission. 16 "Person" has the meaning prescribed in § 1-230. 17 B. No person, partnership, limited liability company or corporation shall conduct or transact business in this the Commonwealth under any assumed or fictitious name unless such person, partnership, limited 18 liability company or corporation shall sign and acknowledge a certificate setting forth the name under 19 20 which such business is to be conducted or transacted, and the names of each person, partnership, limited 21 liability company or corporation owning the same, with their respective post-office and residence 22 addresses (and, (i) when the partnership or limited liability company is a foreign limited partnership or limited liability company, the date of the certificate of registration to transact business in this 23 24 Commonwealth issued to it by the State Corporation Commission, or (ii) when the corporation is a 25 foreign corporation, the date of the certificate of authority to transact business in this Commonwealth issued to it by the State Corporation Commission), and file the same files in the office of the clerk of 26 27 the court in which deeds are recorded in the county or city wherein the business is to be conducted 28 *Commission a certificate of assumed or fictitious name.* 29 B. C. No person, partnership, limited liability company or corporation shall use an assumed or 30 fictitious name in the conduct of its the person's business to intentionally misrepresent the geographic 31 origin or location of any such the person or entity. 32 § 59.1-70. Filing a certificate with State Corporation Commission; fee. 33 A. When business is conducted in this Commonwealth under an assumed or fictitious name by a 34 limited partnership filing a certificate under § 50-73.11, by a foreign limited partnership required to 35 register with the Commission under § 50-73.54, or by a limited liability company or corporation, such 36 domestic or foreign limited partnership, limited liability company or corporation shall file in the office 37 of the clerk of the State Corporation Commission a copy of the certificate described in § 59.1-69, duly 38 attested by the clerk of the court in which the original is on file. The certificate of assumed or fictitious 39 name shall be on a form prescribed by the Commission that sets forth the following: 40 1. The name of the person who will be conducting business under the assumed or fictitious name; 41 2. The assumed or fictitious name of the business: 42 3. Whether the person who will be conducting business under the assumed or fictitious name is an individual or, if not, the type of legal or commercial entity of the person; 43 44 4. If the person who will be conducting business under the assumed or fictitious name is an individual, the post office address of the individual's office or residence, which shall include a street 45 address, city or town, state, and zip code; 46 5. If the person who will be conducting business under the assumed or fictitious name is a domestic 47 **48** or foreign corporation, limited liability company, business trust, or limited partnership authorized by the Commission to transact business in the Commonwealth, the identification number issued by the 49 50 *Commission to the person;* 51 6. If the person who will be conducting business under the assumed or fictitious name is a domestic 52 or foreign partnership that has filed with the Commission a statement of partnership authority or a 53 statement of registration as a registered limited liability partnership that has not been canceled, the 54 identification number issued by the Commission to the partnership; 55 7. If the person who will be conducting business under the assumed or fictitious name is not subject to subdivision 4, 5, or 6, the post office address of the person's principal place of business, which shall 56 include a street address, city or town, state, and zip code; and 57 8. The printed name and title of the individual signing the certificate of assumed or fictitious name. 58

59 B. The certificate of assumed or fictitious name shall be signed by (i) the individual who will be 72

60 conducting business under the assumed or fictitious name or (ii) an authorized representative of the person who will be conducting business under the assumed or fictitious name when the person is not an 61 62 individual.

63 C. The State Corporation clerk of the Commission shall charge a ten-dollar fee of \$10 for the filing 64 of a fictitious or an *certificate of* assumed *or fictitious* name.

65 B. When business is no longer conducted in this Commonwealth under an assumed or fictitious name 66 by a limited partnership filing a certificate under § 50-73.11, by a foreign limited partnership required to register with the Commission under § 50-73.54, or by a limited liability company or corporation, the 67 domestic or foreign limited partnership, limited liability company or corporation may file with the clerk 68 of the State Corporation Commission a copy of a release certificate, duly attested by the clerk of the 69 court in which the certificate is on file. The Commission shall charge a ten dollar fee for the filing of 70 71 such certificate.

§ 59.1-70.1. Certificate of release.

73 A. When a person is no longer conducting business in the Commonwealth under an assumed or 74 fictitious name on file with the clerk of the Commission, the name may be released by filing a certificate 75 of release of an assumed or fictitious name in the office of the clerk of the Commission that is signed (i)76 by the individual who conducted business under the assumed or fictitious name, (ii) on behalf of the 77 person who conducted business under the assumed or fictitious name when the person is not an 78 individual, (iii) by a court-appointed fiduciary of the person, or (iv) by the person's successor in interest 79 when the person is not an individual.

80 B. When a person is no longer conducting business in the Commonwealth under an assumed or fictitious name on file with a circuit court, the name may be released by filing a certificate of release of 81 82 an assumed or fictitious name with the clerk of the court that is signed and acknowledged by the 83 person, a court-appointed fiduciary of the person, or, when the person is not an individual, the person's 84 successor in interest.

85 C. The certificate of release of an assumed or fictitious name shall be on a form prescribed by the 86 Commission. The fee to file a certificate of release of an assumed or fictitious name with the clerk of 87 the Commission or with the clerk of the court shall be \$10. 88

§ 59.1-74. Recordation of certificates and registration of names.

89 A. The clerk of the court with whom the a certificate provided for in $\frac{59.1-69}{9}$ of assumed or 90 fictitious name is filed shall keep a book in which all such certificates shall be of assumed or fictitious 91 name and certificates of release of an assumed or fictitious name are recorded, with their date of record, 92 and shall keep a register in which shall be entered in alphabetical order the name under which every 93 such business is conducted and the names of every person owning the same business. The clerk shall be 94 entitled to a fee of ten dollars for filing and recording such certificate and entering such names.

95 B. No license shall be issued by the Commissioner a commissioner of the Revenue revenue until the 96 a certificate of assumed or fictitious name has been made and filed (i) in the office of the clerk of the 97 Commission or (ii) prior to May 1, 2019, in the elerk's office of the clerk of the court, and evidence of 98 same produced before him the filing has been provided to the commissioner of the revenue by the 99 person conducting business under the assumed or fictitious name.

100 § 59.1-75.1. Penalty for signing false certificate.

101 A. It is unlawful for any person to sign a certificate the person knows is false in any material respect 102 with intent that the certificate be delivered to the Commission for filing.

103 B. Any person who violates the provisions of this section is guilty of a Class 1 misdemeanor.

2. That the provisions of this act shall become effective on May 1, 2019. 104
