10	RESOLVED by the Senate, the House of Delegates concurring, a majority of the members elected to
11	each house agreeing, That the following amendments to the Constitution of Virginia be, and the same
12	hereby are, proposed and referred to the General Assembly at its first regular session held after the next
13	general election of members of the House of Delegates for its concurrence in conformity with the
14	provisions of Section 1 of Article XII of the Constitution of Virginia, namely:
15	Amend Section 1 of Article II and Section 12 of Article V of the Constitution of Virginia as follows:
16	ARTICLE II
17	FRANCHISE AND OFFICERS
18	Section 1. Qualifications of voters.
19	In elections by the people, the qualifications of voters shall be as follows: Each voter shall be a
20	citizen of the United States, shall be eighteen years of age, shall fulfill the residence requirements set
21	forth in this section, and shall be registered to vote pursuant to this article. No person who has been
22	convicted of a violent felony, as defined by the General Assembly, shall be qualified to vote unless his
23	civil rights have been restored by the Governor or other appropriate authority. A person who has been
24	convicted of a nonviolent felony, as defined by the General Assembly, shall have his civil rights restored
25	upon his completion of service of his sentence and any modification of sentence, including any period or
26	condition of probation, parole, or suspension of sentence, and his payment in full of any restitution,
27	fines, costs, and fees assessed against him as a result of the felony conviction. As prescribed by law, no
28	person adjudicated to be mentally incompetent shall be qualified to vote until his competency has been
29	reestablished.
30	The residence requirements shall be that each voter shall be a resident of the Commonwealth and of
31	the precinct where he votes. Residence, for all purposes of qualification to vote, requires both domicile
32 33	and a place of abode. The General Assembly may provide for persons who are employed overseas, and their spouses and dependents residing with them, and who are qualified to vote except for relinquishing
33 34	their place of abode in the Commonwealth while overseas, to vote in the Commonwealth subject to
34 35	conditions and time limits defined by law. The General Assembly may provide for persons who are
33 36	qualified to vote except for having moved their residence from one precinct to another within the
30 37	Commonwealth to continue to vote in a former precinct subject to conditions and time limits defined by
38	law. The General Assembly may also provide, in elections for President and Vice President of the
39	United States, alternatives to registration for new residents of the Commonwealth.
40	Any person who will be qualified with respect to age to vote at the next general election shall be
41	permitted to register in advance and also to vote in any intervening primary or special election.
42	ARTICLE V
43	EXECUTIVE
44	Section 12. Executive clemency.
45	The Governor shall have power to remit fines and penalties under such rules and regulations as may
46	be prescribed by law; to grant reprieves and pardons after conviction except when the prosecution has
47	been carried on by the House of Delegates; to remove political disabilities consequent upon conviction
48	for offenses committed prior or subsequent to the adoption of this Constitution; and to commute capital
49	punishment.
50	He shall communicate to the General Assembly, at each regular session, particulars of every case of
51	fine or penalty remitted, of reprieve or pardon granted, and of punishment commuted, with his reasons
52	for remitting, granting, or commuting the same.
