In accordance with the provisions of §30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of the above-referenced legislation:								
Bill Summary: Allows all localities to impose a cigarette tax by removing the requirement that only those localities that had such authority prior to 1977 are eligible. The bill sets a maximum rate on the cigarette tax imposed by counties of five cents per pack or the amount levied under state law, whichever is greater.								
Executive Summary: SB 1329 allows all localities to impose cigarette tax and set the maximum rate for cigarette tax. Localities have evaluated a positive fiscal impact ranging from \$0.01 - \$400,000.00. Some localities noted that the bill would have positive fiscal impact as they currently are not allowed to impose a cigarette tax. Other localities noted that the bill would not have an impact as they currently administer a cigarette tax. One locality noted that they administer a cigarette tax without state limitation as they are a city and not a county.								
Please note that one professional organization provided a positive fiscal impact of \$6,000,000.00 but noted that the fiscal impact is not quantifiable without knowing what localities would choose to impose the tax.

Locality: City of Winchester

Estimated Fiscal Impact: \$1.00

This is a great one! This bill would enable counties to implement a cigarette tax, an option currently limited to cities, towns and a few select counties. This would be good for our City businesses in helping to "level the playing field" of competitive cigarette pricing versus comparable county businesses. This is also another step in reducing the scourge of cigarette trafficking.

Locality: Commissioners of the Revenue Association of Virginia \$6,000,000.00

Locality: Fairfax County.

Estimated Fiscal Impact: \$1.00

Fairfax and Arlington are the only two counties in Virginia that currently have the authority to levy a cigarette tax. Fairfax County levies the tax at a rate of 30 cents per pack. As such, this bill would not impact Fairfax County.

Locality: Louisa County Estimated Fiscal Impact: \$75,000.00

Louisa County would benefit financially if it was allowed to impose a five cent per pack cigarette tax. Louisa has a current population of approximately 34,602 (as per the Census Bureau 2015 estimate). Of this number, 79% are above 18 years old and smoking statistics show that 16.5% of adults in Virginia smoked in 2015. This equals approximately 4500 smokers in Louisa County, not including those under the age of 18 that smoke. Per statistics, the average smoker smokes a pack a day. Estimating 360 packs per year at .05 per pack, this is \$18 per year per person, which would give the county an additional \$81,000 per year in revenue (4500 people x \$18). This revenue would be reduced by administrative costs associated with collecting the tax (collecting and reviewing reports and recording the revenue from cigarette vendors each month as well as enforcing collection of such taxes). This would be similar to administering other tax sources. Costs are estimated at 25 hours per month times 12 months per year times \$20 per hour staff cost. The costs would total approximately \$6,000 per year for net revenue of \$75,000 per year.

Locality: Rockingham County Estimated Fiscal Impact: \$0.01

We don't impose a cigarette tax at present, but we already have the authority to do so.						
There could be a positive indirect effect for the Town. This bill is a good step for counties' revenue generating authority, and Sen. Carrico should be applauded for pursuing this extension. Other counties I've previously worked around have wished for this authority, and I expect many would activate the 5-cent taxes immediately. I would expect Franklin County to do so. My quick conservative guess at revenue would be \$300,000 annually. This is a significant boost at a time when other revenue sources are stagnant. As a general fund tool, it would do much to help with infrastructure financing, public safety staffing, and other critical local needs.
