4. Title: Virginia Higher Education Scholarship Act and admission of in-state freshmen students at public institutions of higher education

5. Summary: The proposed legislation requires, beginning with the incoming freshman class of 2017, the board of visitors of all four-year public institutions of higher education to maintain a ratio of the in-state and out-of-state student population for each incoming freshman class that is not less than 55 percent in-state students. The bill also establishes the Virginia Higher Education Scholarship Fund and Program. The program provides scholarships to the top two percent of graduates from Virginia public high schools that attend four-year public institutions of higher education.

7. Fiscal Impact Estimates: Indeterminate. See Line 8.

8. Fiscal Implications: Based on data provided by the State Council of Higher Education, all four-year public institutions of higher education currently enroll over 55 percent of in-state freshmen students. (See attached table at the end of the Fiscal Impact Statement)

The legislation also creates a special nonreverting fund in the state treasury to be funded by the General Assembly or through gifts, grants, or donations from public or private sources. The fund shall earn interest and not revert to the general fund at the end of each fiscal year. The monies in the fund are to be solely used for the purpose of awarding scholarships to the top two percent of Virginia's public high school graduates. The scholarships pay for tuition, mandatory fees, room, and board for eight semesters over five years. Recipients may apply the scholarships to one of nine four-year public institutions of higher education on the basis of the locality of the student's high school or to Norfolk State University, Virginia Military Institute, or Virginia State University. Disbursements from the fund shall be made upon written request signed by the Director of the State Council of Higher Education.

The fiscal impact will be determined by the amount of state funding approved by the General Assembly to support this new scholarship program. In addition, there may be additional staff costs to the Council to implement this program, if funded.
