4. Title: Dogs; public animal shelters required to notify intent to euthanize.

5. Summary: This bill requires a public animal shelter to notify any person or releasing agency of its intent to euthanize an abandoned dog, and to wait five days before euthanizing the dog, if the person or agency has requested the adoption or transfer of the particular animal. The shelter is not required to provide such notice if it has reason to believe that the dog has injured a human or the dog meets certain other specified conditions for euthanasia. The bill also makes technical amendments.

8. Fiscal Implications: It is anticipated that this bill will have an expenditure impact on the Department of Agriculture and Consumer Services (VDACS) to provide guidance and standards for shelters to document compliance and to enforce the provisions of the bill. There are 110 public shelters in Virginia that are inspected annually. In 2015, approximately 40,278 dogs entered public animal shelters as strays. Ensuring compliance at each shelter for that number of records will increase the time required for routine inspections. Furthermore, VDACS anticipates that there may be complaints as a result of the complex nature of the process to extend the holding period for select animals. Complaints will require staff time for investigations and may result in civil penalties which require additional time to process. As such, VDACS will require one additional staff member at an annual cost of \$85,412 for salary, benefits, equipment, and travel.

It is also anticipated that this bill will have an indeterminate expenditure impact on localities, as shelters will be required to house, feed, water, and provide veterinary care for animals for longer hold times. A 2016 survey of animal control agencies in 48 localities found that the average number of days an animal remained in the shelter was 18.6. In the same study, the average cost to the locality for one dog to stay in the shelter for one night was \$17.40.
