6	A BILL to amend and reenact § 2.2-1122 of the Code of Virginia, relating to the Department of General
7	Services; aid and cooperation of Division of Purchases and Supply may be sought by any fire
8	company and volunteer emergency medical services agency.
9	Be it enacted by the General Assembly of Virginia:
10	1. That § 2.2-1122 of the Code of Virginia is amended and reenacted as follows:
11	§ 2.2-1122. Aid and cooperation of Division may be sought by any public body or public
12	broadcasting station in making purchases; use of facilities of Virginia Distribution Center; services
13	to certain volunteer organizations.
14	A. Virginia public broadcasting stations as defined in § 22.1-20.1, and public bodies as defined in
15	§ 2.2-4300 who are empowered to purchase material, equipment, and supplies of any kind, may purchase
16	through the Division. When any such public body, public broadcasting station, or duly authorized officer
17	requests the Division to obtain bids for any materials, equipment and supplies, and the bids have been
18	obtained by the Division, the Division may award the contract to the lowest responsible bidder, and the
19	public body or public broadcasting station shall be bound by the contract. The Division shall set forth in
20	the purchase order that the materials, equipment, and supplies be delivered to, and that the bill be
21	rendered and forwarded to, the public body or public broadcasting station. Any such bill shall be a valid
22	and enforceable claim against the public body or public broadcasting station requesting the bids.
23	B. The Division may make available to any public body or public broadcasting station the facilities
24	of the Virginia Distribution Center maintained by the Division; however, the furnishing of any such
25	services or supplies shall not limit or impair any services or supplies normally rendered any department,
26	division, institution, or agency of the Commonwealth.
27	C. The Board of Education shall furnish to the Division a list of public broadcasting stations in
28	Virginia for the purposes of this section.
29	D. The services or supplies authorized by this section shall extend to any volunteer fire company as
30	defined in § 27-6.01 or volunteer emergency medical services agency as defined in § 32.1-111.1 that is
31	recognized by an ordinance to be a part of the safety program of a county, city, or town when the
32	services or supplies are sought through and approved by the governing body of such county, city, or
33	town. Purchases of motor fuel shall be limited for use in vehicles and equipment as defined in
34	subsection A 12 of § 58.1-2259.
35	E. For purposes of this section, "public broadcasting station" means the same as that term is defined
36	in § 22.1-20.1.
