That § 2.2-2101 of the Code of Virginia is amended and reenacted and the Code of Virginia is 11 amended by adding in Chapter 25 of Title 2.2 an article numbered 10, consisting of sections 12 numbered 2.2-2537 through 2.2-2543, as follows: 13 § 2.2-2101. Prohibition against service by legislators on boards, commissions, and councils 14 15 within the executive branch; exceptions. Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils 16 within the executive branch of state government who are responsible for administering programs 17 established by the General Assembly. Such prohibition shall not extend to boards, commissions, and 18 councils engaged solely in policy studies or commemorative activities. If any law directs the 19 20 appointment of any member of the General Assembly to a board, commission, or council in the 21 executive branch of state government that is responsible for administering programs established by the 22 General Assembly, such portion of such law shall be void, and the Governor shall appoint another 23 person from the Commonwealth at large to fill such a position. 24 The provisions of this section shall not apply to members of the Board for Branch Pilots, who shall 25 be appointed as provided for in § 54.1-901; to members of the Board of Trustees of the Southwest Virginia Higher Education Center, who shall be appointed as provided for in § 23.1-3126; to members 26 27 of the Board of Trustees of the Southern Virginia Higher Education Center, who shall be appointed as 28 provided for in § 23.1-3121; to members of the Board of Directors of the New College Institute, who 29 shall be appointed as provided for in § 23.1-3112; to members of the Advisory Board on Teacher 30 Education and Licensure, who shall be appointed as provided for in § 22.1-305.2; to members of the Virginia Interagency Coordinating Council, who shall be appointed as provided for in § 2.2-5204; to 31 members of the Board of Veterans Services, who shall be appointed as provided for in § 2.2-2452; to 32 33 members appointed to the Board of Trustees of the Roanoke Higher Education Authority pursuant to 34 § 23.1-3117; to members of the Board of Trustees of the Online Virginia Network Authority, who shall 35 be appointed as provided in § 23.1-3136; to members of the Virginia Geographic Information Network 36 Advisory Board, who shall be appointed as provided for in § 2.2-2423; to members of the Standards of 37 Learning Innovation Committee, who shall be appointed as provided for in § 22.1-253.13:10; to members of the Board of Visitors of the Virginia School for the Deaf and the Blind, who shall be 38 39 appointed as provided for in § 22.1-346.2; to members of the Substance Abuse Services Council, who 40 shall be appointed as provided for in § 2.2-2696; to members of the Criminal Justice Services Board, 41 who shall be appointed as provided in § 9.1-108; to members of the State Executive Council for Children's Services, who shall be appointed as provided in § 2.2-2648; to members of the Virginia Board 42 of Workforce Development, who shall be appointed as provided for in § 2.2-2471; to members of the 43 Volunteer Firefighters' and Rescue Squad Workers' Service Award Fund Board, who shall be appointed 44 as provided for in § 51.1-1201; to members of the Secure and Resilient Commonwealth Panel, who shall 45 be appointed as provided for in § 2.2-222.3; to members of the Forensic Science Board, who shall be appointed as provided for in § 9.1-1109; to members of the Southwest Virginia Cultural Heritage 46 47 Foundation, who shall be appointed as provided in § 2.2-2735; or to members of the Virginia Growth 48 49 and Opportunity Board, who shall be appointed as provided in § 2.2-2485; or to members of the 50 Henrietta Lacks Commission, who shall be appointed as provided in § 2.2-2538. 51 Article 10.

#### Henrietta Lacks Commission. § 2.2-2537. Henrietta Lacks Commission; purpose.

53 The Henrietta Lacks Commission (the Commission) is established as an advisory commission in the 54 55 executive branch of state government. The purpose of the Commission is to sustain the legacy of the life-changing contribution of Henrietta Lacks to medical science by advancing cancer research and 56 57 treatment through the creation of a biomedical research and data center.

58 § 2.2-2538. Membership; terms; vacancies; chairman and vice-chairman.

59 A. The Commission shall consist of nine members that include two legislative members, three 60 nonlegislative citizen members, and [ three four ] ex officio members. Members shall be appointed as follows: (i) one member of the House of Delegates to be appointed by the Speaker of the House of 61 62 Delegates in accordance with the principles of proportional representation contained in the Rules of the 63 House of Delegates; (ii) one member of the Senate to be appointed by the Senate Committee on Rules; 64 and (iii) one nonlegislative citizen member who is a member of the extended family of Henrietta Lacks, 65 one nonlegislative citizen member who is a member of the Board of Directors of the Henrietta Lacks Legacy Group, and one nonlegislative citizen member who is a member of the Halifax County Industrial 66 Development Authority to be appointed by the Governor. The mayor of the Town of South Boston, the 67 chair of the Board of Supervisors of Halifax County, the Executive Director of the Southern Virginia **68** Higher Education Center, and the Executive Director of the Halifax County Industrial Development 69 70 Authority, or their designees, shall serve ex officio with voting privileges. Nonlegislative citizen members 71 of the Commission shall be citizens of the Commonwealth. Unless otherwise approved in writing by the chairman of the Commission and the respective Clerk, nonlegislative citizen members shall only be 72 73 reimbursed for lodging and travel originating or ending within the Commonwealth of Virginia for the 74 purpose of attending meetings.

75 B. Legislative members and ex officio members of the Commission shall serve terms coincident with 76 their terms of office. Nonlegislative citizen members shall be appointed for a term of two years. 77 Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. 78 Legislative members and nonlegislative citizen members may be reappointed. However, no nonlegislative 79 citizen member shall serve more than four consecutive two-year terms. The remainder of any term to 80 which a member is appointed to fill a vacancy shall not constitute a term in determining the member's 81 eligibility for reappointment. Vacancies shall be filled in the same manner as the original appointments. 82 C. The Commission shall elect a chairman and vice-chairman from among its membership.

83 § 2.2-2539. Quorum; meetings; voting on recommendations.

84 A majority of the members shall constitute a quorum. The meetings of the Commission shall be held 85 at the call of the chairman or whenever a majority of the members so request. 86

### § 2.2-2540. Compensation; expenses.

87 Legislative members of the Commission shall receive such compensation as provided in § 30-19.12. 88 and nonlegislative citizen members shall receive such compensation for the performance of their duties 89 as provided in § 2.2-2813. All members shall be reimbursed for reasonable and necessary expenses 90 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Compensation to 91 members of the General Assembly for attendance at official meetings of the Commission shall be paid 92 by the offices of the Clerk of the House of Delegates or Clerk of the Senate, as applicable. All other compensation and expenses shall be paid from existing appropriations to the Commission or, if 93 unfunded, shall be approved by the [ Joint Rules Committee Department of Health ]. 94 95

#### § 2.2-2541. Powers and duties of the Commission.

The Commission shall have the power and duty to:

97 1. Establish a public-private partnership to create the Henrietta Lacks Life Sciences Center as a 98 cancer research and treatment center located in Halifax County and designed to (i) transform and 99 accelerate cancer research and treatment through the use of biodata tools, (ii) provide tailored cancer 100 treatment medicine to an underserved portion of rural Southside Virginia, and (iii) incubate new biotech 101 businesses across the Southside Virginia region; and

102 2. Submit to the Governor and the General Assembly an annual report for publication as a report 103 document as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports. The chairman of the Commission shall submit to the 104 105 Governor and the General Assembly an annual executive summary of the interim activity and work of the Commission no later than the first day of each regular session of the General Assembly. The 106 107 executive summary shall be submitted for publication as a report document as provided in the 108 procedures of the Division of Legislative Automated Systems for the processing of legislative documents 109 and reports and shall be posted on the General Assembly's website. 110

## § 2.2-2542. Staffing; cooperation of agencies of state and local governments.

111 The Department of Health shall provide staff support to the Commission. Every department, division, board, bureau, commission, authority, or political subdivision of the Commonwealth shall cooperate 112 113 with, and provide assistance to, the Commission, upon request.
