That § 46.2-613 of the Code of Virginia is amended and reenacted as follows: § 46.2-613. Offenses relating to registration, licensing, and certificates of title; penalties. 10 11 A. No person shall: 12 1. Operate, park, or permit the operation or parking of a motor vehicle, trailer, or semitrailer owned, leased, or otherwise controlled by him to be operated on a highway unless (i) it is registered, (ii) a 13 certificate of title therefor has been issued, and (iii) it has displayed on it the license plate or plates and 14 15 decal or decals, if any, assigned to it by the Department for the current registration period, subject to the 16 exemptions mentioned in Article 5 (§ 46.2-655 et seq.) and Article 6 (§ 46.2-662 et seq.). The provisions of this subdivision shall apply to the registration, licensing, and titling of mopeds on or after July 1, 17 18 2014. 19 2. Display, or cause or permit to be displayed, any registration card, certificate of title, or license 20 plate or decal which that he knows is fictitious or which that he knows has been cancelled, revoked, 21 suspended, or altered; or display or cause or permit to be displayed on any motor vehicle, trailer, or 22 semitrailer any license plate or decal that he knows is currently issued for another vehicle. Violation of 23 this subdivision shall constitute a Class 2 misdemeanor. 24 3. Possess or lend use any registration card, license plate, or decal to which he is not entitled or 25 knowingly permit the use of any registration card, license plate, or decal by anyone not entitled to it. 26 4. Fail or refuse to surrender to the Department or the Department of State Police, on demand, any 27 certificate of title, registration card, or license plate or decal which has been suspended, cancelled, or 28 revoked. Violation of this subdivision shall constitute a Class 2 misdemeanor. 29 5. Use a false name or address in any application for the registration of any motor vehicle, trailer, or 30 semitrailer or, for a certificate of title, or for any renewal or duplicate certificate, or knowingly to make 31 a false statement of a material fact or to, knowingly conceal a material fact, or otherwise commit a fraud 32 in any registration application. Violation of this subdivision shall constitute a Class 1 misdemeanor. 33 6. Willfully and intentionally violate the limitations imposed under §§ 46.2-665, 46.2-666, and 34 46.2-670 while operating an unregistered vehicle pursuant to the agricultural and horticultural 35 exemptions allowed under those sections. A first violation of this subdivision shall constitute a traffic 36 infraction punishable by a fine of not more than \$250, and a second or subsequent violation of this 37 subdivision shall constitute a traffic infraction punishable by a fine of \$250. 38 B. For any summons issued for a violation of this section, the court may, in its discretion, dismiss 39 the summons, where proof of compliance with this section is provided to the court on or before the 40 court date.
