18107484D 1 **HOUSE BILL NO. 2** 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the Senate Committee on Education and Health 4 on February 22, 2018) 5 (Patron Prior to Substitute—Delegate Bell, Richard P.) 6 A BILL to amend and reenact § 22.1-298.1 of the Code of Virginia, relating to teacher licensure; 7 reciprocity; spouses of Armed Forces members. 8 Be it enacted by the General Assembly of Virginia: 9 1. That § 22.1-298.1 of the Code of Virginia is amended and reenacted as follows: 10 § 22.1-298.1. Regulations governing licensure. 11 A. As used in this section: "Alternate route to licensure" means a nontraditional route to teacher licensure available to 12 individuals who meet the criteria specified in the regulations issued by the Board of Education. 13 14 "Industry certification credential" means an active career and technical education credential that is 15 earned by successfully completing a Board of Education-approved industry certification examination, 16 being issued a professional license in the Commonwealth, or successfully completing an occupational 17 competency examination. 18 "Licensure by reciprocity" means a process used to issue a license to an individual coming into the Commonwealth from another state when that individual meets certain conditions specified in the Board 19 20 of Education's regulations. 21 "Professional teacher's assessment" means those tests mandated for licensure as prescribed by the 22 Board of Education. 23 "Provisional license" means a nonrenewable license issued by the Board of Education for a specified 24 period of time, not to exceed three years, to an individual who may be employed by a school division in 25 the Commonwealth and who generally meets the requirements specified in the Board of Education's regulations for licensure, but who may need to take additional coursework or pass additional assessments 26 27 to be fully licensed with a renewable license. 28 "Renewable license" means a license issued by the Board of Education for five years to an individual 29 who meets the requirements specified in the Board of Education's regulations. 30 B. The Board of Education shall prescribe, by regulation, the requirements for the licensure of teachers and other school personnel required to hold a license. Such regulations shall include 31 32 requirements for the denial, suspension, cancellation, revocation, and reinstatement of licensure and procedures for the immediate and thorough investigation by the division superintendent or his designee 33 34 of any complaint alleging that a license holder has engaged in conduct that may form the basis for the 35 revocation of his license. At a minimum, such procedures for investigations contained in such 36 regulations shall require (i) the division superintendent to petition for the revocation of the license upon 37 completing such investigation and finding that there is reasonable cause to believe that the license holder 38 has engaged in conduct that forms the basis for revocation of a license; (ii) the school board to proceed 39 to a hearing on such petition for revocation within 90 days of the mailing of a copy of the petition to 40 the license holder, unless the license holder requests the cancellation of his license in accordance with 41 Board regulations; and (iii) the school board to provide a copy of the investigative file and such petition 42 for revocation to the Superintendent of Public Instruction at the time that the hearing is scheduled. The Board of Education shall revoke the license of any person for whom it has received a notice of 43 dismissal or resignation pursuant to subsection F of § 22.1-313 and, in the case of a person who is the 44 subject of a founded complaint of child abuse or neglect, after all rights to any administrative appeal 45 provided by § 63.2-1526 have been exhausted. Regardless of the authority of any other agency of the 46 47 Commonwealth to approve educational programs, only the Board of Education shall have the authority **48** to license teachers to be regularly employed by school boards, including those teachers employed to 49 provide nursing education. 50 The Board of Education shall prescribe by regulation the licensure requirements for teachers who 51 teach only online courses, as defined in § 22.1-212.23. Such license shall be valid only for teaching online courses. Teachers who hold a five-year renewable license issued by the Board of Education may 52 53 teach online courses for which they are properly endorsed.

54 C. The Board of Education's regulations shall include requirements that a person seeking initial 55 licensure: 56

1. Complete professional assessments as prescribed by the Board of Education;

2. Complete study in attention deficit disorder;

3. Complete study in gifted education, including the use of multiple criteria to identify gifted 58 59 students: and

60 4. Complete study in methods of improving communication between schools and families and ways 61 of increasing family involvement in student learning at home and at school. 62

D. In addition, such regulations shall include requirements that:

63 1. Every person seeking initial licensure or renewal of a license demonstrate proficiency in the use of 64 educational technology for instruction;

65 2. Every person seeking initial licensure and persons seeking licensure renewal as teachers who have 66 not completed such study shall complete study in child abuse recognition and intervention in accordance with curriculum guidelines developed by the Board of Education in consultation with the Department of 67 Social Services that are relevant to the specific teacher licensure routes; 68

3. Every person seeking initial licensure or renewal of a license shall receive professional 69 development in instructional methods tailored to promote student academic progress and effective 70 71 preparation for the Standards of Learning end-of-course and end-of-grade assessments;

4. Every person seeking renewal of a license shall complete all renewal requirements, including 72 professional development in a manner prescribed by the Board, except that no person seeking renewal of 73 a license shall be required to satisfy any such requirement by completing coursework and earning credit 74 75 at an institution of higher education;

5. Every person seeking initial licensure or renewal of a license shall provide evidence of completion 76 77 of certification or training in emergency first aid, cardiopulmonary resuscitation, and the use of 78 automated external defibrillators. The certification or training program shall (i) be based on the current 79 national evidence-based emergency cardiovascular care guidelines for cardiopulmonary resuscitation and 80 the use of an automated external defibrillator, such as a program developed by the American Heart Association or the American Red Cross, and (ii) include hands-on practice of the skills necessary to 81 perform cardiopulmonary resuscitation. The Board shall provide a waiver for this requirement for any 82 person with a disability whose disability prohibits such person from completing the certification or 83 training; 84

85 6. Every person seeking licensure with an endorsement as a teacher of the blind and visually impaired shall demonstrate proficiency in reading and writing Braille; 86

87 7. Every teacher seeking an initial license in the Commonwealth with an endorsement in the area of 88 career and technical education shall have an industry certification credential in the area in which the 89 teacher seeks endorsement. If a teacher seeking an initial license in the Commonwealth has not attained 90 an industry certification credential in the area in which the teacher seeks endorsement, the Board may, 91 upon request of the employing school division or educational agency, issue the teacher a provisional 92 license to allow time for the teacher to attain such credential;

93 8. Every person seeking initial licensure or renewal of a license shall complete awareness training, 94 provided by the Department of Education, on the indicators of dyslexia, as that term is defined by the 95 Board pursuant to regulations, and the evidence-based interventions and accommodations for dyslexia; 96 and

97 9. Every person seeking initial licensure or renewal of a license with an endorsement as a school 98 counselor shall complete training in the recognition of mental health disorder and behavioral distress, 99 including depression, trauma, violence, youth suicide, and substance abuse.

E. Each local school board or division superintendent may waive for any individual whom it seeks to 100 employ as a career and technical education teacher and who is also seeking initial licensure or renewal 101 102 of a license with an endorsement in the area of career and technical education any applicable requirement set forth in subsection C or subdivision D 1, 3, 4, 6, or 8. 103

104 F. The Board's regulations shall require that initial licensure for principals and assistant principals be contingent upon passage of an assessment as prescribed by the Board. 105

G. The Board shall establish criteria in its regulations to effectuate the substitution of experiential 106 learning for coursework for those persons seeking initial licensure through an alternate route as defined 107 108 in Board regulations.

109 H. Notwithstanding any provision of law to the contrary, the Board (i) may provide for the issuance 110 of a provisional license, valid for a period not to exceed three years, pursuant to subdivision D 7 or to any person who does not meet the requirements of this section or any other requirement for licensure 111 112 imposed by law and (ii) shall provide for the issuance of a provisional license, valid for a period not to exceed three years, to any former member of the Armed Forces of the United States or the Virginia 113 114 National Guard who has received an honorable discharge and has the appropriate level of experience or training but does not meet the requirements for a renewable license. 115

I. The Board's licensure regulations shall also provide for licensure by reciprocity:

1. With comparable endorsement areas for those individuals holding a valid out-of-state teaching 117 license and national certification from the National Board for Professional Teaching Standards or a 118 nationally recognized certification program approved by the Board of Education. The application for 119 120 such individuals shall require evidence of such valid licensure and national certification and shall not

121 require official student transcripts;

122 2. For any spouse of an active duty member of the Armed Forces of the United States or the
123 Commonwealth who has obtained a valid out-of-state license, with full credentials and without
124 deficiencies, that is in force at the time the application for a Virginia license is received by the
125 Department of Education. Each such individual shall establish a file in the Department of Education by
126 submitting a complete application packet, which shall include official student transcripts. No service
127 requirements or licensing assessments shall be required for any such individual; and

128 3. For individuals who have obtained a valid out-of-state license, with full credentials and without 129 deficiencies, that is in force at the time the application for a Virginia license is received by the 130 Department of Education. The individual must establish a file in the Department of Education by 131 submitting a complete application packet, which shall include official student transcripts. An assessment of basic skills as provided in § 22.1-298.2 and service requirements shall not be imposed for these 132 133 licensed individuals. Other licensing assessments, as prescribed by the Board of Education, shall be required, but any such individual shall be exempt from any professional teacher's assessment 134 135 requirements, subject to the approval of the division superintendent or the school board in the school 136 division in which such individual is employed; and

137 3. The Board may include other provisions for reciprocity in its regulations.
