11	1. That §§ 46.2-742.1 and 46.2-742.2 of the Code of Virginia are amended and reenacted as
12	follows:
13	§ 46.2-742.1. Special license plates for persons awarded the Bronze Star, Bronze Star with a
14	"V" for valor, or the Silver Star.
15	On receipt of an application and written evidence that the applicant has been awarded a Bronze Star,
16	Bronze Star with a "V" for valor, or Silver Star Medal, the Commissioner shall issue to the applicant
17	special license plates.
18	For each set of license plates issued under this section, the Commissioner shall charge, in addition to
19	the prescribed cost of state license plates, a one-time fee of \$10 at the time the plates are issued.
20	The provisions of subdivisions B 1 and 2 of subsection B of § 46.2-725 shall not apply to license
21	plates issued under this section. The design of license plates issued under this section to persons who have been awarded multiple
22 23	decorations shall reflect the number of such decorations.
23 24	Unremarried surviving spouses of persons eligible to receive special license plates under this section
25	may also be issued special license plates under this section.

30	Commissioner shall issue to the applicant special license plates.
31	The provisions of subdivisions B 1 and 2 of subsection B of § 46.2-725 shall not apply to license
32	plates issued under this section.
33 34	Unremarried surviving spouses of persons eligible to receive special license plates under this section

42	Merit Medal, the Commissioner of the Department of Motor Vehicles shall issue to the applicant special
43	license plates for recipients of the Legion of Merit Medal. For each set of license plates issued to
44 45	recipients of a Legion of Merit Medal, the Commissioner shall charge a one-time fee of \$10 at the time
45 46	the plates are issued in addition to the prescribed fee for state license plates. Such license plates shall not be subject to the provincions of subdivision B 1 or B 2 of 8 462 725 of the Code of Virginia. The
46 47	not be subject to the provisions of subdivision B 1 or B 2 of § $46.2-725$ of the Code of Virginia. The design of license plates issued to persons who have been awarded this decoration may vary to reflect the
