Be it enacted by the General Assembly of Virginia: 6

7 1. That §§ 16.1-228 and 63.2-100 of the Code of Virginia are amended and reenacted as follows: 8 § 16.1-228. Definitions.

When used in this chapter, unless the context otherwise requires:

"Abused or neglected child" means any child:

1. Whose parents or other person responsible for his care creates or inflicts, threatens to create or 11 12 inflict, or allows to be created or inflicted upon such child a physical or mental injury by other than 13 accidental means, or creates a substantial risk of death, disfigurement or impairment of bodily or mental functions, including, but not limited to, a child who is with his parent or other person responsible for his 14 15 care either (i) during the manufacture or attempted manufacture of a Schedule I or II controlled substance, or (ii) during the unlawful sale of such substance by that child's parents or other person 16 17 responsible for his care, where such manufacture, or attempted manufacture or unlawful sale would 18 constitute a felony violation of § 18.2-248;

19 2. Whose parents or other person responsible for his care neglects or refuses to provide care 20 necessary for his health; however, no child who in good faith is under treatment solely by spiritual 21 means through prayer in accordance with the tenets and practices of a recognized church or religious 22 denomination shall for that reason alone be considered to be an abused or neglected child; 23

3. Whose parents or other person responsible for his care abandons such child;

24 4. Whose parents or other person responsible for his care commits or allows to be committed any 25 sexual act upon a child in violation of the law;

26 5. Who is without parental care or guardianship caused by the unreasonable absence or the mental or 27 physical incapacity of the child's parent, guardian, legal custodian, or other person standing in loco 28 parentis;

29 6. Whose parents or other person responsible for his care creates a substantial risk of physical or 30 mental injury by knowingly leaving the child alone in the same dwelling, including an apartment as 31 defined in § 55-79.2, with a person to whom the child is not related by blood or marriage and who the parent or other person responsible for his care knows has been convicted of an offense against a minor 32 33 for which registration is required as a violent sexual offender pursuant to § 9.1-902; or

7. Who has been identified as a victim of sex trafficking or severe forms of trafficking as defined in 34 the Trafficking Victims Protection Act of 2000, 22 U.S.C § 7102 et seq., and in the Justice for Victims 35 of Trafficking Act of 2015, 42 U.S.C. § 5101 et seq. 36

37 If a civil proceeding under this chapter is based solely on the parent having left the child at a 38 hospital or emergency medical services agency, it shall be an affirmative defense that such parent safely 39 delivered the child to a hospital that provides 24-hour emergency services or to an attended emergency 40 medical services agency that employs emergency medical services personnel, within 14 days of the child's birth. For purposes of terminating parental rights pursuant to § 16.1-283 and placement for 41 42 adoption, the court may find such a child is a neglected child upon the ground of abandonment.

43 Adoptive home" means the place of residence of any natural person in which a child resides as a member of the household and in which he has been placed for the purposes of adoption or in which he 44 45 has been legally adopted by another member of the household. 46

"Adult" means a person 18 years of age or older.

"Ancillary crime" or "ancillary charge" means any delinquent act committed by a juvenile as a part 47 48 of the same act or transaction as, or which constitutes a part of a common scheme or plan with, a 49 delinquent act which would be a felony if committed by an adult.

50 "Boot camp" means a short term secure or nonsecure juvenile residential facility with highly 51 structured components including, but not limited to, military style drill and ceremony, physical labor, education and rigid discipline, and no less than six months of intensive aftercare. 52

53 "Child," "juvenile," or "minor" means a person less than 18 years of age.

54 "Child in need of services" means (i) a child whose behavior, conduct or condition presents or results 55 in a serious threat to the well-being and physical safety of the child or (ii) a child under the age of 14 56 whose behavior, conduct or condition presents or results in a serious threat to the well-being and HB528ER

57 physical safety of another person; however, no child who in good faith is under treatment solely by 58 spiritual means through prayer in accordance with the tenets and practices of a recognized church or 59 religious denomination shall for that reason alone be considered to be a child in need of services, nor 50 shall any child who habitually remains away from or habitually deserts or abandons his family as a 51 result of what the court or the local child protective services unit determines to be incidents of physical, 52 emotional or sexual abuse in the home be considered a child in need of services for that reason alone.

63 However, to find that a child falls within these provisions, (i) the conduct complained of must 64 present a clear and substantial danger to the child's life or health or to the life or health of another 65 person, (ii) the child or his family is in need of treatment, rehabilitation or services not presently being 66 received, and (iii) the intervention of the court is essential to provide the treatment, rehabilitation or 67 services needed by the child or his family.

"Child in need of supervision" means:

1. A child who, while subject to compulsory school attendance, is habitually and without justification absent from school, and (i) the child has been offered an adequate opportunity to receive the benefit of any and all educational services and programs that are required to be provided by law and which meet the child's particular educational needs, (ii) the school system from which the child is absent or other appropriate agency has made a reasonable effort to effect the child's regular attendance without success, and (iii) the school system has provided documentation that it has complied with the provisions of § 22.1-258; or

2. A child who, without reasonable cause and without the consent of his parent, lawful custodian or placement authority, remains away from or deserts or abandons his family or lawful custodian on more than one occasion or escapes or remains away without proper authority from a residential care facility in which he has been placed by the court, and (i) such conduct presents a clear and substantial danger to the child's life or health, (ii) the child or his family is in need of treatment, rehabilitation or services not presently being received, and (iii) the intervention of the court is essential to provide the treatment, rehabilitation or services needed by the child or his family.

83 "Child welfare agency" means a child-placing agency, child-caring institution or independent foster84 home as defined in § 63.2-100.

85 "The court" or the "juvenile court" or the "juvenile and domestic relations court" means the juvenile86 and domestic relations district court of each county or city.

87 "Delinquent act" means (i) an act designated a crime under the law of the Commonwealth, or an ordinance of any city, county, town, or service district, or under federal law, (ii) a violation of § 18.2-308.7, or (iii) a violation of a court order as provided for in § 16.1-292, but shall not include an act other than a violation of § 18.2-308.7, which is otherwise lawful, but is designated a crime only if committed by a child. For purposes of §§ 16.1-241 and 16.1-278.9, the term shall include a refusal to take a breath test in violation of § 18.2-268.2 or a similar ordinance of any county, city, or town.

"Delinquent child" means a child who has committed a delinquent act or an adult who has committed
a delinquent act prior to his 18th birthday, except where the jurisdiction of the juvenile court has been
terminated under the provisions of § 16.1-269.6.

"Department" means the Department of Juvenile Justice and "Director" means the administrative head
in charge thereof or such of his assistants and subordinates as are designated by him to discharge the
duties imposed upon him under this law.

"Family abuse" means any act involving violence, force, or threat that results in bodily injury or places one in reasonable apprehension of death, sexual assault, or bodily injury and that is committed by a person against such person's family or household member. Such act includes, but is not limited to, any forceful detention, stalking, criminal sexual assault in violation of Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2, or any criminal offense that results in bodily injury or places one in reasonable apprehension of death, sexual assault, or bodily injury or places one in reasonable

105 "Family or household member" means (i) the person's spouse, whether or not he or she resides in the 106 same home with the person, (ii) the person's former spouse, whether or not he or she resides in the same 107 home with the person, (iii) the person's parents, stepparents, children, stepchildren, brothers, sisters, 108 half-brothers, half-sisters, grandparents and grandchildren, regardless of whether such persons reside in 109 the same home with the person, (iv) the person's mother-in-law, father-in-law, sons-in-law, 110 daughters-in-law, brothers-in-law and sisters-in-law who reside in the same home with the person, (v) 111 any individual who has a child in common with the person, whether or not the person and that 112 individual have been married or have resided together at any time, or (vi) any individual who cohabits 113 or who, within the previous 12 months, cohabited with the person, and any children of either of them 114 then residing in the same home with the person.

115 "Foster care services" means the provision of a full range of casework, treatment and community 116 services for a planned period of time to a child who is abused or neglected as defined in § 63.2-100 or 117 in need of services as defined in this section and his family when the child (i) has been identified as

118 needing services to prevent or eliminate the need for foster care placement, (ii) has been placed through 119 an agreement between the local board of social services or a public agency designated by the 120 community policy and management team and the parents or guardians where legal custody remains with 121 the parents or guardians, (iii) has been committed or entrusted to a local board of social services or 122 child welfare agency, or (iv) has been placed under the supervisory responsibility of the local board 123 pursuant to § 16.1-293.

"Independent living arrangement" means placement of (i) a child at least 16 years of age who is in the custody of a local board or licensed child-placing agency and has been placed by the local board or licensed child-placing agency or (ii) a child at least 16 years of age or a person between the ages of 18 and 21 who was committed to the Department of Juvenile Justice immediately prior to placement by the Department of Juvenile Justice, in a living arrangement in which he such child or person does not have daily substitute parental supervision.

130 "Independent living services" means services and activities provided to a child in foster care 14 years 131 of age or older and who has been committed or entrusted to a local board of social services, child welfare agency, or private child-placing agency. "Independent living services" may also mean services 132 133 and activities provided to a person who (i) was in foster care on his 18th birthday and has not yet 134 reached the age of 21 years; (ii) is between the ages of 18 and 21 and who, immediately prior to his 135 commitment to the Department of Juvenile Justice, was in the custody of a local board of social 136 services; or (iii) is a child at least 16 years of age or a person between the ages of 18 and 21 who was 137 committed to the Department of Juvenile Justice immediately prior to placement in an independent living 138 arrangement. Such services shall include counseling, education, housing, employment, and money 139 management skills development and access to essential documents and other appropriate services to help 140 children or persons prepare for self-sufficiency.

141 "Intake officer" means a juvenile probation officer appointed as such pursuant to the authority of this142 chapter.

143 ^{*}Jail" or "other facility designed for the detention of adults" means a local or regional correctional 144 facility as defined in § 53.1-1, except those facilities utilized on a temporary basis as a court holding 145 cell for a child incident to a court hearing or as a temporary lock-up room or ward incident to the 146 transfer of a child to a juvenile facility.

147 "The judge" means the judge or the substitute judge of the juvenile and domestic relations district148 court of each county or city.

149 "This law" or "the law" means the Juvenile and Domestic Relations District Court Law embraced in150 this chapter.

"Legal custody" means (i) a legal status created by court order which vests in a custodian the right to have physical custody of the child, to determine and redetermine where and with whom he shall live, the right and duty to protect, train and discipline him and to provide him with food, shelter, education and ordinary medical care, all subject to any residual parental rights and responsibilities or (ii) the legal status created by court order of joint custody as defined in § 20-107.2.

156 "Permanent foster care placement" means the place of residence in which a child resides and in 157 which he has been placed pursuant to the provisions of §§ 63.2-900 and 63.2-908 with the expectation 158 and agreement between the placing agency and the place of permanent foster care that the child shall 159 remain in the placement until he reaches the age of majority unless modified by court order or unless 160 removed pursuant to § 16.1-251 or 63.2-1517. A permanent foster care placement may be a place of 161 residence of any natural person or persons deemed appropriate to meet a child's needs on a long-term 162 basis.

"Residual parental rights and responsibilities" means all rights and responsibilities remaining with the
parent after the transfer of legal custody or guardianship of the person, including but not limited to the
right of visitation, consent to adoption, the right to determine religious affiliation and the responsibility
for support.

167 "Secure facility" or "detention home" means a local, regional or state public or private locked
 168 residential facility that has construction fixtures designed to prevent escape and to restrict the movement
 169 and activities of children held in lawful custody.

170 "Shelter care" means the temporary care of children in physically unrestricting facilities.

171 "State Board" means the State Board of Juvenile Justice.

172 "Status offender" means a child who commits an act prohibited by law which would not be criminal173 if committed by an adult.

174 "Status offense" means an act prohibited by law which would not be an offense if committed by an175 adult.

176 "Violent juvenile felony" means any of the delinquent acts enumerated in subsection B or C of177 § 16.1-269.1 when committed by a juvenile 14 years of age or older.

179 As used in this title, unless the context requires a different meaning: 180

"Abused or neglected child" means any child less than 18 years of age:

1. Whose parents or other person responsible for his care creates or inflicts, threatens to create or 181 182 inflict, or allows to be created or inflicted upon such child a physical or mental injury by other than 183 accidental means, or creates a substantial risk of death, disfigurement, or impairment of bodily or mental 184 functions, including, but not limited to, a child who is with his parent or other person responsible for his care either (i) during the manufacture or attempted manufacture of a Schedule I or II controlled 185 186 substance, or (ii) during the unlawful sale of such substance by that child's parents or other person 187 responsible for his care, where such manufacture, or attempted manufacture or unlawful sale would 188 constitute a felony violation of § 18.2-248;

189 2. Whose parents or other person responsible for his care neglects or refuses to provide care 190 necessary for his health. However, no child who in good faith is under treatment solely by spiritual 191 means through prayer in accordance with the tenets and practices of a recognized church or religious 192 denomination shall for that reason alone be considered to be an abused or neglected child. Further, a 193 decision by parents who have legal authority for the child or, in the absence of parents with legal 194 authority for the child, any person with legal authority for the child, who refuses a particular medical 195 treatment for a child with a life-threatening condition shall not be deemed a refusal to provide necessary 196 care if (i) such decision is made jointly by the parents or other person with legal authority and the child; 197 (ii) the child has reached 14 years of age and is sufficiently mature to have an informed opinion on the 198 subject of his medical treatment; (iii) the parents or other person with legal authority and the child have 199 considered alternative treatment options; and (iv) the parents or other person with legal authority and the 200 child believe in good faith that such decision is in the child's best interest. Nothing in this subdivision 201 shall be construed to limit the provisions of § 16.1-278.4; 202

3. Whose parents or other person responsible for his care abandons such child;

203 4. Whose parents or other person responsible for his care commits or allows to be committed any act 204 of sexual exploitation or any sexual act upon a child in violation of the law;

5. Who is without parental care or guardianship caused by the unreasonable absence or the mental or 205 206 physical incapacity of the child's parent, guardian, legal custodian or other person standing in loco 207 parentis;

208 6. Whose parents or other person responsible for his care creates a substantial risk of physical or 209 mental injury by knowingly leaving the child alone in the same dwelling, including an apartment as 210 defined in § 55-79.2, with a person to whom the child is not related by blood or marriage and who the 211 parent or other person responsible for his care knows has been convicted of an offense against a minor 212 for which registration is required as a violent sexual offender pursuant to § 9.1-902; or

213 7. Who has been identified as a victim of sex trafficking or severe forms of trafficking as defined in 214 the Trafficking Victims Protection Act of 2000, 22 U.S.C § 7102 et seq., and in the Justice for Victims 215 of Trafficking Act of 2015, 42 U.S.C. § 5101 et seq.

216 If a civil proceeding under this title is based solely on the parent having left the child at a hospital 217 or emergency medical services agency, it shall be an affirmative defense that such parent safely 218 delivered the child to a hospital that provides 24-hour emergency services or to an attended emergency 219 medical services agency that employs emergency medical services providers, within 14 days of the 220 child's birth. For purposes of terminating parental rights pursuant to § 16.1-283 and placement for 221 adoption, the court may find such a child is a neglected child upon the ground of abandonment.

222 "Adoptive home" means any family home selected and approved by a parent, local board or a 223 licensed child-placing agency for the placement of a child with the intent of adoption.

224 "Adoptive placement" means arranging for the care of a child who is in the custody of a 225 child-placing agency in an approved home for the purpose of adoption.

226 "Adult abuse" means the willful infliction of physical pain, injury or mental anguish or unreasonable 227 confinement of an adult as defined in § 63.2-1603.

228 "Adult day care center" means any facility that is either operated for profit or that desires licensure 229 and that provides supplementary care and protection during only a part of the day to four or more aged, 230 infirm or disabled adults who reside elsewhere, except (i) a facility or portion of a facility licensed by the State Board of Health or the Department of Behavioral Health and Developmental Services, and (ii) 231 232 the home or residence of an individual who cares for only persons related to him by blood or marriage. 233 Included in this definition are any two or more places, establishments or institutions owned, operated or 234 controlled by a single entity and providing such supplementary care and protection to a combined total 235 of four or more aged, infirm or disabled adults.

"Adult exploitation" means the illegal, unauthorized, improper, or fraudulent use of an adult as 236 237 defined in § 63.2-1603 or his funds, property, benefits, resources, or other assets for another's profit, 238 benefit, or advantage, including a caregiver or person serving in a fiduciary capacity, or that deprives the 239 adult of his rightful use of or access to such funds, property, benefits, resources, or other assets. "Adult

240 exploitation" includes (i) an intentional breach of a fiduciary obligation to an adult to his detriment or 241 an intentional failure to use the financial resources of an adult in a manner that results in neglect of 242 such adult; (ii) the acquisition, possession, or control of an adult's financial resources or property 243 through the use of undue influence, coercion, or duress; and (iii) forcing or coercing an adult to pay for 244 goods or services or perform services against his will for another's profit, benefit, or advantage if the 245 adult did not agree, or was tricked, misled, or defrauded into agreeing, to pay for such goods or services 246 or to perform such services.

247 "Adult foster care" means room and board, supervision, and special services to an adult who has a physical or mental condition. Adult foster care may be provided by a single provider for up to three 248 249 adults.

250 "Adult neglect" means that an adult as defined in § 63.2-1603 is living under such circumstances that 251 he is not able to provide for himself or is not being provided services necessary to maintain his physical 252 and mental health and that the failure to receive such necessary services impairs or threatens to impair 253 his well-being. However, no adult shall be considered neglected solely on the basis that such adult is 254 receiving religious nonmedical treatment or religious nonmedical nursing care in lieu of medical care, 255 provided that such treatment or care is performed in good faith and in accordance with the religious 256 practices of the adult and there is a written or oral expression of consent by that adult.

257 "Adult protective services" means services provided by the local department that are necessary to 258 protect an adult as defined in § 63.2-1603 from abuse, neglect or exploitation.

259 "Assisted living care" means a level of service provided by an assisted living facility for adults who 260 may have physical or mental impairments and require at least a moderate level of assistance with 261 activities of daily living.

262 "Assisted living facility" means any congregate residential setting that provides or coordinates 263 personal and health care services, 24-hour supervision, and assistance (scheduled and unscheduled) for 264 the maintenance or care of four or more adults who are aged, infirm or disabled and who are cared for 265 in a primarily residential setting, except (i) a facility or portion of a facility licensed by the State Board 266 of Health or the Department of Behavioral Health and Developmental Services, but including any portion of such facility not so licensed; (ii) the home or residence of an individual who cares for or 267 268 maintains only persons related to him by blood or marriage; (iii) a facility or portion of a facility 269 serving infirm or disabled persons between the ages of 18 and 21, or 22 if enrolled in an educational 270 program for the handicapped pursuant to § 22.1-214, when such facility is licensed by the Department as a children's residential facility under Chapter 17 (§ 63.2-1700 et seq.), but including any portion of the 271 272 facility not so licensed; and (iv) any housing project for persons 62 years of age or older or the disabled 273 that provides no more than basic coordination of care services and is funded by the U.S. Department of 274 Housing and Urban Development, by the U.S. Department of Agriculture, or by the Virginia Housing 275 Development Authority. Included in this definition are any two or more places, establishments or 276 institutions owned or operated by a single entity and providing maintenance or care to a combined total 277 of four or more aged, infirm or disabled adults. Maintenance or care means the protection, general 278 supervision and oversight of the physical and mental well-being of an aged, infirm or disabled 279 individual.

280 "Auxiliary grants" means cash payments made to certain aged, blind or disabled individuals who 281 receive benefits under Title XVI of the Social Security Act, as amended, or would be eligible to receive 282 these benefits except for excess income.

283 "Birth family" or "birth sibling" means the child's biological family or biological sibling.

284 "Birth parent" means the child's biological parent and, for purposes of adoptive placement, means 285 parent(s) by previous adoption.

286 "Board" means the State Board of Social Services. 287

"Child" means any natural person under 18 years of age.

288 "Child day center" means a child day program offered to (i) two or more children under the age of 289 13 in a facility that is not the residence of the provider or of any of the children in care or (ii) 13 or 290 more children at any location.

"Child day program" means a regularly operating service arrangement for children where, during the 291 292 absence of a parent or guardian, a person or organization has agreed to assume responsibility for the 293 supervision, protection, and well-being of a child under the age of 13 for less than a 24-hour period.

294 "Child-placing agency" means any person who places children in foster homes, adoptive homes or 295 independent living arrangements pursuant to § 63.2-1819 or a local board that places children in foster 296 homes or adoptive homes pursuant to §§ 63.2-900, 63.2-903, and 63.2-1221. Officers, employees, or 297 agents of the Commonwealth, or any locality acting within the scope of their authority as such, who 298 serve as or maintain a child-placing agency, shall not be required to be licensed.

299 "Child-protective services" means the identification, receipt and immediate response to complaints and reports of alleged child abuse or neglect for children under 18 years of age. It also includes 300

301 assessment, and arranging for and providing necessary protective and rehabilitative services for a child 302 and his family when the child has been found to have been abused or neglected or is at risk of being 303 abused or neglected.

304 "Child support services" means any civil, criminal or administrative action taken by the Division of 305 Child Support Enforcement to locate parents; establish paternity; and establish, modify, enforce, or 306 collect child support, or child and spousal support.

"Child-welfare agency" means a child day center, child-placing agency, children's residential facility, 307 308 family day home, family day system, or independent foster home.

309 "Children's residential facility" means any facility, child-caring institution, or group home that is 310 maintained for the purpose of receiving children separated from their parents or guardians for full-time care, maintenance, protection and guidance, or for the purpose of providing independent living services 311 312 to persons between 18 and 21 years of age who are in the process of transitioning out of foster care. 313 Children's residential facility shall not include:

1. A licensed or accredited educational institution whose pupils, in the ordinary course of events, 314 return annually to the homes of their parents or guardians for not less than two months of summer 315 316 vacation:

317 2. An establishment required to be licensed as a summer camp by \S 35.1-18; and 318

3. A licensed or accredited hospital legally maintained as such.

319 "Commissioner" means the Commissioner of the Department, his designee or authorized 320 representative. 321

"Department" means the State Department of Social Services.

322 "Department of Health and Human Services" means the Department of Health and Human Services 323 of the United States government or any department or agency thereof that may hereafter be designated 324 as the agency to administer the Social Security Act, as amended.

325 "Disposable income" means that part of the income due and payable of any individual remaining after the deduction of any amount required by law to be withheld. 326

"Energy assistance" means benefits to assist low-income households with their home heating and 327 328 cooling needs, including, but not limited to, purchase of materials or substances used for home heating, 329 repair or replacement of heating equipment, emergency intervention in no-heat situations, purchase or 330 repair of cooling equipment, and payment of electric bills to operate cooling equipment, in accordance with § 63.2-805, or provided under the Virginia Energy Assistance Program established pursuant to the 331 Low-Income Home Energy Assistance Act of 1981 (Title XXVI of Public Law 97-35), as amended. 332

333 "Family day home" means a child day program offered in the residence of the provider or the home 334 of any of the children in care for one through 12 children under the age of 13, exclusive of the 335 provider's own children and any children who reside in the home, when at least one child receives care 336 for compensation. The provider of a licensed or registered family day home shall disclose to the parents or guardians of children in their care the percentage of time per week that persons other than the 337 provider will care for the children. Family day homes serving five through 12 children, exclusive of the 338 339 provider's own children and any children who reside in the home, shall be licensed. However, no family 340 day home shall care for more than four children under the age of two, including the provider's own 341 children and any children who reside in the home, unless the family day home is licensed or voluntarily 342 registered. However, a family day home where the children in care are all related to the provider by 343 blood or marriage shall not be required to be licensed.

"Family day system" means any person who approves family day homes as members of its system; 344 who refers children to available family day homes in that system; and who, through contractual 345 346 arrangement, may provide central administrative functions including, but not limited to, training of 347 operators of member homes; technical assistance and consultation to operators of member homes; 348 inspection, supervision, monitoring, and evaluation of member homes; and referral of children to 349 available health and social services.

350 "Foster care placement" means placement of a child through (i) an agreement between the parents or 351 guardians and the local board where legal custody remains with the parents or guardians or (ii) an 352 entrustment or commitment of the child to the local board or licensed child-placing agency.

353 "Foster home" means the place of residence of any natural person in which any child, other than a 354 child by birth or adoption of such person, resides as a member of the household.

"General relief" means money payments and other forms of relief made to those persons mentioned 355 356 in § 63.2-802 in accordance with the regulations of the Board and reimbursable in accordance with 357 § 63.2-401.

358 "Independent foster home" means a private family home in which any child, other than a child by 359 birth or adoption of such person, resides as a member of the household and has been placed therein independently of a child-placing agency except (i) a home in which are received only children related by 360 birth or adoption of the person who maintains such home and children of personal friends of such 361

362 person and (ii) a home in which is received a child or children committed under the provisions of363 subdivision A 4 of § 16.1-278.2, subdivision 6 of § 16.1-278.4, or subdivision A 13 of § 16.1-278.8.

"Independent living" means a planned program of services designed to assist a child age 16 and over and persons who are former foster care children or were formerly committed to the Department of Juvenile Justice and are between the ages of 18 and 21 in transitioning to self-sufficiency.

"Independent living arrangement" means placement of (i) a child at least 16 years of age who is in
the custody of a local board or licensed child-placing agency and has been placed by the local board or
licensed child-placing agency or (ii) a child at least 16 years of age or a person between the ages of 18
and 21 who was committed to the Department of Juvenile Justice immediately prior to placement by the
Department of Juvenile Justice, in a living arrangement in which he such child or person does not have
daily substitute parental supervision.

373 "Independent living services" means services and activities provided to a child in foster care 14 years 374 of age or older who was committed or entrusted to a local board of social services, child welfare agency, or private child-placing agency. "Independent living services" may also mean services and 375 376 activities provided to a person who (i) was in foster care on his 18th birthday and has not yet reached 377 the age of 21 years or; (ii) is at least 18 years of age but who has not yet reached 21 years of age 378 between the ages of 18 and 21 and who, immediately prior to his commitment to the Department of 379 Juvenile Justice, was in the custody of a local board of social services; or (iii) is a child at least 16 380 years of age or a person between the ages of 18 and 21 who was committed to the Department of 381 Juvenile Justice immediately prior to placement in an independent living arrangement. Such services 382 shall include counseling, education, housing, employment, and money management skills development, 383 access to essential documents, and other appropriate services to help children or persons prepare for 384 self-sufficiency.

385 "Independent physician" means a physician who is chosen by the resident of the assisted living
386 facility and who has no financial interest in the assisted living facility, directly or indirectly, as an
387 owner, officer, or employee or as an independent contractor with the residence.

388 "Intercountry placement" means the arrangement for the care of a child in an adoptive home or foster
389 care placement into or out of the Commonwealth by a licensed child-placing agency, court, or other
and the such placements in accordance with the laws of the foreign country under
391 which it operates.

"Interstate placement" means the arrangement for the care of a child in an adoptive home, foster care
placement or in the home of the child's parent or with a relative or nonagency guardian, into or out of
the Commonwealth, by a child-placing agency or court when the full legal right of the child's parent or
nonagency guardian to plan for the child has been voluntarily terminated or limited or severed by the
action of any court.

397 "Kinship care" means the full-time care, nurturing, and protection of children by relatives.

398 "Local board" means the local board of social services representing one or more counties or cities.

399 "Local department" means the local department of social services of any county or city in this400 Commonwealth.

401 "Local director" means the director or his designated representative of the local department of the 402 city or county.

403 "Merit system plan" means those regulations adopted by the Board in the development and operation
404 of a system of personnel administration meeting requirements of the federal Office of Personnel
405 Management.

406 "Parental placement" means locating or effecting the placement of a child or the placing of a child in407 a family home by the child's parent or legal guardian for the purpose of foster care or adoption.

408 "Public assistance" means Temporary Assistance for Needy Families (TANF); auxiliary grants to the
409 aged, blind and disabled; medical assistance; energy assistance; food stamps; employment services; child
410 care; and general relief.

"Qualified assessor" means an entity contracting with the Department of Medical Assistance Services
to perform nursing facility pre-admission screening or to complete the uniform assessment instrument for
a home and community-based waiver program, including an independent physician contracting with the
Department of Medical Assistance Services to complete the uniform assessment instrument for residents
of assisted living facilities, or any hospital that has contracted with the Department of Medical
Assistance Services to perform nursing facility pre-admission screenings.

417 "Registered family day home" means any family day home that has met the standards for voluntary
418 registration for such homes pursuant to regulations adopted by the Board and that has obtained a
419 certificate of registration from the Commissioner.

420 "Residential living care" means a level of service provided by an assisted living facility for adults
421 who may have physical or mental impairments and require only minimal assistance with the activities of
422 daily living. The definition of "residential living care" includes the services provided by independent

423 living facilities that voluntarily become licensed.

424 "Sibling" means each of two or more children having one or more parents in common.

"Social services" means foster care, adoption, adoption assistance, child-protective services, domestic
violence services, or any other services program implemented in accordance with regulations adopted by
the Board. Social services also includes adult services pursuant to Article 4 (§ 51.5-144 et seq.) of
Chapter 14 of Title 51.5 and adult protective services pursuant to Article 5 (§ 51.5-148) of Chapter 14
of Title 51.5 provided by local departments of social services in accordance with regulations and under
the supervision of the Commissioner for Aging and Rehabilitative Services.

"Special order" means an order imposing an administrative sanction issued to any party licensed
pursuant to this title by the Commissioner that has a stated duration of not more than 12 months. A
special order shall be considered a case decision as defined in § 2.2-4001.

434 "Temporary Assistance for Needy Families" or "TANF" means the program administered by the
 435 Department through which a relative can receive monthly cash assistance for the support of his eligible
 436 children.

437 "Temporary Assistance for Needy Families-Unemployed Parent" or "TANF-UP" means the
438 Temporary Assistance for Needy Families program for families in which both natural or adoptive
439 parents of a child reside in the home and neither parent is exempt from the Virginia Initiative for
440 Employment Not Welfare (VIEW) participation under § 63.2-609.

441 "Title IV-E Foster Care" means a federal program authorized under §§ 472 and 473 of the Social
442 Security Act, as amended, and administered by the Department through which foster care is provided on
443 behalf of qualifying children.
