6	A BILL to amend and reenact § 55-210.3:01 of the Code of Virginia, relating to the Uniform
7	Disposition of Unclaimed Property Act; bank deposits and funds in financial organizations; charges
8 9	on inactive accounts. Be it enacted by the General Assembly of Virginia:
10	1. That § 55-210.3:01 of the Code of Virginia is amended and reenacted as follows:
11	§ 55-210.3:01. Bank deposits and funds in financial organizations.
12	A. Any demand, savings, or matured time deposit with a banking or financial organization, including
13	deposits that are automatically renewable, and any funds paid toward the purchase of shares, a mutual
14	investment certificate, or any other interest in a banking or financial organization is presumed abandoned
15	unless the owner has, within five years:
16	1. In the case of a deposit or ownership of shares, increased or decreased the amount of the deposit
17	or the number of shares owned, or presented the passbook or other similar evidence of the deposit or
18 19	ownership of shares for the crediting of interest or dividends, or negotiated a check in payment of interest or dividends on a time dangeit or ownership of cherces
19 20	interest or dividends on a time deposit or ownership of shares; 2. Communicated in writing with the banking or financial organization concerning the property;
2 0 2 1	3. Otherwise indicated an interest in the property as evidenced by a memorandum or other record on
22	file prepared by an employee of the banking or financial organization;
23	4. Owned other property to which subdivision A 1, A 2, or A 3 is applicable if the banking or
24	financial organization communicated in writing with the owner with regard to the property that would
25	otherwise be presumed abandoned under this paragraph at the address to which communications
26	regarding the other property regularly are sent;
27	5. Had another relationship with the banking or financial organization concerning which the owner has (i) communicated in writing with the banking or financial organization or (ii) otherwise indicated on
28 29	has (i) communicated in writing with the banking or financial organization, or (ii) otherwise indicated an interest as evidenced by a memorandum or other record on file prepared by an employee of the banking
3 0	or financial organization if the banking or financial organization communicates in writing with the
31	owner with regard to the property that would otherwise be abandoned under this paragraph at the
32	address to which communications regarding the other relationship regularly are sent; or
33	6. A deposit made with or purchase of shares in a banking or financial organization by a court or by
34	a guardian pursuant to order of a court or by any other person for the benefit of a person who was an
35	infant at the time of the making of such deposit or purchase of shares, which deposit or ownership of
36	shares is subject to withdrawal or transfer only upon the further order of such court or such guardian or
37 38	other person, shall not be subject to the provisions of this chapter until one year after such infant attains the age of eighteen years or until one year after the death of such infant, whichever occurs sooner.
39	These accounts are not subject to dormant service charges.
40	B. Notwithstanding any other provision of this section, share accounts of a member of a state or
41	federally chartered credit union that is subject to or covered by life savings insurance provided by the
42	credit union at no additional charge to the member shall be presumed abandoned five years after the
43	date of the second mailing of a statement of account or other notification or communication that was
44	returned as undeliverable, or after the date the credit union discontinued the mailings to the member,
45	whichever is earlier. Funds held or owing under the life savings insurance policy are presumed
46 47	abandoned pursuant to § 55-210.4:01.
47 48	C. For purposes of this section, "property" includes any interest or dividends thereon. No banking or financial organization may deduct any service charge or cease to accrue interest on any account, from
4 9	the date the account is declared dormant or inactive by such organization except in conformity with
50	cessation of interest or service charges generally assessed upon active accounts and except as provided
51	in this section. With respect to any property described in this section, a holder may not impose any
52	charges due to dormancy or inactivity which differ from those charges imposed on active accounts or
53	cease to pay interest due to dormancy or inactivity that differs from the cessation of payment of interest
54	on active accounts unless:
55 54	1. There is an enforceable contract between the holder and the owner of the property pursuant to
56	which the holder may impose those charges or cease payment of interest;

57 2. For property in excess of \$100, the holder, no more than three months prior to the initial imposition of those charges or cessation of interest, has given written notice to the owner of the amount of those charges at the last known address of the owner stating that those charges will be imposed or

that interest will cease; however, such notice need not be given with respect to charges imposed orinterest ceased before July 1, 1984; and

62 3. When the holder imposes those charges or ceases payment of interest due to dormancy or 63 inactivity, it does not for any reason other than to correct a documented internal error reverse or cancel 64 those charges or retroactively credit interest with respect to such property unless (i) it does so for all 65 customers that request a reversal or cancellation of dormancy or inactivity charges or a retroactive 66 credit of interest, including those customers subject to § 55-210.12, or (ii) it does so to correct a documented internal error. Notwithstanding any provision of this subsection to the contrary, a holder 67 that is a state-chartered credit union may refund charges or reverse or cancel those charges or **68** 69 retroactively credit interest with respect to such property to the same extent that a federally-chartered 70 credit union is authorized so to do pursuant to applicable provisions of federal law.

71 D. Any automatically renewable property to which this section applies is matured upon the expiration 72 of its initial time period. However, in the case of any renewal to which the owner consents at or about the time of renewal by communicating in writing with the banking or financial organization or otherwise 73 indicates consent as specified in subsection A of this section, the property is matured upon the 74 75 expiration of the last time period for which consent was given. If, at the time provided for delivery in 76 subsection D of § 55-210.12, a penalty or forfeiture in the payment of interest would result from the delivery of the property, the time for delivery is extended until the time when no penalty or forfeiture 77 78 would result. Notwithstanding any other provision of this section to the contrary, any automatically 79 renewable time deposit that has matured shall be presumed abandoned five years after the date of the 80 second mailing of a statement of account or other notification or communication that was returned as 81 undeliverable, or after the date the holder discontinued the mailings to the apparent owner, whichever is earlier. However, any automatically renewable time deposit for which no such statement or other 82 notification or mailing is required to be sent by the banking or financial organization shall be presumed 83 84 abandoned as otherwise provided in this section.
