Be it enacted by the General Assembly of Virginia:

1. That § 51.5-116 of the Code of Virginia is amended and reenacted and that the Code of Virginia 8 9 is amended by adding in Article 10 of Chapter 14 of Title 51.5 a section numbered 51.5-169.1 as 10 follows: 11

§ 51.5-116. Definitions.

As used in this chapter, unless the context requires a different meaning:

13 "Case management" means a dynamic collaborative process that utilizes and builds on the strengths and resources of consumers to assist them in identifying their needs, accessing and coordinating services, 14 15 and achieving their goals. The major collaborative components of case management services include advocacy, assessment, planning, facilitation, coordination, and monitoring. 16

"Case management system" means a central point of contact linking a wide variety of evolving 17 services and supports that are (i) available in a timely, coordinated manner; (ii) physically and 18 19 programmatically accessible; and (iii) consumer-directed with procedural safeguards to ensure 20 responsiveness and accountability.

21 'Client" means any person receiving a service provided by the personnel or facilities of a public or 22 private agency, whether referred to as a client, participant, patient, resident, or other term. 23

"Commissioner" means the Commissioner for Aging and Rehabilitative Services.

24 "Consumer" means, with respect to case management services, a person with a disability or his 25 designee, guardian, conservator, or committee. 26

"Department" means the Department for Aging and Rehabilitative Services.

27 "Employment services organization" means an organization that provides employment services to 28 individuals with disabilities that is an approved Commission on Accreditation of Rehabilitation Facilities 29 (CARF) accredited vendor of the Department.

30 "Local board" means a local board of social services established pursuant to Article 1 (§ 63.2-300 et seq.) of Chapter 3 of Title 63.2. 31

32 "Local department" means a local department of social services established pursuant to Article 2 (§ 63.2-324 et seq.) of Chapter 3 of Title 63.2. 33 34

"Local director" means a local director of social services appointed pursuant to § 63.2-325.

"Older person" or "older Virginian" means a person who is age 60 years or older.

"Physical or sensory disability" means a disability resulting in functional impairment or impairment 36 37 of the central nervous system, which may include but is not limited to brain injury, spinal cord injury, 38 cerebral palsy, arthritis, muscular dystrophy, multiple sclerosis, Prader-Willi syndrome, and systemic 39 lupus erythematosus (lupus).

40 "Prader-Willi syndrome" means a specific disorder that is usually caused by chromosomal change, 41 resulting in lifelong functional and cognitive impairments and life-threatening obesity.

42 "Rehabilitation technology" means the systematic application of technologies, engineering 43 methodologies, or scientific principles to meet the needs of and address the barriers confronted by individuals with disabilities in areas that include education, rehabilitation, employment, transportation, 44 45 independent living, and recreation. 46

§ 51.5-169.1. Long-Term Employment Support Services and Extended Employment Services.

47 A. Long-Term Employment Support Services and Extended Employment Services shall be provided in **48** the Commonwealth to assist individuals with a significant disability or most significant disability with 49 maintaining employment. The Department shall administer and make referrals for such services in 50 accordance with the provisions of this section.

B. Long-Term Employment Support Services shall be provided to individuals with a most significant 51 disability, as defined in 29 U.S.C. § 705, to assist such individuals with maintaining group-supported 52 53 employment or individual center-based, facility-based, or community-based employment through an 54 employment services organization.

55 All employment services organizations that provide group-supported, center-based, facility-based, or 56 community-based employment services to individuals with a most significant disability shall be eligible HB916ER

57 to receive funding for Long-Term Employment Support Services.

58 C. Extended Employment Services shall be provided to individuals with a most significant disability 59 and individuals with a significant disability, as those terms are defined in 29 U.S.C. § 705, to assist 60 such individuals with maintaining group-supported employment or individual center-based or 61 facility-based employment through an employment services organization. Extended Employment Services 62 funds may also be used to support such individuals that transition from group-supported, center-based, or facility-based employment into community-based employment. Extended Employment Services shall be 63 64 provided upon the informed choice of the individual being served and in accordance with the Commonwealth's Employment First initiative, federal law and regulation, and the Commonwealth's 65 August 23, 2012, settlement agreement with the U.S. Department of Justice. 66 67 All employment services organizations that provide group-supported, center-based, or facility-based

employment services to individuals with a most significant disability or individuals with a significant
disability, or that provide community-based employment services to such individuals transitioning from
group-supported, center-based, or facility-based employment, shall be eligible to receive funding for
Extended Employment Services. The Department shall make referrals to any such employment services
organization that provides competitive or commensurate wages.

73 D. In allocating funds for Long-Term Employment Support Services and Extended Employment 74 Services, the Department shall consider recommendations made by the Employment Service Organization
