 19 school lesson plans, responsive readings, music, and artwork to help churches organize a meaningful and
 20 engaging event; and

WHEREAS, Recovery Sundays provide a unique opportunity for a congregation to pray for those
 struggling with addiction, learn about the causes of this disease, build partnerships with local recovery
 organizations, provide support for members of the community in need, or start a recovery ministry; now,
