That § 19.2-389.1 of the Code of Virginia is amended and reenacted as follows: 11 § 19.2-389.1. Dissemination of juvenile record information. 12 13 Record information maintained in the Central Criminal Records Exchange pursuant to the provisions 14 of § 16.1-299 shall be disseminated only (i) to make the determination as provided in §§ 18.2-308.2 and 15 18.2-308.2:2 of eligibility to possess or purchase a firearm; (ii) to aid in the preparation of a pretrial investigation report prepared by a local pretrial services agency established pursuant to Article 5 16 (§ 19.2-152.2 et seq.) of Chapter 9, a presentence or post-sentence investigation report pursuant to 17 § 19.2-264.5 or 19.2-299 or in the preparation of the discretionary sentencing guidelines worksheets 18 pursuant to subsection C of § 19.2-298.01; (iii) to aid local community-based probation services agencies 19 20 established pursuant to the Comprehensive Community Corrections Act for Local-Responsible Offenders 21 (§ 9.1-173 et seq.) with investigating or serving adult local-responsible offenders and all court service 22 units serving juvenile delinquent offenders; (iv) for fingerprint comparison utilizing the fingerprints 23 maintained in the Automated Fingerprint Information System (AFIS) computer; (v) to attorneys for the 24 Commonwealth to secure information incidental to sentencing and to attorneys for the Commonwealth 25 and probation officers to prepare the discretionary sentencing guidelines worksheets pursuant to subsection C of § 19.2-298.01; (vi) to any full-time or part-time employee of the State Police, a police 26 27 department or sheriff's office that is a part of or administered by the Commonwealth or any political 28 subdivision thereof, and who is responsible for the prevention and detection of crime and the 29 enforcement of the penal, traffic or highway laws of the Commonwealth, for purposes of the 30 administration of criminal justice as defined in § 9.1-101; (vii) to the Department of Forensic Science to 31 verify its authority to maintain the juvenile's sample in the DNA data bank pursuant to § 16.1-299.1; (viii) to the Office of the Attorney General, for all criminal justice activities otherwise permitted and for 32 33 purposes of performing duties required by the Civil Commitment of Sexually Violent Predators Act (§ 37.2-900 et seq.); (ix) to the Virginia Criminal Sentencing Commission for research purposes; (x) to 34 35 members of a threat assessment team established by a school board pursuant to § 22.1-79.4, by a public 36 institution of higher education pursuant to § 23.1-805, or by a private nonprofit institution of higher 37 education, to aid in the assessment or intervention with individuals whose behavior may present a threat to safety; however, no member of a threat assessment team shall redisclose any juvenile record 38 39 information obtained pursuant to this section or otherwise use any record of an individual beyond the 40 purpose that such disclosure was made to the threat assessment team; and (xi) to any full-time or 41 part-time employee of the State Police or a police department or sheriff's office that is a part of or 42 administered by the Commonwealth or any political subdivision thereof for the purpose of screening any person for full-time or part-time employment with the State Police or a police department or sheriff's 43 office that is a part of or administered by the Commonwealth or any political subdivision thereof; (xii) 44 to the State Health Commissioner or his designee for the purpose of screening any person who applies 45 to be a volunteer with or an employee of an emergency medical services agency as provided in 46 47 § 32.1-111.5; and (xiii) to the county, city, or town manager or chief law-enforcement officer located in 48 a locality that has adopted an ordinance in accordance with §§ 15.2-1503.1 and 19.2-389 for the purpose of screening any person who applies to be a volunteer with or an employee of an emergency 49 medical services agency as provided in § 32.1-111.5. 50
