That § 46.2-1163 of the Code of Virginia is amended and reenacted as follows: 11 § 46.2-1163. Official inspection stations; safety inspection approval stickers; actions of 12 Superintendent subject to the Administrative Process Act. 13 14 The Superintendent may designate, furnish instructions to, and supervise official inspection stations for the inspection of motor vehicles, trailers, and semitrailers and for adjusting and correcting equipment 15 16 enumerated in this chapter in such a manner as to conform to specifications hereinbefore set forth. The Superintendent shall adopt and furnish to such official inspection stations regulations governing the 17 making of inspections required by this chapter. The Superintendent may at any time, after five days' 18 written notice, revoke the designation of any official inspection station designated by him. 19 20 If no defects are discovered or when the equipment has been corrected in accordance with this title, 21 the official inspection station shall issue to the operator or owner of the vehicle, on forms furnished by 22 the Department of State Police, a duplicate of which is retained by such station, a certificate showing 23 the date of correction, registration number of the vehicle, and the official designation of such station. On 24 or before December 1, 2010, any information an official inspection station is required to provide to the 25 Department of State Police shall be accepted by the Department in electronic form. There also shall be placed on the windshield of the vehicle at a place to be designated by the Superintendent an approval 26 27 sticker furnished by the Department of State Police. If any vehicle is not equipped with a windshield, 28 the approval sticker shall be placed on the vehicle in a location designated by the Superintendent. If the 29 vehicle is a motorcycle, the approval sticker may be placed on a plate securely fastened to the motorcycle for the purpose of displaying the sticker or in any other location designated by the 30 31 Superintendent. This sticker shall be displayed on the windshield of such vehicle or at such other designated place upon the vehicle at all times when it is operated or parked on the highways in the 32 33 Commonwealth and until such time as a new inspection period shall be designated and a new inspection 34 sticker issued. A valid approval sticker properly displayed on a vehicle shall give rise to a rebuttable 35 presumption that there are no defects in the equipment subject to such safety inspection on such vehicle. 36 Common carriers, operating under certificate from the State Corporation Commission or the Department 37 of Motor Vehicles, who desire to do so may use with the approval of the Superintendent private 38 inspection stations for the inspection and correction of their equipment. The Superintendent shall provide motor vehicle safety inspection information upon the written 39 40 request of an individual or corporate entity or such entity's agent. Any information provided shall not include personal information. The Superintendent may make a reasonable charge for furnishing 41 information under this section but no fee shall be charged to any official of the Commonwealth,

42 including court and police officials; officials of counties, cities, or towns; local government 43 self-insurance pools; or the court, police, or licensing officials of other states or of the federal 44 45 government, provided that the information requested is for official use and such officials do not charge 46 the Commonwealth a fee for the provision of the same or substantially similar information. Vehicle information, including all descriptive vehicle data, submitted to or received from the Department of State 47 48 Police related to such a request shall not be considered a public record for the purposes of the Virginia 49 Freedom of Information Act (§ 2.2-3700 et seq.). The fees received by the Superintendent pursuant to this section shall be paid into the state treasury and shall be set aside as a special fund to be used to 50 51 meet the expenses of the Department of State Police's motor vehicle safety inspection program.

52 Actions of the Superintendent relating to official inspection stations shall be governed by the 53 provisions of the Administrative Process Act (§ 2.2-4000 et seq.).
