18104335D **SENATE BILL NO. 900** 1 Offered January 19, 2018 2 3 A BILL to provide for the submission to the voters of a proposed amendment to Section 6-A of Article X 4 of the Constitution of Virginia, relating to real property tax; exemption. 5 Patrons-Stuart and Cosgrove 6 7 Referred to Committee on Privileges and Elections 8 9 Be it enacted by the General Assembly of Virginia: 10 1. § 1. It shall be the duty of the officers conducting the election directed by law to be held on the Tuesday after the first Monday in November 2018, at the places appointed for holding the same, to open 11 12 a poll and take the sense of the qualified voters upon the ratification or rejection of the proposed amendment to the Constitution of Virginia, contained herein and in the joint resolution proposing such 13 14 amendment, to wit: Amend Section 6-A of Article X of the Constitution of Virginia as follows: 15 16 ARTICLE X TAXATION AND FINANCE 17 18 Section 6-A. Property tax exemption for certain veterans and their surviving spouses and surviving 19 spouses of soldiers killed in action. 20 (a) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within 21 the restrictions and conditions prescribed therein, shall exempt from taxation the real property, including 22 the joint real property of husband and wife, of any veteran who has been determined by the United 23 States Department of Veterans Affairs or its successor agency pursuant to federal law to have a one 24 hundred percent service-connected, permanent, and total disability, and who occupies the real property as 25 his or her principal place of residence. The General Assembly shall also provide this exemption from taxation for real property owned by the surviving spouse of a veteran who was eligible for the 26 27 exemption provided in this subdivision, so long as the surviving spouse does not remarry and continues 28 to occupy the real property as his or her principal place of residence. This exemption applies to the 29 surviving spouse's principal place of residence without any restriction on the spouse's moving to a 30 different principal place of residence. 31 (b) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within the restrictions and conditions prescribed therein, may exempt from taxation the real property of the 32 33 surviving spouse of any member of the armed forces of the United States who was killed in action as 34 determined by the United States Department of Defense, who occupies the real property as his or her 35 principal place of residence. The exemption under this subdivision shall cease if the surviving spouse remarries and shall not be claimed thereafter. This exemption applies regardless of whether the spouse 36 37 was killed in action prior to the effective date of this subdivision, but the exemption shall not be 38 applicable for any period of time prior to the effective date. This exemption applies to the surviving 39 spouse's principal place of residence without any restriction on the spouse's moving to a different 40 principal place of residence and without any requirement that the spouse reside in the Commonwealth at 41 the time of death of the member of the armed forces. 42 § 2. The ballot shall contain the following question: "Question: Shall the real property tax exemption for a primary residence that is currently provided to 43 44 the surviving spouses of veterans who had a one hundred percent service-connected, permanent, and 45 total disability be amended to allow the surviving spouse to move to a different primary residence and 46 still claim the exemption?" 47 The ballots shall be prepared, distributed and voted, and the results of the election shall be ascertained and certified, in the manner prescribed by § 24.2-684 of the Code of Virginia. The State 48 49 Board of Elections shall comply with § 30-19.9 of the Code and shall cause to be sent to the electoral 50 boards of each county and city sufficient copies of the full text of the amendment and question 51 contained herein for the officers of election to post in each polling place on election day. 52 The electoral board of each county and city shall make out, certify and forward an abstract of the 53 votes cast for and against such proposed amendment in the manner now prescribed by law in relation to

55 The State Board of Elections shall open and canvass such abstracts and examine and report the whole number of votes cast at the election for and against such amendment in the manner now 56 prescribed by law in relation to votes cast in general elections. The State Board of Elections shall record 57 58 a certified copy of such report in its office and without delay make out and transmit to the Governor an

official copy of such report, certified by it. The Governor shall without delay make proclamation of the 59 result, stating therein the aggregate vote for and against the amendment. If a majority of those voting vote in favor of the amendment, it shall become effective on January 1, 60
