9 10	Be it enacted by the General Assembly of Virginia:
10	1. That §§ 40.1-28.9 and 40.1-28.10 of the Code of Virginia are amended and reenacted as follows:
12	§ 40.1-28.9. Definitions; determining wage of tipped employees.
13	A. As used in this article:
14	A. "Employer" includes any individual, partnership, association, corporation, business trust, or any
15	person or groups of persons acting directly or indirectly in the interest of an employer in relation to an
16 17	employee; B. "Employee" includes any individual employed by an employer, except the following:
18	1. Any person employed as a farm laborer or farm employee;
19	2. Any person employed in domestic service or in or about a private home or in an eleemosynary
20	institution primarily supported by public funds;
21	3. Any person engaged in the activities of an educational, charitable, religious, or nonprofit
22 23	organization where the relationship of employer-employee does not, in fact, exist, or where the services
23 24	rendered to such organizations are on a voluntary basis; 4. Newsboys, shoe-shine boys, caddies on golf courses, babysitters, ushers, doormen, concession
25	attendants, and cashiers in theaters;
26	5. Traveling salesmen or outside salesmen working on a commission basis; taxicab drivers and
27 28	operators;
28 29	6. Any person under the age of 18 in the employ of his father, mother, or legal guardian; 7. Any person confined in any penal or corrective institution of the State Commonwealth or any of
30	its political subdivisions or admitted to a state hospital or training center operated by the Department of
31	Behavioral Health and Developmental Services;
32	8. Any person employed by a boys' and/or girls' summer camp;
33 34	9. Any person under the age of 16, regardless of by whom employed; 10. Any person who normally works and is paid based on the amount of work done;
34 35	10. Any person who normany works and is paid based on the amount of work done, 11. [Repealed.]
36	12. Any person whose employment is covered by the Fair Labor Standards Act of 1938 as amended;
37	13. Any person whose earning capacity is impaired by physical deficiency, mental illness, or
38	intellectual disability;
39 40	14. 12. Students participating in a bona fide educational program; 15. 13. Any person employed by an employer who does not have four or more persons employed at
41	any one time; provided that husbands, wives, sons, daughters, and parents of the employer shall not be
42	counted in determining the number of persons employed;
43	16. 14. Any person who is less than 18 years of age and who is currently enrolled on a full-time
44 45	basis in any secondary school, institution of higher education, or trade school, provided <i>that</i> the person is not employed more than 20 hours per week;
43 46	16A. 15. Any person of any age who is currently enrolled on a full-time basis in any secondary
47	school, institution of higher education, or trade school and is in a work-study program or its equivalent
48	at the institution at which he or she is enrolled as a student; or
49 50	17. 16. Any person who is less than 18 years of age and who is under the jurisdiction and direction
50 51	of a juvenile and domestic relations district court. "Employer" includes any individual, partnership, association, corporation, or business trust or any
51 52	person or groups of persons acting directly or indirectly in the interest of an employer in relation to an

54	C. "Wages" means legal tender of the United States or checks or drafts on banks negotiable into cash
55 56	on demand or upon acceptance at full value; provided, wages may include the reasonable cost to the employer of furnishing meals and for lodging to an employee, if such board or lodging is customarily
50 57	furnished by the employer, and used by the employee.

58 D. B. In determining the wage of a tipped employee, the amount paid such employee by his 59 employer shall be deemed to be increased on account of tips by an amount determined by the employer, 60 except in the case of an employee who establishes by clear and convincing evidence that the actual 61 amount of tips received by him was less than the amount determined by the employer. In such case, the 62 amount paid such employee by his employer shall be deemed to have been increased by such lesser 63 amount. 64

## § 40.1-28.10. Minimum wages.

Every A. Prior to July 1, 2019, every employer shall pay to each of his employees wages at a rate 65 not less than the federal minimum wage and a or, if applicable, the federal training wage as prescribed 66 by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.). 67

B. From July 1, 2019, until January 1, 2020, every employer shall pay to each of his employees 68 wages at a rate not less than the greater of (i) \$9.00 per hour or (ii) the federal minimum wage as 69 70 prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.).

C. From January 1, 2020, until January 1, 2021, every employer shall pay to each of his employees 71 wages at a rate not less than the greater of (i) \$10.00 per hour or (ii) the federal minimum wage as 72 73 prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.).

D. From January 1, 2021, until January 1, 2022, every employer shall pay to each of his employees 74 wages at a rate not less than the greater of (i) \$11.00 per hour or (ii) the federal minimum wage as 75 76 prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.).

77 E. From January 1, 2022, until January 1, 2023, every employer shall pay to each of his employees wages at a rate not less than the greater of (i) \$13.00 per hour or (ii) the federal minimum wage as 78 79 prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.).

F. From January 1, 2023, until January 1, 2024, every employer shall pay to each of his employees 80 wages at a rate not less than the greater of (i) \$15.00 per hour or (ii) the federal minimum wage as prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.). 81 82

83 G. From and after January 1, 2024, every employer shall pay to each of his employees wages at a rate not less than the greater of (i) the adjusted state hourly minimum wage or (ii) the federal minimum 84 85 wage as prescribed by the U.S. Fair Labor Standards Act (29 U.S.C. § 201 et seq.). As used in this subsection, "adjusted state hourly minimum wage" means the amount established by the Commissioner 86 87 pursuant to subsection H.

88 H. By October 1, 2023, and annually thereafter, the Commissioner shall establish the adjusted state 89 hourly minimum wage that shall be in effect during the 12-month period commencing on the following January 1. The Commissioner shall set the adjusted state hourly minimum wage at the sum of (i) the 90 91 amount of the state hourly minimum wage rate that is in effect on the date such adjustment is made and 92 (ii) a percentage of the amount described in clause (i) that is equal to the percentage by which the

93 United States Average Consumer Price Index for all items, all urban consumers (CPI-U), as published

94 by the Bureau of Labor Statistics of the U.S. Department of Labor, or a successor index as calculated

by the U.S. Department of Labor, has increased during the most recent calendar year for which such 95

96 information is available. The amount of each annual adjustment shall not be less than zero.
